#### **Board of Ed Votes to Move Elections to November**

Pro's and Con's: Audience Members & Two City Council Members Voice Their Opinions

PERTH AMBOY - At the February 8, 2012 City Council Meeting Fernando Gonzalez on the advice of Council abstained from voting when it came to changing the Board of Education Election Date to November. Councilmen Bill Petrick and Kenneth Gonzalez voted "no" to change the date to November while Joel Pabon and Kenneth Balut voted "yes". The resolution was not passed. This put the decision in the hands of the School Board.

At the February 9, 2012 School Board Meeting Dianne Roman, Kurt Rebovich and Mark Carvaial voted "no" to move the elections to Novem- stated at the beginning of this ber. Rebovich and Carvajal chose to eleaborate on the decision. Carvajal stated, "As far

as the \$35,000 savings is concerned if the elections were moved, I researched other towns who did this. The cost in savings was actually little or next to nothing. By moving the elections to November we are telling the public when to vote and what to vote on. The bottom line is that this was pushed through much too quickly."

Rebovich read from aprepared statement. "If the Board of Education is going to work together we need to listen to the parents and community. We heard many community members speak. If we are going to work together like we meeting, we would not move the election. I think of the elderly voters who work the

polls and need that money to eat and to live. Many of them have reached out to me. They wanted to know if the money is already budgeted this year why would we move the elections?" Rebovich went on to say, "Money spent on our residents changes hands five times in our community before it leaves. I wasn't put here to serve the board for my own interest but to serve the people who elected me. The community has told us twice not to move the election."

Although Fernando Gonzalez abstained at the City Council Meeting on this matter, he urged his fellow Council Members to vote "yes" to change the Board of Ed Elec-

#### **Perth Amboy Council** Meeting 2/8/2012

PERTH AMBOY - "Mr. Snipes saved more lives than the whole State has done. Even the Assemblyman should be embarrassed to be here. They wasted more time on drawing up the proclamation than on the safety of the bridge." These words were spoken by frequent Council Attendee Reinaldo Aviles. Aviles was referring to how Mr. Snipes actions brought attention to the problems associated with the Victory Bridge which has no real barriers to prevent people from attempting to commit to harm themselves by jumping off.

There was a large turnout of people, supporters and family members (Of Mr. Snipes and the troubled young man who Mr. Snipes saved) at the meet-

This also prompted Resident Dorothy Daniel to comment about how it also puts our police, firemen and other emergency personnel in danger. "Whenever they go into the water to retrieve a life there

is a chance that they might be caught in a current. I don't want to lose "my guys". I used to speak to the previous administration about the suicide bridge. I am not sure about the numbers but I believe there have been about 23 attempts and 17 completions of people who took their own lives."

Council President Kenneth Balut said, "The Bridge that is up now is not the original design and it went over budget."

Mayor Diaz commented that she met with Assemblyman John S. Wisniewski in 2008 asking for help for improvements with the Victory Bridge. She also sent a letter dated October 27, 2011 to James Simpson, Commissioner of NJDOT (New Jersey Department of Transportation) asking for funding for bridge improvements. (See Page 10 for complete letter)

There was a letter from NJ-DOT dated December 28, 2011 stating that at this time there was no available funding to help for improvements.

tions to November. As he did at the Council Meeting, he brought up the \$35,000 savings at the Board of Ed Meeting on February 9, 2012. "I believe that you would get between 8000 to 9000 voters to come out compared to the pitiful 700 people who voted at the last Board of Ed Election. Let's not lose sight of what is important. Our people are smart. We are going to save money and increase voter participation."

Bill Petrick took the opposite position from Fernando Gonzalez when he spoke at the Council and School Board Meeting. "Let's not be fixated on numbers. In November you may have a large number of people coming out to vote, but they may not be engaged in voting for School Board Members. Mixing up the School Board with the General Elections is a bad move."


PTO Community Liaison Jeanette Gonzalez was against moving the School Board Elections to November. "We take these elections seriously and get a good caliber of people who run. The voters will not be able to vote on the budget and there are too many elections that will be going on this November."

PTO Vice President Donna Stewart states, " Because we are a minority School District that is why we lack a new High School. Stop playing with our emotions. No one has thought about our children except for three people. There is no follow up when we ask questions. I am hurt with the elections being moved to November."

Concerned parent Melvinia Knight stated, "A bigger turnout does not mean that they will vote for the Board of Education. The \$35,000 savings of moving the election is not going to make much of a difference in my taxes. We should keep the election in April to stay focused on the Board of Ed Issues."

Resident Reinaldo Aviles had strong opinions about keeping the Board of Ed Elections to April. At the February 8, 2012 Council Meeting he agreed with Mr. Petrick that people don't always vote in all elections. "If you vote "ves" on moving the School Board Elections you take it out of the hands of the School Board Members. The people should decide on term extensions which is sacred." He reiterated at the School Board Meeting, "When I voted it was a specific term for the people to serve. You want a sovereignty to the Board of Ed Elections. The Council was divided when they voted. The voters will be confused if you

move the School Board Elections to November. I urge the Board Members to vote "no" for this move."

Besides the School Board Election Issue another topic that was on the minds of some of the audience members had to do with getting a new High School. Ms. Jeanette Gonzalez, Ms. Knight and Ms. Stewart were very adamant that a new High School must be built. "The High School that we have now was originally built for 1200 students. We must have close to 2500," said Ms. Knight. "When we had the High School Graduation inside the seating was very limited. Many family members of the graduates could not attend. You should spend money on a bigger place whenever you have to move the graduation inside."

Jeanette Gonzalez said, "We need a new High School. There is money for a new school! Talk to our legislatures about talking to the Board! This is a Civil Rights Issue when it comes to the need for a new High School!"

"The Buildings and Grounds Committee should get involved about getting a new High School and fixing existing schools," stated former BOE Member Greg Diaz.

Former Board Member Ron Mascenik noted that his daughter a Junior in College was a Freshman in High School when the new High School was first discussed. "You can't always depend on the State. Sometimes you have to take matters into your own hands to get things done. We had a building program in this district in the past. Every year it gets worse."



#### Election 2012 Perth Amboy

I must say I am truly looking forward to the November 2012 Elections coming up. Recently the Board of Education decided to move their elections from April to November. The pro's and con's of doing this was discussed at the Perth Amboy Council Meeting on 2/8/12 and the Board of Education Meeting on 2/9/12. The biggest sticking points were the savings of \$35,000 and the anticipation of the possibility of more voter participation.

Several speakers said that the Board of Education should remain in April to keep the focus on Board of Education matters and that perhaps people would be confused by so many names and items on the November Ballot.

I personally love to vote in both the Board of Education and General Elections. both are held at the same time that means I would vote for the Board Members and the people running in the General Election. So either way if the Board of Education kept the date in April I still would have voted. ### Have We Lost It?

I am not infallible by no means. I make errors and mistakes and if you think otherwise you probably need help.

My thoughts on Coach Joe Paterno may differ with some readers out there . Imet Joe after the first Liberty Bowl in December of 1959. The game was played in freezing weather at Soldier's Field in Philadelphia. Penn State beat Alabama that day 7 - 0. Joe was the assistant coach to Rip Engle. Joe and I were still kids. I remember telling him that I threw baseballs down in Tuscaloosa and he told me that he threw footballs up at Brown. I had no idea where Brown was and I don't think Joe knew where Tuscaloosa was. There were two coaches on that field on Dec. 1959 that would become legends. Paul Bryant became the most winning coach in college football and Joe Paterno broke his record. I've read in some local newspapers that Joe Paterno was not greater than Penn. State University. They came up with the same fairy tale about Bryant. There are still people down in Alabama that believe that Bear Bryant could walk on water. I decided to ask him about this one day. He said,"Tome (Southern accent) I have never tried it but I can't swim a damn stroke."

Another local resident was upset because someone said that College Park was only a Cow Town until Paterno became head coach in 1966. This lady graduated from Penn. State in 1962 if my memory serves me right. I decided to check this one out with a friend of mine that works at the Alumni Office at the University of Alabama. She was born and raised in College Park, lived near the Paterno's, went to grade and high school there and is a Penn. State Graduate.

Beaver Stadium seats over 100,000. She told me that the parking area that surrounds the stadium used to be a cow pasture. You can still see barns in the distance. The lady that once lived near Joe Paterno now lives in North Port, Alabama near Nick Sabin. She says his football players listen to him but his dog won't come back when he calls him. Before the Alabama- Penn State game this past year, Sabin said, "I will be proud and honored just to put my arms around Joe Paterno."

Many years ago I had a Sport's Club in East Brunswick. I was getting some good sports figures to speak at the club. One year Alabama came to the Meadowlands to play Rutgers. The Scarlet Knights almost won that game. I invited both Paul Bear Bryant and Frank Burns to speak at our next meeting. Frank was able to make it but the Bear sent me a wire. It read: "Tome - Thanks for the invitation but I still have one game left to prepare for. Give my regards to Frank." Signed Paul Bryant. Paul Bryant came back to build a football program at his home in Tuscaloosa. He came back from Texas A&M and his famous Junction Boys. The first time I ever met Coach (there were about 58 coaches but if you said coach there was only one) was in the Athletic Department. I was borrowing 25 Cents from one of the basketball players. Bryant asked me my name and why I needed 25 Cents. I told him, "It 's for a book." He gave me a quarter and I thank him. I tried to repay him later but he would never take the 25 Cents.

I lived near the football field and during football season those lights would be on well after midnight. Paul Bryant was building a major football program and Tuscaloosa would be more than just a bus stop. The last time I saw Paul Bryant was in 1974. My son was four years old. I took a picture of the Bear and Johnny at half time of a game against Rice. That is some of my thoughts on the past or yesterday

I have been criticized by some for thinking about the past but we are a product of the past and only a fool refuses to learn from past experiences. I wrote a syllabus in 1975. My study explained how the nervous system can effect health especially if you are already trying to cure an illness. It certainly shows the healing process down.

Check with your doctor and they will tell you the same thing. Yestervear the boss or Big Boys thought about the other guy or that employee who has put many years of his life into his job. You treat that guy the same as you would want to be treated. Yes my friends, I didn't go to school to learn this in a sand box right in my backyard. The new line of thought by the Big Boys is different. They say, "Let's see what we can do t et rid of this long time employee." I doubt if these big boys ever played in a sandbox.

Joe Paterno has to be the ultimate of all cases. I believe he did the right thing by reporting the incident to his superiors. The Big Boys or trustees made a huge mistake. They needed a big name so let's go after the quarterback. They give him a phone call and tell him, "You are fired." They hit a below the belt and they hit a guy that was already down. I think that he was treated shabbily and like dirt. They could even asked him retire early. Do I think this tension killed him while battling lung cancer? It certainly didn't help him recover. Knute Rockne and Paul Bryant will always mean Notre Dame and Alabama to me and now Joe Paterno will always mean Penn State to me.

PERTH AMBOY - At the February PARA meeting, PARA staff and several commissioners were present, including Mayor Wilda Diaz, Chairperson. The meeting began will all aforementioned parties expressing their sincere and "bittersweet" thanks to Helga Van Eckert, who held several positions in the City's government, and who recently tendered her resignation. Ms. Van Eckert has accepted a new position in Florida. She was presented with a lovely bouquet of flowers in appreciation for her years of service.

The next item on the meeting's agenda was the Bill List, which totaled \$63,000 from 10/5/11 to 2/7/12. Ms. Van Eckert, in her role as Executive Director, gave the following report: First, Bunzl Distribution has moved into the Perth Amboy Business Park on the Matrix site. Second, a green engineering firm will be demolishing and remediating some property on 2nd St., with the intention of building new offices and moving in. The property owned by Hampshire Properties. They are seeking design approval for a project that will be powered by solar energy.

In his report, City Attorney Mr. Maraziti mentioned that a review of the contract with Viridian energy will take place in closed session. City Engineer Tom Herits also stated that his report on the Viridian situation will take place in closed session.

The public portion of the meeting began with Ken Balut, City Council President, asking why PARA was not suing the developer JBW for contract violation. This developer transferred ownership of a piece of city property to developer European Homes, without informing the City. A substantial amount of legal fees have been incurred as a result of being caught between developers. City the two Attorney Maraziti stated that he would look into the matter

Billy Delgado, a current

Mayoral candidate next had a question concerning the Landings construction project. Mr. Delgado asked Ms. Van Eckert what role PARA had in the problems homeowners have faced with water leaks and faulty construction in their homes. Ms. Van Eckert responded that the matter was an warranty issue for homeowners to take up with the developer.

The Board President of one of the project's buildings, Eric Horne, then spoke, pleading with the City to force the developer to take some action to remediate the ongoing problems homeowners have faced. Mr. Maraziti stated the PARA has no legal role in this matter. Landings Board Member Neil Hunter stated the PARA has a moral obligation to support the Landings residents in the myriad difficulties they are facing, as well as make the best decision on the project's future for all of Perth Amboy.

Regarding the completion of the project, which has stalled, Mayor Diaz stated, "Conversations are taking place on designs; designs which do not financially hurt the City." Recent comments made by Jared Kushner, son of the developer in charge of the Landings project Charles Kushner, would seem to contradict the City's position on the project. Jared Kushner, in remarks to the Star Ledger, stated the plans for completing the Landings project, "have been submitted, will create jobs, tax revenues and revitalize the waterfront." He also stated that the plans are "shovel ready, with financing in place."

City Attorney Maraziti stated that there had been no meeting of the minds on the Landings project and that many questions remained. He also stated that Mr. Kushner had submitted not one piece of additional information on the completion of the project since providing conceptual drawings last August.

#### Perth Amboy Caucus Meeting February 6, 2012

PERTH AMBOY - At the caucus meeting of Feb. 6, several directors spoke on their departmental budget needs: Police: Replacement of vehicles, 3 SUV's in 2012 and 3 in 2013. These are consumables and cannot be paid for through bond issues.

Jefferson Street Parking Garage: A 3.2M proposal is being re-examined to consider repair versus demolition of some portions. The City also wants to insure enough revenue comes in through increased parking rates before commencing construction this summer.

Fire: The specifications go in the bid for that will a custom-made Fire Engine are being finalized. Delivery time is to be 12 months. A new thermal imaging system purchase was also discussed. Repair of the present system is not feasible, per the manufacturer.

The Redevelopment: County site plan is done and values are being finalized by the city appraiser for right of way purchase for the connector road between Rt. 35 to Amboy Ave. near the old fire station, across from Delaney Homes property. However, there is no definite schedule for any construction since this schedule is controlled by the County.

Recreation: The most important items for the Rec Dept. are lights for the tennis court and the building for the Youth Complex which is under construction on Brighton Avenue at Sadowski Parkway. A Green Acres grant is being pursued.


That concluded the requests.

These requests exceed \$5 million in new debt which does nothing to lower the City's debt by 3.3M, which is the target set by the City for its budget, by Business Administrator Greg Fehrenbach.

Next, it was noted that a letter had been received by Mr. Al Jacobs, whose term just ended on the Port Authority Board. A few of the councilmen voice their approval for Mr. Jacobs and hoped that he was able to stay for a new term.

Discussion was carried out regarding the pros and cons of moving the Board of Education election from April to November. The Pros include reduced expenses for poll workers and a perception that holding the election for the Board would increase the perception of its importance perhaps increase voter turnout. The main Con was having a very crowded ballot with so many elections occurring on the same day, resulting in a difficult and confusing ballot. Also, debate transpired over whether the Board of Ed or the Council should make this decision, since both bodies are authorized to do so.

During the Public Comment: Michael George, Chairman of the Port Authority (Marina) board stated his opposition to repairing the piers before the bulkheads along the water-"That's like building the house before the foundation," he said. He also asked why the City is waiting to do this in summer when we are having a mild winter? Mr. Ferhenbach stated he wished he could have delegated the job to Mr. George, but he can't. George's reply was "I

wish you had, it would have been done already." Mr. Fehrenbach stated that it's being done as quickly as possible under FEMA and DEP procedures. George also asked why we couldn't we go green in regards to the purchase of 3 SUV's? Dep. Chief Ben Ruiz stated that the outside shells may look the same, but inside, these vehicles have good gas efficiencies.

Ricky Aviles addressed the process of advertising board and commission openings, collecting resumes and applications, reviewing these and even having public interviews of candidates. Volunteers cannot just be granted new or extended terms. Regarding the BOE election, his view was it's their (BOE) election, let them decide to move it or not and take the subsequent "heat".

Police Chaplain Greg Diaz also stated his opinion that the BOE should be the party to decide how to handle their elec-

At the end of the public portion, Greg Ferhenbach read a statement which he had prepared regarding "false allegations" that are a deterrent to his use of time dealing with the real problems of the city. An example of this is his having to deal with the placing of a metal sheet on the Veterans Memorial at the waterfront to cover up all of the committee names by Parks and Grounds staff. Fehrenbach stressed that no contractor has been hired, nor purchase order released, for this work - Park staff did

Dear Commissioner Simpson,

I am reaching out to you regarding a serious matter that both the City of Perth Amboy and the Borough of Sayreville are dealing with. When the Victory Bridge was first designed, there was fencing on both sides to prevent people from jumping from the bridge. In the interest of economy, this part of the construction was abandoned, and the bridge was built without the high fencing.

The entire bridge officially opened in September of 2005, and since then, there have been 17 reports of fatal and near fatal occurrences. These horrific incidents required the full attention of both Perth Amboy and Sayreville's emergency personnel. This involved not only the respective Police Departments, but the Fire Departments, First Responders, Police and Fire Boats. In addition, all traffic on the bridge is halted and all rail service on the Conrail bridge is stopped until the conclusion of the incident.

Our Police and Fire Departments are well trained to handle all situations that occur, but in these instances, our men and women are put at serious risk for their own lives in order to search for and retrieve a suicide victim – when they know that the proper fencing could have not only prevented the suicide attempt, but could have saved them from putting their own lives at risk. Also, how do we explain to the families and friends of the suicide victims that their death could have been prevented by building the bridge as originally designed. These are the people that I am deeply concerned about, because the installation of fencing could eliminate the hazardous conditions to our emergency personnel and victims.

The signs listing the suicide prevention hotline have done nothing to prevent people from jumping- in fact, they have been ignored.

Not installing the preventive fencing is a serious lack of compassion and regard for the safety and care of our emergency responders, and I am asking that this matter be reviewed as soon as possible so that we can stand behind our men and women to make sure that everything possible is being done to prevent future life threatening episodes.

 $\rm I$  am asking that we meet at the earliest possible time to address this most serious lack of safety on the Victory Bridge.



The acting is first rate from Jermey Divine as Albert (in his first major film). Emily Watson delivers some of the strongest lines as Albert's mother, Rose.


The book, play and film all give a different perspective of the same story. The novel tells the story from Joey's point of view and the play and film are from a narrative point of view.


