## **Superintendent Janine Caffrey Addresses Hector Muniz Ruling**

Attacks Board Member Varela - Varela Answers Back

PERTH AMBOY - Perth
Amboy Superintendent of
Schools Janine Walker Caffrey addressed the recent
court ruling on Dr. Herbert
N. Richardson 21st Century
Elementary School secretary
Hector Muniz in an interview
last Friday.

Old Bridge Municipal Court found Muniz guilty on Aug. 7 of possessing and selling alcoholic beverages on school property. He was fined \$664 and now the future of his employment in Perth Amboy is in the hands of the Board of Education.

The accusations against Muniz began back in 2012 right before the board placed Dr. Caffrey on paid administrative leave. Unable to complete her investigation, the decision was made by interim Superintendent Vivian Rodriguez to place Muniz and four other Richardson School employees on paid leave.

When she returned to work, Caffrey overturned the decision made by Rodriguez and reinstated the five employees. She said a full police report was completed and it was confirmed that nothing was found

"Serious errors were made in my absence," Caffrey explained. "A principal, vice principal, two secretaries, and a liaison were all put on leave and it was a huge disruption to the operations of that school... we had children to care for"

Caffrey went on to say that neither she nor the board of education knew anything about Muniz's activities before the summons was served by the police department.

She explained that statute 2C:33-16, the main statute in the decision against Muniz, proved nobody in the school district had knowledge of his actions. The statute reads as follows:

Any person of legal age to purchase alcoholic beverages, who knowingly and without the express written permission of the school board, its delegated authority, or any school principal, brings or possesses any alcoholic beverages on any property used for school purposes which is owned by any school or school board, is guilty of a disorderly persons offense.

"In order for Mr. Muniz to be guilty, the judge had to determine that neither the administrators, including me, nor the board knew anything about this," she said. "This was part of the 'finding of fact' that the judge read when he issued the verdict."

Susan Nieves, another secretary at Richardson School, filed a whistleblower lawsuit last year regarding the Muniz case. Nieves claimed that Muniz was selling alcohol to administrators and staff but that her supervisors "retaliated against her".

Caffrey said she cannot legally comment on the details of what Nieves has said while there is an investigation, but she did say that anyone could file a lawsuit against anyone. Her biggest concern was that many of the accusations in the case are hearsay and haven't been proven true in court, such as Nieves' claim that admin-

istrators turned a blind eye to what was going on.

Caffrey also commented on the scrutiny of her conduct and recent allegations made by board member Israel Varela.

She explained that multiple people have told her that Varela has been sending emails and making public comments making allegations about her that were "nasty and untrue".

"His public statements included things like 'she has been convicted of coquito' and he told people I was going to jail," Caffrey explained. "He emailed others telling them I had somehow conducted 'an illegal investigation' and some kind of 'administrative cover up'".

She found it fascinating that the last name Varela was mentioned in Muniz's court case and Israel Varela seemed to be the only one that has an issue with her conduct. She believed Varela was using the case as a way to attack her.

Varela, who has publicly taken on Caffrey on numerous occasions dating back to the beginning of her term, denied any involvement of himself or his family with Muniz.

He also said he would resign if he or anyone related to him were associated with the case,

## South Amboy's Waterfront Walkway Safety Issue Discussed on 8/7/13

By: Joseph L. Kuchie SOUTH AMBOY - At the 8/7/13 Council Business Meeting, there was an extensive discussion about the safety of the Waterfront Walkway.

City Engineer Mark Rasimowicz announced that bidding on the project would begin Aug. 22, but it was the current state of the area that was the topic of discussion.

Despite the fences and barricades that were put up at the walkway after Hurricane Sandy tore through the area, local residents continue to walk on the unstable path at all hours of the day.

Councilman Applegate want-

ed to know what was being done about the fences being knocked down and warned that residents would be hurt if the council continued to do nothing about the area.

He suggested that trespassing signs be added to the area or the fences be chained down so people couldn't get by them. Business Administrator Camille Tooker said she and Rasimowicz would look into alternatives to keep residents from using the walkway before construction begins.

The bond ordinance for the Waterfront Walkway will be discussed at the city's next council meeting on Aug. 21.

#### 9/11 Memorial Could Cost South Amboy \$300 Annually NJ Transit Could Charge Permit Fee for Monument

By: Joseph L. Kuchie SOUTH AMBOY - New Jersey Transit could charge South Amboy \$300 per year if a 9/11 memorial is built on the plaza outside the city's train station.

Independence Engine & Hose Co. No. 1, located next to the train station on North Broadway, came to the city with a plan for a monument to honor those who lost their lives on Sept. 11, 2001.

However, city officials

learned at last Wednesday's business meeting that NJ Transit could charge a \$300 yearly permit fee if the memorial were built on their property. That number would increase by two and a half percent annually after the first year as well.

Councilman Mickey Gross was disgusted by the possibility of the city paying to put up

but also called for Dr. Caffrey's resignation if nobody in his family was involved.

"If it's found that I or someone in my family purchased alcohol [from Muniz], I will resign immediately," Varela said in a phone interview. "But if [Muniz] didn't mention my name, I want [Dr. Caffrey] to pack her bags and resign."

Varela also questioned the emails that Caffrey reportedly received from "multiple people", saying that he only exchanged messages with board members. He explained that if board members were sharing his business emails with Caffrey, they were breaking the law.

"This is confidential information that was put out to board members only," Varela said. "I don't know which board member has given that information out but that's illegal. The only way she could say that is if a board member gave her confidential information and broke the law."

As for the comments, Varela was unsure where the information was coming from but was concerned about the information getting out.

"Sensitive materials are being leaked out by these administrators and they continue to break the law," he said. "I would like to know why these materials are getting put out there. They should not be released to general public until an investigation is done and a special meeting is heard."

Varela said he would be speaking with the board attorney regarding the released information. The fate of Muniz could be determined later this month at the next board meeting on Aug. 29 at 6 p.m.

a memorial in their town. He praised the fire department for making this initiative and wanted the rest of the council to figure something out.

"Our fire department is good enough and kind enough to do what's right by having a 9/11 memorial to remember the people who were possibly using our train station that day and maybe never returned," he said. "They have the nerve to charge us \$300? That's a disgrace."

Mayor Fred Henry noted that

Wednesday was the first time any of the city's officials had heard about this permit fee. He agreed with Gross that the permit fee was unacceptable and said the city would do what it takes to get the fee waived.

"Obviously we are going to let them know this is unacceptable," Henry said. "We can start by requesting a waiver and see where we go from there."

NJ Transit spokesperson John Durso confirmed that there is a fee but also recognized that this was a special use for the property. He said that NJ Transit would be willing to work something out with South Am-

"While it is true that NJ Transit's standard permitting fee is \$300 for the use of NJ Transit property, clearly South Amboy's proposed construction of a 9/11 memorial qualifies as a unique circumstance," Durso said. "To that end, NJ Transit is working with South Amboy to resolve the matter in a positive fashion and further facilitate the continued development of the memorial."

Councilman Gross suggested that the council send a letter to Gov. Chris Christie to explain the situation and try to find a way to get rid of the fee. South Amboy and NJ Transit will continue to work to reach a solution and get the monument built.

#### Skin in the Game

This editorial is reference to the letter printed on this page entitled Community Parental Forum Meeting.

The letter says it is a group forum made by students with supports of parents and other members of the community. They are also known as the "United Messengers of Peace."

The reason I am interested in this meeting to be held Thursday, August 15 at 6 p.m. at Perth Amboy High School because it will give students a chance to voice their opinions specifically on curriculum changes. Hence the title "Skin in the Game."

The students have invited the community, Board of Education Members, School Administrators including the Superintendent and Local Politicians to attend. I am hoping those invited find time to attend or send representatives in their place.

The core of this meeting has to do with the Honors Program being redefined.

Unlike the Board of Education Meetings, the students will be in control.

I was told those in attending will have a chance to speak and express their opinions with little restraint as long as they do it in a respectful manner. Since it is the students that will be affected by this change, they are the ones that should have the biggest and loudest voice.

It's one thing to say, "I understand," and another to walk in another person's shoes. Redefining the Honor's program can make a huge impact on the students who are involved in the classes.

The adults have had their time as students, but this is now affecting the future of the students currently enrolled in this program.

When I've attended the Board of Education Meetings and students spoke I was impressed with how articulate they were. I expect them to be more expressive since they will be in control.

I hope to be able to attend, but if I'm not able to, I will have representatives of the paper there.

I don't know how this meeting will turn out or if there will be any more forthcoming. If the students achieve the outcome they want it may be an encouragement to others.

The Honors Program gives students a head start when attending college. Students earn college credits while in high school which saves them both money and time in college. This allows Honor Students to graduate college early, which will cut down on expenses such as student loans. If an individual has college credits it may put them on the right track in what field they are interested in pursuing. Academic Guidance is so important when going to college. With the right guidance students are able to pursue a career which they are both interested and suited for. The Honors Program gives them that advantage.

### Statement From **Dr. Caffrey**Your recent story regarding

the Muniz case is biased and disappointing. You simply recounted a lawsuit with its allegations, along with the phrase "court documents say." It is important for readers to know that anyone can file a civil suit for anything. No verification of facts will take place until the suit goes through a lengthy process of discovery and eventually either settlement or a determination by a judge. The suit you reference is currently going through that process, so it is inappropriate to comment on it. When you said "court documents say" you led readers to believe this was somehow a proven fact, instead of merely an allegation of one person against another.

Even more disturbing, you stated "There is a question of what Caffrey did or did not know about Muiz' activities prior to his summons." How-

ever, the very finding of Muniz' guilt leaves NO question about that. The statute in this case was 2C:33-16. This statute reads, "Any person of legal age to purchase alcoholic beverages, who knowingly and without the express written permission of the school board, its delegated authority, or any school principal, brings or possesses any alcoholic beverages on any property used for school purposes which is owned by any school or school board, is guilty of a disorderly persons offense." So, in order for Mr. Muniz to be guilty, the judge had to determine that neither the administrators (including me), nor the Board knew anything about this. This was part of the "finding of fact" that the judge read when he issued the verdict.

Let me say for the record that I had absolutely no knowledge about any of this until April, 2012, just before the BOE placed me on administrative leave. I had just begun an internal fact-finding process, which I was unable to

conclude. Had the Board not taken this highly political action against me, I would have been able to address this issue appropriately. However, in my absence it was handled by the acting superintendent in a way that is now the subject of multiple lawsuits. When I returned from leave, I made decisions based on the best information available to me at the time. As more information came available, I took other actions.

The most disturbing part of your article is that you never attempted to contact me at all. Had you done so, I would have been happy to discuss this matter with you so that your story could have been more accurate. Other publications did so, which resulted in more balanced representations of the facts. It is my hope that in the future, The Amboy Guardian will work diligently to provide facts to its readers in a way that is free from bias.

# Reps. Pallone & LoBiondo: Legalized Sports Betting Would Benefit New Jersey's Economy and Crack Down on Criminal Enterprises

News Release 8/7/13 ATLANTIC CITY - Today, New Jersey Congressmen Frank Pallone, Jr.(06) and Frank A. LoBiondo (02) joined with representatives from Atlantic City's casino industry and local elected officials on the Atlantic City Boardwalk in support of legalized sports betting. The Congressmen called for action on their legislative proposals to legalize sports wagering and argued that it will improve the city's competitiveness and benefit New Jersey's economy.

In November 2011, New Jersey voters overwhelmingly approved a ballot measure to allow sports wagering in New Jersey, but its enactment has been delayed due to a lawsuit filed against the State of New Jersey by the NCAA and four professional sports leagues in August of 2012. New Jersey appealed its case after the district court failed to rule in its favor, and a decision is currently pending from the Third Circuit Court of Appeals.


February 2013, LoBiondo and Pallone reintroduced two bills to allow New Jersey to legally offer sports wagering, and they have called for action to change to federal sports gaming law. "New Jersey voted for and

deserves the same opportunity for sports betting which has been allowed in other states, and I hope that the court's upcoming decision puts an end to the delay that is robbing New Jerseyans of the opportunity to share in the profits of sports betting," said Congressman Pallone. "Making sports betting legal in New Jersey would not only help to stem the criminal activity associated with sports gambling, it would also pump much needed revenue into to our state by taking the gambling out of the shadows and regulating this billion dollar industry."

"Increasing competition from neighboring states and the widespread misinformation in the aftermath of Hurricane Sandy the destruction in Atlantic City has put our gaming operations at a disadvantage. Sports-betting can help give our famed resort town a hand up, providing yet another unique option for patrons in addition to the quality entertainment, dining, shopping and beaches. I'm pleased Congressman Pallone, our casinos, local elected officials and an overwhelming majority of New Jersey residents agree and hope that the federal courts act in fairness to our state," said LoBiondo.





The next qualifying tournament for the senior will be in September. The national championship next year will be held in Minneapolis, Min-







#### Book Review: Johnson vs. Johnson by Barbara Goldsmith

Author Barbara Goldsmith published by Alfred A. Knopf, New York in February 1987. The book is based on the true story between the legal battle between the widow, Barbara (Basia) of Johnson & Johnson heir, J. Seward Johnson and Seward's six children from his first two marriages. Barbara, J. Seward Johnson's third wife was left his complete fortune of over \$500 million upon his

Unfortunately the book gets bogged down when Ms. Goldsmith delves too much into the relationships of Seward and his children which has no bearing on the lawsuit. There are subplots into the marriages of Johnson's children and grandchildren dealing with murder plots, drug habbits and deviant behavior. Two or three examples are fine, but Ms. Goldsmith went into overkill. Was it so important to report that at one time the children claimed to live in poverty despite their wealth when they were growing up. There were so many characters and so many different relationships going on that you needed a scorecard to keep up. I found that Ms. Goldsmith jumped around too much in this book and many of the stories from the different people she interviewed seemed out of sequence.

Ms. Goldsmith especially spent a lot of time on the childhood and relationships of Mary Lea Johnson Richards who was the oldest child of J. Seward Johnson. Mary Lea supposedly had an inappropriately close relationship with her father. She had two marriages in which one of her spouses was accused of hiring someone to kill her. She seemed to have found happiness in her third marriage to a producer, Marty Richards.

J Seward Johnson's son, Seward Johnson Jr. was one of the other children that Ms. Goldsmith seemed to favor. Johnson Jr. was depicted as having a love/hate relationship with his father. Despite this, he longed for his father's approval as did his sister, Mary Lea.

Interestingly enough, the City of Perth Amboy is sprinkled throughout the book. Seward Johnson's first wife was named Ruth who was from Bermuda. Ruth's mother was born in Perth Amboy.

Basia was a Polish immigrant that lived in Perth Amboy with a family by the name of Wyszynkis. As a matter of fact, she became engaged to a Polish Sailor named Piotr Ejsmont. Unfortunately, he died when a boat he was piloting tipped over.

Basia went to work as a

cook for the Johnsons, saved up enough money to live in a modest apartment in New York and take English classes. In the time she worked in the Johnson household, she caught Seward's attention and summoned her back to work not as cook or chambermaid but as a art expert.


At the time Seward was married for 34 years to his second wife, Esther. Esther was the mother of his last two children: Jennifer and James. Seward married Basia when she waswas 34 and he was 76. This marriage took place eight days after he divorced Esther. Basia was depicted as either a guardian angel or a mean spirited woman to her husband depending on who was interviewed in the book.

Some of the lawyers on Basia Johnson's side were depicted as intimidating some potential eyewitnesses that may be called to testify on the widow's behalf. Throughout the book there were photos of Basia being very loving to her husband despite the 42 year age difference. There are pictures of them on the beach with her lovingly massaging his legs and feet and other photos of them in a passionate kiss.

Ironically there are also pictures of Basia and Seward's children at affairs having a very good time. According to Basia, she and Johnson's children got along very well as a whole until they discovered that they were left out of the will. According to the book, the main reason Seward's children were left out of his final will was because they were set up with a trust fund. This fund would make each child individually wealthy for the rest of their lives.

Basia said because of the past behavior of some of Seward's children, he felt that they might squander any additional money that might be left in the will. Then the gloves came off on both sides. Seward's children accused Basia of purposing alienating them from their father while he was suffering and dying from cancer. Another aspect of the will that bothered the children especially Seward Johnson Jr. was why his father would cut Harborbranch Research out of the will. His father loved to sail and the sea and Harborbranch Oceanographic Institute was a dream come true for his dad. Employees of Seward and Basia either accused Basia of being a saint to her elderly husband or a shrew. It's up to the reader to decide who they believed is telling the truth in this tangled web of characterizations.

Was Basia an opportunist?



Or was she someone who truly loved her elderly husband? After the suit was settled and the children each received \$6.2 million after taxes, Seward Jr. was given an extra \$8 million as an executor and a trustee. Basia received \$340 million out of the original \$500 million. Harborbranch received \$20 million.

According to the book, in 1987, the Johnson children's net worth individually ranged from: \$38 million (J. Seward Johnson Jr.) to a high of \$106.2 million (Jennifer Johnson Duke)

Many wills were written in a short period of time. The lawyer, Nina Zagat who wrote the last few wills stood to gain a lot of money being the executor of the will, not only that she was a close friend of Basia. Zagat was the wife of the Zagat restaurant fame. Nina Zagat was granted \$1.8 million before taxes instead of \$30 million she would have received based on her life expectancy.

Basia passed away at the age of 76 in Monte Carlo in Poland in April 2013. She never remarried and she contributed a lot of money to humanitarian causes, especially in Poland, the country where she was born. She also gave seed money for St. Joseph's Senior home in Woodbridge, New

If you are interested in learning about the dirt that went on behind the scenes of the Johnson & Johnson family then this book is for you. But those interested in the trial dealing with the contested will, then I would recommend that you look at the internet and at articles dealing with the trial through the newspaper archives. That would include The Daily News & The New York Post.

As an aside I am printing two

letters: One from Perth Amboy Resident Peter Book who supplied this book to me and also a letter from Sister Mary Louise who was an administrator at St. Joseph's Senior Residence. Her letter was originally printed in the Amboy Beacon on August 29, 2001. Part of this letter is edited.

The two letters plus other material were provided to me by Mr. Book.

#### Rebuttal to Mr. Book 8/29/2001

Mr. Book's crude and highly-abusive attack on Mrs. Basia (Barbara) Plasecki Johnson ("Alternative Funding?" August 15) is unfounded. Not only is it false and degrading to her, but also this is public harassment. This is disgraceful and demeaning to Mr. Book, as a lawyer!

Barbara Johnson is a university graduate and an artist. She is an altruistic philanthropist and equestrian who does not look for publicity. She was wealthy in Poland before the war, has contributed several times to St. Stephen's Renovation Fund, and now is finishing the entire marble flooring for St. Stephen's.

Barbara Johnson is our greatest benefactor. She came to our rescue in 1977, when we needed the seed money to open our fundraiser campaign to build our now 20year old St. Joseph's Senior Residence. She graciously donated \$350,000 to begin construction. When construction was halted for lack of funds, she again donated \$350,000. Then, when we needed to pay the salaries of the workers, she donated again - altogether, \$850,000. Because of her, we have been able to give a home to 481 residents of all denominations.

Each year, Barbara holds benefits for the crippled and other children's diseases at her

Princeton homestead, to even read what Mr. Book so viciously wrote when he didn't know the true facts.

As for her love-life with Seward, knowing him as other people and I got to know him, he would not have tolerated or lived married to Barbara for 16 years (not six years as Mr. Book erroneously stated). Seward knew she loved and cared for him. Even though she had professional nurses around-the-clock for him, she herself changed and bandaged his open leg lesions and followed his doctor's orders to the "T." She tended to him delicately, not roughly as she said others did, because she didn't want him to suffer needlessly. She also employed the nursing sisters because she loved Seward and wanted loving care for him.

Another fact: Mr. Book, and readers, too would be like "tigers" as Mrs. Johnson had reason to be. Coming back from a one-week absence, she found her private bath full of scum and filth. I was there and saw it! Naturally, and rightfully, she was devastated and angry!

I hope this letter teaches Mr. Book and all of us not to unjustly criticize or write such false, crude accusations before checking for the true facts.

Barbara Goldsmith's fiction book is not the Bible. She ruined her own reputation by giving evidence how little she knows, or traveled, for she said, "She never has seen as poor or primitive a people!" Mr. Book should think twice before writing such false, offensive letters!

It Started in Perth Amboy (April 9, 2013) A Change of Heart (Of his opinion of Basia Johnson from 2001)

One of the most remarkable successful stories of all time began right here in the City by the Bay with Henry (Heinrich) and Danuta Wyszynski. They resided at Market Street on the same block as the City Hall, the oldest functional municipal city hall in the country. Henry, a former Polish Army officer and diplomat, and his wife, Daunta, a well known artist and portrait painter, made Polish refugees welcome to the U.S. of A. One of them Barbara (Basia) Piasecka lived with them until they found her a job as a cook at the J. Seward Johnson estate in Oldwick. N.J. By the way whenever I visit the Zylka Funeral Home across the street from St. Stephen's Church I marvel at the portrait Danuta painted of Tony Zylka, one of the most popular men in town.

Basia was a college graduate and not exactly a cook. So she became a chambermaid. Being very attractive young Polish girl she caught the eye of J. Seward Johnson, the younger brother of General Robert Johnson, the founder of J&J Company until it became a multi-national corporation. Seward rode along with it until he also became a billionaire.

He fell in love with Basia despite the fact that he was 42 years older. By the way, in World War I he served as a sailor in the U.S. Navy on the Eagle 48 based on the waterfront in Perth Amboy.

Apparently Seward and Basia lived an idyllic life for 12 years until he died in 1983. By terms of his will he left Basia \$450 million. His 6 kids, all mature adults, resented her although he had already made each of them multi-millionaires.

The ensuing probate battle in Manhattan was one of the biggest ever in any court. President Nixon's old law firm shared the legal fees of almost \$30 million. After many months of fighting the case was settled. Basia wound up with \$340 million.

Instead of squandering the money and living extravagantly and being involved in scandals she led a straight life helping many charities and her native country. By astute dealings in the art field she ran the money into billions thus making her one of the richest women in the world. She died in her native Poland mourned and revered by her people and the world. Rest in peace, dear Basia! Requsat in Pace!
