# Mayor Response to Quality of Life Issues and Plans for Rateable's

PERTH AMBOY - In the last few Council Meetings, residents have complained that ordinances, especially when it comes to loud noises have not been enforced.

Mayor Diaz spoke at the 8/11/14 Caucus Meeting to remind the residents how she and the Police Department worked to have some social clubs close up earlier a few years back. "A lot of people were not happy with this because some of these establishments were located in residential areas. Some of these clubs were grand-fathered in by the previous administration." She also mentioned sites that have

been stagnate for many years that we are cleaning up. "Look at Veridian and Buckeye. Celotex is crucial to our City. RP's are going out to bring rateable's that will bring jobs to our residents to help our tax base. Ameristeel will build another facility. A lot of good things are happening in this City. We are now looking for industries instead of building more housing.

Councilman Fernando Irizarry said in response to Quality of Life Issues, "We need to look at the noise ordinance. Some businesses and individuals get a slap on the wrist when they violate this ordinance.

# Off the Table Look Elsewhere For High School

PERTH AMBOY – 8/11/14 - Caucus Meeting Communication #21. Middlesex County Planning Board supporting the City's application to Green Acres Program for funds to develop a park on City owned property along the Raritan River adjacent to the Victory Bridge.

Resident Stanley Sierakowski wanted to know if the 5 acres for the park was contaminated, "The Council needs to get more information about this land to check for any possible contaminants. You should table this before you approve this."

Senior Planner with the City of Perth Amboy Office of Economic and Community De-

velopment, Annie Hindenlang answered the concerns of Sierakowksi about this property. She said, "This property which is located near the Victory Bridge is City owned. We did environmental investigations. It is not part of any discussion related to the High School."

Business Administrator Jillian Barrick talked about the 50 acre Celotex property, "We are looking to make this into a retail/commercial area. There are RFP's (Request For Proposals) going out tomorrow (8/12/14). I talked to the Board of Education Jess about other options to build a High School. The Celotex property is off the table."

### **Clearing It Up: Shooting Incident**

PERTH AMBOY – A few weeks ago there was a shooting that took place in the early morning of 7/25/14. According to some reports, the incident took place at the Z Bar located on New Brunswick Avenue. At the 8/11/14 Caucus Meeting Police Chief Benjamin Ruiz appeared before the Council to clear up some facts concerning the incident.

Ruiz said, "Some media reports were inaccurate." According to Police Chief Ruiz, "Shots were fired and there were 5 separate leg injuries. Those who sustained those injuries sought medical treatment on their own. The Prosecutor's Office is now handling this case. The incident did not happen in the bar which was not open at that time. The shooting occurred at 1:15 a.m. and not 3 a.m."

In the 7/30/14 issue of the Amboy Guardian, we reported that the shooting occurred somewhere between 1:30 a.m. -3 a.m. and that it was unclear if it took place inside the Z Bar or at a nearby parking lot.

During the public portion Businessman and Resident David Caba made reference

to the shooting. He brought up the quality of life issues. He asked the Council if they were aware of the shooting that took place 2 to 3 weeks ago. Some of the Council Members had puzzled looks on their faces. Caba told them, "That is your job to protect us (the residents). This shooting was not reported in the papers. We are losing quality of life. I am not blaming the police. We keep building and not getting the services. I went to Long Branch where there was a developer who had a dream for that town and they got their money's worth. Developers were selling dreams in Perth Amboy that never came true."

A resident who has lived in Perth Amboy for 22 years and who resides on Maple Street complained about a liquor store on the 200 Block of Smith Street. This resident said, "Since April of this year, there has been constant noise going on, especially on Sundays from 4 p.m. – 10 p.m. or sometimes up until midnight. This bar has a backyard where there's a D.J. playing loud music. There must be between 40 – 50 people back there dur-

ing that time. I call the police and sometimes they come and sometimes they don't. This happens every day but the weekends are very bad."

Councilman Fernando Irizarry voiced concerns about the same bar. He noticed that there is a wooden fence and wanted to know if they had a permit for that enclosed area. "Heaven forbid that there is an emergency."

Police Chief Benjamin Ruiz said, "We have given out summons and will do more research and do an investigation"

### **Half Paved Streets?**

PERTH AMBOY - One of the topics of discussion at the 8/11/13 Caucus Meeting dealt with half paved streets. Council President Joel Pabon said, "Residents complained about these streets."

Department of Public Works Director Frank Dann came up to answer this question, but said, "It is a Code Enforcement issue."

Dann explained, "It;s the gas company that are replacing the lines and they only dig up the side of the street where the lines are to make the connection. Sometimes the gas

company may have to go into a resident's property to complete the job."

Pabon said, "Some of the sidewalks on Madison Avenue where the gas lines were worked on have been replaced with tar instead of the cement which was originally there."

Ed Scala from Code Enforcement answered that question, "The gas company has to do large sections and not just of chunks of streets. Any sidewalk that presently has the tar will have it replaced with cement if that's what was there originally."



### **Parking Headaches Resurfaces**

Mary Street & Amboy Avenue

PERTH AMBOY - Along with Amboy Avenue 3 hour parking, Councilman Kenneth Gonzalez took up the concerns of some of the residents who were blindsided on Mary Street when was converted to one-way. Gonzalez says, "To have parking on only one side of the street is not helping the residents who complained of lack of parking. Perhaps we can do parking on both sides of the streets. Do we need 23 feet from the corner of the street for fire trucks to turn in there?"

Fire Chief Abraham Pitre answered that question. He mentioned Rector Street which is also narrow where it is difficult for some fire trucks to turn. Pitre said, "To have parking on both sides on Mary Street would be difficult, especially if you have vehicles parked directly across the street from one another."

Council President Joel Pabon mentioned that there are a lot of back streets in the City that are narrow. "Now you have people flying on Mary Street and there are arguments that people are trying to hold spots for relatives or friends who come to visit. I spoke to Frank Dann (Director of Public Works) about possible solutions for the DPW vehicles. The only other spot for people to park who live on Mary Street is the highway."

Business Administrator Jillian Barrick said, "We need to look at this further."

Pabon suggested, "Public Works, the Police Department and the B.A. should meet with Residents who live on Mary Street."

Councilman Fernando Irizarry said, "Painting yellow lines

on the curbs will not solve the problem. People park there anyway. The City doesn't need any more lawsuits. We have enough. The Business Administrator should look at the issues related to illegal hous-

Barrick answered, "We are looking at other streets besides Mary Street when it comes to illegal housing. There should be enforcement and we should insure that secondary housing meets all legal requirements for secondary housing. The City Attorney and Code Enforcement are looking at other towns to see how they handle illegal housing."

Police Chief Benjamin Ruiz talked about the notification process to determine whether or not there are any changes to streets. "We'll survey the area, ask residents and look at various turning angles. This is done with help of the Fire Department and Department of Public Works. You see how many driveways and handicapped parking spots there are. A lot of residents (Mary Street) knew about turning their streets into one-way and was glad that something was finally done."

Council President Joel Pabon was surprised at this because other residents from that street told him something different. He said, "These residents who he spoke to knew nothing about making Mary Street one-way until a few days before the signs went up."

B.A. Jillian Barrick concluded this discussion saying that she and other directors would like to meet with residents (Mary Street) before we can make any recommenda-

tions. Hopefully we can have answers by the end of September"

Another Street that had its share of problems was Amboy Avenue's active business section. 3 Hour Parking was recently implemented and some of the residents who live on that street were not happy.

Councilman Kenneth Gonzalez said he met with a man who is about 80 years old who lives on that street. "Some of these residents have been adversely impacted by this 3 hour limit. The gentleman I spoke to said that he didn't want to constantly move his car unnecessarily."

B.A. Jillian Barrick said, "We are trying to get a meeting to be held on August 21st at 6 p.m. to be held either in the Council Chambers or in a place on Amboy Avenue, perhaps at the Charter School to discuss a solution with the residents who live on Amboy Avenue. The ordinance creating the 3 hour limit has been suspended temporarily until after this meeting takes place. This is a difficult street, because it's heavily mixed with residents and businesses."

39:4-207. Parking overtime

PERTH AMBOY - Resident John Siberry has been questioning a 2 hour limit on by driver of motor vehicle handicapped parking space on with placard or wheelchair Market Street outside of City Hall. Siberry feels that this restriction was personally aimed at him. He said, "I saw a City Employee who is handicapped park there for more than 2 hours. I have the proof!" He asked the Council a series of 4 questions:

1. What is the intent of this ordinance?; 2. If I park in the handicapped spot, as I have a placard, do I get a ticket if I stayed longer than 2 hrs.?; 3. HOw about 39:4-207; How does it impact this law?; 4. Can a handicapped person still get a ticket under this ordinance despite 39:4-207? Is this not municipal legislation for the purpose of harassment



### The Truth Will Set You Free - Not All The Time -The Plight of Shaneen Allen

I happened to be listening to a radio program the other day and my ears perked up. The radio host talked about a young mother from Philadelphia facing up to 10 years in prison. She innocently told a police officer that she was carrying a gun that she legally had a permit to carry in her state. This radio host went on to say that you can have confessed murderers or people who are here illegally get a slap on the wrist, yet they're going to come down hard on a young single mother.

I didn't get the name of the woman while listening to the radio show because it was near the end of the segment. So, of course I Googled the information on my Android Phone. (Single mother from Pennsylvania who was arrested for carrying a legal gun permit from Pennsylvania)

Shaneen Allen is a resident of Philadelphia, Pennsylvania and the single mother of two young boys. She wanted to protect her family after having her home been broken into twice so she legally purchased a handgun going by the books.

On October 1, 2013 she was pulled over by the police for making an unsafe lane change while driving from Philadelphia to Atlantic City. She gave the officer who pulled her over all the information requested (driver license, insurance, registration, etc.). In her innocence she also volunteered that she had a license to carry a concealed weapon from her state and she had the gun in her possession.

Well, because of the gun laws in New Jersey, she was promptly arrested and could serve at least 3 1/2 years in jail with no chance of early parole.

I'm a person that likes very simple solutions. I know all the states love to get extra income. Just like you would pay extra to upgrade in a hotel room or a seat on an airline,

perhaps someone who has applied and qualified for a gun permit can also be upgraded. The states should establish a special fund, for instance to supply bulletproof vests for police. For an extra \$200 per year the qualified applicant can be placed into a national database that shows with this extra fee was placed in this national fund for that purpose. This would exclude this applicant from being fined and possibly imprisoned for carrying their firearm across state lines that does not recognize their permits. With this extra \$200 that the applicant paid, there should be a special stamp (similar to a passport) that shows they contributed to the bullet proof fund. If the motorist is stopped on a small traffic violation, they can produce the firearms permit with the special stamp the law enforcement officer. The officer can then run a check on the license plate issue a ticket or warning for the traffic violation and let the driver go on their merry way.

If someone else has a better solution I would love to hear it. What about people who can afford to take road trips across the country? They may have permits - and what do they do each time they cross a state border? As we all know people are attacked every day in broad daylight. What about salespeople who travel on the road all the time? They have a right to protect themselves. You have people who carry valuable merchandise. How many times have you read that because of an insider knowing the routine of that person, sometimes robberies occur and it's an inside

Early this year on February 2014 I asked this council to please consider changing the form of government from nonpartisan to partisan. Now that our municipal elections are held together with a partisan general election in November.

This past primary the county paid out \$34,000+ for poll workers in Perth Amboy that only 1 had a 2.01% turnout. That means out of 24,000+

registered voters, only 496 people voted. That is a shame. Including Perth Amboy, a Primary will be at no cost to Perth Amboy. A primary will take place with or without Perth Amboy.

If this council moved to a non-partisan election to November with a general election where those who are running had a run-off in a primary, our municipal candidates should have to do the same. Not doing so cost Perth Amboy taxpayers money in November that could be avoided.

Where is the democracy here? People are not represented properly. It is an educational process. You have elected officials taking advantage of our voters. They only come in to work hard so that they can get back in return. It's time to let the people of their party decide who should represent them on a general election and the only way to do so is to have a primary.
