#### We Build Buildings to be Occupied

PERTH AMBOY - 12/17/15 Caucus Meeting - Topic For Discussion Bridge Development Presentation.

John Porcek, P.E., P.P. - (Principle) Bridge Development Partners, LLC gave an overview of this project which will be located on High Street (near the Outerbridge). Porcek started his presentation by stating that Bridge Dev. has offices in Chicago, New Jersey, Miami and Los Angeles. The company has been involved in industrial retail development for 15 years. "Bridge Development builds Class A Development Complexes. The Heller Industrial Park is where we first starting developing in New Jersey. We took ownership of the property in Perth Amboy (High Street) in September 2015. We'll construct 3 buildings. The largest one will be 17,000 ft. We expect the first two buildings to be completed by the late summer of 2016 and the last one to be completed in the late fall of 2016. We will not tax (burden) the school system. We will be creating jobs. The buildings will have state of the art lighting motion sensors.

No hazardous materials will be stored in any of the buildings and they will have reinforced concrete walls."

Councilman Bill Petrick interjected that the City will be getting rateables on property that was previously unused and underdeveloped with this project.

Porcek spoke again, "Premier Design Builders will be the contractors that will be used. Premier then will bid out more contracts to local businesses. All the buildings are flexible and when we build them, they are built to be occupied."

# C-Town Demolition Completed in South Amboy

The demolition ends an 8 month saga that began in April with a four-alarm fire that ripped through the property. Between legal battles with the owner and insurance company, resident concerns about the safety of the building structure, and fences blocking sidewalks for months, the city is relieved that this has come to an end.

"I want to thank everyone for their patience. It was not an easy process with the insurance companies and so on," Henry said. "I know the owner is very eager to move on from where he is at this point."

Henry added that there are no plans for the property at the moment but the city will begin looking into the future of the

The council also passed Ordinance #20-2015 which amends the Route 35 Northbound Redevelopment Plan, also known as the old Delilah's Den property, to allow the construction of residential units. There is hope that this change will bring in developers quicker and get a project started sooner.

Interim B.A. Peter Pelissier said, "The Law Director and



#### **Master Plan Reexamination Questioned**

PERTH AMBOY - 12/9/15 Council Meeting - Report: Center State Engineering -Master Plan Reexamination Report.

Resident Sharon Hubberman wanted more detailed report.

Councilman William Petrick said, "This is required by the State every few years. Rutgers University did a study and recommended that the City needed more parks and recreation. We were able to get additional grants. There were more changes from the Master Plan from the previous administrations."

Councilman Fernando Gonzalez said, "I just received this information today and it should be tabled."

He also suggested that Bill Petrick should abstain because Petrick is a member of the Planning Board.

Resident Reinaldo Aviles said, "As Chairman of the HPC (Historic Preservation Commission), I'm glad to see the Master Plan on the Agenda." He agreed with Fernando Gonzalez that more time is

needed to reexamine the revisions to the Master Plan.

A definition of a Master Plan is quoted from http://www.edisonnj.org/
The Master Plan is a broad policy statement that guides a municipality's future development. It is the policy umbrella under which reside the official map, the capital improvement program, the zoning ordinance, and the subdivision and site plan ordinances. The Master Plan may include a

wide array of elements, such as a land use plan, housing element, circulation element, utility service plan, community facilities plan, recreation plan, conservation plan, economic plan and an historic preservation element. The Master Plan is adopted by the Planning Board.

The Master Plan should be officially updated every 10 years.

# Vitale-Greenstein Bill to Allow Urgent Care To Victims of Sexual Assault Without Parental Consent Advances

Legislation Updates Law, Authorizes Forensic Examination and Urgent Medical Care Without Parental Consent

TRENTON – Legislation sponsored by Senator Joseph F. Vitale and Senator Linda R. Greenstein that would allow health care professionals and physicians to authorize forensic examination and urgent medical care without parental consent on minors who appear to have been sexually assaulted was approved today by the Senate

Under current law, a minor who appears to have been sexually assaulted may receive "necessary emergency medical or surgical care." The bill, S-3243, would allow, without parental consent, any emergency or urgent medical or surgical care for minors who appear to have been sexually assaulted.

"There is a very narrow window of time to gather forensic evidence following a suspected sexual assault. Removing the red tape and prioritizing a child's well-being as first and foremost when providing any emergency or urgent care following an attack is critical and common sense," said Senator Vitale (D-Middlesex). "Updating our laws is necessary to allow for an expedited process that puts child victims first and lets healthcare professionals do their jobs effectively."

Also under current law, when a minor appears to have been sexually assaulted, the minor's parents or guardian shall be notified immediately, unless the attending physician believes that it is in the best interests of the patient not to do so. The statute provides that the inability of the treating physician, hospital or clinic to locate or notify the parents or guardians shall not preclude the provision of any necessary emergency medical or surgical care. The amendments proposed under this bill would allow other health care professionals, such as nurses, in addition to physicians, to authorize forensic examinations and other medical care.

"Allowing other health care professionals such as nurses to authorize forensic examinations and other medical care is important because they are often the first point of contact in any doctor's office or hospital," said Senator Greenstein (D-Mercer, Middlesex). "With time acting against any forensic examination, it is critical that children get the treatment they require as soon as possible, and this bill will provide the necessary updates to our laws to make that happen."

Pursuant to the Statewide Sexual Assault Nurse Examiner ("SANE") program enacted in statute in 2001, specially trained nurse examiners collect forensic evidence from sexual assault victims for use in prosecutions. However, due to the provisions of a 1968 statute that pre-dates the "SANE" law, a minor who is a sexual assault victim may not be allowed an immediate "SANE" examination upon arriving at a hospital emergency room if the minor's parents or guardian cannot be reached and a physician is not immediately available to authorize the examination.

Under the 1968 statute, a minor can give consent to "medical or surgical care or services" without parental consent if, in the judgment of a treating physician, the minor appears to have been sexually assaulted. The result of these two overlapping statutes is that forensic examinations have been delayed for hours as the victim, the sexual assault nurse examiner, and the police officer wait for a physician's authorization.

The bill was approved with a vote of 40-0. It now heads to the Assembly for consideration

#### Sweeney/O'Toole/Vitale Bill To Integrate **Patient Data Approved By Senate**

Health Database Would Improve Health Care Quality, Reduce Costs

TRENTON - Legislation to create an integrated data system authored by Senate President Steve Sweeney, Senator Kevin O'Toole and Senator Joe Vitale was approved by the Senate today. The bill, S-3220, would establish the Integrated Population Health Database at Rutgers University's Institute for Health, Health Care Policy and Aging Research to collect a wide range of information that would be used to improve health care delivery. The plan would develop an effective means for improving the health, safety, security, and well-being of high-risk residents and reduce the overall cost-efficiency of programs that address their medical needs.

"This is a smart and resourceful way to make use of a wide range of information to help improve the quality of care provided to an at-risk population and to reduce overall expenses," said Senator Sweeney. "This has the potential to transform the healthcare delivery system by taking into account the array of factors that influence medical conditions and treatment. Reducing healthcare costs and improving health outcomes requires understanding the forces within and outside the health service sectors."

"Layers of laws and bureaucratic hurdles significantly impede health data access and connections, while increasing costs," O'Toole said. "Residents, especially those facing complex medical and social issues and those incurring the highest costs, rely on multiple public systems and services. Linking different datasets that

already exist within these systems and programs is essential for a holistic understanding of patient needs."

"By integrating data, we can reduce duplicative efforts in data collection and maintenance and allow for comparison and analysis with accuracy and reliability," said Senator Vitale. "What we learn from the data will allow us to identify and address trends and individual and community-level factors that can ultimately lead us to delivering more efficient and effective health care in New Jersey."

The bill would create the integrated population health data system project. The iPHD will contain data collected by New Jersey administrative departments and agencies related to health and publicly supported programs. The legislation would establish the iPHD Governing Board, in but not of the Department of Health, to approve project-by-project analysis and research.

Senator Sweeney praised the Camden Coalition of Healthcare Providers which has pioneered the concept and practice of using data to improve services.

"Good care needs good data and the integrated population health database legislation is an opportunity to transform NJ's health care delivery system," said Dr. Brenner of the Camden Coalition of Healthcare Providers. "The iPHD will create a comprehensive picture of the complex health and social problems faced by our state's most vulnerable residents, and support smart and innovative policies to improve quality and

reduce the cost of health care. I'd like to thank Senator Sweeney, Senator O'Toole and Senator Vitale for their leadership and commitment to the iPHD. It will be a tool to address some of the most important issues in our state, issues that impact New Jersey's fiscal health as well as the health and quality of life of our residents."

The new program would provide a centralized system with the infrastructure and resources to provide a more complete picture of what factors are affecting New Jerseyans' health. By linking disparate datasets, the iPHD would allow these entities to leverage their current data collection efforts without additional burdens. The system would link health data with other social datasets while safeguarding the privacy and security of the data.

The project would reduce duplicative data collection and maintenance efforts and allow for comparison of data for accuracy and reliability. The linkage of the data sources will facilitate the identification of population trends and individual and community-level determinants directly related to the health, safety, security, and well-being patients.

The Center for State Health Policy at Rutgers University's Institute for Health, Health Care Policy and Aging Research would house the iPHD and allow access to authorized entities, such as policy-makers, researchers, certified local Medicaid accountable care organizations, private entities or researchers and other public support programs.

The vote was 40-0.

#### Codey-Vitale Bill Supporting 'Advance Care Planning' Heads to Governor

Crucial Decisions on End-of-Life Medical Care Could Be Made In Consultation with Doctors In Advance of Incapacitation

Press Release 12/17/15

TRENTON – The crucial decisions about end-of-life medical care made in advance of incapacitating conditions would be supported by Medicaid, according to legislation sponsored by Senator Richard J. Codey and Senator Joseph F. Vitale. The bill, S-2435, requiring Medicaid reimbursement for advance care planning consultations with doctors or other caregivers, was approved by the Senate today.

"As New Jersey residents age, they should be able to have conversations with their trusted health care providers about their future health care wishes should they become unable to make their own decisions in the future due to incapacity," said Senator Codey (D-Essex, Morris). "Those advance medical directives should be supported by Medicaid to make sure the elderly and terminally ill are cared for with dignity and according to their own wishes."

Advance care planning is the practice of preparing explicit written instructions for caregivers, family and friends on the type of care that should be provided or withheld, including palliative care, in case of incapacitation.

"Such planning is important to the elderly and terminally ill because it allows them to maintain control over their own health care decisions even after they are unable to communicate these decisions at a future date," said Senator Vitale (D-Middlesex). "Making those decisions with the help of medical professionals before it's too late is equally important and our Medicaid system should reimburse for this practice."

The American Medical Association recently recommended that Medicare provide reimbursement for the practice. The Medicare statute currently provides coverage for advance care planning under the "Welcome to Medicare" visit available to all Medicare beneficiaries, but they may not need these services when they first enroll. Starting in 2016, Medicare will begin covering advance care planning as a separate and billable service.

Two states, Colorado and Oregon, have already moved forward on similar legislation by approving Medicaid payments for the consultative care.

Once the government-sponsored programs adopt this change, it would set a standard for private insurers and encourage more doctors to engage in these conversations with their patients, Senator Codey pointed out.

"Coverage would raise awareness of this valuable service, and allow residents to make decisions with greater comfort on end-of-life care," said Senator Codey.

The bill cleared the Senate with a vote of 29-8. It cleared the Assembly with a vote of 46-13 and now heads to the Governor's desk for consideration.

# Vitale-Cunningham Bill to Allow Licensure of Art Therapists Heads to Governor

TRENTON – Legislation sponsored by Senator Joseph F. Vitale and Senator Sandra B. Cunningham that would require licensing for art therapists gained final legislative approval today by the Senate.

The bill, S-2020, would allow for the licensure of art therapists. Under the legislation, only licensed art therapists, associate art therapists and other qualified medical professionals could practice art therapy. To qualify for a license as a professional or as an associate art therapist, applicants must be 18 years of age, be of good moral character, and hold a master's or doctorate's degree in a field related to art therapy from an accredited institution, according to the bill. Licenses would be issued for a two-year period after paying a fee and renewed after sufficient proof is shown that an applicant has completed any continuing education requirements. It would also prohibit any person from using titles associated with the practice of art therapy unless licensed to do so.

"It is important that patients suffering from illness and trauma who turn to art therapy to cope with their symptoms are treated and cared for by highly qualified individuals who have the appropriate training, education and experience to tend to their needs," said Senator Vitale (D-Middlesex). "Art therapists practice in a wide range of clinical and other settings. Their licensure will ensure that they have the right credentials to carry out their work, and will allow them the benefit of being reimbursed for their services by insurance carriers that provide coverage for licensed art therapists."

In addition, the legislation would establish an Art Therapists Advisory Committee under the Board of Marriage and Family Therapy Examiners in the Department of Law and Public Safety's Division of Consumer Affairs. The Committee would be authorized to issue, renew, suspend, and revoke licenses, and maintain a record of every art therapist in the State. It would also implement and change the fees of services for applicants including examinations, licensures and renewals. Furthermore, the Committee would establish standards for the education of art therapists, and make rules and regulations necessary to carry out its duties.

"Art therapy provides much comfort to individuals, couples, and families who have survived trauma, abuse, and natural disasters, and those living with serious health issues and emotional disorders," said Senator Cunningham (D-Hudson). "Allowing for the licensure of art therapists will ensure that these vulnerable patients are receiving the right level of care by these highly-educated professionals and will promote the safe practice of art therapy in New Jersey."

An art therapist would be defined as any person licensed to practice art therapy, under the bill. Art therapy would also be defined as the psychotherapeutic use of art media and creativity to assist individuals, families or groups in increasing awareness of themselves and others, providing coping strategies for symptoms and traumatic experiences, and assist persons with cognitive, developmental, mental, and emotional needs.

According to the American Art Therapy Association, other states have implemented art therapy licensing requirements including Maryland, Mississippi, Kentucky, and New Mexico. Currently, licenses are not required in the state of New Jersey.

The bill was approved with a vote of 26-10 in the Senate and 60-11 in the Assembly. It now heads to the Governor's desk for action.

# **Cunningham-Vitale Bill Removing Restrictions on General Assistance Benefits Advances**

TRENTON – Legislation sponsored by Senator Sandra B. Cunningham and Senator Joseph F. Vitale removing the eligibility restrictions for receiving general assistance benefits under the Work First New Jersey program for people who have been convicted of an offense involving the use, possession, or distribution of a controlled dangerous substance was approved today by the full Senate.

"We as a state should show compassion for these individuals who ultimately still have families to support, and are working to turn their lives around," said Senator Cunningham (D-Hudson). "This is a small way to help our residents access the resources they need to get back on their feet and become self-sufficient. This bill could also reduce homelessness in our state; the money from the Work First New Jersey program can go a long way in terms of helping individuals who have just gotten out of prison to pay for shelter stays and different rental assistance programs. It gets them off the streets and under a roof."

The Work First New Jersey

general assistance program provides an essential lifeline for those most in need. Eligible New Jersey residents are provided a small cash subsidy of approximately \$140 per month, depending on family size and whether the recipient is disabled.

"A person's family should not be forced to pay a price for something that happened to their loved one in the past," said Senator Vitale (D-Middlesex). "This bill looks to make the necessary changes to bring fairness to those who are trying to rebuild their lives and be productive citizens. This piece of legislation will help these families as they strive to move their lives forward and not limit them. These are still families that need to be fed, and cared for, and they shouldn't be denied that."


Prior to 1997, New Jersey's general assistance program did not deny benefits based on an individual's drug convictions. In 1996, however, federal legislation was enacted disqualifying individuals with drug convictions from Temporary Aid to Needy Families (TANF) and the Supplemental Nutrition Assistance Program (SNAP). While states were

given the option to opt out of this disqualification through legislation, New Jersey expanded it with the creation of the Work First New Jersey program, which disqualified individuals with drug convictions from receiving general assistance as well.

In 2010, recognizing the need to assist individuals who have paid their debt to society and are struggling to reenter as productive citizens, New Jersey passed the "Women and Families Strengthening Act," repealing the drug conviction ban for SNAP and TANF benefits. This repeal, however, did not apply to general assistance under the Work First New Jersey program. Currently, of the 28 states with general assistance programs, New Jersey is one of only four states that deny benefits to individuals with drug convictions.

S-2806 passed the Senate 25-9 and now heads to the Assembly for further consideration.

# This Week in World War II 75 Years Ago

The start of 1941 finds countries in Europe, Africa and Asia embroiled in war with the "Axis Powers" of Germany, Italy and Japan, and their allies — since 1935 in Ethiopia, 1937 in China, and 1939 in Europe. In the U.S., President Franklin D. Roosevelt has been walking a political tightrope: trying to maintain the nation's official stance of neutrality while extending aid to opponents of aggressive German Nazism, Italian Fascism and Japanese militarism. Far from the fighting and still bitter over U.S. involvement in "The Great War" — Europe's war — Americans wish to remain aloof from further foreign conflicts. The desired isolationism, however, is not to last.

On January 1, Germany's foreign minister, Joachim von Ribbentrop, meets with Prime Minister Bogdan Filov of Bulgaria to negotiate passage for German troops to transit that country. No agreement is reached, but Bulgaria, feeling the Nazi pressure, edges closer to joining the Axis.

On Jan. 2, President Roosevelt announces a program to produce 200 7,500-ton freighters built quickly to standardized designs. They will be known as Liberty ships.

The Allied 13th Corps, bolstered by the newly arrived 6th Australian Division, begins an offensive against Italian-held Bardia, Libya, on January 3. The Australians have replaced the 4th Indian Division, which has been sent to the Sudan.

The Greeks begin a new offensive in Albania on January 4, but are outnumbered by Italian troops there and cannot make much headway.


In Libya, on January 5, Australian and British troops capture Bardia, taking 40,000 Italian prisoners and large numbers of guns, tanks and other vehicles. Allied casualties number less than 400. It is the first battle of the war in which an Australian Army formation takes part.

On January 6 in his State of the Union message, President Roosevelt talks of four essential freedoms: of speech and worship and from fear and want. He refers to the United States — as he has several times in the past — as the "arsenal of democracy."

Two days later, on January 8, President Roosevelt presents his budget to Congress. It envisions expenditures of \$17.5 billion, with \$10.8 billion for defense.

On January 9, British Commonwealth forces complete a strong encirclement of Tobruk, Libya, defended by 25,000 Italian troops, 200 guns and 70 tanks.




