Affirmative Frank Hoffman Appointed Department of Public Works **Director; Jamie Rios Appointed Code Enforcement Director** 

PERTH AMBOY - Resolution: R-84-2/16 - Consenting to the appointment of Frank Hoffman as the Director of the Department of Public Works. Resolution R-85-2/16 Consenting to the appointment of Jamie Rios as Director of Code Enforcement.

There was overwhelming support for the two newly appointed DPW and Code Enforcement Directors. There were several employees for the Department of Public Works who praised Frank Hoffman, who worked his way up through the ranks to become the new leader.

Perth Amboy Democratic Chair Billy Delgado commended the two individuals, "Hoffman should be appointed. His department worked 40-50 hours nonstop during the recent storm. I have known Jamie Rios for 25 years and I'm astounded as to how much he has accomplished in the short period of time as the Acting Director of Code Enforcement. Since Rios has been the acting head of that department, they have been working 7 days a week and have been getting more work done through the use of smartphones. All necessary permits are on site when work is being done. Now only one inspector is needed at the courthouse so others in that department can be out in the field. Rios is also a resident of the City." After Delgado's remarks, an employee from Code Enforcement came up to speak. That employee said, "It's a pleasure to come to work now. Rios preaches customer service and tells us how to educate the public. I've seen more people cleaning up their properties. We have weekly update meetings. If he's done this much in six months, imagine what he'll do in one year." The next speaker was Gregory Pabon, a Democratic Committeeman who has been impressed with Code Enforcement under the leadership of

Rios, "Whenever I call about a problem I'm having in my district, Code Enforcement responds very quickly. That's all that I've come up here to say."

Mayor Diaz then spoke, "Every appointment I've made has been to benefit the City. Employees are uplifted in these departments (Code Enforcement and DPW). Diaz echoed Delgado's comments, "Code Enforcement has been working 7 days a week." She asked the Council to appoint Frank Hoffman (DPW Director), Jamie Rios (Code Enforcement Director) and Adam Cruz (as Business Administrator).

Geri Barcheski, herself a 27 year City Employee, who has periodically acted as Interim Public Works Director during periods of transition spoke next. "In the time I've been in Public Works, I've worked under 9 different Directors. We are concerned with the health and safety of the residents of the City. We are proud of the work we do. Hoffman is tough, but fair and we've had more training under him. The work relations and morale are up in the department. Hoffman has the confidence, intelligence, skills and knows how to get it done. Please make Hoffman the Public Works Director. It's the best decision you'll make. He was born and raised here. People in our department start

work at 3 a.m. and 4 a.m. We do work that we are not even responsible for."

DPW Supervisor Hector Polidura spoke, "Hoffman and I worked as City mechanics and we both worked our way up. The staff has worked long hours and many days with little rest. Hoffman respects feedback from employees. There are positive changes in the office and responses from the residents. Under Hoffman's watch, there have been better communications." Polidura pleaded with the Council to put politics aside and to look at the work all the departments are doing - not just Code Enforcement and the Department of Public Works. An employee who has been in the DPW since 1991 remarked about the snowstorm we had this past January. He was proud to report, "Our town had many roads cleared in 3 days compared to some of the towns in surrounding communities. We are so happy with Mr. Hoffman, that we threw a party for him to show our appreciation." Buildings and Grounds Supervisor Danny Cleaver came up to speak, "I am a 27 year employee. We had another good Director (Ken Schwartz)

### The Battle Continues and **Old Wounds Reopened** 2/10/16 Council Meeting

PERTH AMBOY - Resolution R-83 - 2/16 – Moving the Election Date of the Perth Amboy School Board Members to the first Tuesday after the First Monday in November.

Resident Stanley Sierakowski was very interested in this resolution. As he did previously, Sierakowski told the Council Members that the Board of Education did nothing illegal when they decided to change the election to April. He then asked the Council Members, "Did you read the stature in reference to changing Municipal Elections?" Sierakowski continued, "What's the legal basis for the Council moving the Board of Education Election back to November?"

Law Director Arlene Quinones-Perez answered Sierakowski and proceeded to read the stature: (See Page 8)."

Perth Amboy Republican Chair Sharon Hubberman said, "I was present at the Board of Education Special Meeting 1/12/16 at PAHS when they decided to change their election to April. I sent an OPRA request to the County Clerk and to City Clerk Jasko's office to see if the Board of Education had sent a public notification to the newspapers 48 hours prior to the date of the meeting. I only found it online."

Resident Alan Silber came up and wanted to know who initiated this resolution. Law Director Arlene Quinones-Perez said, "It was either initiated by the Council or the Law Director." Silber also had a question about the candidate chosen to be the new Business Administrator. "Was this candidate ever a Business Administrator?" There was no answer. Resident David Caba also had questions about the salary for the Business Administrators. "Assistant Business Administrator Peter Pelissier said, "The new Business Administrator will be getting a \$130,000 per year."

Caba retorted, "I guess Councilman Fernando Gonzalez won't hire the new B.A. because he's not a resident. Aren't we paying the Assistant B.A. \$157,000? Doesn't a Vice President earn less than a President?

Councilman Joel Pabon answered back to Caba, "He (Pelissier) was paid based on his experience."

The ball went back into Caba's court, "But the Council had an ordinance with a salary cap (with this position.)"

Pabon answered, "It was an old ordinance that we should not have voted on."

Law Director Quinones cited the Faulkner Act, "The ordinance pertaining to the salary range is for department heads."

Perth Amboy Democratic Chair Billy Delgado said, "We need to have an experienced Assistant Business Administrator here to help the new B.A. in his transition."

Mayor Diaz said, "Adam Cruz, the candidate to be appointed as the new B.A. was an Assistant Business Administrator in Newark. Peter Pelissier has over 20 years experience. These are people who really want to work in the City."

Resident Stanley Sierakowski came back later in

the evening (public portion). "Nothing is official. (The date being changed back to April for the Board of Education Elections) According an article published in the Amboy Guardian in 2012, "Three Board of Education Members voted against moving the elections to November." He then again encouraged the Council Members to read the stature on changing Board of Education election dates."

Councilman Fernando Gonzalez showed his displeasure in regards to moving the Board

### **Resident Feels House is in Danger** 2/10/16 Council Meeting

PERTH AMBOY - Water Street Resident Dan Hedberg was concerned about the stones that were removed which secured the hill leading to Bayview Park from Front Street. He presented photos to the Council, "I called Council President Lisa Nanton who is the committee woman in our district about not only my home but other homes that may be affected by this. I came to City Hall and spoke to Mayor Diaz and B.A. Pelissier. Our neighborhood was not told about the rock removal which I feel will put us in danger. Heavy rains can cause the dirt to slide. There was a front-end loader that was digging out the dirt. I'm asking that this project be put on hold."

Hedberg had a list of requests to present before the Council. One included if the town would be able to issue any kind of insurance to protect his residence for any damages. He wanted to know if there were any legal

requirements informing residents in an area that there may be a project that might endanger them. "Why are we putting walkways in the middle of a hill?"

Law Director Arlene Quinones-Perez told Hedberg, "The City does not provide insurance in those cases. I am not familiar with this project and will have to take a look."

who retired. When Schwartz retired, Hoffman stepped in as Public Works Director and did a good job until a permanent replacement could be found for Schwartz. In that short period of time, Hoffman had to do the budget for Public Works and he did a good job and brought it under budget. Both Hoffman and Jamie Rios are dedicated employees."

Councilman Joel Pabon said, "I was impressed by the employees who came up to speak about these two individuals (Hoffman and Rios). Three of the most important departments in the City are the Police, Public Works and Code

Enforcement. Sometimes people in these departments may think that no one is watching them when they're working at certain hours. But, there are a lot of people who are looking when you're working at all different hours of the day. I know, because we get complaints from these people. I know the employees said we are short of manpower and equipment, but that's why we (the Council) are here so you can tell us exactly what you need."

Hoffman's appointment was moved and passed unanimously.

After Hoffman was approved as Public Works Director by the Council, the DPW em-

#### ployees and many others at the Council Meeting stood up, cheered and applauded for that decision. Hoffman stood up with a big smile on his face and thanked the DPW for being here and supporting him. He asked the Council to please vote for Rios as well.

Rios' appointment was moved and passed unanimously as well.

Hoffman complimented the new Code Enforcement Director, Jamie Rios whom he sided as being a "very understanding director." He added, "Rios has to be a disciplinarian as well as a leader.'






# Connections Program Seeks Volunteers

According to the 2010 United States Census, there were 50,814 people in Perth Amboy, including 15,419 households, and 11,456 families residing in the city. Even if you factor only one car per household (being conservative), that's over 15,000 vehicles that need parking in a 4.702 sq mi land area. That's 10,806.8 people per sq mi - and more people coming in. Enough already! Where are these people going to park? As it is now, we don't have sufficient parking for our residents, including all the residents which are living in illegal housing. Even if these vehicles are garaged, there are a large amount of cars on the street and people driving in town. It's getting more and more difficult to navigate while driving in the City. Perth Amboy is bursting at the seams. Any additional housing will put a strain on the City. What will be the straw that breaks the camel's back? Winter has taken its toll on Perth Amboy's roads, as it has been doing so for many years, and it doesn't help our sewer system either. The last snowstorm added to the ever in-

creasing pothole problem. Look around the City and count how many potholes and cracks you see. The roads are continuing to deteriorate and are getting worse and worse each day. The appearance of some roads as they are now is deplorable. Besides being unsightly, they are an accident waiting to happen to both pedestrians and drivers. Some of the roads going through Perth Amboy are state or county roads and are the state's and county's responsibility respectively. Perth Amboy should request that these roads be paved.

While patching helps put a Band-Aid by fixing the problem temporarily, many of Perth Amboy's roads are beyond patching. These roads need to be paved. Paving Perth Amboy's roads will improve the overall appearance of the town giving it a much needed face-lift. At the same time, it will give the City the opportunity to take the time to improve the infrastructure of the sewers (which may collapse one day and cause major sinkholes). It's a job long overdue. ### Equal Pay for Women Can't Wait

Seven years ago, President Obama signed the Lily Ledbetter Fair Pay Act ensuring that anyone whose pay lagged because of gender, race, age, disability, or religion could assert her rights under federal anti-discrimination laws. While the act has helped many deserving individuals since its enactment, according to the National Women's Law Center[i], women remain economically marginalized and underpaid in comparison with men throughout the United States and here in New Jersey.

Enter New Jersey legislative champion state Senator Loretta Weinberg introducing a critical measure to help address the persistent problem of pay inequity that hurts New Jersey families so dramatically. Sen. Weinberg's bill takes steps towards strengthening New Jersey's laws against discrimination particularly as it relates to wages and sex. A requirement for employers contracting with the state to provide demographic and wage information is a good measure to help identify discriminatory practices where they exist. This measure and corresponding initiatives in other states need to be supported with advocacy and activism to move them through attempts to derail and obstruct.

Legislative measures are one tool in what must be a multi-faceted approach to the persistent problem of the gender pay gap.


Our unions continue to advocate successfully for equal pay and make some progress. The Institute for Women's Policy Research found that women represented by labor unions earn 88.7 cents on the dollar compared with their male counterparts, a considerably higher earnings ratio than the earnings ratio between all women and men in the United States (78.3 percent)[ii].

When I started teaching more than three decades ago, the profession was low-paid and comprised of a mostly female workforce. We suffered with low salaries for decades. Collectively bargained salary guides accounting for both experience and education have gone a long way towards addressing pay inequality within the ranks of professional educators, but it is still not enough. Unfortunately old attitudes persist and we still see that men are more likely to be moved into athletics coaching and extracurricular activities that offer stipends and more likely to be hired into district administration with higher salaries. Although we know that education is a great equalizer in many areas and of immeasurable value in shaping our society, the wage gap exists

regardless of education level. Women with master's degrees working full time are paid just 72 cents for every dollar paid to men with master's degrees, according to the National Partnership for Women and Families.[iii] Further, women with doctoral degrees are paid less than men with master's degrees, and women with master's degrees are paid less than men with bachelor's degrees. None of these persistent gaps are going to be closed by the force of wishful thinking or platitudes. We need solid legislation like Sen. Weinberg's to keep us moving in the right direction. We need programs to train women for rewarding careers in trades as well as for professional and managerial roles. We need to change the mistaken impression that





males are family breadwinners and women are only working to supplement a husband's income. In fact, census data show more than 441,000 family households in New Jersey headed by women[iv]. About 23 percent of those families, or 99,308 family households, have incomes that fall below the poverty level.

One strength we have in advocating for local, state and federal legislation is that women vote at higher rates than men since 1980 and in higher numbers since 1964[v]. In 2012, 71.4 million women (64 percent of those eligible) voted, compared to 61.6 million men (less than 60 percent). In 2012, 81.7 million women were registered to vote, compared to 71.4 million men.

Legislators of both parties as well as candidates for higher office should be held to task for their past votes and asked to pledge to support bills that provide accountability and address wage discrimination. These are among the tools that we can use so that subsequent generations of Lilly Ledbetter's daughters and nieces earn enough to be self-sufficient and those who choose to can care for their own families.

Council President Lisa Nanton said, "He was only the Acting Mayor from the January dates that were listed on the previous agenda when the Mayor was out of town."

(Mayor Diaz came back at an earlier date than originally scheduled because of the snowstorm.)

Resident David Caba said, "I should apply for a City Pension because I've been coming to the Meetings for over 20 years. Nobody wanted to run against Joe Vas for many years. I respect Pelissier as a Veteran. I have a right to come up here because of our Veterans fighting for our freedom." When Caba started to speak about an 85 year old man who was a Veteran who he considers as a second father, Councilman Fernando Irizarrv interrupted him and said. "You've told this to us many times already." Caba became agitated and responded, "I can come up and speak as many times as I want - Even if it's on the same subject! 35% of the people voted for Mayor Diaz. The other 65% did not want her." Resident Alan Silber came up to speak. He addressed Councilman Joel Pabon. Silber questioned Pabon about an ordinance that Pabon said the

Council should have pulled from the December 9, 2015 Council Meeting Agenda:

2. ### **PryceLess Foundation: Celebrating The Life Of Richie Pryce in A Memorial Service**

PERTH AMBOY – Violence took his life but his legacy continues to speak out against the violent behavior that devastates communities. Richie Pryce was gunned down one year ago and one year later his vision of starting a nonprofit organization is alive and closer to becoming a reality. ### Five Points by Board President Lebreault 2/11/16 Board of Education Meeting

By: Katherine Massopust PERTH AMBOY – During the President's Report, Board President Sam Lebreault stated five major points he wanted to emphasize. The Amboy Guardian reached out to Lebreault who explained each of the five points.

1.) The Board of Education is looking into purchasing 3 properties near the Patten School located at 500 Charles St. (Off of Hall Avenue). "The reason for this is not only to create parking for teachers and staff, but to create traffic patterns to make it a lot easier for parents to drop kids off. There will be one-way traffic in front of the school and more control of traffic on Charles and Elizabeth Streets. We will be building a cul-de-sac to provide for ease of traffic."

2.) The Bus Depot – the Board of Education is looking at the East Avenue Property as well as other areas to build a bus depot. "We already own the East Avenue Property but if another property is more suited for our needs, the Board will be looking into purchasing it."

3.) The SDA (School Development Authority) has requested that the Board of Education have a name given to the Seamen Avenue School. "The Board will reach out to the public for suggestions, but Board will decide on the name of it."

4.) The final purchase of the Delaney Homes Property is in the works. The SDA wants to know what programs to be

expected to be held at the new high school. "We will work to present to the state what is required by them."

5.) The Board of Education Election has been moved to April 2016. The City is challenging that. In reference to the City Council: "The Board of Education is a separate entity than the Council. We are a self-governing body. The law's written part (referring to the election) is ambiguous. The Board has the right to move it. In some districts the Board of Education is appointed by the City Council. It (this ordinance) was never meant for fully elected bodies. The Board wishes to keep political influence out of the election. The City Council (on 2/10/16) wanted to move the election back to November. We (The BOE) want what's best for the BOE's purpose. We're taking it to court. I'm only guessing, but the court will have to act expeditiously."

### Caesar's Wife Must be Beyond Reproach 2/11/16 Board of Education Meeting

By: Katherine Massopust PERTH AMBOY - During the public portion, Resident Stanley Sierakowski came up to the podium to speak. He began with an old expression: "Caesar's wife must be beyond reproach." This old proverb stems from ancient Rome when Julius Caesar (supposedly) gave the reason why he divorced his second wife, Pompeia because she was suspected of some wrongdoing, and therefore he could not be associated with her anymore. Sierakowski explained, "There are three members of the negotiating committee (with the PA-AFT) who are incumbents. When you have a relationship with a Union Member. 3 of 4 of the negotiating committee are BOE incumbents. As a business practice, that does not happen. See the process at it evolves. In the future, take into consideration Caesar's second wife."



### Dual Language Academy; Board Certified Teachers Superintendent and Assistant Superintendent's Report 2/11/16 Board of Education Meeting

Dr. Roman continued to praise the staff on their hard work during the recent snow storm. "Snow had an impact on the community."

Dr. Roman went on to speak about the Dual Language Academy at the building that used to be Our Lady of Peace School, now being utilized by the Perth Amboy BOE, "The importance of dual languages – we're not just going to open up a building without engaging teachers, parents and meet with them. In reference to the new high school, "How do we build it into our High School.? We will meet with the SDA and include everyone (input) into the new High School. Where we are and what we're doing – our workforce is not viewed as a challenge."

In September of 2016 we are planning to offer technical support on site."

Silber then became agitated with Quinones-Perez and said, "I really didn't have to give you those names. I'll tell you what - have the DeCotiis Law Firm call me."

Before sitting down, Silber said to Quinones-Perez, "It's because of your attitude that a lot of people don't want to come here (to the Council Meetings).

Businesswoman Virginia Lugo said, "I'm appalled. The City Codes are not being followed. You (the Council) have non-caring attitudes. You are supposed to question when something is amiss. You guys are rubber-stamping everything. That is what is wrong with the City."

Perth Amboy Republican Chair and Businesswoman Sharon Hubberman had several subjects she wanted to discuss, "I witnessed City Employees who came to support their Directors. These employees who spoke said, "We haven't had this sort of exemplarity leadership in years. A lot of individuals state their views and as public servants, you are indifferent."

# This Week in World War II 75 Years Ago

On February 14, 1941, the first units of the German Afrika Korps, commanded by Lt. Gen. Erwin Rommel, begin landing at Tripoli, Libya. At Berchtesgaden, Germany, Adolf Hitler meets with Yugoslavia's prime minister, Dragiša Cvetković, in an attempt to persuade him to join the Tripartite Pact (among the Axis nations: Germany, Italy and Japan). Cvetković declines to make a commitment, however, hoping to get assistance from the U.K. and the U.S. Great Britain announces that because of the presence of over 500,000 German troops in Romania, it considers that nation "territory under enemy occupation" and an "enemy destination."

During the night of February 15, Royal Air Force planes, based in Great Britain, drop propaganda leaflets over Kraków and Katowice, in German-occupied Poland. In Italy, the government forces the U.S. to close its consulates in Naples and Palermo.

On February 16, the 1st South African Brigade begins an important battle to seize crossings over the lower reaches of the Jubba River in southern Italian Somaliland.

Pressured by Germany, Turkey and Bulgaria sign a "friendship" agreement in Sofia on February 17 stating that Turkey acknowledges that passage of German troops through Bulgaria does not constitute an act of war. The British conclude that the agreement more or less confirms that there is little to no chance of persuading Turkey to join the Allies.

South African troops, advancing from Kenya on February 18, attack the town of Mega, in southern Ethiopia, which is taken quickly, along with over 1,000 Italian prisoners. In Asia, thousands of Australian troops arrive in Singapore to help prepare defenses against a possible attack by the Japanese.

The Luftwaffe begins the "Three Nights' Blitz" of Swansea, Wales, on February 19. The central portion of the town is almost completely destroyed by 896 high-explosive bombs dropped over the nights of February 19, 20 and 21. 230 people are killed and 397 are injured. In Cairo, Egypt, on February 19, Anthony Eden, of the British Foreign Office (an assistant to Prime Minister Winston Churchill), Gen. John Dill, Chief of the (British) Imperial General Staff, and local commanders Gen. Archibald Wavell, Commander-in-Chief Middle East, and Lt. Gen. Alan Cunningham, Commander East Africa Force, meet to discuss whether they can send help to Greece, and, if so, how much. British political leaders strongly favor sending as much help to the Greeks as possible, and Gen. Wavell agrees that sending assistance can be done effectively. In Amsterdam, Occupied Netherlands, two German policemen enter an ice cream parlor where they are sprayed with ammonia by a protective device that had been installed by the establishment's German-Jewish owners. The incident will have repercussions. In Washington, D.C., President Roosevelt signs legislation that converts the U.S. Coast Guard Reserve from a civilian organization to a military one.

On February 20, British and German patrols make contact for the first time in North Africa, in the desert near Sirte, Libya.






