

2/6/17 Caucus



Topic: Changes in NJ Judiciary Jorge Sanchez

PERTH AMBOY - Jorge Sanchez (Asst. Criminal Div. Mgr. Pre- trial Svc.) discussed new laws regarding how low offense defenders will be treated. Sanchez stated, "In 2014, 82% of New Jersey approved this new law."

He went on to explain the steps taken when summonses are issued for low level offenses. "The defendant is given a court date and a bench warrant is issued if they don't show up for that court date. If their is a complaint warrant, that person goes directly to Middlesex County Jail and they can be held up to 48 hours and then released on certain conditions. Some of the conditions may include: electronic monitors, contact by phone or a visit by us in person. We have to make sure that they appear in court and do not commit any further offenses when they are out. We make sure they rebuild their lives through counseling and other resources. Another aspect of this law is a Pre-trial Attendance Motion. The Prosecutor will determine if everything is in place. Depending on the infractions, the defendants may spend more time in jail. We monitor until the case is heard, then dismiss if permissible. Another program includes a Detention Motion granted. Their case must be heard within 90 days. They can be held in jail until that time. Our office averages about 10 of these cases a day. We make recommendations





to the judge on each individual case. It might take us from 45 minutes to 2 hours to present these cases. We are the first State to have an automated system. In case the computers go down, we have all the information available to do by hand. It will just take longer. These new rules take effect for anyone who was arrested or charged from January 1, 2017. Some of the factors we take into consideration includes the age at the time of the offense. There are no attorneys on our staff. We have court service officers who can handle drug screening/referrals and to see who is eligible for a Public Defender. If you would like to see actual proceedings taking place, you may go into the website of njcourts.gov/virtual on Saturdays at 2:30 p.m. Motor Vehicle Violations and Disorderly Conduct Offenses are not eligible for this program

The next topic of discussion was an update on the Remediation Site of St. Demetrios Hall on Sadowski Parkway.

Candice Baker from Langan Engineering came up to speak. She stated, "The site contains petroleum contamination. Elizabethtown Gas has to clean the site. My company has worked on at least 50 similar sites. All the contractors working are licensed and vetted. The contaminations are under St. Demetrios Church Hall Property. We'll have to destroy the building. We're also removing underground oil tanks. We talked to Code Enforcement, the Engineers and the Police Department about the plans. We will hold public meetings and have a hotline set up. There will be sig-

# "This is Embarrassing!" The Plea

2/6/17 Caucus & 2/8/17 Council Meetings

PERTH AMBOY - Regarding Resolution R-67-2/17, the Council retaining the services of the Law Offices of Robert L. Tarver. Councilman Jelmin Caba had concerns about the Council having their own Attorney. He stated: "Now the Mayor is suing the Council. This is embarrassing! Dragging this through court is going to cost us more than we are going to recoup. Let's move forward and get rid of this. I don't wish to entertain or participate in any of this."

Council President Bill Petrick responded and said, "We,the Council didn't initiate this lawsuit. They are taking us to court."

Caba wanted to know, "Are we going to countersue?"

Petrick responded, "Maybe the Mayor can withdraw her suit?"

Caba was still adamant, "We're going to end up paying more than the money we are trying to recoup. Taxpayers are paying for all of this. Behind closed doors we can come to a compromise."

Petrick responded, "We need to have legal representation, even going into remediation."

Councilman Fernando Irizarry added to the conversation, addressing Jelmin Caba, "Maybe you need to abstain on R-67. Maybe we can take out the whereas clause."

Some of the public responded. Resident Jeremy Baratta sated, "The Mayor filed two lawsuits. Who is she suing? I could see (Councilman) Caba's point about wasting taxpayer's money, but where do you draw the line? If you don't fight her (the Mayor) on this one, then you become her lapdog."

Resident and Businesswoman Susan Batista commented, "Who is paying for Wilda Diaz's attorney and what did they restrain you with? You have a date for the 15th (February 2017). You're not allowed to talk about certain things. In my suit, I'm suing Fehrenbach (Former B.A.) I then added Pelissier and then Cruz to my suit. Those previous lawvers that I named are not from the DeCotiis Firm. When we get to trial, I will get three times as much as I requested. All professional services have to go out for bid."

At the end of the Meeting, Councilman Caba continued his plea, "I'm asking the Mayor and Council to drop all of this - this nasty politics! The losers will be the taxpayers of the City."

Councilman Fernando Irizarry was frustrated and reiterated some of Caba's sentiment, "Is their any room for compro-



nage indicating that this site has an environmental cleanup going on. A Security Guard will be onsite and the water supply will be protected. Because of the digging and the compacting materials, tents will be erected covering the site. Part of Sadowski Parkway will have to be excavated. These tents will also control the dust, noise and any odors. Odor suppressing foam will be used and the air quality will be monitored. We're working under the MCIU and DEP guidelines. All the City sites we dig up will be returned to their original forms. Public meetings will be advertised in newspapers and other media sites."

At this point Stephen Cooke of Elizabethtown Gas came up to speak, "We have our mailings with updates. We also have gone door to door in the past. We can do certified mail and all notices will be in English and Spanish."

After Cooke made his statement, Councilman Fernando Gonzalez had some harsh words: "Your credibility with me is zero. I will be on top of this situation. I want to make sure you guys don't come here to make presentations and don't follow through. I'm concerned about the environmental history."

Cooke responded, "The DEP requires us to remove contaminants and put in clean fill."

Councilman Gonzalez mentioned all the streets that were dug up by Elizabethtown Gas and now are in horrible shape.

A spokeswoman from Elizabethtown Gas came up to speak to address Gonzalez's concerns about the street conditions, "There is a 90 day resettlement period before we can go back to do final work."

Business Administrator Adam Cruz then made some remarks, "We (the City) have shut down Elizabethtown Gas operations as of February 2, 2017 because of the road conditions existing now. We can't wait a couple of months to have patches done on our roads. We need to have these roads looked at in a couple of days."

The Elizabethtown Gas Representative answered, "We will look at the situation."

Next up were Representatives from the E-Port Logistics Center. They were put on the hot seat by Councilmen Jelmin Caba and Fernando Gonzalez. They were concerned about the square foot cost of the build-

The City Appraiser came up to answer these questions. He told them the advantages of having a PILOT Program. The PILOT Program is \$3.30 per square foot will be the tax burden. The rental will be \$8.00 per square foot. The City will receive \$2.40 per square foot. Without HPC Chair Reinaldo Aviles

the PILOT, the tax burden will be \$3.30 per square foot, but the City will only receive \$1.90 per square foot."

Councilman Jelmin Caba questioned the amount of the permanent jobs. "They stated there will be 650."

The Representatives from E-Port stated, "The first big building that goes up will have 100 jobs. When other buildings go up, there will be at least 500-600 additional full time jobs going up."

The last topic for discussion was the Thomas Mundy Peterson Project.

Pastor Amos Dickerson from the St. James AME Zion Church came up to speak. The first thing he did was mention the Bill of Rights banner hanging up the Council Chamber and read the words: "We will be commemorating on March 31 a ceremony of the historic vote in the Council Chambers." He mentioned 3 proposals, one which included commemorating Thomas Mundy Peterson in City Hall and on the outside. "Where are we on these proj-

Mel Knight who is an officer of the NAACP came up to speak and mentioned about a possible plaque going up in City Hall, a monument on the outside and then a dig. "You (the Council) can control what goes on in the building. I went around to different places to see how much a plaque would cost. "Shevchenko Monuments was one of them, but I could not present myself a representative of any organization The Thomas Mundy Peterson Property is on Kushner Property. The statue should be in town. We want the property adjacent to Kushner's to put the monument on it. Who has the definitive authority to make a decision?"

Council President Bill Petrick spoke up and said, "One person can't make that decision. The NAACP, the HPC and any groups that are interested can form a committee that can determine what should be done."

Knight responded, "We have been sent around the mulberry bush. This should have been done years ago."

Councilman Fernando Gonzalez stated, "I have been in this town close to 50 years and I've heard about Thomas Mundy Peterson then. We have a Duarte Park because an organization had the power and money to get it done. Get a petition together. It ain't gonna happen with this Mayor or Council to get it done."

Councilman Fernando Irizarry spoke next and wondered, "Who gets the final word about who can authorize High and Commerce Street property for a Thomas Mundy Peterson stat-

At this point, Resident and

came up to speak, "We have given the City what we have. There are 3 things that we are working on: 1.) The dig - The County secured the funds and are working with Gordon Bond. Kushner is preventing us from doing the dig. The site should be a commemorative and it would be easy to put a monument on that site. 2.) The Council Chambers should be named after Peterson with the plaque. There is \$7,000 set aside for this. This is an American issue. We should be very proud to celebrate this. In any other town this would have been done already. A bust would cost at least \$30,000. I encourage everyone to be at the next HPC Meeting. 3.) I would like to have this done before March 31st. If you start another committee, it's just going to slow things down. We would like to make a presentation on all of our projects and I would like to see a statue. In my opinion, it would be quicker to put a statue in front of City Hall. The lots where the Mundy Peterson House should be kept in-

Resident John Dyke who has also produced several documentaries about the history of Perth Amboy came up to speak, "Six years ago, I got involved with the Thomas Mundy Peterson Site. Myself and the Former Chair of the HPC, Bill Pavlovsly surveyed the property with Kushner's permission. I support having the plaque and the statue." He then asked those in attendance if they knew who the second African-American to vote was.

When there was no response, he gave the answer: "Marcus Curless voted a few minutes after Peterson. He lived in Perth Amboy with his family who were involved with the Underground Railroad at Eagleswood. While other communities were trying to stop Black Americans from voting, the good people of Perth Amboy encouraged it."

Dyke also said, "In 3 years, it will be 150 years that Thomas Mundy Peterson voted in this place (The Council Chambers).

Councilman Joel Pabon was not present at the 2/6/17 Cau-

### **Unhappy With Pipeline Meeting**

PERTH AMBOY - Councilman Fernando Irizarry had requested information and a legal opinion regarding the Pipeline approval process from B.A. Adam Cruz and Acting Law Director Judy Verrone. "I'm requesting a second hearing on the pipe-

Councilman Fernando Gonzalez said, "Maybe having the lawyer representing us in this matter can come here to explain this to us."

Verrone responded, "The Lawyer (Wendy Rubenstein) can come here to give a further explanation."

Council President William Petrick was concerned because, "We didn't have a cameraman or audio to record the meeting. You only had a stenographer and it should have been put on Channel 34. We need to have the money that's coming to us from Verizon and Comcast to improve the audio on Channel 34. We need to work together to fix it."

Councilman Jelmin Caba agreed with Petrick, "We should recommend that Buckeye tape the scope hearings to put on Channel 34."

Resident and Businesswoman Virginia Lugo remarked, "Councilman Irizarry couldn't understand things being said at the Buckeye Meeting. I had asked for a list of all of the PARA Projects and all of the specifications attached to them. This should also be available to the public. People should not be presenting projects here if they don't have all the proper facts. I was at the Woman's Club Meeting earlier in the day and the Mayor was also there and said that Buckeye was a done deal. We don't have enough facts to vote on a lot of items presented here to-

night."

At the 2/8/17 Council Meeting, Businesswoman Sharon Hubberman also spoke about the Buckeye Scope Hearing stating, "There were two Councilmen present. There were no mic's, nor were there cameras present and there was a room full of people. There were mostly Union Representatives. We should have had a handout. The Mayor uses a smokescreen. There is a pipeline being built in people's backyards. The Mayor always talks about looking out for Latinos, but all the Buckeye literature is in English. Did the Mayor make robocalls to those residents. We are susceptible to terrorists. In my research, in 2012, there were pipelines mentioned. This is a travesty and this lawsuit (Mayor suing the Council) is a smokescreen."

Resident Vincent Mackiel said, "You should check into the legality of the pipeline and take seriously what Sharon said. There is serious danger in building any pipeline." He also commented to the Council, "You (the Council) have done some good things, but the Tennis Courts still need more work done."

Business Administrator Adam Cruz explained, "The application goes to the City Clerk and myself. The Clerk provides them to the Council."



### **Marketing Perth Amboy's Rich History**

Some of the Most Significant Moments in American History Began in Perth Amboy

Perth Amboy has a lot of history and is truly a City of Firsts. It's embarrassing that the City of Perth Amboy hasn't had a significant commemoration to Thomas Mundy Peterson after all these years. It was disheartening when Councilman Fernando Gonzalez stated that he's heard about Thomas Mundy Peterson and he wants a committee to be formed to raise funds to build a statue or some other significant maker to honor Peterson as they did with the Duarte Monument.

Here's the big difference: Thomas Mundy Peterson's Vote in the Historic City of Perth Amboy was a major stepping-stone in America, because it was the first time Blacks were given the right to vote. This happened in the same City Council Chambers in use today. The money for this monument should have been put in the City's budget. Even if a monument costs the City \$80,000, the return will be a thousand-fold. To say that we need a committee to raise funds is preposterous. The City should pay for this monument. There is so much confusion as to who own the piece of property where Peterson lived, if it is owned by Kushner, the plea that you made to him about establishing a decent tribute on this plot of land is very weak. Tell Kushner he

can get a tax write-off and save a little face by doing so.

Instead of paying for a lawsuit against the Council and the Council using taxpayer's money to have their own lawyer, why not combine all that money and put up a monument? We're missing a golden opportunity. Ex-Councilman Ken Balut said that the Controller should have been involved in the case against Pelissier.

We also noticed in South Amboy when they were digging for roads going to the new Ferry, historical artifacts were found. That delayed the project until those artifacts could be properly identified. We have lost so much history with the destruction of the Innis House (the last remaining building of Eagleswood).

As we have mentioned many times, Perth Amboy is one of the 10 most historical cities in the United States. Not only that, when they talk about naming schools or parks besides the Thomas Mundy Peterson School, we should pay homage to Marcus and Rebecca Spring. It was James Lawrence Kearny (Son of Lawrence Kearny of the famous Kearny Family of which the Kearny Cottage is named) and Marcus Spring who encouraged Thomas Mundy Peterson to vote. In case you're asking, Marcus and Rebecca Spring

founded the Raritan Bay Union and its famous school, Eagleswood founded in Perth Amboy in 1853. It was here that both girls and boys of all races were taught. Every student was encouraged to think and have opinions on all matters including politics.

We agree with City Historian Anton Massopust that one of the new schools should be the Rebecca and Marcus Spring School.

This can be the start of a beautiful movement for Perth Amboy that has been a long time coming. There should be monuments all over town for such historical figures as the Springs, Kearnys and Solomon Andrews. Make a reason for people to come and enjoy Perth Amboy.

Why not reach out to the Freeholders, the County and our State Representatives to secure funds?"

At the Council Meetings, people talk about crime not being reported and the quality of life not being what it should be, illegal housing and bad road conditions. These are all legitimate complaints, but we need to put a positive spin on Perth Amboy. Emphasize what is positive about the town. When you have outsiders coming into Perth Amboy to spend money to see what you have to offer historically and otherwise, it can only help your economy.



mise here? This is going to wind up losing the taxpayers money. It's not going to get everything that we want. Let's not inflame the situation."

Arguments about the Mayor's lawsuit spilled over to the 2/8/17 Council Meeting.

Former Councilman and Resident Ken Balut said, "The Council needs their own lawyer and it should be in your budget. The Controller's Office should look at this conflict with Pelissier - not a lawyer. We've had three different DeCotiis lawyers, and on a legal document, they didn't have the Mayor's name right and had the City in the wrong county."

Resident David Caba came up to speak. He wanted to know: "How much did Tarver (Council Attorney) give to elected officials."

The Council responded, "He didn't."

David Caba responded, "Oh, he's an independent." He continued, "The Mayor goes on social media about the lawsuit. Let the people know that you (Some of the Council Members) took money (campaign contributions) from North Jersey. North Jersey is running the City. Tarver is independent and he is the one who has not given any political contributions."

He also questioned who was

paying for the lawsuit (filed by the Mayor).

Council President Bill Petrick responded, "Taxpayers are."

Resident Caba finished by stating, "And the Mayor states she is looking out for the tax-payers."

Resident Jeremy Baratta said, "Anytime there's a lawsuit, the Council has to go into closed session. How will this be handled? I wonder if this will be a conflict."

Acting Law Director Judy Verrone answered him, "I don't represent the Mayor in this lawsuit. The court will make the determination as to how the suit will proceed. The court will not have the Council make the decision."

Baratta continued, "I see there are three filings." He wondered how many hours and time was spent.

Council President Bill Petrick answered him, "I haven't seen the bills."

Resident and Lawyer Daniel Gonzalez said, "People are paying attention to politics because of Trump." He went on to congratulate the Council Members who were recently elected and re-elected and who have been on the Council. "We have to deal with Diaz and Cruz. I was offended by the Mayor suing the Council. Why can't the Mayor admit to doing something wrong? When I see

the Mayor telling the City she is saving them money by suing, I'm telling the Mayor just to relax - you already won the election. Mr. Jelmin Caba is my neighbor and a gentleman. We can all be friends and address the issues together."

D. Gonzalez then commented, "DeVos (Secretary of Education (at time of the 2/8/17 Meeting Nominee)) is against cities like us."

During the Council Comments, Jelmin Caba stated, "I am pleading with the Mayor and Council about this suit To Mr. Daniel Gonzalez, I appreciate your comments. Our decision can't be politically motivated. In the surrounding town, the Mayor is the one who appoints PARA Members. We should work with the Administration and not undermine them. I also want to congratulate Edison Jasquez (B-Men Founder) for their work. I also want to thank the Department of Public Works for treating the streets for the upcoming snow storm."

Councilman Fernando Gonzalez said, "I must make it known to the citizens if proper procedures are not followed. If the Council made a mistake, we will admit it. On February 15, 2017 at 10 a.m., we have to appear in Superior Court. After the statement that the Mayor made on Facebook, I reached out to her."

### Coughlin, Sumter & Wimberly Bill to Help Those Found Innocent Rebuild Their Lives & Reputations Now Law

Press Release 2/10/17

TRENTON – Legislation Assembly Democrats Craig Coughlin, Shavonda Sumter and Benjie Wimberly sponsored to help those found not guilty of charges start to rebuild their lives and reputations has been signed into law.

"The American justice system is built on the rock solid foundation of innocent-until-proven guilty, but while charges can be dismissed and people acquitted, the Internet is forever," said Coughlin (D-Middlesex). "This requirement won't solve every problem for a person looking to rebuild his or her life and reputation, but it's a common-sense step government can take to make it a bit easier."

For all indictments and prosecutions by the attorney general of an individual who was later acquitted of criminal charges, the law ((A-1945) requires the attorney general, upon the person's request, to remove from the attorney gen-


eral's website any press release or other published information that includes the individual's name, or inform the public on the website that the person was acquitted of the charges or that the charges were dismissed. Similarly, in the case of indictments and prosecutions by county prosecutors, the county prosecutor would be required to remove related press releases from the office's website or inform the public that the person was acquitted or that the charges were dismissed.

Furthermore, the attorney general or the county prosecutor, whichever is appropriate, must provide a letter to every person who was indicted or prosecuted and thereafter acquitted or had charges dismissed, certifying that the person was acquitted of, or that there was a dismissal of, charges arising from the indictment or prosecution.

"The Internet enables things to live on in perpetuity so a person who is later found to be innocent can be haunted by unsubstantiated charges forever," said Sumter (D-Bergen/Passaic). "This change would at least bring a modicum of closure to the innocent to help them move on and clear their name."

"Innocent parties have an absolute right to be free of the consequences reserved for criminals," said Wimberly (D-Bergen/Passaic). "Helping those who were wrongfully accused or convicted restore their lives is just the right thing to do."

# This Week in World War II 75 Years Ago

As of February 13, 1942, the Japanese control Borneo, Sarawak and the Celebes Islands in the East Indies. In Europe, the British submarine *HMS Tempest* is depth-charged and sunk by the Italian torpedo boat *Circe* in the Gulf of Taranto, off southern Italy.

On the Eastern Front, Rostov-on-Don, Russia, falls to the Red Army on February 14. A ferocious battle breaks out between Soviet and German troops in Kharkiv, Ukraine. The Soviet Union mobilizes all able-bodied males between the ages of 16 and 65. The majority of resistance groups in Occupied Poland band together to form the "Home Army (Armia Krajowa)," that is loyal to the Polish Government-in-Exile in England. In London, RAF Bomber Command issues its controversial "Area Bombing Directive" that says civilian areas will be legitimate targets in future air raids. In Asia, the Sarawakian vessel SS Vyner Brooke, carrying 65 Australian Army nurses and several hundred wounded British and Australian soldiers — as well as civilian men, women and children — away from Singapore, is bombed and sunk by Japanese planes. Over the course of the next day, about 100 survivors, including 22 nurses, make it to Japanese-held Bangka Island in the Dutch East Indies. There, on February 16, Japanese soldiers shoot the walking wounded, machine-gun the nurses on the beach (one survives and is sent to a prison camp), and bayonet and kill the wounded on stretchers.

At Singapore, the Commonwealth defenders are running out of food and ammunition, and they cannot stop Japanese aerial attacks that are causing heavy casualties in the center of the city. In addition to the defenders, over one million civilian refugees are crammed into the three-square-mile area within the defensive perimeter. Finally, at 5:15 p.m. on February 15, after six days of fierce fighting, Lt. Gen. Arthur Percival, British General Officer Commanding – Malaya, surrenders, and 130,000 British and Commonwealth troops pass into captivity. British prime minister Winston Churchill categorizes the fall of Singapore as the "worst disaster" and the "largest capitulation" in British military history.

Palembang, on Sumatra, falls to Japanese forces on February 16. Japanese troops on Borneo capture the town of Sintang, West Kalimantan. Three German submarines attack oil facilities and tanker ships at Aruba in the Netherlands West Indies. The Caribbean island is home to two of the largest oil refineries in the world, as well as extensive petroleum storage and loading facilities. The attack results in a significant disruption of Allied fuel production.

The order is given on February 17 to evacuate Rangoon, Burma, as Japanese troops approach. In the Soviet Union, Hitler visits with Field Marshal Erich von Manstein to review plans for the coming counteroffensive in the Caucasus. Looking to exploit a breakthrough made at the end of January, the Red Army launches an offensive at Rzhev, some 130 miles northwest of Moscow. Despite temperatures that reach –52°F, the fighting is fierce and the Germans hold. In Singapore, the British Malaya Command officially surrenders the 40,000 troops of the British Indian Army to the Japanese, who in turn, pass the authority over them to Mohan Singh, an Indian nationalist and a captain in the British Indian Army. Singh announces the formation of the Indian National Army (INA), urging the captured Indian soldiers to join the INA to fight against the British Crown Rule in India (the British Raj). Eventually, around 12,000 of the Indian POWs join the Japanesedirected INA. South of Bangka Island, in the Dutch East Indies, the Dutch destroyer HNLMS Van Nes is bombed and sunk by the Japanese with the loss of 68 of its 149 crewmen.

Soviet forces overwhelm the Germans defending Kharkiv, Ukraine, on February 18 and the city is retaken by the Red Army. In Singapore, the Japanese occupiers begin the "Sook Ching" operation: a "purge" of the portion of the Chinese population of the city deemed to be "hostile" to the Japanese. In 14 days, thousands of Chinese are killed — the Japanese say the number is fewer than 5,000, while Singaporeans claim that between 70,000 and 100,000 Chinese are murdered. In Calcutta, India, visiting Nationalist Chinese leader Chiang Kai-shek meets with political activist Mahatma Gandhi.

On February 19, some 240 Japanese aircraft bomb the harbor and airfields around Darwin, in Australia's Northern Territory, sinking 17 docked ships. Mandalay, the capital of Burma, is bombed for the first time by Japanese airplanes. In Ottawa, the Canadian Parliament passes a conscription (draft) law. In Washington, D.C., President Roosevelt signs Executive Order 9066 that permits the U.S. military to define "exclusionary zones" precluding people of certain nationalities from residing within them. The Executive Order affects Japanese on the West Coast, and, to a lesser extent, Germans and Italians on the East Coast. Among those forcibly displaced and moved to guarded internment camps are more than 110,000 people of Japanese ancestry, over 60% of whom are American citizens.
