### Not Letting It Go: Former B.A.'s Unexpected **Departure Still Takes Centerstage**

6/27/18 Council Meeting

PERTH AMBOY - During the first Public Comments at the 6/27/18 Council Meeting, Resident and Businessman David Caba came up to speak. He wanted to know, "Did the old Business Administrator resign, get fired, or what? Taxpayers pay the B.A.'s salary. Is he still getting paid? I also heard a rumor that someone else resigned? Is that person still getting a salary?"

Law Director Peter King responded, "This (the B.A.) was an Administrative appointment. He was appointed March 2016 and had a contract. He was not removed for good cause. He was not going to be reappointed again."

Council President Bill Petrick then commented, "I heard he re-

King then told the Council, You will introduce in a new ordinance as to what you can do regarding this matter. Any Business Administrator can get paid under the circumstances that he left. You can discuss this in closed session."

Councilman Fernando Gonzalez spoke up and stated, "You are asking me to spend an additional \$50,000 without giving me a reason why (the former B.A.) left."

King responded, "He wasn't fired. He just wasn't reappointed. Your ordinance requires you pay additional money.'

David Caba then continued, "If he didn't do anything wrong, he can get paid. Someone received a \$12,000 increase in their salary with less than 2 years on the job and they re-

signed so I heard. Let's be honest – there's more to this."

King responded to David Caba's comments: "I've heard rumors. If you have any information, please give it to me. You've made an allegation. I've not found anything."

Resident Jeremy Baratta came up next and questioned if certain behavior with a subordinate "constituted a moral dilemma?" He then said, "I see two new Resolutions that weren't here before. R-304-6/18 - Appointing Jill A. Goldy CFO/Comptroller to serve as a Temporary Interim B.A. for an additional annual salary of \$36,000. Another Resolution R-305-6/18 - Authorizing a contract for Interim City and Administrative Services at an hourly rate \$135/

Baratta asked, "Why two new resolutions for replacement for one guy? Why was there a failure to reappoint if there was no expiration date on the (contract)? Why wasn't there a reappointment a year and a half

King responded that when a Mayor's term expires, Directors have to be reappointed. "

Alan Silber came up next, "On Monday (6/25/18/) at the Caucus Meeting, you talked about the Business Administrator contract. You used the word supersede. Now we're talking about City Codes. The State Codes and the City Codes are the same. The state statute says "may" not "shall". You can do anything you want and still get paid. It's taxpayer's dollars. He (King) knows there's more to it than this. Somebody in the Court System resigned. This is a misuse of our taxpayer's dollars. We're going to pay him (Former B.A. Cruz) so the Mayor doesn't get embarrassed."

Silber then questioned, "Can the B.A. and CFO bee the same person?"

King responded, "In some cities, that can happen."

Before sitting down, Silber responded, "It's a conflict. You should hold off on your votes."

The day finally arrived, and the Thomas Mundy Peterson Plaque was unveiled at Historic St. Peter's Episcopal Church where Thomas Mundy Peterson was a member, and is the site of his final resting place. On the program were many speakers who spoke about the importance of Thomas Mundy Peterson casting a historic vote as the first Black man to vote after the passage of the 15th Amendment. This vote took place in the Historic City of Perth Amboy.

Thomas Mundy Peterson had a personal connection to two powerful men (J.L. Kearny and Marcus Spring) who encouraged him to vote. This sealed Peterson's importance in American and Perth Amboy history. Peterson was an honorable man, who was very community minded and well respected. He wanted to make sure he was the first Black voter before he was presented with any kind of recognition.

Historian John Dyke mentioned in his speech that if Thomas Mundy Peterson were dows urging people to sign up. alive today, he would wish Perth Amboy a happy 300<sup>th</sup> anniversa-

ry of being incorporated. I, myself would wonder what Thomas Mundy Peterson would think of Amboy today. I feel he would have a tinge of sadness. He would be looking at the number of people registered to vote in Perth Amboy and wonder why a majority who can vote, don't. He probably would wonder of what he did was that important if most people do not exercise the right

### Addressing Recreational

**Drug Fight**I attended the June 20th South Amboy City Council meeting where I heard resident Kim Seber speak so passionately about the ramifications of the potential legalization of recreational marijuana in the city. I've had the pleasure of meeting and speaking with her on several occasions and feel that she is one of the region's most vocal drug abuse treatment advocates and has worked tirelessly to help find solutions to the problem and save lives. I am in full agreement with Ms. Seber in believing that South Amboy has no place for legal recreational marijuana dispensaries, shops or stores because the risks outweigh any potential positives.

Back on April 19th, Ms. Seber and I attended a marijuana legalization discussion forum in Perth Amboy. Later, that evening I posted on my Facebook page that I believed the legalization of recreational marijuana could lead to a significant increase in the use of other recreational drugs, including opiates, and that much more needed to be examined before making such a quick decision on something that could have such crucial consequences such as addiction, an increase in crime and most importantly, the potentials of overdose and death.


I am a retired Middlesex County sheriff's officer who has seen first-hand what drug addiction and related crimes can lead to. I am a proponent of stricter drug laws regarding the dispensing of substances for mere recreational purposes. I am in favor of the use of medicinal marijuana, provided the drug is dispensed in a medically controlled and regulated environment or facility. However, recreational marijuana is just the tip of the proverbial iceberg.

Two years ago, I campaigned to become Middlesex County sheriff where I gained an even better understanding of what drug abuse can do to not only its victims but to their family members, as well as the communities they live in. During my campaign, I released "The Pisar Plan," my own five-point strategy to combat the deadly drug abuse problem in Middlesex County, which has some of the highest drug deaths in the state. Law enforcement officers, recovery specialists, medical professionals, and educators are fighting abuse and addiction each and every day and we need to support them. Not make it more difficult.

While I am pleased our local elected officials now want to take up the issue of stopping recreational marijuana facilities in South Amboy before they become legal, the council and mayor need to focus on addressing and stopping opioid/heroin abuse, overdoses and deaths within the city, which should have been a top priority in the first place.

I am a candidate for South Amboy mayor and if elected, I will be sure to work hard to end the drug crisis by applying relevant components of "The Pisar Plan" to my overall drug abuse mitigation plan to help stem the tide of drug addiction, overdose, and death. Doing whatever we can to keep recreational marijuana facilities from opening right in here in the city is paramount. However, we must not ignore the prescription opioid and heroin problems that we are presently faced with in South Amboy and finish what hasn't even really started.

PERTH AMBOY – There was a lengthy discussion regarding R-291-6/18 regarding a property located at 319, 320 & 322 McGuire Place. There was question as to whether it was in need of redevelopment.

Code Enforcement Director Jamie Rios explained that this was presented to the Planning Board (If this property is in need of rehabilitation). "There was no mention of what they want to do with the property."

City Engineer Jeffrey Rauch then spoke, "There have been no proposals yet for this property. A study has to be done first. They (the property owners) had talked about a possibility of townhouses. They had to go to the Planning Board, then the Council, and then to the Redevelopment Agency."

Councilman Fernando Gonzalez spoke up next, "We should all look at this property. I don't remember this resolution being passed."

Rios replied, "It's in a Hard 25 Zone. It's an odd shaped lot."

Council President Bill Petrick stated, "There are a couple of easements."

Councilman Gonzalez then replied, "I don't know why the owners had to go to Zoning instead of straight to Redevelopment"

Another property that was discussed was R-279-6/18: 613

Penn Street. – Directing the Tax Collector to place a lien in the amount of \$800.88 for charges incurred by the Department of Public Works.

DPW Director Frank Hoffman came up and explained that a bunch of people use this property as a dumping ground. "And we had to fence the property in. Since doing this, the dumping has calmed down."

Jamie Rios then commented, "This property was purchased by private developers. They will be demolishing the building in a few weeks."

The next discussion was related to R-285-6/18 – Accepting proposal of and awarding a contract to Center State Engineering for professional engineering services related to a housing study for the Department of Human Services in an amount not to exceed \$35,000."

Tashi Vazquez from the Department of Human Services came up to talk about R-285, "This is part of the Capital Budget for \$67,000. This study will focus on the City's demographics and housing stock (how much housing is available). We submitted RFP's that we reviewed. Center State came back with half of the amount that we requested. The Master Plan hasn't been done in 15 years. The Rutgers Study (Bloustein School) was 5 years old and

doesn't address housing or fair share. We have to look at the rehabs in the entire City."

Vazquez also explained when asked by the Council if this had to go out for bid. She explained that this is professional services and not a bid. "We had to use a scoring system for these professional services. There were 3 engineering firms who we considered. CMS, Center State, and Clark. We had to base what was needed for the study and who had experience in urban communities. Myself, Jamie Rios, and Adam Cruz made up the committee (to see who would give the best services for the amount of money)."

Council President Bill Petrick then asked Vazquez if they can see the paperwork of all 3 proposals

Vazquez said she could have the information sent to the Council electronically by the next day.

Councilman Fernando Gonzalez then complimented Vazquez on basing the (committee's) decision not just on the lowest proposal.

CFO Jill Goldy then spoke up and told the Council that professional services are not bid, and they are not just based on price. "They have to meet certain criterio"

### Questions Arise on Proposed New Pay Stations 6/25/18 Caucus

PERTH AMBOY – Councilman Fernando Irizarry stated that he heard that some of these pay stations are not working in some of the in some of the cities that have them and they are being phased out. Those cities are trying to sell them to other cities

Bryan Walensky from the Parking Utility came up and stated, "I was not aware that these pay stations are being replaced by other cities. It may be that refurbished ones are being sold."

Councilman Fernando Gonzalez said, "I would like to see a demonstration of the one we are supposed to be getting."

Walensky replied, "New Brunswick has the same ones that we are getting. Our machines are brand new and will ask for your plate number. The pay stations also take dollars, quarters, and credit cards. They are solar powered, backed up by a battery, and backed up by the Cloud."

Law Director King said, "We can go to New Brunswick and see their meters. We'll just have to call them ahead of time and let them know we're coming."

During the public portion, Resident Jeremy Baratta had a question regarding R-285 (The Housing Study). He wanted to know if the data collected would be sold. He also had a question in regard to R-299 (Related to the Painting of the Backwash Tank at the Runyan Water Treatment Plant and the Albert Street Standpipe in an amount not to exceed \$71,780.00

Baratta wanted to know, "What are we getting for that price?"

Petrick responded, "It's a big tank."

Baratta then made a statement regarding Communication No. 7 – The Mayor appointing Jill A. Goldy CFO/Comptroller to serve as the Interim Acting Business Administrator and Communication No. 8 Jill A. Goldy Acting B.A. advising that Mayor Wilda Diaz will assume the duties of the appointing authority where personnel action to be taken on behalf of the City pursuant to NJ Civil Service Act and NJ Department of Personnel Regulations.

Baratta explained that he didn't see anything about a resignation about the former B.A. (Cruz).

Council President Petrick responded, "There's no correspondence for the reason (why the former B.A. is no longer here)."

Baratta then questioned, "How can resignation be handled?"

Petrick replied, "A letter can be sent to the Council President. It wasn't presented to the Council. You should go ask the Administration."

Baratta then continued, "I heard there was a resignation in the court system. You (the Council) would know only if you would get a letter."

Alan Silber came up to speak next, "How many pay stations? And how many parking meters are in the City?"

Walensky came forward, "There's 13 pay stations and over 700 parking meters."

Silber then asked the Council, "Was there a letter sent about the former B.A. leaving and will he get paid?"

Law Director Peter King responded, "He (Former B.A. Cruz) will get paid for 3 months. He had a contract. The contract supersedes ordinance."

Silber then continued, "There was a question about another former B.A. leaving. People act like a crime was committed and we are paying him (Cruz) for sitting at home."

Resident David Caba came up to speak next. He mentioned that one of the Councilmen made remarks that a resident will come up here and speak, but doesn't stay for the whole Meeting to hear the Council Comments. "I'm not obligated

to stay here for the whole Meeting. How many times did Pabon come to Meetings before he got elected? Why should I stay here and listen to lies? Maybe people don't come here because they weren't informed. We get attacked when we come here." He then questioned, "Did the former B.A. (Cruz) resign or quit? I bet Pabon didn't attend any meetings before he got elected. A leader takes a stand. We are lacking leadership in this City."

Resident Sharon Hubberman came up to speak, "I had watched the last Council Meeting (June 13, 2018) on TV. I have talked about overcrowding and illegal housing. It was indicated that we have to attract a different kind of people. It's disingenuous to rezone the entire downtown. How will this help the businesses if one developer is more prominent? You represent the people. We don't discount the minority for the majority." Hubberman then asked, Will there be parking meters on Amboy Avenue?" She then indicated that the businesses there said that the 3 hour parking limit there is just fine.

Another Resident came up to speak about the proposed changes in the downtown area. "Look at the Master Plan. Anyone with half a brain will know that more units will impact schools. Vote "No" on the changes."

### Lopez, Benson and Egan Jones Bill Establishing NJT Office of Real Estate Economic Development Advances Out of Assembly

Press Release 6/21/18

TRENTON – Legislation sponsored by Assembly Members Yvonne Lopez, Daniel Benson and Patricia Egan Jones requiring the New Jersey Transit Corporation (NJT) to establish an office of real estate economic development and transit-oriented development advanced Thursday by the General Assembly by a vote of 74-2-0.

"NJ Transit is the second largest landholder in the state, and there has never been a listing of all their properties," said Lopez (D-Middlesex). "This will help us moving forward in determining how to allocate funding to ensure that there are no wasted dollars."

Under the bill (A-3654), the Office would assess and develop recommendations for economic development and transit-oriented development opportunities for parcels of real estate property in which NJT holds a property interest in order to increase their non-fare revenue sources.

"Exploring ways to increase NJ Transit revenue without hiking fares on riders is absolutely critical to reforming the agency," said Benson (D-Mercer/ Middlesex). "Increased revenue for NJ Transit means better, safer and more efficient service for all New Jersey Transit customers."

NJT would have to report annually to the governor and legislature on an inventory of each parcel of real estate property in which the NJT holds a property interest, as well as any revenue NJT receives from that property interest

"This will add transparency to NJ Transit and allow us to greater understand what funding is necessary," said Egan Jones (D-Camden/Gloucester). "This will help both us in the legislature, as well as those in NJ Transit, serve our residents better.

The Assembly Appropriations Committee was approved the measure during an afternoon session. The bill was approved by the Assembly Transportation and Independent Authorities Committee on May 10 and the Assembly Appropriations Committee on June 4. It will now go to the Senate awaiting further action.

# Not Letting It Go: Former B.A.'s Unexpected Departure Still Takes Centerstage

CFO/Comptroller Jill Goldy who was sitting up-front with the Council responded to some of the remarks made by the speakers. She stated that when she was informed by the Mayor that the Business Administrator resigned, the Mayor asked her to be the Interim B.A. "The Mayor can make a temporary appointment. I would not vacate my CFO position and I asked if (Former B.A.) Fehrenbach could partner with me because of a conflict of duty (my position as a CFO) and also as a Business Administrator. Because of my 19 years of experience with the City as a CFO/ Comptroller and Fehrenbach's 45 years of experience, we can address the Council, Mayor, Administrators, and Director's needs. I felt it was important for the Council to approve my temporary appointment and also for Greg's appointment. Greg would be putting in anywhere between 15 - 20 hours per week. I felt I needed to be compensated for additional responsibilities (day to day). Fehrenbach can assist with finding a new Business Administrator. He will look at the bill list that I may have to sign off on. Fehrenbach said it may take 3-6 months to get a new B.A. We have to put arrangements in place to post an advertisement for a B.A. My additional salary of \$36,000 would be divided into 24 months."

Councilman Fernando Irizarry questioned, "Will we have to reappoint you after 90 days if no B.A. is found?"

Law Director Peter King responded, "Yes."

Goldy then stated, "I will not apply for the Business Administrator Job."

When the public was allowed to speak again, Alan Silber stated, "You don't have the option of ignoring a statute. You should just appoint Jill Goldy as Business Administrator and put in a request for a Chief Financial Officer."

When it came to vote on the Resolutions, Councilman Fernando Irizarry made a motion to approve R-251 thru R-281, and R-283 thru R-284, R-286 thru R-290, R-292 thru R-294, R-296, R-298 thru R-299, R-302 thru R-303.

For R-291, Councilman Fernando Gonzalez wanted to table, "I read the report and went to look at the place for a closer look at it. The only person who voted "No" to table was Council President Bill Petrick.

R-282 was voided; R-285 – Jill Goldy said the Administration asked that this be pulled. – Accepting the proposal and awarding a contract to Center State Engineering for professional Engineering Services related to the Housing Study for the Department of Human Services in an amount not to exceed \$35,000.

R-295 was voided. Goldy said the Administration also asked that R-297-6/18 Accepting the bid and awarding a contract to IPS for parking pay stations in an amount not to exceed \$208,500.

R-300-6/18 was voided. R-301-6/18 was pulled for a separate vote - Authorizing a contract with Test Products International Inc. for the purchase of single gas (CO Monitors PGM-100 in an amount not to exceed \$20,000. Councilman Irizarry asked that this be pulled for a separate vote. This was moved by Councilman Irizarry and seconded by Councilman Helmin Caba. When it was voted on individually, all said "Yes" except for Councilman Irizarry who voted, "No."

Now, the Council had to vote for the last two Late-Starter Resolutions which require a unanimous Council approval for consideration. R-304-6/18 Consenting to the appointment of Jill A. Goldy, CFO of the City of Perth Amboy to serve as Temporary Acting Business Administrator for an additional annual salary of \$36,000. The Council was polled: Helmin Caba "Yes"; Fernando Gonzalez, "No" – Resolution did not pass.

R-305-6/18 – Approving and accepting the proposal from Government Management Advisors, LLC and authorizing a contract with said for Interim City Administrator Services at an hourly rate of \$135 an hour. It was moved by Councilman Helmin Caba and seconded by Councilman Fernando Irizarry. All Voted "Yes."

After these two Late-Starters were voted on, Councilman Helmin Caba asked, "Who will be the Interim B.A.?"

At that point, Jill Goldy started to pick up her books and notes which she had on the table in front of her and left the Council Chambers. She stated she was leaving the Meeting because her Interim Appointment had to be unanimous. She said she agreed to this position only if it was approved that way.

Resident Jeremy Baratta came up to speak at the last public portion. In apparent reference to Jill Goldy's leaving the Council Chambers, Baratta stated, "Did a City Director just go home because she didn't get a raise? We go through Business Administrators and Attorneys like who know what. This is the level of professionalism we have?"

Councilman Fernando Irizarry answered, "You don't know her and you should not speculate."

Baratta answered back, "You should not defend this (her actions)."

Resident Alan Silber came up next. "This (2 Late-Starters) should never have been on the agenda. The State and City Statutes say the same thing. When Perlee (Former B.A. under the Vas Administration) left, he was replaced by Dianne Roman. Vas helped her. The Law Director ignored the City Code. Goldy knew there was a problem. The Business Administrator doesn't need to be certified. There has to be a separation of money. She (Goldy) told you so."

David Caba came up to speak, "We don't get proper information. I know there's more to this and there is an investigation going on. The truth is going to come out and this is an insult to the taxpayers. You are on taxpayer's terms. How long was the person in their position who got a \$12,000 raise? How many Police Officers or Department of Public Works Employees got a \$12,000 raise (in a short period of time)? The City Council should be aware of any pending investigations. People watch the news and many taxpayers will be informed. This will be in Spanish and English. I've been a taxpayer for over 30 years."

Law Director King responded, "I've asked people who come here to give me facts. Any agencies will send out subpoenas requesting documents if they are doing investigations."

Jill Goldy came back into the Council Chambers to let the Council know that she put in a phone call to Greg Fehrenbach in regards to the vote on the two Late-Starter Resolutions. Goldy then informed the Council that Fehrenbach said the proposal was to work with herself (Goldy) and he withdrew his proposal (after she was voted down).

Council Comments followed: Helmin Caba wished everyone a Happy Fourth of July.

Councilman Fernando Gonzalez said he wanted to set up a Zoning Board Meeting that was cancelled. "I believe there is a conflict of interest with the CFO and the B.A. You can't have the same person who controls the money sign off on it. We keep breaking our ordinances. We need to know the facts. The community trusts us, but we don't have the facts. To spend \$50,000 of taxpayer's money without knowing what's going on is a waste of money."

Councilman Fernando Irizarry spoke next. "When did you discover it was a conflict? It was my understanding that the Business Administrator resigned. I need clarification. A person resigning is different from removal. It looks like he's getting paid no matter what. Can the CFO and B.A. be the same person? I want to thank Miss Goldy and her resolution as to what can be done. She has integrity and honesty and answers my questions thoroughly and she has no malice against the City." He then wished everyone a happy Fourth of July.

Council President Bill Petrick stated, "Comcast is failing the City with poor sound quality. I want to thank Goldy for her time as CFO and B.A. (referring to B.A. Cruz's sudden departure). He wished everyone a happy Fourth of July.

Councilman Fernando Gonzalez had one last remark, "We need to bring people here to answer questions or have Mr. King investigate more."

Councilman Joel Pabon was absent due to an emergency.





PERTH AMBOY - Finally, the day arrived and the official plaque honoring Thomas Mundy Peterson was unveiled at a ceremony that took place at Historical St. Peter's Episcopal Church in Perth Amboy. The importance of having this event at St. Peter's Church is because Thomas Mundy Peterson was a parishioner there, and that is his final resting place along with other Perth Amboy notables.

The church was filled not only with residents from Perth Amboy, but from other towns and out of staters. Anna Wilkins Daily who is a member of the Perth Amboy Historic Preservation Commission and was the driving force for the Thomas Mundy Peterson Project introduced the speakers. She spearheaded the committee to make this day possible.

The plaque will eventually be hung in the Perth Amboy City Council Chambers.

The Historic Preservation Committee had a discussion on how to honor Thomas Mundy Peterson. Several ideas came to the table including a statue

of Thomas Mundy Peterson to be put on the site of where his house used to stand. Also discussed was a plaque to be hung in the City Hall Council Chambers so that future generations would know the importance of Thomas Mundy Peterson's historic vote. The then Chair of the Perth Amboy Historic Preservation Commission, Reinaldo Aviles went to Buckeye Partners and asked them to fund the cost of the plaque. Buckeye agreed. The Commission composed the writing on the plaque which was verified by local historians. HPC Commissioner Anna Daily was like a gnat to the City Council who pushed the plaque through. Anna Daily made it her mission to make sure this happened. It finally came to fruition on Friday, June 29, 2018.

Daily enlisted the help of Perth Amboy Resident Dorothy Carty-Daniel who is the one who was instrumental in renaming the Elementary School on State Street the Thomas Mundy Peterson School. Peterson worked as a Custodian a that school Daniel was persistent in bringing Thomas Mundy Peterson's Medal (awarded to him by the Citizens of Perth Amboy when it was authenticated he was the first Black voter under the 15<sup>th</sup> Amendment) temporarily back home last year. She personally contacted Xavier University who owns the medal to agree to her request.

her request.

Besides Anna Daily, others who spoke included: Mayor Wilda Diaz, Tahesha Way (New Jersey Secretary of State), Perth Amboy City Historian Anton Massopust, Historians John Dyke and Gordon Bond, Carole Dortch -Wright (Executive Board Member of PRAHD), Congressman Pallone and a Representative for Senator Cory Booker (The First African-American Senator from New Jersey).

When Mayor Diaz made her remarks, she thanked Buckeye, the City Council, the HPC, especially Anna Daily and Melvinia Knight. "Peterson was ahead of his time," Diaz stated. She mentioned how many of the people of Perth Amboy respected and embraced him at that time. "I'm

proud of the work done here. This is just the beginning of us honoring him and we hope to build a monument."

NJ Secretary of State Tahesha Way thanked Anna Daily and the City of Perth Amboy for inviting her to this momentous occasion. "Peterson became active in his community and we embrace all Americans. The right to vote is maximized and protected. In 1965, the Voting Rights Act was passed and in 2013 it was struck down. Voter discrimination exists. This plaque is to strive for a more perfect union. Individual voices do matter. Governor Murphy sends his regards."

When City Historian Anton Massopust came up to speak, he said, "St. Peter's is the oldest Religious Congregation in New Jersey. The day that Peterson cast his vote, he was taking care of horses. James Lawrence Kearny happened to see him and told him today he could exercise his right to vote. Thomas Mundy Peterson then went home for lunch, and met Marcus Spring who told him he could go vote."

custom of the Blackfeet Tribe (American Plains Indians) having sage in their moccasins when going on a new adventure (for luck). "Peterson did not have sage in his moccasins. He did not have even have moccasins on. He had the courage of the Kearny family, the wisdom of Marcus Spring and the grace of St. Peters Church. The result was the first Black man to vote in the United States of America (under the 15<sup>th</sup> Amendment) right here in Perth Amboy, New Jersey."

Historian John K. Dyke remarked that it was great to be back in St. Peters. He encouraged visitors to take time to walk around the graveyard and see the names on the gravestones. "Many are unmarked graves of slaves and indentured servants who came before Peterson. I really like Thomas Mundy Peterson. He was a tempest. He didn't want the medal awarded to him until he was sure he was the first Black man to vote under the 15th Amendment. He voted





for a revised charter in Perth Amboy and he knew about the history of both Perth Amboy and the State of New Jersey. Perth Amboy was given a royal charter by Governor Robert Hunter in 1718. This means the Mayor's Office, City Clerk Office, Business Administrator, and other City offices are 300 years old. As Thomas Mundy Peterson would say, "Happy 300th Anniversary Perth Amboy."

When Historian Gordon Bond came forth, he stated that Perth Amboy held the first election after the 15th Amendment was passed. "Peterson was awarded the medal on May 30, 1884 (on Decoration Day) from the citizens of Perth Amboy. Peterson embraced the democratic process (in spite of how he and those who were like him were treated.) I am working with the library to restore a damaged photo of Thomas Mundy Peterson. I am also working on a new book about Thomas Mundy Peterson. I'm glad to see all of you here on this occasion."

Carole Dortch-Wright came forward to represent PRAHD and the Community. She thanked Anna Daily and said, "God bless you for all of your work." She also acknowledged the Local, State, County and Federal representatives that were present and the clergy. "I'm honored to represent my community and this bond that strengthens us. We need this kind of acknowledgement. You being here steers up the courage of others. The community builds and maintains the social support and common unity. We all need help in fulfilling our vision in different ways. It can be through the government, church, and different organizations.

When Anna Daily spoke, she first recognized Mel Knight for going to meetings to speak about Thomas Mundy Peterson. She acknowledged the City Council, "Because you heard us, but we're not finished. We need a statue and an archeological dig, and the community was behind us. I want to thank our Secretary of State for coming and I also want to recognize Kim Nesbitt Good who brought people by bus from Elizabeth." She also acknowledged Pastor Amos Dickerson Jr. and members from St. James AME Zion Church, the Perth Amboy Library Staff "For putting up with me." She acknowledged the Perth Amboy Historic Preservation Committee, the Program Committee Members and the NAACP. "I don't think Mayor Diaz knew what she was in store for, when she honored me with the Thomas Mundy Peterson Inspirational Award."

Congressman Frank Pallone spoke next, "Peterson represents that we always have to be vigilant about voting rights. I'm glad to see everyone here to pass this on for future generations."

The plaque was unveiled and Daily called Thomas Mundy Peterson's descendants to come up for a photo-op. She then continued to call the clergy, and she specifically asked for former Assemblyman John Wisniewski who sponsored a bill pertaining to Thomas Mundy Peterson.

Anna Daily concluded, "I want to thank God. I had surgery and I'm walking better today than I have in the last few months."

Following the conclusion of the unveiling, a wreath was carried outside by the clergy which was laid at the St. Peter's Church gravesite of Peterson and his wife, Daphne. Refreshments followed.

# This Week in World War II 75 Years Ago

"Operation Husky" — the Allied invasion of Sicily — begins on July 9, 1943, with the U.S. 82nd and the British 1st Airborne Divisions making the first landings on the island, at night. However, due to navigational errors, hundreds of U.S. paratroopers are dropped into the sea and drown, while many others dropped over land are widely scattered and miss their assigned targets. The island is defended by 230,000 Italian and 40,000 German troops. In Russia, the Soviets say that the German attack at Kursk has been held and claim that they have destroyed 2,000 German tanks in four days (a major exaggeration).

On July 10, "Operation Husky" is fully underway, with 12 divisions (160,000 men and 600 tanks) of the British Eighth Army (under Gen. Sir Bernard Montgomery) and the U.S. Seventh Army (led by Lt. Gen. George S. Patton) being brought ashore by 3,000 landing craft (200 of which sink in rough seas) on the southeast coast of Sicily. The Italians are caught by surprise, not expecting an attack during stormy weather. Landings are assisted by a new amphibious truck — the DUKW (widely known as the "Amphibious Duck"). The British, approaching the Sicilian port of Siracusa (Syracuse), meet with little German resistance. U.S. forces, however, are held back by strong counterattacks by the German Hermann Göring and the Italian Livorno divisions.

The attacking German forces at Kursk, Russia, are depleted by heavy losses in men and armor and have nearly spent their momentum, even though the 4th Panzer Army and Army Detachment Kempf, in the southern sector, succeed in capturing the pivotal town of Prokhorovka. To prevent further attrition, especially of the vital armored forces, Field Marshals von Kluge and von Manstein on July 11 urge Hitler to call off the operation, but *der Führer* refuses. In Sicily, a thrust by the German Hermann Göring Panzer Division almost reaches U.S. forces on the coast near the landing sites of Gela and Licata. The German attack is turned back by U.S. paratroopers.

What historians call "the largest tank battle in history" takes place on July 12 near Prokhorovka, Russia. The Red Army's Central, Bryansk and West Fronts begin a massive counteroffensive around Orel, Bryansk and Kursk. (The Soviets call Army Groups, consisting of several armies, "Fronts"). As many as 615 Soviet and 430 German tanks are involved. At Krasnogorsk, a Moscow suburb, a group of captured German officers — including Field Marshal Friedrich Paulus — and exiled German communists form a "National Committee for a Free Germany" that calls for overthrowing Hitler and ceasing hostilities against the Soviet Union.

The Japanese on July 13 sink the destroyer *USS Gwin* and damage three U.S. Navy cruisers at the Battle of Kolombangara, an island in the Kula Gulf, off New Georgia in the Solomons. In Russia, no further German gains are made despite a maximum effort to break through the Soviet defenses at Kursk.

In Krasnodar, in southwestern Russia, the first war-crimes trial of the global conflict begins on July 14. Evidence is presented against 11 German defendants accused of the mass murder of Soviet civilians. The trial is witnessed by Allied journalists, who file the first reports detailing Nazi atrocities to the West. (Eight of the Germans will be sentenced to death and shot.) In Sicily, two groups of soldiers of the U.S. 180th Infantry Regiment perpetrate the Biscari Airfield Massacre near the village of San Pietro. In two separate incidents, 73 unarmed Italian and German prisoners of war are summarily executed by the GIs involved. In the Caribbean, Free French administrators take over the former Vichy French governments on the islands of Guadeloupe, Martinique, Saint-Martin and Saint Barthélemy.

On July 15, Brig. Gen. Renzo Chierici, chief of police in the Italian-occupied sector of France, agrees to Nazi demands to turn over all German Jews who had fled over the border of German-occupied France into his area of control.






