Loose Ends Come Back to Haunt2/11/19 Caucus

PERTH AMBOY – One of the topics of discussion was a Capital Budget Proposal. Former B.A. Greg Fehrenbach spoke first. "There were no proposed expenditures with the water and wastewater utilities. There are no new projects. They are finishing up old projects. The Council will receive an introduced budget to be adopted in late April or May and a bond ordinance then would be introduced."

Fire Chief Ed Mullen came up to discuss a few of the items in the Fire Department Capital Budget Proposal. He stated, "There would be \$150,000 for a traffic/light and gate control for the new school (by the Public Safety Complex). This would be \$500,000 cost to the City. We will also be recycling equipment that can be put in other vehicles in the department."

Acting Police Chief Roman

McKeon came up to talk about the proposals for the Police Department. "We need to get a new fingerprinting/scanning system. The one that we have now is 15 years old. We also need a new thermal plastic lining machine to paint the yellow curb lines and crosswalk lines. The new one that we're looking to get is more efficient and it has a smaller tank. It will work much better in our parking lots."

Deputy Police Chief Larry Cattano then came up to speak, "The old one that we have now has a large propane tank and it's good to use on larger streets and big parking lots that have longer parking lines."

McKeon then continued to speak, "We also need to purchase a wide format printer for the street signs. This new printer will use the same materials as the old one. We also need a vehicle loader and equipment to tow our own cars. We will be training someone inhouse to do this."

The next topic was the Handicapped Parking Committee. Council President Bill Petrick wanted it to go back to the old way.

City Clerk Victoria Kupsch said, "Only two people who were on the Committee wanted to return."

Chief McKeon spoke up, "There's only one officer on the Committee."

Petrick then requested that any renewals should be going back to the way in the past.

Kupsch responded, "A lot of the new requests have been addressed. Now, we only have 31 new requests."

Petrick suggested that the Committee should only deal with new requests coming in.

Kupsch agreed and said, "The Committee does not want to go

over any medical records."

Petrick concluded, "The Committee should not review medical records and with any new applicants coming in, a doctor's note should be sufficient. Renewals will be done through the Clerk's Office and not the

Handicapped Parking Committee."

There was a resolution: R-75-2/19 Accepting the proposal of and awarding a contract to

And In This Corner...Not So Fast! 2/13/19 Council Meeting

PERTH AMBOY - During the first public portion to address agenda items, Resident Ken Balut came up to address item R-75 - Auditing the YMCA. Balut read a letter pertaining tothe YMCA's contract under Mayor Joe Vas's administration. It stated in 2007, there was a 20-year contract and in 2013, the Board of Education gave the YMCA \$300,000 for service es. "Tax dollars are being given to the Y. The Charter School gave money to the Y. Services were to be bidded out. Did we get the Jefferson Street Parking Lot yet?"

He then turned his attention to R-86 – Granting a Waiver of Residency to Solenny Pena as Municipal Court Administrator. Balut asked, "If we're not appointing a Deputy (Court Clerk), so it means we didn't need one before?"

He next addressed R-92 – Authorizing a contract with Jasinski, P.C. as investigator in a personnel matter in an amount not to exceed \$9,500. "You need to have a second group to investigate employees."

He next talked about Communication No. 21. Concerning a Neville Street Resident who complained about loud music and other disturbing activities. "This person is afraid, and that is why they don't want to be identified. "We had a study that said we needed more parks. Fix illegal housing first."

Former Councilman Fernando Gonzalez came up next, "Before I left the Council, I asked for a monthly revenue that the courts received, but there were no comparisons of the revenue (from year to year). I'm pleased to see that you're not appointing a public defender. You can't have a public defender who is not bilingual, especially in Spanish. They should live in town or have an office in town. You should eliminate a judge and not public defenders. I see that the courts got \$160,000 in revenue last year."

Resident and Businessman David Caba came up next. He turned around and pointed to the large crowd and said, "It should be like this every time. Are we getting a new Police Chief?" Council President William Petrick responded, "It's up to the Mayor."

Caba continued stating, "We had a special meeting to interview a candidate for the Business Administrator position, but the public was left out. Will the Mayor pick whomever she wants (as Police Chief)? I see a late (resolution starter) appointing Larry Cattano."

Petrick responded to Caba's last statement, "This was not acted on at Monday's Caucus Meeting, but it was discussed in Monday's (2/11/19) closed session. This is just a recommendation. If the Council wants this resolution (Late Starter – Resolution R-95-2/19 – Recommending Lawrence J. Cattano be appointed as Chief of Police for the City of Perth Amboy).

Resident Robert Mesi came up to speak. He mentioned Larry Cattano's father, and what a great guy he was. "I recommend Cattano for Chief."

The new CEO of PRAHD Kim V. Ruiz came up to speak and said, "I support Chief McKeon who is the Acting Police Chief

to become Chief. He has been very supportive (of our organization) and he has been very hands-on. We had security concerns for our students, especially the after-care program, and he helped us out a great deal."

Resident Gregory Pabon came up to speak. He stated, "As a citizen, I can campaign for whomever I want. I support McKeon. I think he will do a better job. I never use my Chaplain uniform when campaigning."


Monsignor John Gordon came up to speak, "As the Police Chaplain Coordinator, Acting Chief McKeon is very inspiring. In emergency situations, he's making an impact. I do respect our Deputy Chief (Cattano). I see the way McKeon works with the rank and file and I support him."

Rev. Michael Leach came up to support McKeon for Police Chief. "I also respect Deputy Chief Cattano. On any given day, we have children and seniors (that attend activities). Chief Roman has always shown his concerns for us. We've had shootings and threats. Bullets go through our buildings. We had a level of insecurity. Now, we have a bridge and a relationship with the Police and the community and feel more secure."

Former Police Officer Jay Martinez came up to speak to talk about R-95. He talked about the leadership that Roman McKeon showed when they were both a part of the Swat Team. "McKeon was a Lieutenant at the time. You have to set and be an example. McKeon put aside his personal needs and was in the forefront. His agenda was: "Do and know your job!" Part of this approach is in his DNA. He put his needs aside. We have a cultural diversity and a melting pot here. McKeon takes community policing seriously. He takes the bull by the horns and wholeheartedly believes in serving the community. He drilled this into all of his officers."

Dorothy Carty-Daniel questioned if R-95 (late starter), "Is

the firm of Magone and Company, P.C. for audit services regarding the agreement City of Perth Amboy/Raritan Bay Area YMCA operating a facility at the Public Safety Complex in an amount not to exceed \$25,000.

Law Director Peter King explained, "This is to do a forensic audit of the last 10 years to try to get back money from the Y.

Councilman Joel Pabon then stated, "\$25,000 is a lot. I hope we get something out of this."

King then explained, "This is to go through all of their (the Y's) documents."

Fire Chief Mullen came forward to talk about R-76-2/19 -Authorizing the proper City Officials to submit an application to FEMA for the Port Security Grant Program 2019 to be used for the replacement of Marine 5.

"The new boat will be at zero cost to the City. To maintain the boat will be between \$10,000-\$12,000. The existing boat is falling apart, and we will be trading it in."

Greg Fehrenbach gave an explanation of R-79-2/19 -Accepting the Safe & Secure Communities Program Grant in the amount of \$60,000 administered by the division of Criminal Justice, Department of Law and Public Safety. "This would be to offset wages and salaries of Police Officers."

CFO Jill Goldy then added that the money is going to surplus.

Business Administrator Frederick Carr talked about R-80-2/19 – A local Arts Program Grant from Middlesex County Office of Arts and History for the 2019 Arts Program in the amount of \$2,800. "This is the CDBG grant for an oral history program."

He also explained R-81-2/19 – A Grant to provide services and innovative approaches for atrisk youth in Middlesex County in the amount of \$56,580. "This is also a CDBG grant."

On Resolution R-83-2/19 - Accepting a grant from the MCO of Arts and History through the Perth Amboy Office of Economic and Community Development/Historic Preservation Commission in the amount of \$4,500.

Carr explained that this is for oral history.

Council President Bill Petrick disagreed. At the time, no one was present to speak about this.

Deputy Police Chief Larry Cattano spoke about R-89. A contract to NAPA Autoparts for the purchase of a tire-changer in accordance with Sourcewell, a national co-op in an amount not to exceed the sum of \$13,599.99. "This equipment can change up to 22-inch tires. The old one we have now is not able to."

Fehrenbach gave an explanation on R-94 – An emergency contract with A & D Industrial Pump Repair Companies for Emergency Repairs to the Ranney Well 4 MGD Pump at the Runyon Water Treatment Plant

in an amount not to exceed \$26,629.00. "The pump had given way and it was better to replace to it."

When it came to the public portion, Resident Ken Balut spoke first, "It was about time that they did the audit of the Y. They owe us over \$2 million. The Charter School is paying them to use the facilities." He also suggested that parties involved should have a practice run to make sure all the equipment installed runs properly before the school opens up. He then talked about the different lawsuits involved with the City and what is the City's liability. "Our liability is \$250,000 on lawsuits. It used to be \$100,000. Did you know we were changing our liabilities?"

Law Director King explained, "That number is actually down because the figure was based on old cases."

Balut then asked, "Can we get a list of those cases?'

Balut then talked about handicapped parking spaces. He stated there is handicapped parking on his street that are not in compliance. "What are we hiring the private investigator for regarding sexual harassment? You should hire investigators to investigate lawyers."

Businesswoman Sharon Hubberman came up to speak next, "Last Tuesday (2/5/19) there was a strong smell of gas on Amboy Avenue. The Fire Department response was wonderful, and we need to support them more. The KinderMorgan pipeline exposes us to too many chemicals. There are issues with the sewer system. Our EMT's are exposed to these chemicals. People are knocking on doors in Ward 6 District 5 and telling people it's mandatory to install solar panels. These people do not have permits." Hubberman then asked, "Can the Council implement an environmental committee? We have been having terrible smells lately."

City Clerk Kupsch responded to one of Hubberman's concerns. "Solicitors have to come to our office and have to be approved by the Police Department."

Resident Renee Skelton came up to speak. She remarked about the grant given the His-(R-83). "This is for a research project." She stated it will help establish boundaries for potential historic properties. She then stated why she came to speak before the Council. "The private buses that were parked on Sayre Avenue have been gone since July 2018. The Zoning Board never voted on this matter. The Zoning Board just told their representatives (for the owner of those buses) to come back to secure the buses and not make them an eyesore. The bus company did this on their own (move the buses) but I see they are back on the Zoning Board Agenda. No one in the neighborhood knew this. This will affect our property values. The Zoning Board should have postponed this meeting. It's too late to cancel the Zoning Board Meeting. Is there some way to pass an ordinance so people know that if a matter is not resolved, it has to be carried over to the next Zoning Board Meet-

Law Director King responded, "The Zoning Board should have requested to carry this matter over."

Fehrenbach then added, "There could be a challenge to the Zoning Board."

Law Director King then told Skelton, "You can address this matter when they (the Zoning Board) ask for comments from the public." King then told the Council, "You have control over the Zoning Board to make suggestions."

Resident and Businessman David Caba came forward to speak. He stated, "I have been in Perth Amboy for 36 years. Based on the last time I was here, it was said there was zero Chaplains as of now. It's nothing against the Chaplains, but what are they being used for? Is it for the good of the City, or for political purposes? We went from 2 to 90. I know one who has integrity and doesn't attend Council Meetings. God cannot be used as a toy, and we need answers."

Acting Police Chief McKeon came up to answer Caba's concerns, "Between 28-30 of the Police Chaplains were reinstated. We need a letter from their church, and they have to have a brick and mortar building. Sgt. Zaleski is in charge of the Chaplains. They are called when there is a death notificatoric Preservation Commission tion or a hostile situation. They

have an office in our building. I remember how they counseled the firemen when the Fire Chief passed away. They don't cost the City any money. They have helped us when we needed someone to cook and when we have tours for children."

Council President Bill Petrick said, "I remembered seeing some of the out-of-town Chaplains passing out campaign lit-

eratures in the City when they were in their uniforms."

McKeon said, "I know that this happened, and it was stopped."

Councilman Joel Pabon said, "I know Chaplains are present 24 hours/7days a week and we commend those who are active."

McKeon then explained, "They (Chaplains who are out-of-towners and in uniform working on campaigns) are no longer working in Perth Amboy."

Resident Vince Mackiel came up to speak, "In November and December, there were three accidents involving City garbage trucks. You need at least two people working on them. Was the vehicle put out of service? You need appropriate staff." He then talked about the new fire equipment that will have the foam. "Buckeye is donating \$100,000 towards it. Did the City every consider having a Wind Service come in? I'm

always walking Convery Blvd and the Waterfront and I always see excavating signs on those streets. When are you going to talk about the future of our City? There are four spills on the agenda tonight. Cleanups and remediations are always going on. Stop greenlighting these projects. Look at Denmark and see what they are doing."

Council President Bill Petrick responded to Mackiel's comments about Wind Services, "The State did not allow some of these projects."

Mackiel concluded with, "We need to move away from fossil fuels."

Councilman Fernando Irizarry was not present due to illness.

this a common practice (of an appointment such as this)? Because I never heard of this being done before (the Council being involved in recommending an appointment of police chief)."

Council President Petrick answered, "We were never involved before."

Daniel continued stating, "We are a Faulkner B City. The Chief of Police or Fire Chief is appointed by the Mayor. If you vote "Yes," what happens? I've been involved with the Police Department since Yuro was the Chief. I worked with the DVRT (Domestic Violence Response Team). You (the Council) don't have the ability to do anything after your recommendation. Where is it going? You can't enact it. At the end of the day, it's the Mayor's decision."

Resident Kareem Mann said, "My family has owned a business for over 50 years. We've made a full circle. The Mayor has done a good job, and all I want is for all of us to come together. The Chiefs have done a good job, too."

Businessman Adele Tawfik said, "Someone already holds the Chief position. Why are people from other cities here (at the Council Meeting)?"

There were six more communications that were added on 2/13/19's Meeting Agenda - all from either retired chiefs from Perth Amboy or current chiefs from other municipalities supporting Deputy Chief Cattano for the Police Chief position.

Tawfik then said, "The Acting Chief (McKeon) is doing a great job."

A young woman came up to speak, "The Acting Chief (McKeon) has inspired me. He is caring and loving. Why remove someone who is doing a great job? What are you basing your recommendation on? I believe in the Chief (McKeon) and the Mayor."

Councilman Helmin Caba responded "The Council is not pushing for this (Resolution)."

Council President Petrick also responded, "We have an Acting Chief who is holding the title of Captain. Only one person has held the title of Police Chief in the last few years."

Law Director Peter King added some comments, "He (Ben-

jamin Ruiz) is terminated, but he is fighting that decision and a Judge will render a decision in 40 days."

Petrick commented again, "There's a conclusion drawn by some of us that this would be a late-starter. There are three Council Members present to vote to see if it will be put on as a late-starter. We conduct business in the open to hear what the community has to say. We generally have the same people (residents) who come to the meetings."

Councilman Joel Pabon spoke next and said, "I personally didn't think the late-starter R-95 should be here on the agenda. All three (Ruiz, Cattano, McKeon) have all been responsive when I called them. Whoever the Mayor puts in that position, we will have to work with him."

Councilman Caba said he agreed with Pabon. "We don't have a say in the choice."

When City Clerk Victoria Kupsch took a vote of the three Council Members that were present regarding putting late-starter R-95-2/19 on the agenda, no-one seconded the motion. "Since we have no second, R-95-2/19 dies."

During the last public portion, Ken Balut came up to speak. He talked about the Chaplain (Rev. Michael Leach). "She spoke about crime, but it's not reported. The Chaplains know, but the public didn't. The City should report about OD's and maybe they can be reduced. Our last B.A. (Cruz) recommended having a Deputy Court Clerk." Balut then read Cruz's comments about being invited to a special church service in Newark celebrating Senator Corey Booker's decision to run for President in 2020. He then had a complaint about the salary of \$143,000 for a Recreation Supervisor. "The Chief of Police didn't stand up to defend the Police and their low pay. Certain people are being taken care of, but you are not taking care of the salary of the Police. Crime is not being publicized. Investigate what's going on in the courts."

Law Director Peter King responded to Balut's last statement, "We investigated why the Court Administrator left. It was for personal reasons because they had to care for a sick relative. It was stated in a letter."

Former B.A. Greg Fehrnebach

said, "The court said they need a Deputy Court Clerk. Through attrition, this position will not be filled because of budget concerns."

Businessman David Caba said, "I asked questions about the Chaplains, and we're all here to work together. "I've been here since 1991. I've fought for the community this long. I am not here because I'm against the Chaplains, but what is the purpose of having so many? The Acting Chief said it's not political, one of the Chaplains was a treasurer of a political campaign. There was a Chaplain that came to support a candidate for position of Police Chief but stayed away from politics. Stop using God as a toy! The person who is a Chaplain and was a treasurer (for a political campaign) has never shaken my hand."

Businessman Adele Tawfik came up again and asked if Benny Ruiz (the Last Chief of Police) has been terminated.

Law Director King responded, "He has been terminated, but he is fighting it on appeal. The termination is based on certain actions. I and his (Ruiz's) representative have presented evidence as to why he should or should not been terminated."

Resident and former member of the Zoning Board Roisin Dowling stated that she had talked to the Council at a previous meeting about a person who is on the Zoning Board who resigned in 2018. "In January of this year, the Zoning Board put that person in a position." She mentioned his questionable background. "Why was that person put back on the Zoning Board?"

Bill Petrick responded, "That person resigned from the Board."

Dowling was puzzled to why this person was allowed to come back and put in a position on the Zoning Board, "What are you guys afraid of?"

Councilman Caba then spoke, "The Zoning Board votes for their own chairs and secretary. We have no say on who they appoint."

Petrick then commented again, "We're going to ask the lawyer. Have you gone to the Zoning Board and asked them these questions about the individual who resigned?"

Law Director King respond-

ed, "The Council appoints the members to that Board, and the members vote for their officers and secretary."

Fehrenbach added additional comments, "The appointment (of the secretary for the Zoning Board) is not consistent with the City's Ordinance, but the Zoning Board Attorney disagrees. Actions are being taken."

Resident Gregory Pabon came up to speak. He stated, "I'm not here to argue. As a private citizen, I can support and campaign for whomever I want. The man who spoke can shake my hand. The people (Chaplains) who were at a political campaign headquarters in Chaplain uniforms were not from Perth Amboy. I will not speak about this again. I'm leaving it in God's hands. I will pray for all, including him. I will humble myself and go and shake his hand."

Resident Dorothy Carty-Daniel said, "I don't come up here to criticize you (the Council) or beat you up, but I think the Council is its own worst enemy. This is a wonderful town, but it's a secret. The first Mayor I remember was Flynn. At that time, each Council Member had a specific job. Each Council Member should have a report on what's happening in town. Promote yourself more. You need to let every citizen know you are doing something worthwhile."

Two young women from the We Love You Foundation (part of the UN Initiative) came up to speak, "We are asking if we can help you in any way. Some of the activities that we have done in other towns have been donating books, street cleanups, walkathons for Haiti, and blood drives."

Former Councilman Fernando Gonzalez came up to speak regarding the Y, "We have given them \$24,000 each month since 2008. Maybe it was a contract with the prior Mayor. I compliment the Council for taking this action (to have the Y's books audited). Woodbridge Township took over their Y and made it a community center. With the profits they made from that, they were able to buy a private club."

Resident Vince Mackiel came up next, "Last year I asked the Council about what's happening with the Transit Bridge between Elm and Market Streets. I wrote to Transit about this problem. A lot of people in town don't have cars and walk."

Fehrenbach responded, "When we first notified NJ Transit, they said it's the County's problem. The County said it's NJ Transit's problem because of the steel erosion."

Mackiel continued, "I talked to DPW Director Frank Hoffman who told me that the County can do it. The Community can benefit from the trains."

Fehrenbach stated, "The steel structure had to be fixed first before the County can pour the cement. Transit will deal with it with the upcoming construction period."

During the Council Comments, Helmin Caba thanked everyone for coming. "Those who can't come can call us or contact other City Departments. We don't have the resources to be able to be in contact with everyone."

Councilman Joel Pabon spoke next, "In the past three weeks, the Mayor, Councilwoman Tejeda, myself, and Department of Recreation Supervisor Kenny Ortiz have met with the Board of Education. We need to have a dry run at the New Seaman Street School (to make sure the traffic signals, gates, and anything connected to the traffic in that area) is cleared up before the school opens. The Board of Education pulled up a map that showed how the traffic flow will be. We should be able to do that. There's a possibility of opening up Elizabeth, Cortlandt, and First Street to improve Traffic. We need to sit down and talk about this. They are talking about building another school which will be in a congested zone."

Council President Bill Petrick said, "There has been a discussion on multimedia outlets about why the Council can't get a boat ramp. This would be an Administrative decision."

For the consent agenda R-64-2/19 thru R-69-2/19 and R-73-2/19-R-94-2/19 was moved by Councilman Joel Pabon and seconded by Councilman Helmin Caba. R-70-2/19 thru R-72-2/19 were pulled per request by B.A. Frederick Carr. They all were regarding contracts with public defenders.

Councilman Fernando Irizarry and Councilwoman Milady Tejeda were absent.



Tips to Protect Yourself From Tax Scams

Too many people downplay the threat of identity theft because it hasn't been witnessed or experienced firsthand. This false sense of security can leave you exposed, especially during tax season. Here are some tips to keep your identity safe from scammers:

- 1. Be naturally suspicious. Understand that there are people out there trying to get your information, and others willing to pay for it. With that knowledge, be suspicious of anyone asking for personal information especially your Social Security number (SSN). Even when a known vendor asks for your SSN, ask what they will be using it for and refuse most requests unless you deem it necessary.
- **2. File your tax return as soon as possible.** A popular tax scam is to file a fake tax return and deposit the refund into the thief's account, all before you get the chance to file your own return. You close the door on scammers once your tax return is filed with the IRS.
- **3. Shred (don't just crumple) your documents.** Get in the habit of shredding all paperwork before it's thrown out to keep personal information from falling into the wrong hands. If you don't own a shredder, contact your bank or other local community services as they often offer free shredding services on specific days.
- **4. Keep your Social Security card safe.** Only carry your Social Security card with you when it's needed for a specific purpose. Your wallet or purse is not a good permanent spot for your card. Any criminal would have a treasure trove of personal data if it were to get lost or stolen along with your driver's license and credit cards.
- **5. Periodically check your credit reports.** The three major collection agencies (Experian, Equifax and TransUnion) are legally required to provide you with a free credit report each year. Take advantage of this service and review the reports. Correct any errors and use this report to monitor your accounts for any potential identity theft.

Be smart when handling your personal information. Don't get caught off guard by identity theft, especially by being careless. If you think you are a victim of a tax scam, alert the IRS right away and go to identitytheft.gov for more information.



This Week in World War II 75 Years Ago

The Royal Navy light cruiser *HMS Penelope* is torpedoed and sunk off Anzio, Italy, with the loss of 415 crew members on February 18, 1944. It earns the dubious distinction of being the last British cruiser to be lost in the war. The Germans conduct their heaviest night raid on London since 1941 as the *Luftwaffe* intensifies "the Little Blitz." The American raid on the Japanese base at Truk Lagoon is completed. Over the two days of the raid, the Japanese lose two cruisers, four destroyers, several other warships, 140,000 tons of cargo shipping and over 250 airplanes. In Italy, a third attack in as many days by Indian troops fails to dislodge the Germans from Monte Cassino. New Zealanders manage to force their way across the Rapido River near the town of Cassino, but ultimately are pushed back.

The Allies begin the "Big Week" bombing campaign against German industrial cities on February 19. First target: Leipzig, on which 2,300 tons of bombs are dropped. Danish saboteurs attack rail lines round Aarhus, Denmark. Unable to withstand sustained Allied air attacks and heavy ground artillery fire, the Germans halt their Anzio counterattack and withdraw.

On February 20, the ferry boat *SF Hydro* — carrying "heavy water" for nuclear-weapons research from Telemark, Norway, to Germany for safekeeping — sinks on Lake Tinn, the largest lake in Norway and one of the deepest in Europe — up to 1,500 feet deep. The vessel had been sabotaged by the Norwegian Resistance. The British Admiralty announces that the Royal Navy had engaged in an 11-day battle with U-boats in the Strait of Gibraltar, during which three ships have been sunk and several damaged.

On February 21, organized Japanese resistance ends on Eni-

In Europe, on February 22, planes of the U.S. Eighth Air Force, flying in dense clouds and freezing conditions, bomb the Dutch cities of Enschede, Arnhem and Nijmegen by mistake. More than 800 civilians are killed. In the Mariana Islands, Japanese bombers and torpedo planes attack the ships of U.S. Task Force 58, led by Adm. Raymond Spruance. In Moscow, Joseph Stalin announces that three quarters of Soviet territory has been liberated and that the Red Army has advanced over 1,000 miles in some places.

U.S. Navy planes on February 23 attack the Japanese-held islands of Saipan, Guam and Tinian in the Mariana Islands. In Asia, "Merrill's Marauders" (U.S. Army 5307th Composite Unit [Provisional]) begin U.S. Lt. Gen. Joseph "Vinegar Joe" Stilwell's Sino-American advance into northern Burma. In the Marshall Islands, American forces complete the occupation of Eniwetok Atoll. U.S. losses are 339 killed, 750 wounded. The Japanese garrison has been wiped out. Of 3,400 troops on the island, only 66 prisoners are taken. In Italy, Maj. Gen. Lucian Truscott replaces Maj. Gen. John Lucas as commander of the U.S. Fifth Army's VI Corps at Anzio.

On February 24, the U.S. government announces that, so far, American casualties total 19,499 killed, 45,545 wounded, 26,339 missing and 26,754 captured.
