# It Got Ugly 9/25/19 Council Meeting

PERTH AMBOY – During the public comments on agenda items, resident Stanley Sierakowski questioned R-417-9/19 – A contract with Norris, McLaughlin, and Marcus, LLP for continued legal services in the matter of Perth Amboy vs. Catel Inc. in the amount not to exceed \$100,000.

He asked, "What is the issue?" Law Director King responded, "It's a continuation of the library litigation."

Sierakowski suggested, "Before doing a contract, there should be a binding contract negotiation."

The next speaker to come up was lawyer Billy Delgado, whose position as chief prosecutor was defunded. He first told the Council that 5 minutes was not enough time for him to speak.

Councilman Helmin Caba responded, "You were invited to our closed session meeting."

Delgado spoke up, "I was not informed about that." He then went on to explain how he was appointed as chief prosecutor. "I was appointed on July 17, 2017. We had one prosecutor for 5 court sessions. I said I would take the position only if I had a team. With this position being defunded, a lot of cases will be dismissed because of not having enough prosecutors. We also have bilingual personnel, and our revenue on Thursdays was \$8,500. You (the Council) don't understand what goes on in court when you are not there. The assignment judge runs the court. One prosecutor can't cov-

Council President William Petrick then asked Delgado if he could come back at the next Caucus Meeting and do a presentation.

Businesswoman and resident Sharon Hubberman came up to speak next to discuss R-415 and R-416 which dealt with placing a lien on properties for charges incurred by the Department of Public Works. She found these liens to be very interesting. "Can these liens be done on any property owing \$10 or more?" She also stated, "It says that there will be any default on any payments as of November 11th, but a property owner has until that day to make a payment. It's illegal to put them on a tax sale list prior to that date. Suppose a property owner dies before then? I believe it's illegal. I have serious issues and late notices should be sent prior to putting properties on a tax sale list."

Law Director Peter King responded, "These two resolutions are for Code Enforcement cleanups of the properties and not water bills."

Business Administrator Carr further explained, "It's state statute, and it's the law. The list you are talking about are accelerated tax sales. These resolutions are abandoned property tax sales."

Councilman Joel Pabon then spoke up, "We had a person who came to a meeting who owed millions on their property."

Carr explained, "This property (Anchor Marine) went into foreclosure. The Armory Restaurant has a lien."

Resident Alan Silber came up next. He still had concerns about R-418 where there was a change to the name of Peter King's law firm. Silber insisted, "This is a completely different law firm. Was there an RFP submitted?"

King responded, "There was a new RFP submitted under a new name."

Silber also asked, "Why was Billy Delgado allowed to speak on something not on the agenda?"

King responded, "He was asked to come here to speak to-night."

Council President Petrick confirmed that the Council had invited Delgado.

Silber then questioned, "Then why didn't you allow him to speak?"

King spoke up to clarify the prosecutor's position, "The prosecutor comes under the Law Director. I'm getting something together to present to the Council numberwise. There used to be two prosecutors. One resigned, then we decided to go back to two prosecutors."

Nancy Diaz came up to speak next. She said, "I am an activist and I live in Sayreville. This is not a good time for Latinos when we are demeaned every day. It's not good when other Latinos support a man who likes or makes misogynist posts and support white supremacy and demeans countries that have large Latino populations.

It's disgraceful of anybody who supports such vile posts."

Councilman Helmin Caba spoke up, "I never said those things. In 2016, those things (social media posts) were used for political gains. Petrick had posts from all political parties and views: Democrat and Republican. These posts were held for two years and Petrick was even elected Council President, so let's knock this off. Mayor Diaz is just using this to divide the community. In 2012, the Mayor accused Delgado of supporting someone who made misogynist comments. What is bad is the Mayor proposing a 5% tax increase."

Resident Stanley Sierakowski came up and asked about the Anchor Marine property. "Who are the owners and the principles? \$2.3 million over 20 years

has not been collected. It didn't go into foreclosure until 25 years. The assessment should have gone up on that property. Kushner did get the additional acres."

Carr responded, "I resent that you said I had no integrity. This happened 35 years ago."

Councilman Fernando Irizarry addressed Sierakowski, "You said you've done so much research on this property and all that time you couldn't find out who the owners were?"

Resident Debbie Foley came up next. She stated, "This is totally disgusting. I'm white, but I feel like I've been discriminated against. All I hear is Latino, Latino, Latino, Latino. This is a bunch of crap. We need to become a community again. All you do is call each other names and we are the laughingstock of the state. We

need a 3% tax increase because of our sewer systems. We are not fixing the problem. We lost a prosecutor and Code Enforcement Officer whom we need. Forget this Facebook crap! Look at all the crime we have."

Another resident whose first name is Elizabeth came up to speak, "I am just as disgusted as the last speaker. We are supposed to teach our children to give back to the community. Mr. Petrick has a vendetta against these four women. You can't run a business without raising taxes. Put those people back in those positions and defund Mr. Petrick. The internet is forever. You want to claim me as a deduction? We will protest as long as you (Petrick) are

PERTH AMBOY – Perth Amboy Public School District leaders, students and the Perth Amboy Board of Education celebrated the Grand Opening of the Rose M. Lopez Elementary School with a ribbon cutting ceremony joined by the New Jersey School Development Authority, state and local officials and family members of Rose M. Lopez.

"The opening of the New Rose M. Lopez Elementary School will provide students of the Perth Amboy Public School District access to a state-of-the-art educational facility that will provide exemplary resources to achieve greater standards of academic excellence," said Dr. David A. # Ordinance Prohibiting Puppy Mill Dogs and Cats Sales

9/18/19 Council Meeting

By: Katherine Massopust SOUTH AMBOY –Humane Society from the United States County Leader (Union County, NJ) Volunteer Larry Cohen addressed the Council regarding Ordinance #20-2019 - Prohibiting the sale of puppy mill dogs and kittens which was introduced on first reading and advertised for second reading which is scheduled for the October 16, 2019 Meeting.

"I've been a volunteer for 3 years. I've been retired for 3 years, and I came to know the horrors of puppy mills," stated Cohen. "This ordinance is welcome. 137 Communities in New Jersey have laws prohibiting the sale of dogs and cats. 2 states have made it state law. It's going mainstream. If you go to www.puppymillspetstores.com, there's a ton of information."

Cohen continued, "There are a couple of pet store owners that bombard you with information. Their goal is to confuse or overcome you. If you run into that instance - I did want to warn you. They come on strong. It's a worthwhile cause. It's easier to come into a town when you don't have a store in town selling dogs and cats. There's plenty of ways to get a dog or cat from a shelter or a reputable breeder. A responsible breeder will never sell a dog to a pet store."

Councilman Thomas Reilly stated, "I read about plenty of horror shows."

Cohen then added, "There are some people who operate fake rescues. They take the same dogs from puppy mills and launder them."

Council President Mickey Gross stated, "I applaud what you do for our furry friends."

After Cohen spoke, the remainder of the business portion of the Meeting continued. Regarding Resolution R-153-2019 – Resolution Authorizing grant application to Middlesex County Department of Planning, Division of Solid Waste Management for Recycling Center Signage. Council President Gross stated that this is a program that South Amboy appeals for grants from Middlesex County Department of Planning. "Different municipalities apply for the grants."

Council President Gross wanted to make it clear that even South Amboy. Was moved by

though he is employed by the Middlesex County Department of Planning that he personally stays out of the loop of who gets these grants and these monies are determined by other individuals. "I am abstaining from the vote on R-153. I want that clear."

R-156 – 2019 - Resolution Appointing Camille Tooker to SARA (South Amboy Redevelopment Organization) and R-157 – 2019 – Resolution Authorizing Mayor to sign NJDEP TWA Grant Application for Lighthouse Point.

City Clerk Debra Brooks stated that R-157 was time sensitive.

Business Administrator Glenn Skarzynski explained R-157, "It's a matter of approval for 150 ft. of new piping, for explanation to go to the DEP (Department of Environmental Protection)."

Law Director Francis Womack stated, "No township money is being used. It is being paid for by the developer."

Councilwoman Zussette Dato asked, "Has the project been approved by the Planning Board?"

B.A. Skarzynski answered, "I'm not sure."

Law Director Womack then added, "If they didn't have approved, it wouldn't be time sensitive."

Councilwoman Dato then said, "If we're being told if it's time sensitive, can we vote by email? (when more information is given)?"

Skarzynski called the Planning Board Secretary to clarify the matter, but Gross then stated that he felt it was better to pull the Resolution. "There are too many questions."

Resolutions R-150 thru R-152, R-154, R-155 and R-158 were all passed unanimously. For R-153, Council President Gross abstained. The Resolution passed. R-156 and R-157 were both pulled to be put on the agenda for the October 2, 2019 Business Meeting for further discussion. Oridance #18-2019 - An Ordinance adopting the enforcement of Title 39 Entitled, "Motor Vehicles and Traffic Regulations" on the property located at 611 Bordentown Avenue in the City of

Council Vice-President Christine Noble and seconded by Councilman Brian McLaughlin. It passed unanimously.

For Ordinances #19-2019 thru #23-2019, including #20 (Puppy Mills) all passed on the First Reading unanimously.

Regarding the South Amboy ArtFest (Sunday, September 22, 2019) it was noted to thank Camille Tooker who spearheaded the event and the hard work that Joan Convery and Mary Zarrow that made the Arts Festival happen.

Council Comments: Councilwoman Dato spoke about the Scarecrow Contest. "Kids can pick-up a scarecrow to take home and decorate to be returned to the Y for hanging and voting around town on the SA Arts Facebook page."

here. You (Petrick) don't belong in our community and you never will!"

Jeanette Rios whose position as Mayor's Aide was defunded came up next. She addressed Councilman Helmin Caba and told him, "You agree with Petrick. Why defund us to move us to another position? And now it's okay to move us elsewhere? Mr. Petrick had a political position and we won't forget it. Your binder for the budget has not been picked up yet."

Councilman Caba responded, "We took into consideration the taxpayers as a whole."

Councilwoman Milady Tejeda spoke up, "If you want respect, then you have to give us respect."

Yvette Rios, whose position in Code Enforcement was defunded came up to speak, "Ms. Tejeda is correct. We have to show respect. It was Mr. Petrick who decided who was being defunded. I have the documents. There has never been a council in the state who has defunded positions. This is a first. As of September 30th, we don't have a job. You are replacing police officers – not hiring more. We're not taking care of them. We have an open position for a supervisor in Code Enforcement. I was told that a female could not fill this position. We are disappointed in you, Mr. Pabon. And Mr. Caba – you need to grow up. To Ms. Tejeda - he is using you to destroy Hispanics and women."

Councilman Fernando Irizarry translated for the next speaker, Antonio Merino who spoke only in Spanish. He resides on First Street and stated he was a bishop. "I am happy to do this meeting because the Mayor is here. I heard a decision could not be made without the leader being here. The budget will be tripled. These women solve the problems of the City. With all of your work, you don't know what they do. Consider the seniors at Olive Street. You want to divide us and diminish the Mayor's position."

Councilman Caba responded to Merino's comments, "You are mixing religion and politics. You are going to use your position as a religious leader to diminish us (the council)."

Maria Peralta who lives on State Street came up next. She spoke only in Spanish and Councilman Irizarry translated. "I am here for the three women and thought it was good for our community to raise taxes. These women supported me, and it's not good having this fighting. I work for the community. I think it's against these women. Why did you only take Lissette who has worked for the city for 28 vears? She has been working for our seniors. I witnessed her work with them, and they are not happy with Lissette leaving. You all supported the Mayor before, except for Milady who is new. I believe changing their positions is not right if they will make the same money."

28-year employee Lissette Martinez, whose position is being defunded came up to speak next. "Petrick called us useless and I wish that Milady had told Petrick to respect us." Martinez then addressed Councilman Caba and told him, "In 2016, Helmin, you came to us."

Councilman Caba responded, "I never came to you."

Martinez continued, "I supported you (Caba) because you

came to me. I had supported you all. You all use these meetings to run for 2020. I didn't say anything against you guys. I'm hurt because of what you're doing to me after I and my family supported you all. I urge you all to try to run that senior center and have to write all those grants. You know that I do my work."

Sharon Hubberman came up next, "I give you all (the council) credit for listening to all of this. America has no color. America is all of us. All we have here is vitriol. Where is the vitriol when we discuss the bad water? We are in debt. Who is in charge? The administration. It is up to her (the Mayor) to hire people. We are not seeing the money from the PILOTS. I propose that politics should not be involved in running the city. I was called a racist and a chauvinist by the Mayor at the NAC-CP Mayoral Debate (in 2016). I've been talking about the water situation since 2016 and we need to focus on the quality of

As Hubberman spoke, some of the audience members were booing her.

Noelia Colon who is presently the public information officer came up to speak, "The Council doesn't have the power to defund us. We have the qualification and credentials for our positions. Civil Service does not recognize your power. Why don't you forfeit your stipends to save money?"

Mayor Diaz came up to speak, "You accepted a 3.7% budget. You misled the facts."

Petrick responded, "5.4% was presented to us in the beginning."

Law Director Carr responded, "It went from 5.4% to 3.7%."

Mayor Diaz continued, "You voted to accept 3.7%. No assessments were done for over 300 employees. You arbitrarily decided to defund these women. Some of them were here before I became Mayor. I did not know about these meetings or conversations that took place in 2016 (about who will become Council President). The posts (Petrick's Facebook page) came to my attention in 2018. I am staying focused on building up businesses and the community."

Resident Alan Silber came up to speak. He spoke about a police officer who made \$100,000 a year. "He drove the mayor to an event in New York. Leslie Dominguez (Former P.A. Dem Chair) was a Puerto Rican woman who didn't support the Mayor. What does Lissette Martinez do for her seniors at election time? She said she didn't want to be political, but she was a challenger (during an election). Two Puerto Rican women left the city because they weren't on the mayor's team. They never went to a political function. President Lincoln was a Congressman from Illinois. He served only one term because he was against the American - Mexican War. Maybe people came here to trv to get a city job. Sharon Hubberman was bullied while she was talking."

After Silber made that comment, Hubberman shouted out, "Nobody bullies me!"

Billy Delgado came up to speak, "I was disrespected when invited to speak before the council and was not given additional time when the time was up. I haven't been to a meeting for two years. It's the same misinformation and everything falls apart. Issues are

not being faced and departments are in disarray. What do you expect if you invite people to speak and they are not given enough time? No one called the assignment judge about my position being defunded. I know because I talked to him. I came here in good faith and I fail to see leadership."

Councilman Caba responded, "This is embarrassing to the City of Perth Amboy that we are in this predicament because of the mismanagement of the administration. Can you imagine what would happen if we didn't get state funding? The school funding is \$300 million, and we pay \$25 million of it. We don't have multiple businesses. Little people can't pay high taxes and that's why we have illegal housing. We did the right thing by having a small tax increase. This has been political since 2012. Our prosecutor was a victim then. It shouldn't be about race. Morale is down in all departments and I don't want to say who they blame. We have barely 100 police officers. Is this going to continue every meeting? The 1% increase is better than the 2.5% increase and up. The important matters should be the sewers and

Councilman Irizarry spoke up, "What was gained today? People can express themselves. It didn't work if you wanted to change anyone's minds. I'm not saying you should not be angry or upset for losing jobs. It's time for us to move on and take care of serious issues. The last 9 months have been difficult for the public and those involved. The council, our employees, and the city are demoralized.



Board Vice President Tashi Vasquez asked about FIN-18) 37.) Approval to increase the cost of school lunches in accordance to Section 205 of the Healthy Hunger Free Kids Act of 2010 and as mandated by the PLE Price Adjustment Calculator. Paid lunch for preschool and elementary to be increased from \$2.70 to \$2.80 and paid lunch for Middle, High School and Adult School from \$2.95 to \$3.05. (Spanish/English) there. Every time Rose went to apply for a job, she brought a nun with her. Because of Rose's time in Lakewood, she became Bilingual Director in Lakewood, Patterson, and Elizabeth. In 1977, Rose learned there was a job in Middlesex County. She brought a Roman Catholic nun with her. Rose got the job. In 1982 she was working with Dr. Kearny. Rose came into an interview as Principal in New Jersey with a nun. She came home and said I got a job with Frank Sinatra (referring to the Former Superintendent of Schools in Perth Amboy). I thought at first (the singer). You see, Rose was a trained musician. Her school was pre-Julliard. Because of her love of music, we went to many concerts. "It's not that Frank Sinatra," she said. Rose gave her heart, body, and soul to the children of Perth Amboy. She

came to work at 7 a.m. I used to run sometimes for miles. I made friends with the owner of the Brass Rail in Matawan and the Red Paint Diner. Both got to know Rose and came to her funeral. When she spoke of the Saturday Morning Family School, she said, "It's my school.""

Lopez continued, "She played in church. A musician, she was once a music therapist in the psychiatric wing of Belview Hospital. She could not stand the sadness, so she stopped going. Rose was an excellent typist and was once secretary for Peter Jennings (Commentator for ABC News)."

Lopez, now in tears spoke of the children's book, "Something Special for Me," by Vera Williams. "The book mimics Rose's life. There was a man on the street with an accordion. Rose played the accordion. I would like to give the schools Rose's accordion, plus 25 plaques of Rose's awards. Vera lived in Washington Heights. The accordion is a delicate instrument. IN January 1998, many people didn't know Rose was sick. At her retirement dinner, she was in incredible pain. "Smile" by Charlie Chaplain was her favorite song. In January 1998, she was playing the accordion. "Joe, I can't hold it any longer," she said. She put the accordion on a stool. On the last day of her retirement, I had secretly made arrangements that the JROTC go to the Elementary School and blow their whistles just like a Captain leaving his ship. The Cadets whistled as she walked out of school, but she walked back in, "I'm not finished," she said, referring to helping out the new Principal. There are a lot of stories."

After Jose Lopez spoke, there was a plaque unveiling and the ribbon cutting. The Rose M. Lopez School has officially opened.

### Fire Chief Ed Mullen Discusses the Fire Department Needs

9/23/19 Caucus

PERTH AMBOY - Fire Chief Ed Mullen discussed with the Council a desperate need for a new firehouse, additional equipment, and additional personnel. "So far, this year between September 20, 2018 thru September 20, 2019 there have been over 2,500 incidents and 200 fire responses. There is a need to have additional personnel because each shift requires 17 people. We're down to only 15 (per shift). With the addition of the Seaman Street School, the response time to get to a fire on the other side of town has increased to 8 minutes. Response time for all fires should be under 4 minutes. That is why we need to have a second firehouse built. We have money for an architect and design work. We already looked at one location which has everything in place. Our response time to get to a fire is our number 1 priority. The Fire Prevention Program was moved to be put under the Fire Department. 500 inspections are performed annually because of having two part-time employees. We're asking to have funding for the firehouse in place for 2020. The revenue has been set in the ordinance. The State keeps a part of the money generated by the inspections. Inspections should be made for all two-story structures annually. These inspections can help reduce fire hazards. People who have violations are given a 30day abatement to correct them before fines are issued. The current fleet is basically new, except for Engine #3 which needs to be replaced. The cause of some of the larger fires are due to smoking materials or improper electric wiring. As far as commercial buildings, all appliances should have their own outlets. We are coming up to Fire Prevention Month. We go around to schools and have an open house at the Fire Station. We have two crews instead of five. During the El-Boy (corner of State Street and Dekalb Avenue) fire, we had minimum staffing and we were there for 17 hours. A South Amboy Firefighter fell through a floor and was injured."

reach programs to ask for volunteers?"

Mullen replied, "It's hard. Even Avenel and Keasbey are getting paid firefighters. Some of our volunteers left because of not passing the test. Other towns are struggling (in getting volunteers). Some volunteers left because it's difficult to balance a full-time job and go through fire training. And we have those who claim presumptuous cancer. You can get paid medical care when you state you got the cancer from fighting a fire. We have received a donation of \$195,000 from Buckeye for training firefighters and to use the foam tinder material. Mutual aid is supplied by the Kindermorgan Fire Department. The fire department is broken down into levels: The Fire Chief, Administration, Captains, Fire Officials, two part-time Fire Inspectors, and Battalion Chiefs. Each truck has the driver plus two crew members. The fire engines are the only ones who have the hoses. We have 5 fire companies. We're looking at two properties on Amboy Avenue that are possible locations for the new firehouse. I don't see any congestion problems on Convery Boulevard, even with the proposed new High School. because it is a 4-lane highway."

Business Administrator Frederick Carr spoke up, "We had a meeting with the designer and architect to look at the Convery Boulevard location. They are specialists at building firehouses and they will not have to use subcontractors. They have built over 300 firehouses. 70% of the 2019 Fire Department budget has been expended."

PERTH AMBOY - During the discussion on Ordinances First Reading, Councilman Joel Pabon had concerns about Ordinance No. 2 regarding: Parking Prohibited on Andrews Drive and Wagner Avenue. He discussed the HEAT Bar whose patrons would park on those two streets. "If we grant these residents to have prohibited parking, then I think the patrons of that bar will just go and park on other streets in the Spa Springs Section. You need more patrolling of that club. Al Cibelli's (The former establishment) never had any trouble."

Business Administrator Carr responded, "They (The HEAT Bar) had a deal with the gas station next to it to allow the patrons to park there."

Council President William Petrick then spoke up and stated, "The Andrews Street Residents are just looking for some kind of relief."

Pabon continued, "The HEAT Bar should hire a police officer. It would drastically help them."

Councilman Fernando Irizarry spoke up. He also had concerns about this ordinance. "What about other residents near bars? Do they ask for the same consideration? And what happens if the police don't respond to those resident's complaints?"

Petrick said, "If the police don't enforce the ordinance, then we will have to bring the police here for discussions."

Irizarry then went to another subject regarding the trash pick-up on Wagner Street. "We need to change the hours for the cars to be removed off of the street."

Department of Public Works Director Frank Hoffman came up to answer Irizarry's question, "We need to get to the streets early, so we don't interfere with the school buses on the road, so we start out at 5 a.m. We have to get our trucks in early for pickups, and we may have to tow cars that are in the way."

There was a question if they could have smaller trucks come in pick up the trash in the Budapest section (which has smaller streets).

Hoffman explained that the smaller trucks would have to make more trips. "We have trucks (that have extended mechanical arms)."

There was then a question regarding Resolutions 415-9/19 and 416-9/19.

R-415 – Placing liens on property for charges incurred by the Department of Public Works. B.A. explained that these prop-

erties were on the abandoned property list.

Council President William Petrick questioned, "Why do we never go after people like Anchor Marine like we do for people who own small properties?"

Regarding R-418-9/19 – Extending the contract with Peter J. King Esq., and the law firm of King, Moench, Hirniak, and Mehta, LLP formerly known as King and Petracca, LLP to perform legal services beyond the regular duties of the Director of Law in an amount not to exceed \$60,000.

Law Director King explained, "Some of the cases are active litigation involving the City and PARA acting in bad faith. Kushner was involved in that suit."

When Joel Pabon heard the name Kushner, he mentioned the lights that were out by the Landings property. "Those lights were connected to the old naval building and then all of a sudden the building was knocked down."

King went on to explain other duties were performed regarding R-418. "There was an employee who went on maternity leave and was paid for it and she never came back. We went to get the money back and she filed for bankruptcy. We are still working on that case. Another case involved the Benny Ruiz lawsuit where he claimed backpay because he was found not guilty. We won that case."

Petrick spoke up and stated, "I would like to know what Kushner will do with the old naval building property."

Pabon spoke up and stated, "I would guess that Kushner will pay less taxes now that building no longer exists."

During the public portion, resident Alan Silber came up next and asked, "Can some of the speakers can talk louder so people can hear what they are saying?" He then asked, "When we hired an assistant prosecutor, was it a new position?"

King responded, "There used to be two prosecutors and one left due to retirement but said they would return if they were paid more. An assistant prosecutor was hired by the Mayor."

Silber continued stating that a judge shut down the court and this judge was in conflict because of having many relatives employed by entities of the City. "Was it a conflict to have that judge close the court? Was it proper for the assistant prosecutor to come a Council Meeting to talk about Puerto Ri-

can women being discriminated against?"

Silber then questioned R-414 and stated, "This is a new law firm. If work was done, then it should say the exact amount and not the phrase not to exceed the amount of."

Petrick responded and said, "The Resolution did have an exact amount."

Silber then said, "It should have stated that."

Resident Vance Mackiel came up to speak next. He had a question regarding Communication No. 5 — Anchor Consultant, LLC submitted a copy of the NJDEP Waterfront Development Permit Application Package for Kinder Morgan Perth Amboy Terminal Dock B Dock House at 920 High Street.

He asked, "When the City was recovering from Superstorm Sandy, there was 1 million gallons of oil spills. Have they stabilized their properties to prevent this from happening again? The smell of stench was a result of those companies not taking care of their properties."

Council President Petrick spoke up and suggested that Mackiel write a letter to the NJDEP about this.

Mackiel responded, "It's not proper not to discuss this. Discuss this with the City Engineer. It's your responsibility. You submitted information to FEMA."

Petrick then suggested that Mackiel come to the Planning Board Meetings because the City Engineer is always there.

Mackiel then finished his statement with, "Environmental concerns are of interest to the whole state."

During the Council Comments, Councilwoman Tejeda asked if the money that came from Comcast could be used for the safety of children in Washington Park.

Petrick responded, "The money went into the general fund and we can look at using it at Washington Park."

Councilman Joel Pabon suggested that they talk to Kenny Ortiz in the Department of Recreation and Frank Hoffman in the Department of Public Works regarding this information.

Tejeda also asked if the Council can get the agenda earlier.

B.A. Carr responded, "We needed to put the firefighter's contract on the agenda and that is why it was delayed."





The Consumer Financial Protection Bureau recently reported in financial exploitation cases that older adults lost an average of \$34,200. Unfortunately, these funds are often never recovered. You can ensure this doesn't happen by learning more about scams and how to protect yourself. Here are some

- Recognize the scams. The best way to protect yourself from a scam is to understand what they look and sound like. Here are a few key elements to look for when identifying a scam: Did you know? IRS impersonation scams are the No. 1 scam targeting older adults, according to the Treasury Inspector General for Tax Administration, with more than 2.4 million Americans targeted.
  - o You are promised a great offer or benefits
  - o You are forced to make quick decisions
  - o You are pressured to provide financial and/or personal information
  - o You are threatened
- Know why you are a target. You and other older adults may be targeted because you own a home, and have retirement savings and exceptional credit - a treasure trove for con artists to pillage. Scammers take advantage of trusting older adults because they're less likely to say no and sometimes have cognitive issues that affect decision-making skills. In other cases, family members and non-related caregivers may have easier access to their funds, making them more susceptible to theft.
- · Keep your personal and financial information safe. Keep your bank information, Social Security card and other finances stored somewhere secure in your home. Think twice about what you are sharing on Facebook, and don't give out your Social Security or account numbers without vetting the person or company asking you for it. Con artists find useful information on social media sites about your family members and then pretend to be a relative who asks for money, or they could directly ask you for sensitive information over the phone or via email.
- Hang up if you feel uncomfortable. Don't worry about being impolite if someone on the phone is pressuring you into sharing sensitive information. Hang up. If the call comes from a company you trust, you can call back and ask for the department that handles your account to determine if the call is for a legitimate reason.
- Turn down unsolicited offers. If you receive a call or an in-person visit from someone you don't know selling you a product or service you didn't request, turn it down or tell them you'll decide at a later time. If the service or product interests you, conduct independent research on three suppliers. Proactively contact all three and determine the best offer. Include a trusted family member in the decision-making process. Doing this can effectively eliminate most scams.
- Use direct deposit. You can avoid having your checks stolen when you arrange for your checks to be directly deposited into your bank account. Ask your bank to show you how.
- Speak up if you think you're a scam victim. There's no need to feel embarrassed or ashamed if you think you've been scammed. Instead, let people know right away.
  - o Call your bank and/or credit card companies.
  - o Reset your account passwords.
  - o Call the police to report stolen property.
  - o Submit a consumer complaint using the FTC consumer Complaint Assistant.
  - o Report the scam by calling the United States Senate Special Committee on Aging Fraud Hotline at 1-855-303-9470.
  - o If you suspect elder abuse is also involved, contact adult protective services.

### World War II - 75 Years Ago

The Red Army on September 29, 1944, begins to move toward Yugoslavia from Romania. Farther north, the Red Army begins amphibious landings to clear German Army Group North from islands in the eastern Baltic Sea.

On September 30, the German garrison occupying the French port of Calais surrenders to besieging Canadian forces. There is rejoicing in the streets of Dover, England, at the announcement that the last of the German cross-Channel guns (at Calais), which have pounded the southeast coast of Great Britain for three years, have been silenced.

Soviet troops enter Yugoslavia on October 1. In Finland, the Finnish Army continues its assault against German troops in Tornio, on the Gulf of Bothnia. In Greece, British commandos land at Poros, about 30 miles south of Piraeus, while Greek troops land at Lesbos and Lemnos, islands in the northeastern Aegean Sea.

The Germans on October 2 finally put down the Warsaw Uprising, after 63 days. The Armia Krajowa (Polish Home Army) is forced to surrender after all its food and ammunition has run out. The Wehrmacht, recognizing the Poles' valor, agrees to treat the surviving combatants not as partisans but as regular POWs under the Geneva Convention. Some 9,000 Polish fighters have been killed in action, and 6,000 are missing. Between 150,000 and 200,000 Polish civilians have died in the fighting. The center of Warsaw is in ruins. Almost immediately, the Germans begin expelling the 500,000-700,000 civilians remaining in the city, moving them to a transit camp in Pruszków, about 12 miles southeast of Warsaw. Around a fifth of these will be sent to Nazi death camps, the rest will be transported to various destinations and released. The Red Army remains immobile on the east bank of the Vistula River, across from the Polish capital. In the Aegean Sea, the Allies land troops on the island of Crete. The Australian Army's II Corps assumes the responsibility for mopping up and securing Papua-New Guinea. This frees up the U.S. Army's XIV Corps to assist in offensives

The Allies, which have besieged Dunkirk, in northern France, since September 15, 1944, on October 3 negotiate a 60-hour truce with the Germans to allow the evacuation of 17,500 civilians, as well as Allied and German wounded. North of Aachen, Germany, elements of the U.S. First Army break through the German forces holding the Siegfried Line. In Germany, the Messerschmitt Me-262 jet fighter officially becomes operational. A total of 40 are deployed at an airbase near Osnabrück, in

The British on October 4 launch "Operation Manna," involving joint British and Greek activities in Greece in the wake of German withdrawals. The British 2nd Airborne Brigade makes a landing at Patras. Additional landings take place on Crete and other islands in the Aegean Sea. The Soviet 46th Army is within 10 miles of Belgrade, Yugoslavia. Meanwhile, the Soviet 3rd Ukrainian Front captures Pančevo, on the north bank of the Danube River, east of Belgrade. The Allies bomb Prague, Czechoslovakia, for the first time. On New Britain, in the Bismarck Archipelago of Papua-New Guinea, the Australian 5th Infantry Division arrives to relieve the U.S. Army's 40th Infantry Division, which will be transferred to the Philippines. The Australians will continue to contain Japanese troops who have been bypassed on the island and mop up pockets of resistance.

Canadian troops cross from Belgium into the Netherlands on October 5. The Red Army enters Hungary. The Soviets begin an offensive to capture Riga, Latvia. The first German Me-262 jet fighter is shot down over the Netherlands; the "kill" is shared by five Royal Canadian Air Force pilots. In Germany, the minimum draft age for military service is cut to 16. Additionally, all hospitals are placed under military control.

Soviet troops enter Czechoslovakia on October 6, 1944. The Allies conduct heavy daylight and night-time air raids over Berlin. On Bougainville, in the northern Solomon Islands, the Australian 3rd Infantry Division comes ashore, relieving the U.S. Army's 129th and 145th Infantry Regiments. The Australians will conduct offensive operations to contain or eliminate as many as they can of the 40,000 Japanese troops that have been bypassed and remain on the island. Several squadrons of the Royal New Zealand Air Force will provide air support for the Australian ground troops.

Forces of the U.S. Third Army make progress in Luxembourg and near Metz, France, on October 7. Warned of their imminent murder, Sonderkommandos — death-camp inmates forced by the Nazis to help dispose of corpses from gas chambers by burning them in crematoria — revolt at the Birkenau concentration camp (at Auschwitz), attacking SS guards with stones, axes and makeshift hand grenades. The uprising is put down by nightfall, with 451 Sonderkommandos killed, along with three SS guards. In the commotion, hundreds of other prisoners escape the camp, but all are quickly recaptured and immediately executed.

In Greece, British forces occupy Corinth and Samos on October 8. On the Western Front, the Allies face strengthening resistance from the Germans. In Cairo, Egypt, a meeting of representatives from Egypt, Iraq, Lebanon, Syria and Transjordan ends with a call for the formation of an Arab League. In the U.S., The Adventures of Ozzie & Harriet makes its debut on the CBS Radio Network. The Nelsons' sons, David and Ricky, are portrayed by professional actors, as the boys — aged 8 and 4, respectively — are considered too young to perform.

In the Soviet Union, the Fourth Moscow Conference begins on October 9, with Winston Churchill, Joseph Stalin and U.S. Ambassador to the Soviet Union Averell Harriman discussing, among other things, post-war spheres of influence in the Balkans and elsewhere in Europe. Heavy fighting occurs in the region between Aachen, Germany, and Metz, France. In the Netherlands, the Germans shut off the electric power in Amsterdam.

The Red Army on October 10 reaches the Nemen River in Prussia and continues the fighting around Riga, Latvia. The Soviets reach the Baltic Sea at Memel, Lithuania, and cut off 26 divisions of German Army Group North. Allied combined forces — primarily British and Greek – Corinth, in southern Greece. In the Pacific Theater, U.S. Navy planes from Adm. William Halsey's Fast Carrier Task Force 38 bomb Okinawa. At Auschwitz, 800 Romani (gypsy) children are murdered by the Nazis.

The Red Army captures Cluj-Napoca in Romania on October 11. The Soviet Union and Hungary begin secret negotiations for a ceasefire. In the Pacific, Peleliu, in the Palau Group of the Caroline Islands, is declared secured, although fighting against Japanese pockets of resistance continue for another month and a half.

U.S. Navy carrier aircraft begin attacking Formosa on October 12. In the seven-day bombing campaign against the island off China, 650 Japanese planes are reported destroyed. In Greece, Allied paratroopers land at Athens airfield, British troops land on Corfu and the Germans evacuate Piraeus.



Fighting is not helping the situation. Put the axes and swords away everybody and move the city forward. This is a spectacle that people in other towns enjoy watching because it doesn't happen in other towns. Do I agree with what everyone says? I do disagree about what was said about our water. There are contaminants in the water of all towns. State and Federal standards say the water can have certain contaminants."

Councilman Joel Pabon spoke up, "I'm 60 years old. My career is done and I'm moving forward. There are 476 city employees of which 334 are Latinos. The majority of people who voted in the last election put us back in here. I spoke for having money put back into the Mayor's salary. I told the Mayor I needed one person from her side and one person from the Business Administrator's side for layoff. I reached out to the prosecutor. You (the Mayor) did not defend those positions that were cut. I ask you to give

me information on what those people did. You never presented anything to me."

Mayor Diaz responded, "You voted every year for them."

Pabon spoke up and stated, "Let's look at those meeting minutes."

The Mayor answered back, "You (the Council) are always blaming someone else."

Councilwoman Tejeda spoke up, "Since I've been here, there hasn't been any cooperation. You (the Mayor) are the leader, but you are talking over everyone. You think this is the way to get people to come here. Employees got a \$20,000 raise. I really didn't like to see anyone defunded. Bring me the data about these defunded positions which was never given to me."

The Mayor shouted back, "You targeted them!"


