Unresolved Issues Continue

11/25/19 Caucus & Council Meeting

PERTH AMBOY - Code Enforcement Director Irving Lozada was present at the caucus to give a brief overview of the operations and the differences between what has occurred so far versus the same time period in 2018. "This year, we've had 396 citizens' complaints. This includes illegal housing, noise, and parking problems. The illegal housing complaints are down because of more enforcement. We are going after owners of multiple houses. There have been more significant issues regarding code compliances certificates because of more people who either bought or sold their houses."

Scott Melski who is a Sub-Code Supervisor in Code Enforcement spoike next, "There were 3,568 licenses issued for construction. These numbers are higher than last year. Many regulations were relaxed by 30% because the state no longer requires permits to be issued for certain work or improvements done to a house. For instance, in the past if you wanted to do siding, roofing, or any kind of window treatments to your house you needed to have a permit. State regulations said that permits are no longer required for those types of jobs. We are battling the state on some of those changes."

Councilman Fernando Irizarry then questioned, "If someone does a roofing job on your house, and they do a terrible job, do you have any recourse?"

Melski said, "The owner would have to take that person to court."

Councilman Helmin Caba suggested, "We should upload on the city's website what a person no longer needs a permit for."

Council President William Petrick then added, "People can go on the city's website to see if the contractor they hired is telling them the truth regarding needing a permit to do a job."

Melski said, "We have received \$1.5 million in fees for permits and the fees for 2018 were over \$600,000. This figure does not include plumbing, electric, and fire permits."

Lozada then spoke up, "People are buying and fixing more houses. There was \$1.7 mil-

lion collected in fees so far this year."

Petrick then questioned Lozada about the IPads that Code Enforcement had obtained in previous years. "They were supposed to input information into these IPads while conducting a property inspection to transmit to the office computer. This was before you became Director of Code Enforcement."

Lozada replied, "That never happened. We are requesting additional vehicles for Code Enforcement, and we will be using the money from collected fees for this purpose."

Councilman Joel Pabon talked about making sure that permits are not closed if there is a call for reinspection.

Melski said, "Fees are collected before the work is done."

Lozada then told the Council, "We need more people in Code Enforcement. We are down because one person is expecting a baby."

Melski then added, "We need at least 3 people in the office all the time."

Pabon then suggested, "We should have a team focusing on illegal housing. I think it's that serious. It affects parking and the quality of life."

Lozada responded, "We only have 5 inspectors for 5 zones in the city. Sometimes people will begin to work on a house, but that work will not be finished. They can take as long as they want due to the fact that the state relaxing some the permit laws. This make the city look bad."

Melski continued, "We can only enforce what the state guidelines tell us."

After the presentation, Councilman Irizarry had a dispute regarding the minutes from the November 13, 2019 minutes in regards to R-500-11/19 – Resolution. He stated, "At that meeting, I said we are being taken advantage of (regarding being a Code Blue city). Mr. Carr said the same and Mr. Carr also said he saw an out-of-town police car drop off someone by the 7-11 near the train station. This should have been reflected in the minutes."

There was also a brief discussion regarding Ordinance No. 2 – Rescinding Chapter 353, Rent Control, of Ordinances of

the City of Perth Amboy – first reading.

Law Director Peter King told the Council, "We need the Rent Control Board in place for this ordinance (to take place)."

Council President Petrick then asked, "Is there is a 5% cap statewide when it comes to raising rent?" Deputy Municipal Department Head Department of Human Services Office of Housing and Social Services Tashi Vasquez said she believed the state does not have a 5% increase, "They leave it up to the town to decide what they want to do."

Law Director King then replied, "The courts will decide under certain circumstances what a rent increase should be."

Director of Recreation and Humans Resources Ken Ortiz came forward and stated, "There is a renter's registration. This will show the number of people in an apartment and the rents they are being charged. This is important because it has evidence and it will benefit both the owners and the renters."

It was decided that Ordinance No. 2 to be tabled.

During the public portion, Resident Ken Balut came up to speak. He talked about 2 cases that have not been settled in court yet. "So far, the legal fees

are over \$300,000. The Mayor is filing a deposition on one of these cases. The lawyer fees are more than what the plaintiff requested. In 2016, a woman was accused of killing someone in a motor vehicle accident. Now, the Mayor is giving this woman a community service award. This woman is going on trial now for that 2016 accident. So, is the Mayor trying to influence the jury by all of sudden giving this woman an award?"

Balut then turned his attention to the YMCA, "They are not getting billed for any utility services."

Carr explained, "We don't send them bills."

Council President Bill Petrick spoke up, "When one of our former B.A.'s Greg Fehrenbach was here, he would send bills to the YMCA."

Balut then asked, "What was given by the companies who were given PILOTs? This is incompetency."

Petrick spoke up again, "Now, it's hard to separate all the utility bills."

Resident Vince Mackiel came up next, "We need to recreate the Rent Leveling Board. The rents are too high. I'll even vol-

Multiple Ordinances Introduced, One Pulled in South Amboy

11/25/19 Council Meeting

By: Joseph L. Kuchie SOUTH AMBOY - Five ordinances were introduced on first reading and one was pulled from the agenda for further review at Monday's city council meeting.

The first ordinance introduces a fee for non-residential senior citizens who participate in the activities and programs at the South Amboy Senior Center. As it was discussed at the November business meeting, the fee will be \$60 if paid on or after January 31st, or \$50 if paid on or before January 31st.

Another ordinance introduced will appropriate \$200,000 from the capital improvement fund for the demolition of an unsafe structure at 131 South Broad-

way. The building currently resides across the street from Sciortino's Harbor Lights near the train tracks.

One ordinance taken off the agenda for further discussion was Ordinance #27-2019, which would introduce a "No-Knock Registry" and would limit the posting of handbills or circulars. The ordinance would allow residents to sign up for a list that prevents people from coming up to their door to solicit items.

However, the council were concerned about certain things that would potentially be banned, including the South Amboy newsletters. The council decided to pull the ordinance until they could review what

was being banned or limited.

Law Director Francis Womack made a mention to the council that he planned to introduce a new ordinance regarding vape products within the next few meetings. He asked the council to send any notes or ask any questions they may have before they move forward.

Friends of South Amboy will be hosting a basketball event on December 21st at South Amboy High School to benefit the Leonard Family. Games will be at 2, 4, 6, and 8:00 PM.

All council members were in attendance for the meeting. The next meeting will be held on December 11th at 6:00 p.m.

unteer to be on the Board. I appreciated the comments made by Councilmen Irizarry and Pabon and their concerns for the residents. Some people affected by rents going up may be Veterans and low-income people. A C/O (Certificate of Occupancy) is always needed first. The Ordinance was created to protect the citizens (Rent Leveling Board)."

Councilman Helmin Caba responded to Balut's questioning the woman who got the Community Award who is on trial for killing a pedestrian in a motor vehicle accident in 2016. The lady who got the award does a lot for the community. She made a mistake that could have happened to any of us."

The council went into closed session at 6:56 p.m. The council came back at 7:39 p.m. to adjourn the caucus and opened the regular meeting at 7:40 p.m.

In the first public portion, resident Ken Balut came back to question the closed session Item No. 2 – Potential litigation – redevelopment – PARA.

Balut stated, "One of the PARA members, Mr. Jacobs had a conflict of interest. Jacobs had sued the developer (Kushner) and settled, so he should not have been able to talk about any case (involving the Kushner Companies). Even the PARA lawyer sued Kushner. The Mayor's daughter got a scholarship from a college that Kushner sits on the board. I heard this is done to other politicians' There are no firestops installed in the Kushner building apartments. There was one apartment that had water leaking into an apartment below it. Annie Hindenlang (Executive Director of PARA) had lived in one of Kushner's apartments."

Council President Bill Petrick then remarked, "This could be a level of corruption."

Balut then mentioned, "A member of PARA phoned into a 10 a.m. meeting when there was no pubic discussion. Former Law Director Arlene Quinones said that she was representing the Mayor at a meeting with Kushner's representatives after she had left the city."

Businessman Jeremy Baratta came up next and questioned R-518-11/19 – Authorizing professional service agreements with qualifying attorneys who submitted responses to request the qualifications for various legal services for CY 2020. He stated, "The council can reject any RFP's and they would not be on the approved list."

Petrick then questioned, "Can they be disqualified due to cause?"

Baratta then continued, "The engineering firm Centerstate was cut by the Planning Board. You have a right to reject and resubmit."

Law Director Peter King spoke up to make a clarification, "This resolution is an RFQ, which is for qualifications. You (the Council) have a right to refuse to use the services of someone on a qualified list. This is an RFQ which is a request for qualifications." King continued, "If they meet the qualifications and you reject them, they can sue."

When it came time for the consent agenda R-507 thru R-530 was moved by Councilman Fernando Irizarry and seconded by Joel Pabon. For one resolution, the council asked for a slight change to be made. For R-521-11/19 – Authorizing a temporary 2-hour suspension of parking meter fees on Smith Street from November 29, 2019 thru January 1, 2020. At the caucus meeting Joel Pabon said it should be free parking - period during this time-frame. All the council members present agreed.

During the last public portion, Ken Balut came up and was concerned about the buses that were parking illegally in the Budapest section, especially on Bruck Avenue where he lives. He also mentioned there was a flyer for a house that was for sale near him. "According to the flyer, it said that the house had 2 driveways even though it's only about 25 ft. wide. There are a lot of cars parked there. Code Enforcement needs to be there to do their job instead of always complaining about a lack of manpower. Irving (Lozada -Director of Code Enforcement) is a nice man, but he is not qualified. Send the DCA to do an investigation. The clerk who worked at the court who left had a special meeting to make her a deputy court clerk. The Mayor should be made to testify about this."

Resident Vince Mackiel came up to speak next. He asked, "What are the qualifications and duties of the Rent Leveling Board? The city has public places on Convery Boulevard to safeguard them for the city to use for renewable energy to create something for the public to use."

Businessman Jeremy Baratta came up next. He was concerned because the BID is a separate legal entity and has its own budget. Since I'm in the business district, I receive their email updates. Recently, I started getting emails connected to the BID website that are from Noelia Colon. It's connected to P.I.O.PerthAmbovNJ.org. This is containing political information related to Mayor Wilda Diaz. Why am I getting my BID emails about Wilda Diaz's accomplishments and awards she has gotten? There are emails from BID which are promoting non-BID activities. They are using BID resources to promote Diaz a year before her reelection."

Resident Alan Silber came up next and questioned why was a Code Enforcement Vehicle parked illegally in front of City Hall. He also questioned the award which was given by the Mayor to a woman who was involved in a tragic motor-vehicle accident. "This award was given to this woman 3 weeks before she the trial was to begin. Was the victim a good person and did she deserve to die? I

don't know if this was an attempt to influence the jury and the judge."

Silber then talked about a shooting that happened on Hall Avenue a few years ago when a man was killed, and the 2 police officers involved also got an award." Silber then addressed the council, "How would you feel if it had been your family member that was a victim (and the person who caused their death received an award). Council Comments:

Councilman Helmin Caba wished everyone a Happy and Blessed Thanksgiving and remembered those who were having a hard time or are lonely or dealing with stress. "I am very grateful. We're always hearing about tragic news. I hope everyone has a joyous holiday."

Councilman Fernando Irizarry wanted to thank everyone who helped out during the community dinners. He also thanked PRAHD. "They did a great job on Puerto Rico Discovery Day. The food and cultural entertainment were very good." He also thanked Code Enforcement and those who did a presentation regarding the upcoming census. He also mentioned the upcoming business parade and tree lighting (Saturday, November 30th). He then asked if someone from the court system can do a presentation. "I heard someone ask on a radio show: What are you thankful for?" I want to thank everyone here, the city employees, my fellow Council Members and the administration for trying to make the city better." He also thanked the public who watch on TV. "I wish everyone a happy and healthy Thanksgiving."

Councilman Joel Pabon had an issue with the woman who got the award shortly before she was to go on trial. "It could happen to anyone. Texting and driving is an epidemic. Pedestrians are also at fault. Many times, they have their heads down and are looking at their phone when they are crossing the street. When I saw the video (of the accident), it hit home. It's very easy to hit someone." Pabon also cautioned, "Especially nowadays you have to look after your children. You could turn around for 2 seconds and someone can take your child. You have to pay attention. People are getting very bold with child abduction and human trafficking. We need to get this on social media. Have a safe and healthy Thanksgiving."

Council President Petrick thanked everyone and wished everyone here and those watching on TV-land a Happy Thanksgiving.

Councilwoman Milady Tejeda was absent from both the caucus and council meetings.







11/21/19 Board of Education Meeting

Superintendent Dr. Vivian Rodriguez, Director of Curriculum and Instruction, Dr. Damian Medina, and Supervisor of English Language Arts Ms.
Jessica Urban recognized all the students who received a perfect score on the 2019 NJSLA (New Jersey Student Learning Assessments (replacing the PARCC)) and 2019 AP (Advanced Placement) Achievement Tests.

Dr. Rodriguez explained, "The NJSLA was given to students from grades 3-10. All students have to take the same assessment and every district receives the scores back. We are able to see our brightest stars tonight. We are here to recognize these students." Dr. Rodriguez then explained that the AP exams are college level courses taken at an advanced level in High School. Depending on your score, you can receive college credit or placement. Students that received a 5 were recognized. "Congratulations. You've done a great, great job!" stated Dr. Rodriguez.

The Board went into closed session at 6:18 p.m. and returned at 7:52 p.m.

No one spoke at the public portion on agenda items only.

Board Vice-President Tashi Vasquez wished everyone a blessed holiday season. She mentioned the Winter Wonderland which will be on Smith Street on November 30th and on the Taste of Perth Amboy which will be on December 3rd.

Superintendent Dr. David Roman said there was a problem at McGinnis School due to a water main break on Market Street. The students were given a fire lunch, which is monitored by the Police and Fire Departments and students and staff were given an early dismissal. "I would like to thank the parents and staff and to assure that the students were safe."

During the Business Portion of the Meeting, the subject of need for PreK was discussed. Board Member Junior Iglesia asked, "What is the total enrollment in the 2020 program?"

Dr. Damian Median was brought up to answer the question, "We are filled up to capacity. Currently we have 5 providers. These are preliminary numbers. As far as preschool, approximately 1100 students are currently enrolled in our buildings. We anticipate for that number to continue to grow."

Iglesia then asked, "Budget wise?"

Board Secretary Derek Jess answered: approximately \$25,800,000. Up \$2 million for this year. Based on a per pupil level for 2008-2009 school year. The Department of Education has not increased the money the district funding itself."

Board Member Igelsia later stated that he was thankful to the SDA (School Development Authority) for the construction of the new high school. "It's important to the accountability of the taxpayers to question what items is the SDA not respon-

sible for? What are these funds being utilized for?"

Board Secretary Derek Jess answered Iglesia, "The SDA accepted bids for the new high school. Bids were for terminal construction. \$240 million to be signed by the governor. If the governor does not veto it (in time), we will proceed with the construction. The SDA has money, but they are no longer purchasing land. That is why we purchased Seaman Avenue and the Delaney Homes. It's for emergencies and add an additional amount for emergencies.

Dr. Jessica Neu came up to speak about inclusiveness in sports, "The Special Olympics changed their policy on inclusive sports for students. It's the first unified track team for students with or without disabilities. There is unification of basketball and we will play other teams (with unification).

Board Member Stephanie Márquez-Villafañe spoke about the contract with the Perth Amboy Federation which is still not resolved. "If we could just get the contract closed."

It was Board Member Randy Convery's last meeting. He had declined to run for office again due to getting a job in another school district.

Board Member Lissette Lebron thanked Convery for his service, "I'm proud to have served with you."

Convery stated, "It's hard to believe how quick something happens. Every student that walks into this door. I'll definitely miss you all. Thank you all very much."

Convery was presented with a plaque for his service and dedication to the Board.

Board Member Junior Iglesia (who just won reelection) congratulated Tashi Vasquez, Dr. Danielle Brown and Maria Rodriguez for winning the election. "The voters who came out and supported me – I appreciate what you do. We are moving forward, and I thank all the organizers who endorsed me. We will continue to move the district closer to exemplary status. I will not let you down. Thank you, Perth Amboy."

Board Member Stephanie Márquez-Villafañe thanked the staff of McGinnis School, "I'm glad to see all the communications going back and forth. I want to thank them as well. I want to thank Millie and Dr. Roman for all the emails."

Board Member Stephanie Márquez-Villafañe commented that it is the last Board Meeting of this year and that the previous Board Meeting was not on PATV on demand.

Dr. David Roman remarked that there were some issues with Ch. 34 (Fios 47) and that Brian Wilson would get back to her.

During the public portion, Wilfredo Soto was the sole speaker. He congratulated the students who were recognized for their achievements. "The people of Perth Amboy spoke loudly, and every school had accomplishments. God Bless. My prayers are with you."

In Mr. Rogers' wonderful neighborhood of make-believe, Lloyd Vogel (Matthew Rhys) a cynical reporter who's going through some family problems (mainly with his father) toils with his feelings because of anger he has from his father, Jerry (Chris Cooper) who left him and his sister with a sick mother. With all his own personal problems, a very angry Lloyd is assigned to write an article for Esquire Magazine to write a small profile on Mr. Rogers. He usually writes cynical expose about people who are in the public eye, but this time things are different when he meets Mr.

Rogers.

The movie starts just like any episode of "Mr. Rogers Neighborhood" as he walks in the door and sings his signature song and puts on one of his very famous sweaters and tells us the story of Lloyd and his problems. When Lloyd meets Mister Rogers, he reveals a little bit about himself, but he also reveals to Lloyd that he doesn't have to hide his feelings and he can deal with the anger deal that he has. Lloyd's father wants to make amends with him, but he just can't let go of his personal

Tom Hanks nails it completely with his performance of Mr. Rogers. Hanks' performance is not a parody as comedians have done in the past. Hanks does an acting job showing us how Mr. Rogers truly was and how. Mr. Rogers didn't play a character - Fred Rogers was that person. We understand some of his attributes through his world-famous

puppets from the Neighborhood of Make-Believe, especially Daniel the Tiger. Mr. Rogers would address issues that children have and bring them to light.

This beautiful well-orchestrated movie is not just a biopic. It is based upon a true story on the 1998 article "Can You Say ... Hero?" by Tom Junod, published in Esquire.

Everyone in the supporting cast is terrific as well, and you understand who Mr. Rogers is. As a companion piece, I also recommend the documentary, "Won't you be my neighbor." It talks about all the things that made Mr. Rogers Neighborhood so famous, and the wonder who Fred Rogers was. This could be the Academy Award winner for best picture and Tom Hanks is sure to get an Oscar nod for best actor. Yes, go see "A Beautiful Day in the Neighborhood."

World War II - 75 Years Ago

On December 1, 1944, the U.S. Ninth Army, commanded by Brig. Gen. William Hood Simpson, captures Linnich, Germany, about 19 miles northeast of Aachen. Regular mail deliveries resume in the southern part of the Netherlands. Six communist members of the Greek Provisional Government in Athens resign.

The 11th (East Africa) Division of the British Fourteenth Army, pursuing the Japanese who are retreating from Imphal and Kohima, India, arrives at the Chindwin River, in Burma, on December 2. In France, the U.S. Seventh Army advances to the Rhine River after the Germans withdraw across it to Kehl, Germany, located directly across from Strasbourg, France. Progress halts, though, as the Germans destroy all three bridges in the vicinity.

In Athens, fighting breaks out on December 3 between the leftist National Liberation Front and government forces, which are backed by the British. An attempt by British troops and Greek police to break up a massive demonstration and to disarm the leftists results in the deaths of 28 people and the wounding of over 100 others, triggering a general strike throughout Greece. In England, with the threat of a German invasion extremely diminished, the British Home Guard — the volunteer civilian militia assigned to defend Britain against an assault — is ordered to stand down. King George VI declares: "You have fulfilled your charge."

The Greek government declares martial law in Athens on December 4 as fighting continues between communist and anti-communist forces. With food supplies becoming increasingly scarce in the northern, Nazi-occupied region of the Netherlands, German occupation authorities reduce the bread ration for civilians to two pounds per week per person.

The Allies take control of Ravenna, Italy, on December 5. The Soviets attack with two armies from northeast of Budapest, Hungary, and make a 60-mile advance in eight days. British Army tanks become involved in the fighting between communists and anti-communists in Greece. British warships shell communist positions in Piraeus.

The Japanese on December 6 capture Tushan, China, south of the Nationalist capital of Chungking. In Greece, fighting between government forces, supported by British troops, and communist rebels continues. The British commander says there is evidence that a number of former German soldiers are being employed by the communists. In the Netherlands, the Germans begin removing electric-powered trains and their associated wiring and shipping them to Germany to replace equipment destroyed in Allied bombings. In the Philippines, 400 Japanese paratroops are dropped on Leyte to coordinate with Japanese infantry attacking the Allies from the west.

In Hungary, the Red Army reaches Lake Balaton, about 80 miles southwest of Budapest, on December 7. Gen. Nicolae Rădescu, Chief of the General Staff of the Romanian Army, becomes prime minister of Romania and forms a new government with strong anti-communist leanings. U.S. forces on Leyte, the Philippines, counterattack and stop the coordinated Japanese paratroop-infantry offensive.

On December 8, a 72-day "softening up" bombardment of the island of Iwo Jima begins, conducted jointly by the U.S. Army Air Forces and the U.S. Navy, using planes, three heavy cruisers and a destroyer escort. In Europe, the Red Army begins an offensive aimed at encircling Budapest, Hungary.

The Red Army reaches the Danube north of Budapest on December 9. The U.S. 8th Air Force bombs Stuttgart, Germany, during daylight hours. In Great Britain, the government relaxes blackout regulations for private homes. The U.S. government says it will reinstate the drafting of men between the ages of 26 and 37 for military service.

The U.S. Army's 77th Infantry Division captures Ormoc, on Leyte Island, the Philippines, on December 10. In Moscow, representatives of the French and Soviet governments sign a 20-year treaty of alliance and mutual assistance. In Burma, British and Indian forces capture Indaw, 78 miles north of Mandalay, along with two Japanese airfields.

Soviet troops are within five miles of Budapest, Hungary, on December 11. Over 2,000 U.S. Army Air Force bombers from the 8th and 15th Air Forces attack various rail targets in Germany as well as an oil plant and several ammunition depots near Vienna, Austria. The Germans gas the last patients at the Hartheim Euthanasia Centre, in Alkoven, Austria, near Linz. (It is estimated that some 300,000 mentally and physically handicapped patients were gassed or otherwise murdered under the Nazis' "Aktion T4" euthanasia program to eliminate "incurables" since its beginning in May 1940.)

In Burma, a new British offensive begins on December 12 with an advance toward Aykab, near the Bay of Bengal. In Greece, the communists, having suffered recent heavy losses, ask for a cease-fire. The government demands that the rebels surrender their weapons. In eastern France, the U.S. Third Army captures a German V-rocket factory at Wittring.

On December 13, the Battle of Mindoro, in the central Philippines, begins. A kamikaze strikes the American light cruiser *USS Nashville* off Negros Island, the Philippines, killing 133 sailors and wounding 190. In Greece, the communists continue their offensive, with heavy fighting in Athens. Communist attacks are made on several British bases in and around the Greek capital, but they are beaten off.

A Japanese prison ship on December 14 is mistakenly sunk by U.S. planes off the Philippines. Less than half of the Allied POWs survive, only to be recaptured. In Washington, D.C., Congress passes, and President Franklin D. Roosevelt signs into law, an act authorizing the creation of the ranks of General of the Army and Fleet Admiral, both to be indicated by five stars. This is done so that the highest-level American officers will hold a rank equivalent to that of Field Marshal. Over the next week, George C. Marshall, Douglas MacArthur, Dwight D. Eisenhower and Henry "Hap" Arnold are promoted to the rank in the Army, while William D. Leahy, Ernest J. King and Chester Nimitz are made Fleet Admirals. (Subsequent to the war, William F. Halsey will be promoted to Fleet Admiral and Omar N. Bradley will become the last General of the Army.) In the Philippines, units of the Japanese Fourteenth Area Army perpetrate a massacre on Palawan Island. To prevent captured soldiers from being liberated by the approaching Allies, 150 POWs are herded into air-raid shelter trenches, doused with gasoline and set afire. Those who try to escape are machine-gunned, clubbed or stabbed. Eleven prisoners survive and escape to Allied lines, aided by Filipino guides and guerrillas.

Tom's Tax Tips

Reminder: Major Employment Tax Deadlines

Handling employment taxes can be complicated, especially when you're required to file important tax documents throughout the year. Here's a list of key forms and deadline dates to help keep you on track:

Form 941 - Employer's quarterly federal tax return

This form is used to report income tax withheld from employees' pay and both the employer's and employees' share of Social Security and Medicare taxes

Employers generally must deposit Form 941 payroll taxes on either a monthly or semiweekly deposit schedule. There are exceptions if you owe \$100,000 or more on any day during a deposit period, if you owe \$2,500 or less for the calendar quarter, or if your estimated annual payroll tax liability is \$1,000 or less.

- Monthly depositors are required to deposit payroll taxes accumulated within a calendar month by the 15th of the following month.
- Semiweekly depositors generally must deposit payroll taxes on Wednesdays or Fridays, depending on when wages are paid.

Return filing deadlines:

- Jan. 31, 2020 Due date for filing Form 941 for the fourth quarter of 2019. If you deposited your taxes in full and on time, you have until Feb. 10, 2020, to file this return.
- **April 30, 2020** Due date for filing Form 941 for the first quarter. If you deposited your taxes in full and on time, you have until May 11, 2020, to file this return.
- July 31, 2020 Due date for filing Form 941 for the second quarter. If you deposited your taxes in full and on time, you have until Aug. 10, 2020, to file this return.
- Nov. 1, 2020 Due date for filing Form 941 for the third quarter. If you deposited your taxes in full and on time, you have until Nov. 10 to file this return.

Form 940 - Employer's annual federal unemployment tax return (FUTA)

This return is due annually. However, FUTA tax must generally be deposited once a quarter if the accumulated tax exceeds \$500.

- Jan. 31, 2020 Due date for filing 2019 Form 940. If you deposited your taxes in full and on time, you have until Feb. 10, 2020, to file this return. This day is also the deadline for depositing federal unemployment tax for October, November and December 2019.
- **April 30, 2020** Deadline for depositing federal unemployment tax for January, February and March 2020.
- July 31, 2020 Deadline for depositing federal unemployment tax for April, May and June 2020.
- Nov. 1, 2020 Deadline for depositing federal unemployment tax for July, August and September 2020.

Form W-2 - Wage and tax statement

Employers are required to send this document to each employee and the IRS at the end of the year. It reports employee annual wages and taxes withheld from paychecks.

• Jan. 31, 2020 - Due date for employers to provide 2019 Forms W-2 to employees, and for employers to send copies of 2019 W-2s to the Social Security Administration, whether filing electronically or with paper forms.

Tax deadline extensions for disaster areas

For taxpayers living in designated disaster areas, the IRS extends certain filing and tax payment dates. Taxpayers living in the affected areas (and those whose tax professionals are located in those areas) have relief from penalties for filing under the new extended dates. These filing and payment extensions are also available to some relief workers.




