Budget, Contracts, and CDBG Among Topics Discussed

3/22/20 Caucus & Council Meeting Via Phone Conference

PERTH AMBOY – During the 3/22/20 Caucus, Councilman Joel Pabon questioned all the different union contracts, "Where are we going with these? If we (the city) go into bankruptcy, are we (the city) held accountable?"

Business Administrator Frederick Carr responded, "These contracts are in the budget. There are some minor changes. We have an obligation to pay those contracts in the budget as it was introduced 2 months ago. There are also \$460,000 of COVID-19 related expenses on the agenda. Do we not want to pay or not have people come to work? A referendum of agreement was made. I've been in contact with other CFO's in the state."

Pabon continued, "I'm asking about contracts going forward. I know we have money already allocated for the present contract. I don't want to put us in a bind going into the future."

Carr then explained, "There's money for 2020 in the budget. 2021 and 2022 are questionable. Don't vote on it if you are not comfortable. I don't have an answer right now going into the future."

Pabon was still concerned, "I've been listening to discussions with other mayors and the governor. We are not thinking ahead. We need to be prepared. We have to see how we fall into this."

Council President Bill Petrick then spoke up, "Our main concern is how much money we will have to operate with." Petrick also stated that the Teamsters Ordinance (No. 2 - First Reading – No public discussion) will be pulled.

There was a question concerning Ordinance No. 3 – No public discussion RE: An Ordinance amending an ordinance entitled: Wreckers. Law Director Peter King stated he was not at the March Meeting when that ordinance was being discussed.

Petrick stated, "I sent out a summery and CC'D you (King) and Law Director Carr on changes that the council made."

Councilman Fernando Irizarry then asked King about Resolutions R-144 – A Worker's Compensation Settlement entitled Joseph Sassine vs. City of Perth Amboy in the amount of \$35,919 and R-145 – Settlement of the Workers Compensation Litigation entitled: Angel Velez vs. the City of Perth Amboy in the amount of \$138,510.

Irizarry asked, "What depart-

ments did they work in?"

King responded "R-144 was

King responded "R-144 was in the police department (2018). The officer was injured while making an arrest. R-145 was an employee in the department of public works who was injured during snow removal (2016)."

Carr explained further, "The DPW worker was injured in 3 places."

Irizarry then questioned, "What kind of training do they have in the DPW?"

There was no response.

Carr then explained R-146 – Authorizing submission of an application to the US Department of Justice Office of Justice Programs, Bureau of Justice Assistance for the FY: 2020 Coronavirus Emergency Supplemental Funding Program. He explained, "This was a \$70,751 grant which for reimbursement for money that we spent on overtime, supplies, and managing our workforce."

Irizarry made a comment regarding R-147 - Accepting a grant for the New Jersey Department of Community Affairs for the Green Infrastructure 2020 Grant in the amount of \$250,000. He thanked Assemblywoman Yvonne Lopez for helping with this. Irizarry then added up the money from the CDBG grants which included R-148 - and R-149. R-148 - The grant monies were \$574.360 + \$360,120 + \$388,023 (the Coronavirus Funds) and R-149 – the grant monies were \$659,638 + \$420,621. (Total \$2,402,762).

Carr responded regarding R-148. "We have already received some of the funds and some were added. Regarding R-149, this is new money of \$1.1 million for year 2021. This shows the importance of the census. There is \$2.5 million allocated for HUD through the CDBG, and what is earmarked for COVID-19."

Irizarry asked, "How are we going to prepare on handling

the COVID-19? Do we have any details or an action plans?" Carr responded, "We will have

a report in May."
Assistant Housing Manager Tashi Vazquez spoke up during the video conferencing. "There will be a public meeting next week (Monday, April 27, 2020 at 2 p.m.) The topic will

2020 at 2 p.m.) The topic will be funding to help keep people employed. For those who are not able to participate, it will be online on Friday, May 1, 2020."

B.A. Frederick Carr then re-

B.A. Frederick Carr then responded to a question regarding R-152 – Authorizing a contract for emergency Wet Cleaning and Disinfection of City Hall and the Perth Amboy Municipal Court to Insurance Restoration Specialists Inc. in accordance with the New Jersey State approved co-op in an amount not to exceed \$15,600. "This cleaning has already been done."

R-154 was removed (Teamsters contract).

Irizarry had a question regarding R-156 – Authorizing Preparation and Issuance of estimated third quarter tax bills. "Is our tax rate 3%?"

Carr responded, "There is a 0.00% increase for the municipality and school. There's a 3% increase for the library and county which will be adjusted for the fourth quarter. The school, county and municipality will be factored in."

During the public portion, Resident Jeremy Baratta was the only person to speak, "Councilman Pabon was right. The budget, and regarding future payments and regarding the state - it looks like a possibility of going bankrupt. We have to make hard choices. I want to thank Bill Petrick for getting the whole agenda online." He then remarked about the two resolutions (R-144, R-145) workers compensation that Irizarry talked about, "We are overpaying on these cases and they should be taken to trial. The awards are ridiculous."

After the close of the public portion, Council President Petrick requested that the Council not make any comments at close of the caucus. Petrick



then continued, "I was asked by Bill Schultz (the Riverkeeper) to mention that today is Earth Day."

The caucus concluded at 5:15 p.m. As per council vote, the regular meeting followed two minutes after the caucus ended.

At the beginning of the regular council meeting, Stephanie Márquez-Villafañe spoke during the phone conference regarding Ordinance No.1 designating restricted parking spaces for use by a handicapped person regarding additions. "Who is making these decisions?"

Councilman Fernando Irizarry, who is on the Handicapped Parking Committee along with Márquez-Villafañe, asked the city clerk to respond.

City Clerk Victoria Kupsch stated, "This was already approved by the Handicapped Parking Committee. The March 25th and 30th meetings already had these applications on their agenda."

Council President William Petrick answered a question from Resident Jeremy Baratta regarding accepting a contract from January 1, 2018. Baratta questioned, "Can the city afford the backpayment awarded on this contract?"

Petrick answered, "The money was already allocated (for this)."

B.A. Frederick Carr added, "2018 came and went. In 2019, money was transferred to pay members under union contracts. I don't have the numbers right now."

Baratta stated, "I can't believe the council doesn't have the numbers."

Councilman Irizarry said, "The council was sent an email stating the cost."

Carr said, "The 2018 and 2019 sheets were provided to the council in March. The council already passed a memorandum of agreement for one of the union contracts. If the council chooses not to pass the resolution, we have to go back to the union, and it can lead to unfair labor practices."

Law Director King spoke up, "We can go back to the union, but I can't tell you what they will do."

CFO/Comptroller Jill Goldy joined the conversation, "Between 2018 and 2019, \$92,000 was budgeted into the 2019 contract for the OPIE Union."

Baratta then questioned, "Who is in the OPIE?"

Carr explained, "It's the blue and white collar supervisors in various departments. The overall cost it \$20,000. There's a 1% increase built in."

After the close of public comments for the ordinances, the Citizen's Campaign came up to make a presentation. Caesar Romero spoke briefly about the Citizen's Campaign and their objectives. Founder of the Citizen's Campaign Harry Pozycki came up to speak. "22% of the COVID-19 cases in the county are in Perth Amboy, yet we are

only 6% of the county." Pozycki wanted to present a resolution to the council for the Citizen's Campaign, "We'll be having a Corona Task Force implemented in Perth Amboy."

Council President Bill Petrick said, "We can't pass a resolution we don't have."

Pozycki continued, "The Citizen's has implemented a Task Force and we have talked to several agencies in the city such as the Director of Housing, the Superintendent of Schools, and the hospital regarding COVID -19 tracing. I have even spoken to Barry Rosengarten regarding donations of food supplies and also supplying masks. We already have people who are agreed to do so. When I talk to OEM (Office of Emergency Management), they said they can only supply training through Zoom (an App. for phone conferencing)."

Council President Petrick asked who will be supplying gloves (when will your taskforce goes out in the field)?"

Pozycki said, "I hadn't thought about that, but it's a good idea. We have teams going out in the field, but citizens have to be a part of it."

Petrick then questioned the high number of COVID-19 cases in Perth Amboy. "Are they all residents?"

Pozycki answered, "Perth Amboy has very dense housing."

Petrick wanted to know, "Where is the data coming from regarding the percentage of the cases in Perth Amboy?"

Pozycki said, "The figures are coming from the county, and passed down to the police department."

Councilman Joel Pabon spoke up, "It's a great idea that the Citizen's Campaign are having trackers. We have to start doing things now. We can use all the help that we can get. We are not getting the true numbers. I think the trackers being here will have a huge success. Where are most of the cases coming from in the city?"

Pozycki said, "The idea is to be ready."

Councilman Irizarry spoke up next. He thanked Pozycki and his committee. He then asked, "Will they be looking at what kind of access to healthcare the residents have when it comes to the Coronavirus? Will you be looking into this? I never thought about gloves and having a facemask. The demand is exceeding the supply and the money to get these items is high. Besides the expense and being hard to get, even when you order these supplies online, it takes time to get them."

Pozycki responded, "Individualized Shirt Company (in Perth Amboy) is making masks."

Councilwoman Milady Tejeda wanted to commend the Citizen's Campaign, "To do tracking, you need information from people who tested positive. The whole country is short on testing supplies."

Pozycki continued, "The State Health Registry gets people's names, and the community and that gets sent to the police department so that person can get isolated."

Council President Bill Petrick then asked, "Will that be a violation of HIPPA Laws?"

Pozycki responded, "We will be working under the existing (local, state, and county) laws. HIPPA will be complied with."

Councilman Helmin Caba spoke up. He also congratulated Harry Pozycki and his committee. "Caesar Romero is an upcoming star. We need to plan ahead with the pandemic and be ahead of the curve." Harry Pozycki concluded, "We are always looking for the most up to date procedures."

The next person who spoke via teleconferencing was Deputy Police Chief and OEM Coordinator Larry Cattano. He addressed Harry Pozycki. "We have an OEM plan that has been in place for 20 years and it is reviewed by the state annually. A pharmaceutical distribution plan also has been in place for years. We have the people in place. We are only one of 4 cities that get federal funding. Regarding protective equipment, people have to learn the proper use of gloves. Someone mentioned that people are not using masks in public. New Jersey does not require that. In food establishments – yes, and in other public buildings, you are required to wear them. As far as the hospitals, they have to report the cases to the state. We would get the locations and addresses sent to us. The county numbers are accurate. We have to vet all the addresses given

2020 Budget Passed

4/15/20 Council Meeting via Phone Conference

By: Katherine Massopust SOUTH AMBOY – The South Amboy Council Meeting took place via phone conference.

When it came time to discuss the 2020 budget, Councilman Brian McLaughlin wanted verification that the budget provided for a new ambulance and two firetrucks as well as city employment program. B.A. Glenn Skarzynski assured him it was in the budget. The Budget was passed.

Councilwoman Zusette Dato asked about repairing a sewer main at the South Amboy YMCA. She asked if the funds to pay for this come out of the YMCA's budget. City Engineer Mark Rasimowicz stated that he did not believe the funds will come from their budget. Council Comments:

Vice President Christine Noble stated that everyone should stay safe and be well. "These are hard times."

Councilwoman Zussette Dato stated, "During these times, we need to think of others. I thank everybody who works in emergency management. I want to give a callout to Amy McLaughlin Photography (Councilman Brian McLaughlin's wife). Her Porch Project raised a huge sum of money for Friends of South Amboy."

Councilman Tom Reilly stated, "The meeting notice was not posted on the South Amboy Facebook Page or on the sign of City Hall. We should be more transparent about meetings." Reilly then added, "Amy McLaughlin raised over \$10,000 along with her daughter. The money is going back into the community. Hat's off to Amy McLaughlin." Reilly then cited Jay Kennedy, owner of Printed Pixels in South Amboy. "Friends of South Amboy benefits from his efforts. They continue to donate to the food pantry."

Council President Mickey Gross exclaimed, "Hats off to Brian and your family!"

Councilman Brian McLaughlin thanked the Police, Fire, First Aid. "Are we going to help the squad out?" he asked.

Law Director Francis Womack stated, "There are some townships and municipalities that does this. It has to be done as a referendum. The way we are proposing this will not impede the validity of the First Aid Squad."

Mayor Fred Henry agreed that more research was necessary.

Councilman McLaughlin asked that punch cards be eliminated due to the crisis. Council President Mickey Gross agreed with him.

Councilman McLaughlin wanted to know, "People ask me why we don't have a laundrymat. We need an ordinance." McLaughlin commented he would not want it to be open 24 hours.

Mayor Fred Henry stated, "A change in the ordinance may have to go through SARA (South Amboy Redevelopment Association)."

Law Director Francis Womack stated, "Right now, it can be initiated, then go to the Planning Board with stipulations."

Council President Mickey Gross agreed that this should be discussed at the next business meeting (May 6, 2020 at 6:00 p.m.). He felt the public would like to give their input.

Mayor Fred Henry thanked the Council for passing the budget. "Continue to stay safe. Stay at home."

During the public portion, a man named Larry asked how much the taxes will be increased. It was stated that for a home with the value of \$250,000, there will be a \$46 increase for the year.

Council President Mickey Gross stated as of today (4/15/20) there are 66 cases of infections with COVID-19 in South Amboy.

Larry asked if anyone was removed from the list.

Gross emphasized to go to the CDC website for any information on COVID-19. "We are requiring everyone to follow CDC guidelines. The CDC is where the best information is."

The meeting adjourned at 7:36 p.m. All Council Members were present.

PERTH AMBOY - Due to the state of emergency declared by the Governments of the State of New Jersey and the United States regarding COVID19, the next regularly scheduled meeting for the Board of Education will be held on Thursday, May 7, 2020 at 5:30PM via remote conference in order for the Board of Education to conduct its business and to hold a public hearing on the proposed 2020-2021 budget. The meeting, including public comment will be held remotely through the use of electronic equipment. Compliance is required with P.L. 1975, c. 231, with regard to the posting and publication of meeting notices, which was amended by (A3850/S2294) and approved by the Governor on March 20, 2020, permitting that during a period declared as a state of emergency a public body shall be permitted to perform any of the following by means of communication or other electronic equipment: conduct a meeting and any public business to be conducted thereat, cause a meeting to be open to the public, vote, or receive public comment without being deemed to have violated the provision of P.L.1975, c.231 (C.10:4-6 et seq.) in performing such functions by means of communication or other electronic equipment. Members of the public who wish to provide comment at this meeting may do so through Conference Bridge, a remote conferencing system. The Conference Bridge phone number to dial into the board meeting will be listed on the District's website on Monday, May 4, 2020. Members of the public will be able to use this phone number to call into the board meeting. Upon joining the meeting, members of the public will be muted to ensure that there is no disruption to the business being conducted by the Board of Education. Individuals will be welcomed to provide comment during the public portion of the meeting. Members of the public will be recognized to speak when name or identifier is announced. Individuals will be invited to speak in the order the requests are received. The Board will hear public comment through Conference Bridge. Formal action will be taken. The Board reserves the right to retire into Closed Session, and to exclude the public from such portions of the meetings in accordance with the P.L. 1975, c.231, upon adoption of a conforming Board Resolution for Executive Session.

to us. Contact Tracing is out of hand. You have to get an antibody test. As far as HIPPA laws, there is a special state dispensation. We cannot share information. That is handled through the state department. Regarding masks, and the type of material, cloth masks have minimal face covering." Cattano indicated that cloth masks are better than nothing.

Pozycki responded to Cattano's comments. He complimented Cattano and the city. He continued, "The Citizen's Campaign is looking at different masks to make sure they get the best and the proper use of gloves. It's not a New Jersey mandate for masks, but eventually masks will be mandatory. I'm glad the council recognizes the importance to be prepared."

Council President Bill Petrick then mentioned how important it is having gloves, especially when it comes to small cuts on your hands. He then mentioned Anton Massopust (EMT, Fire, First Aid Instructor) who always emphasized this when teaching his classes, "If you think having a small cut on your hand is not important, try putting peroxide or rubbing alcohol on that small cut and see how it affects you."

Petrick suggested that the Citizen's Campaign put something together (an Ordinance or Resolution) to be presented to the public.

No one spoke at the public comments on agenda items only.

Ordinance No. 1 – Re: Renewal documentation for handicapped parking – was moved by Irizarry and seconded by Caba. Ordinance No. 2 Re: Teamsters - January 1, 2018 thru December 31, 2022 was pulled. Ordinance No. 3 – Wreckers – was removed.

The public was then invited to make comments on R-122-3/20 - Public Hearing on the introduced CY:2020 Municipal

The first person to speak on the conferencing was Resident Stephanie Márquez-Villafañe. She asked, "What kind of cuts were there?"

Council President Bill Petrick responded, "There were no cuts per say, and no tax increases."

Márquez-Villafañe was surprised and questioned the reason there was no increase.

Petrick stated, "We are using surplus money."

B.A. Frederick Carr spoke up and said, "It's the council's budget for 2020: \$4,886,000 of surplus money was used."

Márquez-Villafañe questioned, "How much money will

B.A. Carr answered, "I am not sure, but maybe between three to five million dollars."

CFO/Comptroller joined the discussion, "\$5 million will be left in the surplus."

Resident Jeremy Baratta spoke next. He questioned the \$790,000 in additional spending. "What are the three top increases?"

Goldy explained that the big-

gest increase was in salaries. She stated there was also an increase in pension contributions and the city had an offset from a \$2 million reimbursement in its insurance plan. The city also has a reduction in some of their required debt services and utility costs."

Comments were then closed on R-122.

The council proceeded to vote on the consent agenda. R-143 thru R-150 and R-152, R-153, R-155 and R-156 were moved by Councilman Fernando Irizarry and seconded by Councilman Joel Pabon. R-154 was tabled. Councilwoman Milady Tejeda asked for R-151 – (Authorizing the refund of restoration bond to United Dominicans of Perth Amboy in the amount of \$6,000 due to the cancellation of the 2020 festival.) to be pulled and voted on separately. R-151 was moved by Irizarry and seconded by Caba. When it came to vote, all voted "yes", and Councilwoman Tejeda abstained on R-151

Last Public Portion:

Resident Jeremy Baratta then again questioned since the meetings have been held remotely, "Is City Hall open, and can the public attend the meeting?

Again, the council answered in unison, "No."

Baratta again asked if there were any provisions for the homeless or others that do not have phones, computers, or other devices (to participate in the meeting). "Did the city set something up?"

Council President William Petrick responded, "I can't answer that.'

Baratta then questioned a previous speaker who talked about an upcoming meeting (regarding how to help businesses). "How was this meeting advertised? I have two businesses and I didn't get anything from the BID about available money (to help businesses)." He then said that he heard there was supposed to be funding of around \$370,000. "Can this meeting be put out by the BID?"

Petrick responded, "I believe it was advertised like other meetings."

Baratta continued, "I saw a listing of the check register. There was an item for a garage door repair and that repair is spelled incorrectly. I also saw an amount of \$12,000 for an email service. This company called AVAYA Inc. received a government contract for \$3,012.70 for support services for the Perth Amboy Parking Utility, the Library, and SIP Trunking Software. What kind of vetting did they go through? I didn't see that this company was registered as an LLC."

CFO Goldy answered that question, "This company is providing a filter for all the city's email. They are dealing with issues regarding our email spam and they do have an LLC. Not all companies are required to have a business registration number."

Resident Stephanie Márquez-Villafañe spoke next. She questioned a census contest that the mayor has on her Facebook Page where every two weeks the mayor's office is giving out \$50. "The ages to participate are 12 thru 18. During one of her Wilda Live Facebook broadcasts, there was a mention that the Law Department is looking at some of the Coronavirus cases. Why are they doing that and not the OEM? There is also a decrease of staffing at City Hall. What is the role of the Code Enforcement Director? The mayor also went to two houses to say, "Happy Birthday." How many officers went with her and how were they paid? What is the city doing for all of the immune compromised citizens?"

B.A. Carr responded, "Director of Human Resources Ken Ortiz talks about this issue (reaching out to all citizens) every day and also talks about all of the outreach programs avail-

Márquez-Villafañe continued, "I reached out to the Human Resources Office and I'm still waiting for a callback."

Council President William Petrick spoke up, "Our Human Resources Office is stretched to the max. Reach out to the owners of the supermarkets to make accommodations."

Márquez-Villafañe continued, "I did reach out to them, and they said they are following the Mayor's directions."

Petrick then suggested, "Maybe the Mayor can be made aware of this so all citizens can be accommodated. The Mayor is telling people to post comments if they completed their census forms."

B.A. Frederick Carr then responded to some of Márquez-Villafañe's questions. "Regarding the contest open to youth from ages 12-18 regarding the census. It is an opportunity to show people that they complied with the census and they encourage others to do so. The Mayor is paying the \$50 out of her own pocket and we are not violating the census rules. Code Enforcement Director Irving Lozada is changing his title. Sometimes people have to do things that are normally not in their job title. For instance, I am doing things in the mailroom because of the present circumstances. The Mayor is reaching out to our youth. People have been homebound for months."

Law Director Peter King spoke up, "I'm helping out and reviewing some of the COV-ID-19 cases."

Council Comments:

Councilman Helmin Caba thanked OEM Director and Deputy Police Chief Larry Cattano about the information he provided regarding the rules and regulations during the Coronavirus Crisis. He extended his congratulations to the entire OEM team. He then expressed thanks to Mr. Carr and Council President Petrick talking about the importance of doing the census. "So far, only 42% of the people who were sent out the information have responded. It can be done online, by phone, or mail. Please do this so we can do our proper funding. I want to thank all who work and give to the community. Kenny Ortiz is doing an excellent job. Please practice social distancing and my condolences to all who have lost a loved one."

Councilman Fernando Irizarry wanted to thank all who meet the needs of others. He mentioned those who worked for the food pantries, the Board of Education, the Jewish Renaissance, the OEM, and Kenny Oritz. "The COVID-19 cases are increasing in Perth Amboy and the curve is not flattening. Please take the restrictions seriously."

Councilman Joel Pabon also thanked OEM Director and Police Chief Larry Cattano. "He is always working behind the scenes and for also correcting me regarding wearing a mask in public. It was scary to see a negative trend of COVID-19 cases in Perth Amboy. We are right behind Woodbridge in cases which is much bigger population than we do. Kenny Oritz and his staff (some whom we never see) work long hours. Thank you a million times. I have called Kenny Ortiz a number of times for people who need help. We as a community have to come together to do our part. God bless everybody and stay safe."

Councilman Helmin Caba then spoke up again and stated, "We are now number one surpassing Woodbridge Township in COVID-19 cases (as of 4/22/20)."

OEM Director Larry Cattano also spoke up to make additional comments. He wanted to clarify how COVID-19 cases are counted. "People are being retested. The tests are counted – not the people. The Jewish Renaissance is doing 150 tests a day. People should wear masks or other face coverings, even if it is not required when walking outside. We will be getting a test center on State Street soon."

Councilwoman Milady Tejeda spoke next, "Who can go through the drive-in testing cen-

Cattano answered, "Only peo-

ple with symptoms those who are asymptomatic can be tested by appointment only."

Council President Petrick questioned, "What kind of tests are being administered?"

Cattano responded, "Oral swabs."

Councilman Irizarry asked the numbers of deaths. Cattano answered as of 4/22/20 it was 53.

Law Director King spoke up to let everyone know why he was reviewing some of the CO-VID-19 cases. "We wanted to make sure there was no spike in certain areas in the city.'

Tejeda continued speaking. She thanked Police Chief Cattano, Kenny Ortiz and his staff, and the citizens who stay home. "This is very serious. Make sure the elders are taken care of and do shopping for them. I want to commend our community leaders who look out for their friends and neighbors." She also wanted to thank one of the High School teachers who is also a businessowner who is helping the community. "Make calls to your friends to make sure they do the census and help them if they need your guidance. Call people to make sure they are okay, and let them know you care. Thanks to all who work to keep the city going."

Council President Bill Petrick thanked everyone including Chief Cattano and all the unsung heroes, the DPW workers, emergency services, Kenny Ortiz, Iriving Lozada, B.A. Carr, City Clerk Victoria Kupsch, DPW Director Frank Hoffman, and all who participated in the meeting. "Be safe and wear protective equipment."

Councilwoman Tejeda spoke up again, "I want to wish everyone a happy Laboratory Week. We are here for the community."

Petrick responded, "Lab technicians are handling dangerous samples. I hear it's also Administrative Assistants Day. Good night and everyone stay safe."

Coronavirus Powerful Community-Wide Response Plan

Press Release

NEW JERSEY - Protecting our residents for the extended length of time coronavirus (Covid-19) is predicted to be a threat to our health and giving us the opportunity to safely open up our cities for business requires a sustained and enhanced community response. This plan strengthens and adapts the existing emergency management structure already in place in cities, better equipping them for a robust long-term response to Covid-19 and proposes using the lessons learned to update and expand emergency management plans and training to be better prepared for future pandemics.

It centers around expanding, training and employing Community Emergency Response Teams (CERTs) or their equivalents that are already in place in most cities and towns to provide needed 'boots on the ground" for a more effective Covid-19 response.

The plan components outlined below will be tailored to each individual city.

Plan Components:

- Employing CERT members as contact tracers: Coordinating with local health departments charged with contact tracing, interested CERT members will be enlisted in performing this essential function. Tracking down all close contacts that were exposed to someone who tests positive for Covid-19 and ensuring that they are notified and isolated is an evidence-based public health strategy that experts, including Dr. Anthony Fauci, of the National Institute of Allergy and Infectious Diseases, and the Center for Health Security at Johns Hopkins University, consider fundamental to slowing the spread of the virus once we stop sheltering in place. There is a shortage in most communities through- out the nation--a shortage that can be alleviated by enlisting CERT members. This work is mainly done over the phone and the training is accessible remotely.
- Distributing masks to areas in need: CERT members will be used to distribute masks, prioritizing the parts of the community where the highest percentage of people have the highest exposure. Bandanas of suitable material that can be easily re-used with the city logo or a city sports team logo on it to build community spirit and solidarity will be provided.
- Food delivery for quarantined, older, and low-income residents: CERT members will assist in food delivery for quarantined, older and low-income residents, plugging in to existing community food delivery initiatives wherever possible.
- Expanding CERTs: A community-wide effort will be launched to recruit new CERT members. High school seniors will be provided the opportunity to become Jr. CERT members.
- Form a Corona Control Task Force: To ensure consistent and saturation level communication with residents and businesses, a Corona Control Task Force will be established comprised of the mayor, council president, school superintendent, hospital CEO, Director of the Housing Authority (or their designees) and the Director of the Office of Emergency Management (OEM). Leaders from the faith-based and non-profit community may also be added by the OEM. The Task Force will be responsible for ensuring that all communications concerning standardized health protocols and CERTs recruitment going out to the community are continually reinforced with sufficient repetition that they are driven home.
- Set standardized community health protocols for individuals and businesses: Coordinating with the mayor and council, emergency management officials together with the CERT team will set standard health protocols for individuals and businesses to ensure that a consistent and amply reinforced message about best practices is sent to better ensure adherence. (See below for examples of personal health care protocols).
- Establish a Coronavirus Relief Fund: In order to pay for any of the marginal costs associated with this plan, including masks, communication materials and CERTs support, cities and towns will establish a relief fund. Crowd-funding can be used to raise the necessary dollars.
- Update community emergency management plans to prepare for future pandemics: Employing the lessons learned during the coronavirus pandemic, communities will update their emergency management plans to be better prepared for future epidemics.

Examples Attachment:

- 1. To avoid getting the virus, follow these simple steps:
- -Wear a mask when going to the supermarket or on any errand outside the home
- -Practice social distancing when you leave your house -Stay home if you are feeling sick except to seek medical attention
- 2. Keeping safe at home, practice the following:
- -Clean frequently touched items and surfaces daily with soap and water
- -Cover your mouth with a tissue when coughing or sneezing and then discard the tissue
















World War II - 75 Years Ago

On May 4, 1945, German Adm. Hans-Georg von Friedeburg, commander-in-chief of the *Kriegs-marine*, arrives at British Field Marshal Bernard Montgomery's headquarters at Lüneburg Heath with German plenipotentiaries. A few hours later, Supreme Headquarters, Allied Expeditionary Forces, announces that "Field Marshal Montgomery has reported to the Supreme Allied Command that all enemy forces in Holland, northwest Germany and Denmark, have surrendered." The U.S. Seventh Army takes Innsbruck and Salzburg, in Austria, and nearby Berchtesgaden, in Germany, which is still smoking after the RAF raid of a few days earlier. In the Pacific, Japanese *kamikaze* planes hit 14 Allied ships off Okinawa, sinking four.

The Battle for Castle Itter, about 38 miles northeast of Innsbruck, Austria, takes place on May 5 The "strangest battle" of the war, as it comes to be called, is the only action where American and German soldiers fight as allies. They are aided by high-level, French political prisoners being held at the castle. The motley force — 16 American troops (tankers and infantrymen, including two officers). a Waffen-SS officer (whom the prisoners had befriended), 11 Wehrmacht POWs (an infantry officer and 10 artillerymen) and 14 prisoners — holds off an assault by two artillery-supported companies of Waffen-SS troops ordered to take the castle and kill the prisoners and any other occupants. The sevenhour battle ends with the arrival of the U.S. 142nd Infantry Regiment, with tanks in support. A number of the SS soldiers are killed, around 100 are captured and the rest are scattered into the surrounding forest. The castle's defenders suffer one dead (the Wehrmacht officer) and four wounded. Denmark is liberated by the Allies. Col.-Gen. Johannes Blaskowitz, the German commander-in-chief in Holland surrenders at a ceremony in the small Dutch town of Wageningen in the presence of Prince Bernhard of the Netherlands. The first British victory salvo of the war is fired at 3 p.m. at Field Marshal Montgomery's headquarters. Amsterdam is liberated. Gen. Eisenhower announces the capitulation of German Army Group C, which was covering the front from Linz, Austria, to the Swiss frontier. The U.S. Third Army takes Karlsbad, Germany, and Pilsen, Czechoslovakia, and prepares to drive towards Prague. In Prague, a civilian uprising begins, aided by defecting units of the German-allied, anti-Bolshevist Army of former Soviet general Andrey Vlasov. The U.S. freighter SS Black Point last Allied vessel attacked by a U-boat — is sunk within sight of land off Point Judith, Rhode Island; 12 crewmembers die, 35 others are rescued. One of some 9,000 balloon-borne bombs launched from Japan starting in November 1944 lands in Oregon and kills five children and an adult woman on a picnic near Lakeview, in the central southern part of the state. Theirs are the only known deaths from enemy attack on the mainland of the U.S. during the war.

On May 6, German *Waffen-SS* soldiers fire on a crowd celebrating the liberation of the Netherlands in Amsterdam, killing 22 people. From Berlin, Axis Sally — Mildred Gillars, an American engaged to a German citizen — delivers the last episode of her "Home Sweet Home Hour" propaganda broadcast to Allied troops.

German Chief-of-Staff of the Armed Forces High Command, Gen. Alfred Jodl, representing Reich president Grand Adm. Karl Dönitz, signs Germany's unconditional surrender to the Western Allies and the Soviet Union at 2:41 a.m. on May 7, at Gen. Eisenhower's headquarters in Reims, France. All military operations are to cease at 12:01 a.m. (GMT) on the 8th of May.

A cease-fire takes place at one minute past midnight on May 8. It is V-E Day, as the Allies celebrate Victory in Europe. After radio appeals to the Allies early in the day for protection against heavy German shelling, the Prague Resistance reaches an agreement with the Germans for the capitulation of the city. The U.S. 4th Armored Division, approaching from the west, stands fast in light of the announced cease-fire. Soviet troops, approaching from the east, continue to battle German forces in an around the Czechoslovakian capital. In North Africa, nationalists and French forces clash in Algeria. Between 15,000 and 20,000 Algerian Muslims and over 100 French citizens die in violent confrontations over the next 20 days. From Washington, D.C., President Truman warns Americans that the war is only half won.

Field Marshal Wilhelm Keitel, Chief of the Armed Forces High Command, repeats the German unconditional surrender signing on May 9, this time at Field Marshal Georgy Zhukov's Red Army headquarters in Berlin. In Moscow, Stalin announces the end of the war against Germany. A British naval squadron arrives in the harbor of Copenhagen to receive the surrender of the remains of the German fleet. Off France, in the English Channel, the German garrison in the Channel Islands agrees to surrender to British troops after five years of occupation. The surrender terms are signed aboard the destroyer *HMS Bulldog*, which is moored off St. Hellier, Jersey. In the Aegean, German forces in the Greek islands surrender. In Syria, tensions between French troops and locals explode into open fighting

The first German U-boat to surrender, *U-239*, puts in at the Royal Navy base at Isle of Portland, England, on May 10. Soviet forces are now in control of Prague after five days of fierce street battles between the Germans and Red Army troops and Czech partisans comes to an end. Over 5,000 civilians have been killed in the fighting. Seven years after he was forced to flee, Czechoslovakian President Edvard Beneš re-establishes his government in Prague, with the first order of business being the arrest, trial and execution of those convicted of collaboration with the Nazis.

On May 11, the Soviet Prague Offensive comes to an official end with the liberation of Czechoslovakia's capital city, the last major European city to be freed, although the war is already over. In Croatia, German troops continue to resist against Yugoslavian forces.

The war in New Guinea continues, with Australian troops attacking Wewak on May 12. In Czechoslovakia, Lt. Gen. Andrey Vlasov, a highly decorated Soviet commander who defected to the Nazis to form the anti-Bolshevist Russian Liberation Army, is captured by the Red Army about 25 miles southeast of Pilsen. (Vlasov will be brought to the Soviet Union, tried, convicted and executed for treason on 1 August 1946.) The U.S. government orders a suspension of Lend-Lease supplies to the U.S.S.R.

Rear Adm. Erich Brüning, commander of the *Kriegsmarine's Schnellboot* ("fast boat") forces, arrives at Felixstowe, England, on May 13 to sign the unconditional surrender of all vessels under his command. In Norway, Crown Prince Olav, some members of the exiled government, and the head of the Allied mission, Gen. Sir Andrew Thorne, arrive in Oslo.

U.S. Army Air Forces B-29s firebomb Nagoya on May 14, the heaviest raid on the Japanese home-

U.S. Army Air Forces B-29s firebomb Nagoya on May 14, the heaviest raid on the Japanese homeland so far, with 3,500 tons of bombs being dropped. The raid destroys the Mitsubishi Works. In Europe, Radio Vienna announces the re-establishment of the Austrian Republic — the Anschluss (annexation of Austria into Nazi Germany) is declared null and void. In Scandinavia, the Norwegian resistance movement (Milorg) is officially disbanded. In the U.S., horse racing resumes after being banned in January because of wartime concerns over the amount of manpower and resources being used by the racing industry. On this day, 30,000 people turn out at Narragansett Park in Pawtucket, Rhode Island, to watch the races.

On May 15, after considerable confusion on the part of the Allies as to what should be done with them, Axis-allied Croatian forces that escaped Yugoslavia and surrendered to British troops in Austria are handed over to Tito's Partisans who, without delay, proceed to massacre them and any who were deemed to collaborate with them. In all, a minimum of 70,000 persons, and possibly as many as 250,000 people, including women and children, are killed. In Burma, nationalist leader Aung San ioins the Allied drive against the Japanese, his former allies.

German submarine *U-234* surrenders at the U.S. Naval Base at Portsmouth, New Hampshire, on May 16. One month earlier — on April 16 — she had departed Norway and was *en route* to Japan with an extremely important cargo, which included technical drawings, an Me-262 jet fighter in crates, 550 kg of U-238 uranium ore for atomic-bomb development, several high-ranking German officers and technological experts, and two Japanese officers. When *Kptlt*. Johann-Heinrich Fehler received the cease-fire orders on May 4, he decided to surrender to the Americans, rather than to the Canadians, being in a relatively equal position to do either. Still at war with the U.S., the two Japanese officers commit hara-kiri (ritual suicide) rather than surrender. British forces liberate Alderney, Channel Islands.

Two U.S. Republic P-47 Thunderbolt fighter-bombers bomb Kyushu, the third-largest of Japan's five main islands, on May 17. In the Philippines, the U.S. Army's 43rd Division captures Ipo Dam and its reservoir that is Manila's main water source. French troops land in Beirut, Lebanon, to reassert colonial control.

Perth Amboy's Dachau Priest

PERTH AMBOY - April 29 marks the 75th anniversary of U.S. forces liberating the Dachau concentration camp. Less than two weeks before Germany's surrender, the 45th Infantry Division of the U.S. Seventh Army freed the camp, just outside Munich. Upon liberation, they found more than three dozen box cars with corpses outside the camp and barracks inside the camp equally stuffed with the dead and the dying.

Dachau was the first Nazi concentration camp, opened in 1933. Long into the postwar period, it epitomized "concentration camp" for most Americans, perhaps because—unlike Auschwitz, liberated by the Soviets—it was American forces that freed the camp and American journalists that displayed its horrors for Americans to see.

Dachau was a particular hell for clergy: over 2,700 of them, most of them Catholic, many of them Polish, were held in the camp. Nazism was an enemy of religion, particularly Christianity. Catholic priests in countries under German occupation were brutalized. Polish Catholic clergy were decimated during the War, for they had to contend with two atheist totalitarianisms intent on strangling the spiritual in their country: Hitler's Nazis and Stalin's Communists, both of whom invaded Poland in

Polish religious orders, includ-

ing the Franciscan Capuchins, suffered heavy losses. By 1940, many were in concentration camps. Dachau was the most common destination, so much so that a clandestine, underground seminary that produced new priests even operated in its barracks.

When the War ended, some of those Capuchins decided to remain in the West rather than return to a Poland over which an Iron Curtain was falling. One of them eventually made his way to Perth Amboy. But not first without a detour to Oklahoma.

Władysław Lechański was born in August 28, 1908 in Zuski, in central Poland. He entered the Capuchins in 1926, taking the name in religion "Alexis." Fr. Alexis studied philosophy in Holland then returned to Poland for his seminary studies in theology. He was ordained a priest on June 14, 1934. He earned the equivalent of master's degrees in moral theology and Church law at the Catholic University of Lublin, and had a promising career ahead of him as a teacher of canon law. He lived at the Capuchin monastery in Lublin, Poland, a beautiful university town about 110 miles south of Warsaw, when World War II broke out.

He was arrested by the Gestapo on January 25, 1940, along with 25 other Capuchins then living in the Lublin monastery. At first, he was detained in the notorious Gestapo prison located in the Lublin Castle then, in June, was transferred to the Sachsenhausen concentration camp near Berlin. His final move was in December 1940, when he was sent to Dachau. He was a prisoner of Dachau for four years and four months. He became Number 22639.

When American troops liberated Dachau, Fr. Alexis remained in the West. He went to Paris, apparently in the hope of continuing his studies in law. (He was said to have taught canon law in the "underground seminary" that the priests of Dachau conducted at night, training vocations to the priesthood that came out of that hell). His Capuchin superiors asked him to go to the United States to try to raise money for the Polish monasteries destroyed during the War, so Fr. Alexis traveled to Ireland to learn English while waiting for his U.S. visa, which finally came in 1947. He arrived in New York July 2, 1947, spending some time leading a retreat for Felician Sisters in Buffalo and residing at the Capuchin parish of St. John's in Manhattan, just outside Madison Square Garden. That's where the Oklahoma detour came in.


The Catholic bishop of Oklahoma City-Tulsa was in need of priests. He had established a parish in the 1930s, St. Ann's, in Broken Arrow. The area was a hotbed of Ku Klux Klan activity, where Catholics were unwelcome. The first pastor left to become a World War II chaplain. The bishop needed priests;

Fr. Alexis went to Oklahoma and became St. Ann's pastor.

Five of the Polish Capuchins' "Class of Dachau" eventually passed through Broken Arrow: Fathers Alexis Lechański, Hyacinth Dabrowski and his brother Robert, Wacław Karas, Jan Salwowski, and Rafal Nienaltowski. Capuchins were responsible for that parish until 1996.

But the Sooner State, with few Catholics and fewer priests, also had few Polish Americans, and these priests also wanted to work with their fellow countrymen. Gradually, then, many made their way back east, to staff Polish American Catholic churches in New Jersey and in New York. The "class of Dachau" eventually served in Polish American parishes in Bayonne, Laurence Harbor, Manville, New Brunswick, Passaic, Paterson, Perth Amboy, and Trenton, Father Alexis arrived at St. Stephen's (now St. John Paul II) Church on State Street ca 1970. He remained there until his departure was forced for health reasons in the mid-1980s. He died in 1988 and is buried in the Capuchin plot at Sacred Heart Cemetery in Manville.

One remaining artifact of the Polish Capuchins who served the Catholic Church in New Jersey is St. Stanislaus Friary in Oak Ridge, in Jefferson Township near Sparta. As members of a religious order, the Capuchins wanted to retain their communal life and the Friary—which had originally been

constructed by Alfred T. Ringling of circus fame, who lived there until 1919. The last of the Dachau Capuchins died in 2010, but Oak Ridge remains alive under the care of a modern day Polish Capuchin, Brother Jerzy Krzyśków. I vividly remember Fr. Alexis walking around the backyard of the rectory at now St. John Paul II Church, praying his Rosary in the evening twilight. He was regularly in the confessional at that parish, and served that parish until his health failed. As New Jerseyans recall the anniversary of Dachau's liberation, let's not forget: one of its survivors served Catholics in our own city by the bay.

City of Perth Amboy Maintains Credit Rating During Covid-19 Pandemic

Standard & Poors Releases Rating on Refunding Bonds

PERTH AMBOY – S&P Global Ratings has just released its rating report for the City of Perth Amboy.

According to the report, S&P Global Ratings assigned its 'A+' long-term rating to Perth Amboy, N.J.'s series 2020A general improvement general obligation (GO) refunding bonds. At the same, time, the American credit agency affirmed its 'A+' rating on the city's existing GO debt. The outlook is stable.

The city's full faith and GO credit pledge secures the bonds. The proceeds from the series 2020A bonds will current refund all or a portion of the city's series 2007 refunded bonds.

Perth Amboy is home to many essential businesses who have continued to operate throughout the pandemic and in turn have continued to support the community. Maintaining this excellent credit rating, similar to credit reports generated for individuals, during the CO-VID-19 pandemic enables the city to save money, which directly benefits residents. The rating also means that whenever it comes time for the city to refinance their debt, they are afforded the ability to negotiate better rates; the city refinancing at a lower rate ultimately saves the taxpayers money in the long run. It is fiscally prudent to strive to maintain a strong credit rating in order to stabilize the tax rate.

The rating was derived by taking into account the following information, listed directly from the report:

- Strong management, with good financial policies and practices under its Financial Management Assessment (FMA) methodology;
- Strong budgetary performance, with an operating surplus in the current fund in fiscal 2018 with another surplus estimated for fiscal 2019, as per the 2019 Annual Financial Statement (AFS);
- Strong budgetary flexibility, with an available fund balance in fiscal 2018 of 12.9% of operating expenditures;
- Very strong liquidity, with total government available cash at 40.6% of current fund expenditures and 2.6x governmental debt service, and access to external liquidity that it considers strongly;
- Very weak debt and contingent liability profile, with debt service carrying charges at 15.6% of expenditures and net direct debt that is 127.7% of general fund revenue, and a large pension and OPEB obligation and the lack of a plan to sufficiently address the obligation, but low

overall net debt at less than 3.0% of market value and rapid amortization, with 68.3% of debt scheduled to be retired in 10 years; and

• Strong institutional framework score.

"I am very proud to see Perth Amboy has been assigned an A+ rating for its 2020A general obligation refunding bonds," said Mayor Wilda Diaz, "This report better helps us conceptualize the current state of the city and where we are succeeding. We will continue to identify cost cutting strategies and prepare for the future impact of COVID-19 to support our community during this defining moment in our city's history."

While the City continues to operate under emergency conditions due to the COVID-19 pandemic, The City of Perth Amboy remains focused on its financial situation and pursuit of long-term stability despite the current challenges.



Historical Reflections of Anguillian Offspring in Perth Amboy, NJ

And now I proudly present the outstanding and historical stories, careers and talent of these pioneering young men, spear-headed by their dedicated Anguillian immigrant parents.

David W. Rey - President, Junior Class of 1951

David Wilfred Rey was born and raised in Perth Amboy to parents William B. and Agnes T. Rey, who were immigrants from Anguilla. He was the youngest of three siblings.

David became one of the most popular students in high school. He was a member of the Senior Council, Senior Chorus and participated in many other extracurricular activities. Because of his outgoing personality and comedic but sly disposition, humor and wit unparalleled and fun and friendliness galore, he sought and was elected Junior Class President of 1951, only two years after Austin Gumbs was elected class president.

During David's early years, he took tap dance lessons and appeared in and won many talent shows in the Perth Amboy area. He portrayed two prominent African American entertainers at school events and other contests: Cab Callaway, a very popular, zoot suited actor/entertainer from the 1930s and 1940s; and Bill "Bojangles" Robinson, an expert tap dancer and respected actor from the 1920s and 1930s. David received rave reviews for his performances.

David was a very good athlete. He played on the baseball team, ran track and later in life became a very good tennis player.

He was a very intelligent person and soon began thinking of college as a junior. Eventually, David attended Saint Paul's College graduating with a B.Sc degree in 1956. He continued his education at Newark State College and earned an M.A. degree in 1963, and completed eighty-seven credits beyond an M.A. degree at Columbia University in 1968.

Professionally, David was an educator. He was appointed Assistant Principal of School No. 10 in 1969, and taught at William C. McGinnis School in 1976 and the Samuel E. Shull School in 1987 until his retirement from the Perth Amboy School System in 1994.

David was also president of two important organizations in Perth Amboy: The Sons and Daughters of Anguilla whose mission was working towards maintaining the connection to the Motherland (Anguilla) and identifying Anguillians worthy of achievement recognition. He also led the Modern Gents Social Club that promoted social events and sponsored academic scholarships to deserving and needy black students.

<u>Franklin R. Gumbs – President, Senior Class of 1954</u> Franklin Gumbs, younger brother of Austin Gumbs, was born and raised in Perth Amboy and was the fourth and youngest son of William Alexander and Edith Gertrude (Richardson) Gumbs of Crocus Bay and The Valley, Anguilla. He was affectionately called "Frankie" and came from the very popular and successful Gumbs family of Perth Amboy.

"Frankie" was large in heart and personality, with a remarkable natural ability to vocalize

the issues affecting the Class of 1954. To be more specific, his assertive personality gave his classmates assurances that they could solve whatever problems they faced. He had a gift of gab, an easy laugh, a mind of his own and was just a happy-go-lucky fellow. Oft-times, just calling his name automatically brought a smile. His classmates loved him and his election to president of his class was expected.

He attended Fisk University, Lycoming College, and Seton Hall University. Professionally, "Frankie" served in the city's Recreation Department for more than thirty-five years, where he was a Physical Education teacher in most of the parochial schools in Perth Amboy

The Best Way to Avoid an Audit: **Preparation**

Getting audited by the IRS is no fun. Some taxpayers are selected for random audits every year, but the chances of that happening to you are very small. You are much more likely to fall under the IRS's gaze if you make one of several common mistakes.

That means your best chance of avoiding an audit is by doing things right before you file your return this year. Here are some

Don't leave anything out. Missing or incomplete information on your return will trigger an audit letter automatically, since the IRS gets copies of the same tax forms (such as W-2s and 1099s) that

Double-check your numbers. Bad math will get you audited. People often make calculation errors when they do their returns, especially if they do them without assistance. In 2019, the IRS sent out more than 1.2 million examination letters correcting math errors. The most frequent errors occurred in people's calculation of their amount of tax due, as well as the number of exemptions and deductions they claimed.

Don't stand out. The IRS takes a closer look at business expenses, charitable donations and high-value itemized deductions. IRS computers reference statistical data on which amounts of these items are typical for various professions and income levels. If what you are claiming is significantly different from what is typical, it may be flagged for review.

Have your documentation in order. Keep your records in order by being meticulous about your recordkeeping. Items that will support the tax breaks you take include: cancelled checks, receipts, credit card and investment statements, logs for mileage and business meals, and proof of charitable donations. With proper documentation, a correspondence letter from the IRS inquiring about a particular deduction can be quickly resolved before it turns into a full-blown audit.

Remember, the average person has a less than 1 percent chance of being audited. If you prepare now, you can narrow your audit chances even further and rest easy after you've filed.


