## Going Around in Circles 9/23/20 Council Meeting

PERTH AMBOY – During the public comments, resident Ken Balut came up to talk about Resolutions R-349-9/20 thru R-352-9/20 (settlements filed by Landings at Harborside LLC for various properties). Balut insisted that whoever who did the tax appeals did it wrong. "One of the tenants was given a summons for not having a firewall. It is Kushner's responsibility and why are there no amounts listed for the settlements? It's really sad what Kushner gets away with." He then went on to talk about R-359-9/20 - Adopting the personnel policy manual revised as of September 18, 2020. "Does this include judges, chaplains, business administrators, and other administrative hiring's? What about sexual harassment? A judge dismissed (sexual harassment) charges without a hearing. No one wants to handle sexual harassment charges. There were no penalties for someone who wrote sexual harassment letters. Can the public see the Best Practices/Personnel Manual? Don't pass this resolution until the public views the manual?"

Resident Alan Silber came up next to talk about the same resolution. "When was the manual put up for the public to see? Was it in the backup material on Monday? The public couldn't even ask questions. Did the Former Business Administrator (Frederick Carr) work on this policy?"

Council President Bill Petrick answered, "Yes. There's a possibility that the personnel manual was late because of Carr being let go. The manual is also 117 pages long."

Silber then continued, "There was no continuity and instability because of personnel being changed."

Interim Business Administrator Patricia Perkins spoke up, "Only a few abbreviated changes were made - not the full mannal"

City Clerk Victoria Kupsch said, "The latest changes in the manual were not available until today for me to distribute to the council."

The council voted on the ordinances: Ordinance No. 1 – Renovations to the Parking Deck and Parking Utility; Ordinance No. 2 & 3 – Bond Ordinance for the water/wastewater utility improvements; Ordinance

No. 4 – Bond Ordinance for various capital improvements; Ordinance No. 5 – Designating handicapped restricted parking spaces for handicapped persons; Ordinance No. 6 – Salary and salary ranges regarding Blue Collar Teamsters Local#27. (First Reading) were all moved by Councilman Fernando Irizarry and seconded by Councilman Joel Pabon.

For the consent agenda: R-345 thru R-348; R-353 thru R-358; R-360, R-361, R-363, R-366, R-368 thru R-370 was moved by Irizarry and seconded by Pabon. R-349 thru R-352 (Landings Settlements) and R-367 (Change Order to contract of Maser Consulting for the Raritan River Park Green Acres Project in an amount not to exceed \$36,000) were asked to be pulled by Councilwoman Milady Tejeda. When it came to vote, R-349 thru R-352 was moved by Irizarry and seconded by Pabon. Tejeda was the only council member to vote "No" on R-349 thru R-352. Pabon made a comment that he had talked to people in Code Enforcement and there were 6 fines pending on these properties. Petrick also made a statement regarding these resolutions, "The reason I voted "yes" is the tax assessor stated that if the city had to go to court, it would cost us more money.'

For R-367, Tejeda asked, "What was the reason for the change order?"

Petrick explained that it was in the backup material.

B.A. Perkins then stated, "It has to do with abutment by Conrail or New Jersey Transit."

Law Director Peter King had additional comments and stated, "That additional property had been discussed."

Council President Petrick then added, "It had to be determined what property was under the Department of Transportation. Surveys were needed for the mason to do other plans. Most of the property is a parking lot and this is off Riverview Drive"

R-367 was moved by Irizarry and seconded by Tejeda. All voted "Yes".

Irizarry had asked that R-359 (Adopting the Personnel Policy Manual) be pulled to be voted on separately. The council had many concerns.

Irizarry said, "We got the manual on Friday and the rest I

got on Monday. I will not vote on something handed to us at the last minute. Our financial situation is not good."

situation is not good."
Petrick said, "It is 117 pages and most of the documents were revised."

Caba said, "We need more time to review the manual because there are too many pages."

Irizarry wanted to know if the chaplains and all city employees would be under the guidance of this personnel manual.

Law Director Peter King said he didn't know.

Irizarry asked, "Are the chaplains considered city employees?"

Interim B.A. Perkins said she would confirm if the chaplains were city employees and whether or not they are paid.

Irizarry moved to table R-359 and it was seconded by Caba. All voted "yes" to table.

Petrick stated, "I don't know if the chaplains receive stipends. I think they get badges.

Irizarry asked, "Are they under the personnel policy?"

Law Director King explained that the policy is put out by the city's insurance policy which you can go on the city's website to view."

For R-362 – Renewal of certain plenary retail consumption licenses, club licenses, and distribution licenses effective September 24, 2020.

Petrick stated that these licenses cannot be renewed until after their hearings, so it was voted on to table that resolution. Irizarry moved and Caba seconded. R-362 was tabled.

The topic of the Personnel Policy Manual was still a hotbed. Irizarry asked, "Is there a sexual harassment clause it the policy?"

Petrick stated, "We need to make sure the administration follows up on these cases (sexual harassment)."

Law Director King then rattled off some of the resolutions on these cases: "Some of these employees were terminated. The Police Department has more stringent policies and a hire-up was taken to court and terminated."

Petrick asked if there is anything in the policy regarding whistleblowers.

King responded, "We review their statements and have them file complaints if necessary. It depends on the circumstances

(if it is verbal or physical abuse or a combination of both). We need to separate the two parties involved for safety sake. You want all complaints reviewed. We need to make sure everything is reviewed due to liability issues."

Public Portion:

Resident Ken Balut came up first. He questioned the responsibility of who transfers people in the library. "The Library Board of Trustees were in charge of personnel. The chaplains are very important. Everyone should be held accountable. The Personnel Manual is not proper. You are always getting last minute stuff. There is no accountability for people who act irresponsible. High ranking people are not being held accountable. The bottom of the barrel is always taking the brunt. The mayor yelled at former B.A. Fehrenbach. You should start investigating judges. Another employee had an illegal lottery. One of the prosecutors gave me the finger."

Law Director King spoke up, "The municipal prosecutor falls under the present personnel manual. It doesn't address citizen complaints and we are looking to make a change to this. One of the previous Law Directors (Mark Blunda) had been working on the personnel manual."

Balut concluded his remarks, "The council can investigate the top moneymakers not being held accountable. This needs to stop."

The next speaker was Mr. Tejeda who spoke about the building his mother resides in and the rent had been doubled. "The owner of this building (Candyland LLC) is suing the

city."

Petrick responded, "The mayor appoints members to the Rent Leveling Board."

Tejeda continued, "We got a call from the city saying that the court settled the case along with the council."

Petrick then went on to explain that the council creates the legislature for Boards and the mayor assigns who is on the Boards. The lawyer (who represented the tenants of the building) should be able to explain this to them. You and your mom can be on the Rent Leveling Board."

Mr. Tejeda then asked, "Who represented the city?"

Law Director King replied, "I did." King then continued, "Candyland LLC which owns the building proved why rent had to be increased, and the judge made the final decision. (JB) Vas (the tenant's attorney) is a very good attorney."

Mr. Tejeda then stated, "Candyland never made any improvements to the building."

Petrick then stated, "Your attorney should have filed the proper paperwork."

Pabon then spoke up, "The decision (by the judge) was based on no one following up. You could go to the post office to see if the tenants got certified letters regarding the court date."

Petrick continued, "The only remedy is to go to the court system because we have no power to help you."

Tejeda said, "I am concerned, because if it can happen to us, it can happen to anyone."

Petrick countered, "It will be the Rent Leveling Board who can help if it is ever created and

## What Lies Ahead 9/21/20 Caucus

PERTH AMBOY – Before the start of the Caucus Meeting, Council President Bill Petrick announced that Councilwoman Milady Tejeda would not be able to attend. Because of her work schedule, she requested if the starting time for the Caucus could be changed to begin at either 5:30 p.m. or 6 p.m.

Councilman Joel Pabon started off the meeting with a question on road improvements taking place. "Will we be doing Kushner's property this year or next year?"

DPW Director Frank Hoffman came forward, "We hope that road improvements (which will include milling) will be this year." Hoffman warned that if the temperature falls below 400, the materials used cannot be put in place.

Council President Bill Petrick asked if the city put a lien on Kushner's tax bills.

Law Director Peter King responded, "We are going after the bonds on the Kushner properties."

Pabon then talked about pavers missing and the lights are still not working on the large buildings that we knocked down that the contained the models for the Landings condos.

Petrick then said, "The administration is responsible for this matter."

Pabon continued, "It's also pitch dark in that area."

Interim Business Administrator Patricia Perkins stated, "We can see if bond money can be used to get the lights fixed."

Frank Hoffman came up to answer Councilman Fernando Irizarry's question regarding work to be done on Hall Avenue. "There will be no paving or milling. We will be working on sidewalk improvements."

Council President Bill Petrick explained why 2 contractors were awarded bids for lumber and supplies. Continental Hardware Inc. was the main contractor, and the backup supplier was Henning Building Supply (in case Continental Hardware Inc. ran out of needed supplies). An example he gave was when a main supplier ran out of materials after Superstorm Sandy aftermath. "We need a backup supplier just in case we have an emergency such as this."

Interim Business Administrator Patricia Perkins answered a question pertaining to bids for a stair tower reconstruction at the Perth Amboy Public Library with alternates. "This will include an elevator and a lift."

Bill Petrick then questioned if the company who won the bid (H&S Construction and Mechanical) can do this job. The backup material that we received on this company looks good."

A representative for H&S construction came forward to speak who is an architect in Trenton. "H&S has done a lot of construction work with community colleges, municipalities, and mechanical work. They will not have to hire subcontractors and they are qualified by the state to do masonry and steelwork which was a challenge for the old contractors. The first masons who started the job were replaced by a second contractor.

That second contractor could not match the materials used by the first contractor. When we looked at what was being done to the building, there was no need to tear it down. There were no existing drawings from the original building."

Councilman Fernando Irizarry then spoke up and stated, "We (the city) have a liability and a fire hazard, and I'm concerned about the quality of work and safety issues. Are we working under the current subcode and in a 6-month timeframe?"

DPW Director Frank Hoffman fielded that question, "There had been some leaking affecting the children's department which was fixed."

The representative from HSM also spoke up, "The boilers were fixed in the children's room."

The next item discussed was Ordinance No. 1 – Renovations so to the Parking Deck on Jefferson Street.

Irizarry questioned, "What improvements are to be made?"

Petrick responded, "There were spots in the ceiling that were falling and holes in the ramps."

Interim B.A. Perkins said, "These cracks need to be repaired before the winter comes in"

CFO Jill Goldy came in to respond to Irizarry's question regarding long term improvements and repairs for the parking deck. "\$115,000 would be used."

Irizarry continued, "The cleaning of the decks and stair-cases are needed because they are very dirty, and urine infested. The trash has been accumulating and money is needed for cleaning on a regular basis."

Goldy then mentioned that there are cameras that are placed in the parking deck.

Councilman Pabon spoke up and stated, "There is an office right there (under the parking deck) and people can see the stairwell from the street. Someone should be checking those stairwells everyday (to make sure they are clean)."

Petrick then added, "We need cameras to monitor all parts of the deck, including parking spaces, the cashier's office. The ticket agents should check the stairwells."

There was a question regarding Ordinance No. 3 – A bond for various water/wastewater utility improvements appropriating \$3,790,000 and issuing \$2,930,000 bonds or notes of the city to finance part of the cost.

CFO Jill Goldy explained, "There are minor operating costs and major costs that are in the ordinance."

Director of Operations at the USA-PA (Utility Service Associates Perth Amboy) Middlesex Water Company) Luis Perez Jimenez added some comments regarding this bond, "We have to do a Treatability Study to see a different treatment is needed for the Runyon System. The last Treatability Study was done in 1995. We have to make sure that the chlorine is sufficient and that our hydraulic system is working correctly. We need to improve our GIS (Geographic Information System). Water can ferment if left alone too long. There are 2 buildings on Smith Street that will be demolished and replaced by a new building."

Ordinance No. 4 – Providing for various capital improvements. Appropriating \$5,110,355 and authorizing an issuance of \$4,200,000 in bonds

Goldy explained that this was upgrades for the Department of Public Works.

DPW Director Hoffman explained that this was needed for old, beat-up trailers.

Godly continued, "The BID uses the city's mini-sweepers, and they also provide the money for the salaries of the mini-sweeper operators. Part of this money will also be used for the new firehouse."

Fire Chief Ed Mullen came up and spoke regarding this matter, "There is a feasibility study being done to determine where the new firehouse should be located, and we worked with Councilman Joel Pabon. We are looking at property located on the corner of Amboy Avenue and Inslee Street. A quarter of a million dollars is needed to buy these properties and we have been pursuing building an additional firehouse for 6 years."

Council President Bill Petrick then remembered that there was a gas station located at a property where there were 5 to 6 old oil tanks discovered.

Councilman Irizarry lives in that area and said that he has neighbors who are concerned about speeding, especially near schools and houses that are shaking due to truck traffic.

Mullen stated, "There will be yellow flashing lights if the fire-house is built there and we will have utmost caution when dealing with the schools."

Pabon then stated that his sister and others who live in that neighborhood are happy that the firehouse is coming there. "The building that the firehouse wants to purchase is falling apart and should be taken down. That road should be a priority. We need to get this done and we also need another access road in that area. The members of the fire department gave their input into a new firehouse and its location."

Mullen then continued, "Since 2014, we have been looking for property for a new firehouse and we have money set aside for an architect. We need money to go out for bid and need to lock in low rates. A building is needed to house an engine, a ladder, and space for extra equipment."

Irizarry then asked, "What items are needed for the Office of Emergency Management?"

Goldy came up to answer, "It's to enhance the existing systems. The audio-visual equipment which is located in the basement is 13 years old."

Irizarry continued, "We need improvements for audio and visual in the council chambers so we can do a better job during the meetings."

Councilman Helmin Caba stated, "If we had that in place, we could have Zoom Meetings right now."

Petrick chimed in and emphasized, "We want equipment that can be used in the future. It's over-do."

Irizarry also stated, "It's embarrassing."

Pabon asked, "How many meetings have we had at the Y so far?"

Petrick suggested that the IT guy come to the meetings (so he can answer some of these questions).

Pabon then said, "It would be nice if the administration was here."

Interim B.A. Perkins said, "The IT guy (John) said we need to do the best job and not just rush it and it's a great undertaking. Covid tariffs need to be considered. Right now, Zoom can only have 100 participants."

Pabon suggested, "If we can't do this (with city personnel), maybe we need to hire outside contractors.

Perkins then stated, "When the IT Department put in for additional funding, it was looked at as being assessed as too much."

Petrick spoke up, "We have been talking about updating technology in the council chambers for a long time."

Goldy made one additional comment about Ordinance No. 4 regarding money for Code Enforcement. "There was \$800,000 in capital improvement money for the land purchased for the firehouse." She also stated that the \$5 million debt - \$4.2 million will be issued thru bonds."

Petrick had a question in regard to some of the vehicles that Code Enforcement were looking to purchase, "Are they looking at fuel-efficiency vehicles?"

Code Enforcement Director Irving Lozada came up to answer, "We are looking at 4x4 vehicles that will be used at construction sites so they don't get stuck (sometimes in muddy conditions)."

There was then a question regarding R-349 thru R-352 – all regarding settlements resolving complaints filed by Landings and Harborside LLC for various properties. Tax Assessor William FitzPatrick came forward, "These cases are from June. The property owners agreed on a settlement and one person withdrew. These cases go back to 2014. The judge involved in these cases required appraisals. If we went to court, we would probably have had to pay out more money."

Councilman Pabon asked, "Is there anyone paying taxes?"

FitzPatrick explained, "Kushner is paying the taxes on the properties."

There was a rather lengthy discussion regarding R-359. Council President Bill Petrick asked, "What is the deadline for Best Practices (one of the questions on Best Practices dealt with personal policy manuals for the city)?"

CFO Jill Goldy stated that the last time the personnel manual was revised was September 2017.

Law Director Peter King then added, "It's based on a 3-year cycle."

Councilman Pabon spoke up, "We received the personnel manual at the last minute."

Interim B.A. Perkins said, "We'll miss the Best Practices Deadline if we don't complete the form in October or Novem-

her"

Petrick then responded, "We are already out of compliance if we already missed the deadline. Do you want to table R-359? (adopting the personnel policy manual for the City of Perth Amboy revised as of September 18, 2020). We can table it until Wednesday's meeting."

The council decided to table the resolution until Wednesday (9/23/20).

Some of the council members then decided to make remarks on Communication No. 1 – The Perth Amboy Municipal Alliance thanking Rosemary Oarsley for her long-term commitment for over 20 years to the prevention of drug & alcohol abuse in the city of Perth Amboy.

Pabon thanked Oarsley for her commitment for 20 years. Petrick suggested a resolution be drawn up and a certificate made up to present to her. Councilman Caba said Oarsley has been dedicated to the city for 20 years. "I've worked with her and this is a well-deserved recognition."

Public Portion:

Resident David Caba spoke first. "It's been a while – maybe a year since I've been here, and I've been in real estate for over 20 years. Some of Rector Street is not paved and whoever is doing that project is insulting our residents. We have several candidates running for office who mention nothing about our beautiful waterfront. Other communities have improved their waterfronts and the real estate, but not here. Can we at least bring someone to make a difference in our waterfront? I only criticize to make things better, but we need to hold people accountable. We have a poor community and need to have a better quality of life. A billionaire has abandoned his property for 14 years, but residents get a letter if they neglected their property.'

Resident Alan Silber spoke next. He mentioned the Landings settlement on the agenda. "This guy (Kushner) leaves a property from 14 years ago. Condos selling originally for \$450,000 now sell for half the price. Commerce Street is not safe to walk at night. My neighbor gets cited if they have a halfinch of grass that is overgrown, but nothing is done about Kushner's neglected properties. This is pathetic. We need prices on the agendas for property settlements. The mayor has been in office for 12 years and the new ballpark looks very nice."

Department of Recreation and Human Affairs Director Kenny Ortiz came up to speak, "The county will maintain the park. The Vocational School will have first use of the facility, and then the city."

Silber then said he needed an explanation of the personnel policy manual.

Petrick explained the council needs to wait for the Governor to send out the Best Practices checklist which involves the city's personnel manual.

Silber concluded his remarks, "It makes no sense to vote on something (until you have a chance to review it).





#### The Covid Card (Mail-in Ballots)



I really don't understand the reason that Governor Murphy insisted that New Jersey has to vote-by-mail. Look how many times people had to stand in long lines for hours just to buy essential goods. Before Covid-19 hit, there were already many people requesting absentee or vote-bymail ballots. If people go to vote in person, they essentially want to vote and go home, especially if they have to work the next day. The only people I've seen hang around longer than that are the challengers who are working for the specific candidates. People use Covid and the rules associated with it only when it serves their advantage.



Council Vice-President Christine Noble asked for prayers for the recovery of Jimmy Kehoe who was recently struck by a vehicle.

There were questions about the upcoming November 3, 2020 election. Councilwoman Zusette Dato explained that the goal is to get ballots out by September 24, 2020. "No one has to apply for it if you are registered to vote and are an active voter. As soon as you get it, fill it out and put it in a secure dropbox. Right now, 10 dropboxes are in place. There is one in the Sayreville Municipal Building. Another option is to bring your ballot at South Amboy High School, or you can drive it to the Board of Elections, Kennedy Boulevard, New Brunswick. The county is doing what it can to educate voters."

Councilwoman Zusette Dato then spoke about the Rotary Club Car Parade at 1p.m. on Sunday, September 20, 2020. "The map is on the city website. The Rotary Club is collecting nonperishable food products which are really needed at South Amboy High School from 11 a.m. to 12:30 p.m.

Councilman Brian McLaughlin asked about the illegal palate operation going on.

Business Administrator Glenn Skarzynski stated that they have been cited for violations, but they have not gone to court, yet. He stated that the fire marshal was also called.

Councilman McLaughlin asked how many businesses hired South Amboy residents at Manhattan Beach.

B.A. Glenn Skarzynski answered that he would get a full list of all local suppliers. He stated that he only knew of 2 local residents who were hired.

McLaughlin stated that there should have been a job fair to offer residents employment.

Skarzynski stated he would get back to the council with more insight on the matter.

Councilman McLaughlin asked about expediating the acquisition of a fire truck for the city.

B.A. Skarzynski stated that if the city ordered the fire truck today, they were still looking at a 4 month waiting period.

McLaughlin answered, "Let's order it tomorrow."

Councilman Tom Reilly thanked the food pantries and

gave a shout out to Janet Kern who gave a lot of her time to help with the food pantries.

Reilly noted that the palette operation has been going on for years. "It's a fire hazard. These stacks of pallets are piled up next to a building." Reilly then inquired about illegal rentals and inspections of boarding houses

B.A. Skarzynski informed the council that Code Enforcement Director Jay Elliot was addressing the boarding house issues. "As far as the illegal rentals, letters are going out. The building (owners) have been issued a notice." The council was concerned when Skarzynski informed them there are over 200 illegal apartments in South Amboy.

Council President Mickey Gross noted that it is important to stay on target regarding the illegal apartments. "I'm alarmed there are over 200 illegal apartments in South Amboy. Our focus should be on that."

B.A. Glenn Skarzynski informed the council that addressing the illegal apartment issue is difficult. "It's not a quick process. It took us 9 months to get a list. Each building is a separate case. We must have proof ahead of time. All proceedings are virtual. Each residence will be inspected by different departments (in code enforcement)."

Council President Gross noted that there is a chance of a coro-

navirus spike and added, "Flu shots are coming out soon."

Mayor Fred Henry spoke about shared services with Woodbridge Township. "Our very capable First Aid Squad needs our help. We worked out a deal to do what we can." Henry noted that it will cost \$24,000 to replace the airbags in the South Amboy Fire Department. Thanks to City Engineer Mark Rasimowicz for replacing the handicapped ramp in front of city hall." Henry then added, "I thank Congressman Frank Pallone for the \$5.4 million grant for the Ferry. Thanks to Governor Murphy for the groundbreaking of the new train bridge."

B.A. Glenn Skarzynski noted that Roswell Market has changed hands and been demolished.

Public Portion:

Resident Bill DeMasi thanked the council for following up with the bamboo issue with his neighbor. "I don't know what happens at this point. My neighbor is required to remove all the bamboo in my yard. Do I need to remove my shed (where bamboo was growing under)? What do I do? I need to understand the process."

B.A. Skarzynski assured De-Masi that he would get Code Enforcement to help. Law Director Francis Womack added, "I will give you a call to help with legal options." Resident Greg Batluak stated, "I've been attending the council meetings. I was looking at the archives (online) from 2007-2019 of council minutes. There are a lot of missing minutes. In 2017 –12 months are posted. In 2018 there are 11 months posted. In 2019 – 2 months posted. For 12/19/18 there were no minutes posted. This was one of the most important meetings being held in this town – there were a lot of people at that meeting."

Law Director Francis Womack stated, "There were minutes taken. We can provide you with those minutes. The recording device was not working. The minutes were taken by the acting city clerk at that time."

City Clerk Debra Brooks stated, "I started a year ago in September. All the minutes have been approved and posted. Before that, the past practices of the acting city clerk – I don't know what happened. We can work in getting the gaps posted."

Law Director Francis Womack stated that the city is not required to record audio or video but minutes are required be taken.

Batulak stated, "It's very important to trust this administration. Ms. Brooks has to take measure that minutes are posted."

The meeting was adjourned at 7:50 p.m. All council members were present.

#### Virtual vs. In-School Learning Request for Half-day Lessons Heat up Board of Education Meeting

#### 9/17/20 Board of Education Meeting Via Phone-Conferencing

By: Katherine Massopust PERTH AMBOY – There was no executive session at the 9/17/20 BOE Meeting due to the fact the Board had nothing to discuss. Therefore, the meeting began with one public por-

ing began with one public portion of which anything could be discussed. There would be no public portion at the end of the meeting.

The first person to speak (first

name Johanna) was a parent of students in the Rose M. Lopez School. She argued that the virtual learning school day was from 8:35 a.m. to 3:45 p.m. and it was too long and stressful day for her child. "It's hard to focus. At 1 p.m. my daughter gets tired. Consider the half-day model."

The next person to speak was a mother of a boy in elementary school. "My son's elementary school there are so many distractions. Every time you update the computer system something happens. Everyone blames it on the Wi-Fi. A lot of times since this is going on everything is out of control. No one is looking out for the kids. Reconsider for all the kids to have a half-day. Right now, half the day I take him to work. The kids are straining their eyes and the teachers don't give them a break. Leave selfishness aside. We are in a crisis and there should be a half-day for all

District Representative Lynn Audette for the PA-AFT spoke next. "The parents' preference for remote decision – do here for grades 5-12. Then there is more planning time for teachers. Teachers have a 45-minute preparation period and they are losing that prep time. Please consider the time for teachers."

President of the PA-AFT Pat Paradiso spoke next. "I echo what Lynn Audet said, specifically spending hours and hours to prepare from scratch. We need books and Brain Pop for science. Everything they do – they are exhausted. We need clear protocols when teachers get sick. We need it in writing and in English and Spanish."

The next person to speak was the mother of 4 children in the school system. "I'd like to voice my opinion on virtual learning. 3 of my 4 children are miserable. Children who love to go to school are miserable. My one daughter thinks of this as an invasion. It takes its toll on mental health. A full day is too much. Go to the half-day learning. Kid's need to socialize in 1:1 groups."

After the public spoke, there was a long discussion of the survey sent out to parents on their preferences for online learning, how many responded, and what needed to be done.

Board President Tashi Vazquez began the discussion, "We hear you – the survey - the administration has been working around the clock. This situation is not ideal, and we will continue to reach out for suggestions. DO NOT use social media for your platforms. Email your teacher, the superintendent, a Board of

Education Member. We hear you. Social media is not an avenue. I have concerns. Let's continue to do that. We work together to get the steps needed to get there. We are not alone. These issues are not unique to Perth Amboy. Let's do this together. Covid is still very real."

Superintendent Dr. David Roman said, "Putting your heart out on the line puts you in jeopardy. I ask parents to continue. I want to commend the board. This pandemic is not easy. We are listening to you. We are getting email daily. Please communicate with us. We welcome correspondence of parents. Dr. Vivian Rodriguez and Mr. Delvis Rodriguez are actively involved to resolve issues. We cannot make everyone happy. Some parents want half-day. Some parents want a full day. As superintendent, to the parents of this community, I hear you. I see you. I love your children. We are trying to get them to compete in this world. If we don't provide instruction, they may not be able to reach their ability to compete in this nation. To balance - that's what we are up against. They need to be at a reading level that has to be on the level of this nation. We will make the decision that is best for the community. Children need to be able to read at an appropriate level. I want them to be able to compete in this world. Staff members have concerns. We have to come to some balance. We need to be transparent - what would you

like? I can't provide for halfday programs in the afternoon. We want to provide instruction for students. It's complicated."

Dr. Roman then stated that for pre-school children, mornings on the computer are better, but effectively parents must assume all of the tutorials. "For Kindergarten and Grades thru 4, 60% to 80% of parents want half day morning online classes. We are looking at that. We have to look at the availability of staff. We have special ed students to think about. For grades 5 thru 12 there is no way that any district can solve all the problems. I will challenge their students. There are 2000 school districts in the state of New Jersey. Our focus is on helping to reach the students."

Assistant Superintendent Dr. Vivian Rodriguez said, "Proficiency for the third-grade reading goes from learning to reading to learn. 4 out of 5 low income students miss this critical milestone. Many parents work and come home and go over the lessons with the children. Some can't work and stay home with their children. All over the country - what to do with the earlier grades? Parents are asking for half day schedules. I can't say how worried I am at this schedule. This is a very serious decision. I don't know how far we are going behind. We try to look at all sides of the decision. It is not isolated. We have to know the decision on the elementary level."

Superintendent Dr. David Ro-

man said, "Respectful, thoughtful, considerate – we have to design a new schedule. I hear you. It is very cumbersome. Our graduation rate has increased again. I care about the child in the graduation rate. We have to do it the right way."

Dr. Vivian Rodriguez added, "We have to schedule elementary (level) first."

Dr. Roman said, "As far as the half-day, the reality of the afternoon is we cannot provide a serious level of instruction for your children."

Dr. Vivian Rodriguez said, "Everyone said small group inside (school) in the afternoon. We have only a finite number of teachers and staff. We may be looking at scattered tutoring during the week. There is a desire of coming in in small groups."

Dr. David Roman said, "As long as parents understand it is a major responsibility. The decision we make today impacts us 2 years from now. In 2 years from now, the children won't be where they need to be. If everyone is okay with that, I'm okay with that. We'll accommodate what we need to accommodate. Programs need to be modified to meet the needs of the community. For us to address students with special needs, teachers need to be in a classroom."

Assistant Superintendent Delvis Rodriguez said, "\$620,000 is spent to ensure the safety of

people are appointed."

Councilman Irizarry then added, "Even if we had a Rent Leveling Board, it has limited powers."

JB Vas (the attorney who represented the tenants) came up to speak, "You are sidestepping the real issue. You knew the Rent Control Board was not operating."

Petrick responded, "We saw no evidence that the Rent Leveling Board was not filled."

JB Vas continued, "This affects 70% of the people in this town. They are being stripped of their rights. On November 25, 2019, the council considered removing the Rent Leveling Board under Ordinance No. 2. Council Members could have served on the board. This entire council did nothing in the middle of the pandemic. The rent was doubled, and you can't blame it all on the mayor. You can change the ordinance so you can appoint members."

JB Vas then addressed Councilman Caba and asked him if he volunteered to be on the

Board.

Caba turned the question around and asked Vas the same thing.

Petrick advised Councilman Caba not to answer that question.

King then commented, "The mayor appoints members to the Rent Leveling Board and the council approves the appointments. Without the Rent Leveling Board being active, the owner has to go before the courts."

Petrick told Attorney JB Vas, "When your dad was mayor, he wanted to do all the appointments of members to the Boards with the consent of the council."

Vas also mentioned that he represented the residents of this building pro-bono. "I filed all paperwork diligently."

Tejeda's mother then came up to speak (in Spanish). Councilman Irizarry translated for her, "I am a 40-year resident and I never want to leave this town. Legal services didn't want to deal with me because I didn't have the money. I always heard the rent could not be increased more than 5%. I went to see many people in city hall. I was

not taken care of. My sister and I went to see Wilda. I've known Wilda since she was a little girl. Wilda's aunt had lived in that building and she told me to speak to a lawyer. Wilda was a good friend in the past. If there was a law (stating the rent can only be raised by 5%), it's not for the poor, and only for the rich. We need a mayor so that people can be respected. No one will do anything for me."

Resident Samantha Castro came up to speak as a member of The Perth Amboy Advocacy Group, "Frontline Views". She had a list of 17 Demands that she presented to the council. She talked about a few of them - #11 – which included a violation of human compliance; #4 - Civilian Review Board; #16 - Need to celebrate Perth Amboy's history; #17 – Having an open dialogue. She also mentioned Thomas Mundy Peterson importance in Perth Amboy and that he needed to be recognized, "Especially since we have a statue of George Washington who was a slave owner."

Council President Bill Petrick told the young woman, "If you get the chance to visit the Perth Amboy Council Chambers, there is a large plaque on the wall honoring Thomas Mundy Peterson."

Resident Dorothy Daniel came up to speak next. She wanted to let Castro know, "When I was member of the Board of Education, I was instrumental in getting a school named after Thomas Mundy Peterson (on State Street)." Daniel also commented on the Police Chaplain Corps, "It is an adjunct of the city under the Police Department and they should be protected from being sued. And as a member of the Housing Authority, I was appointed by the council - not Mayor Vas. In the last year, there has been racial violence against black people in general. My grandfather was born in Anguilla and came to New York. Some people went to Cuba. One of my grandfathers lived in Cuba until the age of 6. He came to Perth Amboy at the age of 21. This is the best town in New Jersey, and I appreciate the town and the elected officials. We can live in this town and treat each other with respect."

Resident David Caba came

up next, "A millionaire disrespected our residents. I grew up in that lady's (the woman whose rent was raised) building. No one is looking out for them and it is shameful. I have no problem with people who go back to their mansion and I don't think the owner of that building cares about the tenants. Kushner doesn't care about maintaining their buildings. How many developers live in town? They just collect poor people's money. Tears came from my eyes when that lady whose rent was doubled was speaking. I will find out where that owner lives. They just want their money. Now Kushner wants to build 500 new rental apartments. In 2007, the average price of Landings Condos was going for \$450,000. In recent sales lowest priced Landings Apartment went for \$190,000. The highest sales price was for \$385,000. In Asbury Park and Long Branch, the sale prices (for comparable units) have increased."

Resident Alan Silber came up last, "I think it's great that people come out and speak their minds

PERTH AMBOY - James Dean "JD" Garrison is the first Black firefighter to achieve the rank of captain in the Perth Amboy Fire Department. James Garrison's father was Carl Dean Garrison, known as "Pee Wee" Garrison. Carl Dean Garrison was the first Black firefighter in the Perth Amboy Fire Department. He was a firefighter from 1987 until 2006 (a total of 19 years) and a U.S. Army veteran of the Vietnam War. He died in 2010 at the age of 60.

Carl's father-in-law, Eugene Francis Foley was a Volunteer Firefighter in the McClellan Fire Company, Engine 3 in Perth Amboy from 1957 until his death in 1990. It was Eugene Foley and Anton J. Massopust (PAFD Fire Chief 1984-1987) who encouraged Carl to take the Firefighter exam and he passed the test.

This makes James Garrison (age 33 with 7 years of service) a third-generation firefighter in the Perth Amboy Fire Department. As a child, James would visit his father at the firehouse after school. They would hang out with fellow firefighters. When James would watch a fire on television, he would run around the house with his father's fire boots and helmet on. It was difficult for James because his father never got to see him being sworn in as a firefighter.

As a captain, Garrison will be assigned to Battalion 4, out on Rescue 1 and will be involved with heavy rescue service that does special operations.

The swearing-in ceremony took place on September 30, 2020 at Perth Amboy Fire Headquarters on New Brunswick Avenue. Garrison was one of four new captains sworn in during the ceremony. The others are: Captains Brian Bonilla, Derek Kraese and David Ramos. Bonilla's father was a volunteer firefighter and Kraese's father, the late John Siberry, was a city firefighter for 28 years. Also sworn in were city Firefighters Jermaine Clark, Michael Delfosse and Piotr Matusewicz.

Also during the Ceremony, Civilian Isaias Rodriguez received a Mayoral and Department Citation. "On Saturday night (9/19/20), a basement fire broke out at 410 Smith St. A quick-thinking Good Samaritan, Isaias Rodriguez, was passing by and saw the building engulfed in smoke, with lights on in the apartment on the second floor. Seeing that no one was outside, he banged on the first-floor door to no avail. He then proceeded up the stairway, through the smoke, to yell and bang on the second-floor apartment door. Here he was able to alert the family that their building was on fire as smoke now began to fill the apartment. Isaias was able safely evacuate all the occupants, who were having a small

There also was a blessing of a statue of Saint Florian, Patron Saint of Firefighters which was donated on behalf of the Gall family to the Perth Amboy Fire Department during the promotion ceremony in memory of The Most Reverend Father Florian Gall who died June 28, 2003. Fr. Martin Vavrak (Police & Fire Chaplains Corps.) gave the blessing.

#### In Perth Amboy, Mayor Wilda Diaz Rallies with Essential Laundry Workers Seeking Greater Protections Against COVID-19 and Fair New Union Contract

If Employer Unitex Fails to Address the Concerns of These Workers, the Company May Force a Strike and Create a Health Crisis at Many Area Hospitals



Press Release 9/29/20 PERTH AMBOY — Today, Perth Amboy Mayor Wilda Diaz rallied with essential laundry workers who are calling for greater protections against CO-VID-19 and a fair new union contract as they continue to perform difficult jobs cleaning and processing medical linens for many area hospitals and nursing homes.

Mayor Diaz joined the workers in front of the Med-Apparel laundry processing plant at 35 Washington Street in Perth Amboy, which is owned by Unitex. (Several photos from the news event are attached to the bottom of this press release.)

The unionized employees at this Perth Amboy industrial laundry facility are considered essential workers. During the current pandemic, these dedicated workers have cleaned patient bed linens, gowns and other linens for hospitals and nursing homes that were often contaminated with COVID-19.

These workers are overwhelmingly Latina immigrants who live in northern New Jersey on low incomes. Their essential, demanding jobs cleaning and processing medical linens – gowns, sheets, towels, scrubs, and other washableshave helped ensure the safety of hospital and nursing home patients, staff, and visitors during the COVID-19 pandemic.

At the rally, Mayor Diaz and

Unitex employees were joined by leaders of the Laundry, Distribution, and Food Service Joint Board, Workers United/ SEIU, the labor union representing these essential workers in contract negotiations.

Recently, Unitex refused to disclose exactly how many employees of its Perth Amboy facility have contracted CO-VID-19. Despite a clear requirement to keep employees at least six feet apart whenever possible, according to Governor Murphy's Executive Order 122 that covers all essential businesses, Unitex claims it has "not measured" the distance between employees.

Unitex is also under investigation by Region 22 of the National Labor Relations Board for alleged unfair labor practices, including illegally threatening to fire its Perth Amboy workers during contract negotiations if they walk off the job.

Unitex is a financially successful and growing company that once reported more than \$150 million in annual revenue. It currently owns several laundry plants in New Jersey and New York. But instead of rewarding its Perth Amboy employees for their dedication and sacrifice during the COVID-19 pandemic, Unitex is demanding unreasonable concessions on retirement benefits, and treating employee's safety demands with callous indifference.



If Unitex keeps ignoring the health and safety concerns of its Perth Amboy employees, and tries to force concessions on benefits, the company may force these essential workers to strike. A strike would disrupt the cleaning and availability of medical linens for many hospitals and nursing homes in New Jersey and New York.

If hospitals and nursing homes are unable to get clean linens, infection and disease could spread more quickly and could create a major health emergency endangering patients, staff, and visitors as New Jersey and New York grapple both with COVID-19 and flu season in the weeks ahead.

"During the most challenging days of the COVID-19 pandemic, these essential laundry workers here in Perth Amboy have put their lives on the line to keep many hospitals and nursing homes safe. It's time for Unitex to deliver a fair new contract that includes increased health and safety protections for these workers, along with continuation of earned pension benefits for current and future employees. No one should have to worry about contracting COV-ID-19 while on the job. Unitex should immediately address the concerns of these workers, and implement the social distancing guidelines that Governor Murphy's executive order requires for all essential businesses,"



said Perth Amboy Mayor Wilda

"These essential laundry workers in Perth Amboy have helped Unitex achieve extraordinary growth and success in recent years. Our members have stepped up during the CO-VID-19 pandemic and faced significant health risks to keep many hospitals and nursing homes safe. They have earned a fair new contract. Unitex should immediately give its Perth Amboy employees stronger health and safety protections against COVID-19, and continue paying into the pension fund for current and future employees," said Alberto Arroyo, Co-Manager of the Laundry, Distribution, and Food Service Joint Board, Workers United/SEIU, and a top union official negotiating on behalf of the Perth Amboy Unitex employees.

"I have dedicated years of my life to this job. It's very hard work cleaning and processing gowns, sheets, and other linens for hospitals and nursing homes in New Jersey and New York City. But I am proud to help keep these healthcare facilities clean and safe every day, especially during the COVID-19 crisis. My co-workers and I have helped Unitex become a very wealthy and successful company, and we deserve to be treated fairly. We hope Unitex does not force us to strike and prevent hospitals from receiving the

clean medical linens they need," said Brigida Vidal, a Perth Amboy Unitex employee who lives in Perth Amboy and has worked at the facility for 5 years.

Unitex employees in Perth Amboy clean and process medical linens for the following New Jersey hospitals: Hackensack Medical Center in Hackensack; John F. Kennedy Medical Center in Edison; St. Peter's Hospital in New Brunswick; Trinitas Regional Medical Center in Elizabeth; and South Ocean Medical Center in Stafford Township.

They also clean and provide linens to a large number of New York City hospitals.

That list of New York City hospitals includes: Columbia University Medical Center, The Allen Hospital, Lower Manhattan Hospital, David H. Koch Center, Weill Cornell Medical Center, Brooklyn Methodist Hospital, all part of New York Presbyterian; Brooklyn Hospital (affiliated with Mt. Sinai Hospital); Mt. Sinai Hospital (Mt. # Ending with a Zoom 9/23/20 Council Meeting Comments

PERTH AMBOY – During the Council Comments, Councilman Helmin Caba recognized the young woman who spoke from an organization called, "Frontline Views". The spokeswoman for the group presented each member of the council a list of 17 demands. One of the items they discussed was having a statue built of Thomas Mundy Peterson whom they gave a brief history about.

Councilman Caba appreciated their concerns that Thomas Mundy Peterson should have a statue, "We need to take it a step further. We need a bust or a monument, and it was talked about when I was on the Historic Preservation Commission. The best spot would be in front of city hall, so all can see not only what he did for the town, but for the country. What are we doing about the Surveyor's General Office? There was a grand opening, and it was open to the public for a little while. but then it closed down."

Councilman Fernando Irizarry thanked everyone who came to the meeting to express their views and concerns. "Everyone spoke in a civil manner." He then asked to be provided with information on a recent homicide, a violent rape and cases that have been solved so far (this year). He urged all residents to fill out the census forms that are due on September 30th and emphasized that this can also be done online. "If you want better and improved streets, fill out the census so we can get funding."

Councilman Joel Pabon spoke. He asked the City Clerk to give him the information as to who applied for the Rent Leveling Board. He stated he was confused when the woman who was part of the group (who had her rent doubled) mentioned

that she talked to the Mayor and Pabon about this rent increase matter. "I was not at any meetings at all with this woman. People in this building who had their rent increases should have received certified letters about pending court dates. That is what they should have looked into first." Pabon then turned his attention to a clothing bin located at the corner of Market and Second Street, "It looks terrible. Trash is also being dumped there. If owners can't maintain those boxes, they should get rid of them. There are a lot of food being donated to Perth Amboy residents and we should thank the suppliers. A lot of the food coming into Perth Amboy are being supplied from people who are from out-of-state. Let's not take credit for the goodness of others. I hope that we are able to get back to city hall to have our meetings there."

Councilwoman Milady Tejeda thanked all for coming and then asked Councilman Pabon if he had an update on the Patten School Road opening. Pabon answered, "There is

Pabon answered, "There is supposed to be an opening of the Elizabeth Street going to the Division Street, but because of the Covid-19 situation there was a holdup and there has been no update from Conrail. There was also supposed to be an opening of the cul-de-sac near Sadowski Parkway and we even had prices for what it would take to do that project, but so far there has been no further updates."

Tejeda continued, "There is no need in pointing fingers. Everyone has done their jobs and tried to move forward. I came here in 1974 and we need to work together for the betterment of the town."

Council President Bill Petrick then added, "We are committed to this town and this is why we serve. My grandfather came here and had ten kids. We are in a crazy season. I feel badly for those tenants who had a rent increase, but someone came to this meeting to grandstand (regarding this issue). If they (the people who had the rent increase) were not given proper notice, can a (judge's) decision (who granted the landlord the increase) be overturned?"

Law Director Peter King responded, "Yes."

Petrick then held up a flyer and asked the person manning the camera to zoom in on this flyer, which happened to have a picture of the municipal complex on it. Petrick continued, "We will be paying for this building for 30 years. The person who built this building was incompetent. The C/O was not issued until a new council came in. All safety measures were not in place when the building was first opened. We still have one courtroom which still cannot

be used because of deficiencies. This is propaganda material stating how they are going to fix all these problems, but they were all caused by the prior administration's problems. Under renegotiated contracts, we took over the billing from the water company. We have a schedule of lining repairs and improved water."

Councilman Fernando Irizarry then spoke up, "We spent \$17.7 million in water improvement."

Law Director Peter King then spoke up, "The Kushner projects began under the Vas administration."

Petrick continued speaking, "Mayor Wilda Diaz released Kushner from his obligation on the city buildings. The Mayor doesn't run the city. She sometimes appoints qualified people, but department heads run the city. We had a very qualified Business Administrator who was fired on a whim and she

(Diaz) broke all levels of the law (in doing so). This Business Administrator (Frederick Carr) was not given a 20-day notice and we were not given any notice either. The last B.A. (Carr) had the support of this council, but Wilda doesn't care about the city. There was recent activity by the MS-13 Gang with gunshots, a shootout, and multiple gunplay. Under Vas, we did have a professional police department and now we have none of that. There were even bullet holes in one of the Cathedral International Buildings. She had many ribbon cuttings for businesses that closed shortly afterwards. When there are food distributions, she pretended the food is coming from her. Corruption is happening under her." He ended by saying, "God Bless everyone."



#### World War II - 75 Years Ago

The news program "American Mercury Presents: Meet the Press" premieres on the Mutual Broadcasting System radio network on October 5. (Moving to television in November 1947, the show, which still airs today, is the longest-running program in television history.) In Hollywood, a sixmonth-long strike by motion-picture set decorators boils over into a riot at the gates of Warner Bros. studios in Burbank.

In the Netherlands, Gen. of the Army Dwight Eisenhower, arriving in The Hague on October 6—on what had been Adolf Hitler's personal train—is given a hero's welcome.

In Germany, Gen. George S. Patton on October 7 turns over command of the U.S. Third Army to Lt. Gen. Lucian Truscott. At Southampton, England, the liner *SS Corfu* docks, carrying home the first 1,500 British prisoners of war from Asia.

President Truman announces on October 8 that atomic-bomb secrets have been shared with the United Kingdom and Canada. Former Deputy *Führer* Rudolf Hess is transferred from the United Kingdom to Germany to stand trial for war crimes at Nuremberg. Hess had been imprisoned in England since being captured in Scotland in May 1941 on an unauthorized, ill-advised "peace mission." In Palestine, Jews stage a five-hour general strike to protest British restrictions on Jewish immigration.

British troops occupy the Andaman Islands, in the Bay of Bengal, on October 9. In France, Pierre Laval, the former head of state of Vichy France, is sentenced to death for collaborating with the Germans. In Argentina, Juan Perón — the nation's vice president, secretary of war and minister of labor — under pressure from opponents in the military who are wary of his growing power in the government and popularity among the general populace, resigns from all his public offices.

The Communist Party of Korea is established, on October 10. The Detroit Tigers defeat the Chicago Cubs 9-3 in the seventh game of the World Series. It was in the fourth game of this series that the "Curse of the Billy Goat" was visited upon the Cubs. The Cubs were up in the Series, two games to one, when William Sianis, owner of Chicago's Billy Goat Tavern, as the story goes, brought his pet goat, Murphy, the tavern's mascot, with him to Game Four. Despite his paid-for box seats, Sianis is asked to leave the park because the goat's odor is offending nearby fans. Outraged, Sianis leaves, and then sends an angry telegram to Cubs owner, Philip K. Wrigley, which says: "You are going to lose this World Series and you will never win another World Series again . . . . because you insulted my goat." And, indeed, the Cubs never again win a World Series — until 2016, 71 years later. In New York City, CBS conducts a successful test of color television when it broadcasts images in color between two locations in Manhattan.

On October 11, Nationalist leader Chiang Kai-shek and Communist leader Mao Tse-tung announce an agreement in Chungking to maintain peace and order, to find a way to reconcile and to promote democracy. In North Africa, the governments of the U.S., the U.K. and the Soviet Union set up a new international administration to govern Tangier, located in Morocco on the western side of the Strait of Gibraltar. The city, strategically located where the Atlantic Ocean meets the Mediterranean Sea, had been occupied by Spanish troops in June 1940 and held by them for the duration of the war.

In the Netherlands East Indies, the Dutch government on October 12, 1945, offers to negotiate with Indonesian nationalists who are willing to agree to self-government for Indonesia under the Dutch crown (that is, accepting Commonwealth status). In Italy, *General der Infanterie* Anton Dostler becomes the first German general to be tried for war crimes. Dostler stands before a military tribunal in Caserta, accused of ordering the execution of 15 American POWs who had been captured in a raid in March 1944. Although the soldiers were in U.S. Army field uniforms and carried no civilian clothing, they were classified as commandos. Dostler defends his action by saying he followed Hitler's "Commando Order," issued in October 1942, that stated (in part): "...all Allied Commandos encountered in Europe or Africa should be killed immediately without trial, even if in proper uniform, or if they attempted to surrender."

French troops in Vietnam on October 13 are fighting Viet Minh insurgents that are led by Hồ Chi Minh. In Argentina, Juan Perón is arrested and imprisoned. Political opponents and the military fear that, enormously admired by the country's workers and the poor (Perón had done much toward eliminating poverty and dignifying labor), Perón's popularity could surpass that of the sitting president and of even the government itself.

A new, provisional, national legislature is elected in Czechoslovakia on October 14. In the Dutch East Indies, the Indonesian People's Army declares war on the Netherlands. At Bad Nauheim, Germany, Gen. George Patton takes command of the U.S. Fifteenth Army, at this time a small organization tasked with documenting the war in Germany. Insiders consider that Patton has been "kicked upstairs."

Pierre Laval, the former head of state of Vichy France, on October 15 is executed by a firing squad for treason. In London, the House of Commons votes to extend the British government's wartime emergency powers for five more years, in an effort to recover from the cancellation of American Lend-Lease support. The British economy relied heavily on the transfusion of American aid, and the British find they must maintain austere economic measures to prevent financial collapse. In Manchester, England, the Fifth Pan-African Congress opens. Some 90 delegates spend the week discussing independence for African colonies.

The Food and Agriculture Organization is established in Québec, Quebec, Canada, on October 16 as a specialized agency of the United Nations. Its mission is to lead international efforts to eliminate hunger worldwide.

In Argentina, following huge demonstrations of popular support (300,000 people rally in Buenos Aires alone), Juan Perón — the country's vice president who had resigned on October 9 because of pressure from the Argentine military — on October 17 is released from prison and returns to politics as a "strong man." In Tokyo, Emperor Hirohito grants amnesty to nearly one million Japanese as a "step toward national unity." Soviet troops begin to evacuate Manchuria.

The first open session of the International Military War Crimes Tribunal at Nuremburg, Germany, takes place on October 18, with the indictments of 24 top Nazis. First on the list is Hermann Göring, Supreme Commander of the *Luftwaffe* and President of the *Reichstag* (the German parliament), followed by: Rudolf Hess, Deputy *Führer* of the Nazi Party until 1941, when he was captured in Scotland and held prisoner by the British; Martin Bormann, Chief of the Nazi Party Chancellery and private secretary to Adolf Hitler; and Wilhelm Keitel, Chief of the *Wehrmacht* High Command. All are charged with four counts: conspiracy to commit crimes, crimes against peace, war crimes and crimes against humanity, in violation of international laws governing warfare. Japanese troops quell an uprising in Semarang, Java, Netherlands East Indies, then hand the city over to British forces.

# Posting Home Addresses & Phone Numbers of Judges and Prosecutors Online Passes Assembly

TRENTON – To protect the privacy and safety of judicial officers and prosecutors, the full Assembly on Thursday voted 79-0 to approve legislation to prohibit their home addresses and telephone numbers from being posted online.

Under the bill (A-1649), sponsored by Assembly Democrats Annette Quijano (D-Union), Lopez, Yvonne Assembly Speaker Craig Coughlin (both D-Middlesex) and Ralph Caputo (D-Essex), individuals, State and local agencies, and businesses would be prohibited from posting or publishing home addresses and phone numbers of judicial officers and federal, State, county or municipal prosecutors, regardless of whether they are currently working or retired, as well as their spouse or child. Specifically, the bill would amend the current law that prohibits such disclosure for law enforcement officers.

Additionally, the measure would make it a crime of the third degree for a person to knowingly and purposefully post this information online to expose another to harassment or risk of harm to life or property. A third-degree crime is punishable by three to five years in prison, a fine of \$15,000, or both.

If a person posts the information online with reckless disregard for the risks it may cause to another, it would be a crime of the fourth degree punishable by up to 18 months in person, a fine of \$10,000, or both.

Under the bill, the home addresses of law enforcement of-

ficers, judicial officers and prosecutors would be redacted from government records before a document is provided to a member of the public through the Open Public Records Act.

If the home address of a law enforcement officer, judicial officer or prosecutor is posted online, they may request the person or entity that disclosed the information to remove it. If the information is not removed in a timely manner, the affected individual could bring civil action in Superior Court.

After the attack at the New Jersey home of federal Judge Esther Salas this summer, it was discovered that the shooter had found her home address online. This legislation would be known as 'Daniel's Law' after Judge Salas' son, Daniel Anderl, who lost his life in the attack.

The measure's sponsors released the following joint statement on the bill:

"Making tough decisions is part of the job for judges and prosecutors. Sometimes these decisions aren't popular, and they become a target. It's frightening to think that disgruntled individuals may be able to find their home addresses and personal phone numbers readily available at the touch of a but-


