# Vainieri Huttle, Reynolds-Jackson Measure Requiring Registration of Vacant and Abandoned **Properties Released by Assembly Panel**

Legislation Establishes Enforcement Tools to Maintain Properties

TRENTON - To help ensure that communities can enjoy their home's surroundings, a bill that would require the responsible parties of vacant and abandoned properties to register them in the municipality where they are located was released by the Assembly Housing and Community Development Committee Thursday.

The measure (A-2877) includes enforcement tools to help ensure that the properties are properly maintained and

allows municipalities to hold is pleasant visually. those parties accountable.

Assembly Democrats Valerie Vainieri Huttle (D-Bergen) and Reynolds-Jackson (D-Hunterdon, Mercer) are sponsors of the legislation and released the following joint statement:

"Whether a single or multifamily home, a modest dwelling or a mansion, properties that are well-maintained help instill a sense of pride in our communities and make them more inviting. There truly is 'no place like home'—especially when home

"Yet when properties and lots are abandoned and not maintained, they become an eyesore to the community, bring down property values, and are a source of stress to those who must see them daily.


"This measure will help ensure that the parties responsible for such nuisances are held accountable, take corrective action and are fined accordingly when they fail to do so."



Catholic Charities, Diocese of Metuchen Announces Free COVID-19 Testing at Unity Square, New Brunswick, NJ on Tuesdays in December

NEW BRUNSWICK The NJ Department of Health through the City of New Brunswick is offering COVID-19 testing at Catholic Charities, Diocese of Metuchen's Unity Square at 81 Remsen Avenue in New Brunswick. The testing will be offered on Tuesdays throughout December from 10AM to 2PM and will be free of charge. Those wishing to obtain a rapid test are advised to refrain from eating or drinking within 30 minutes of testing. Insurance is requested but not required.

Unity Square is a community organizing and social concerns initiative of Catholic Charities, Diocese of Metuchen that works to empower community members and catalyze change in the residential neighborhood of New Brunswick, NJ. Unity Square's efforts focus on a target neighborhood of about 6,000 low-income residents. Unity Square addresses a diverse set of issues, including economic development, employment, civic participation, immigrants' rights, and tenants' rights. More recently, Unity Square began emergency food distribution as a result of the Covid-19 pandemic. Since April 2020, Unity Square has provided emergency food bags to over 1,000 unique households. Catholic Charities Acting Executive Director, Julio Coto said "We are committed to the health and safety of the New Brunswick community and are pleased to partner with the City of New Brunswick and the NJ Department of Health to make COVID-19 testing accessible to Unity Square residents."

# Masks

Perth Amboy is the coronavirus hotspot in Middlesex County, with the most cases, and they are rising. Dr. Anthony Fauci, the director of Infectious Diseases at the National Institutes of Health, has predicted continued surges of Covid-19 into at least the end of February, making this period even more dangerous than the Spring surge. # The Perth Amboy Renaissance



# **A Difference of Opinion**

12/7/20 Caucus

By: Carolyn Maxwell PERTH AMBOY - The meeting started at 4:38 p.m. Councilman Fernando Irizarry spoke first regarding Ordinance No. 2. – Special Event permit.

"At the last meeting, we requested that changes be made to this ordinance regarding the timeframe of people presenting their events for approval, etc."

City Clerk Victoria Kupsch said, "The changes were made."

Council President Petrick requested, "We need to have the present ordinance that we made changes on."

Irizarry continued, "My email is not working again."

Kupsch said that he needed to bring in his IPad for this problem to be fixed.

There was then a long discussion on Ordinance (First Reading – No public discussion) RE: Creating a Perth Amboy Citizens Public Safety Advisory

Petrick started the conversation, "We (the council), the police, the FOP, and the PBA had no real involvement. We want openness, responsibility, and accountability.'

Police Chief Roman McKeon came up to speak, "I'm not saying that this advisory council is a negative, but we all need to be together in those meetings."

Petrick then advised the council, "Maybe we need to table (this ordinance)." He also suggested that it should be changed to an Advisory Board or Committee and not use the word, "council".

Irizarry agreed, "It should be changed to an advisory board.

Petrick also was concerned about the number of people that could be on this advisory committee and the ages of the people to be on it.

Law Director Peter King suggested that the ages start anywhere from 18 to 20 years old.

McKeon continued, "I have a problem. I had very brief discussions with Bob McCoy (From JEDI) and Donna Stewart (Perth Amboy Chapter of NAACP). I also agree that having somebody on this advisory group from the ages of 15 to 20 will be too young. The original age group are not even old enough to live on their own."

Police Chief McKeon also entioned "They were one of the first departments to have bodycams, and we have an open-door policy. A lot of discussions were done behind my back. They left me out of a lot of discussions, and I felt that I was being disrespected. Harry Pozycki (Founder of the Citizen's Campaign and one of the spear-headers of this group) and I agree with the residents on having large participation."

Harry Pozycki then raised his hand for permission to speak, "We came here six months ago to meet with the police chief and mayor. You (the council) have to adopt this - not the police chief or the mayor. Take your responsibility to lead. You (the council) could have met with the FOP and the PBA. You can save the lives of the police and also save money. I am ask-

ing you to introduce this ordinance."

Petrick responded, "It's very tricky. We need to fully flush it out. Let's get it right the first time. These are very legitimate concerns, but there has not been enough input from the police department. Why are you pushing for this to be passed in December?"

Pozycki answered, "We have offered you this proposal in good faith and are bringing you fact-based solutions. You are turning away our good youth who want to be involved and want to help. All of your questions were answered at previous meetings (when we were here)."

Petrick talked again, "We respect our authority, but I'm hearing from the police chief and the FOP that you never really met with them. I don't think this advisory committee is ready."

PBA Local 13 President John Marcinko came up to speak, "We have put down several areas that the PBA had a voice and responsibilities for."

Councilman Irizarry then asked, "Did the PBA Local 13 agree with the ordinance presented by the Public Safety Advisory Group?"

Marcinko said, "We could not be in the room when the group were voting on certain items. I don't have the same ordinance that the council has in their hands." Marcinko then handed a copy of the ordinance that he had for the council to look at. They all agreed what he had, and they had was different.

McKeon spoke up again, "There is a miscommunication and we (the police) need to be in the same room when the public safety council were having their discussions."

Councilman Joel Pabon then spoke up, "I remember when we had the peaceful protest in Perth Amboy. This has been going on for six months. This group also said that the Police Chief and the Mayor were involved (in discussions) and they weren't. Only the PBA was involved, and there is too much pointing of fingers going on. What is the problem? Something needs to be put in place. I hope everybody reads this ordinance."

Petrick continued, "The copy of the ordinance that the PBA have, and our copy are different. We need to be on the same page."

Pozycki continued, "We met with the PBA's attorney who drew up the documents. There was no real change in the substance, except maybe in parts of the language. It is consistent to what the PBA has."

Irizarry then said, "The citizen complaint review board is not part of the ordinance presented that we have. What we have may be the final draft."

Petrick then said, "We all should have the same draft."

Councilwoman Tejeda voiced some concerns, "I can see the urgency, but let's take the time to meet so we are on the right path. Get everyone who needs to be involved to be here. We (the council) need to be a part

of the process and the Council President should be at those meetings."

Petrick then turned to Councilman Irizarry, "I nominate you to be on this advisory board. You'll have plenty of time now (that you no longer will be on the council). You can also take notes at the meeting."

Irizarry then asked, "Are you going to pay me?"

Petrick continued, "This is important for the community, but I hope it's not adversarial."

Pabon spoke up, "At first, the PBA was not even part of the committee."

Petrick then suggested, "We need to have the police department's point of view. It needs to go back so this committee so they can meet with the PBA and the FOP." He then asked that Ordinance No. 1 (first reading) be tabled. Councilwoman Tejeda seconded the motion.

City Clerk Victoria Kupsch said she would have it removed for the next meeting.

Councilman Helmin Caba had a couple of thoughts regarding this ordinance, "This has been going on too long and it was presented to us 6 months ago. I talked to many people about this public safety ordinance and each person had a different view. Neither the police nor the mayor was present at the council meetings to discuss this. We will be the first city in the state to have this."

Pozycki then corrected Councilman Caba stating that Orange Township has a Citizen's Public Safety Council.

Caba then said, "We will be the first city in Middlesex County to have this."

After that discussion, DPW Director Frank Hoffman came up to discuss R-502 – Inserting \$7,439 into the revenue in the CY: 2020 budget for the Middlesex County Recycling Sub-

He explained, "The reason why we got this money is because we are not in the Countywide Collection Program. It cost us about \$45,000 a month for recycling."

For Resolution R-503-12/20 – Authorizing cancellation of current appropriations, balances, and the water/wastewater utility fund.

CFO/Comptroller Jill Goldy came up to explain R-503, "We have a running deficit. The governor said we can't put residential accounts into our tax sales. We are moving some of the unpaid bills to close out some of the \$300,000 of unpaid bills. We are not allowed to shut off residential water. Commercial buildings are different."

Councilman Irizarry then spoke up, "People don't realize that after the executive orders are lifted, your rent and other bills will have to be paid."

Law Director King then clarified, "The landlord will have the liens on their properties."

There next was a discussion regarding R-528 - 12/20 Adopting official newspapers

for legal notices.

Law Director King said, "This will be done in the reorganization meeting in January."

Petrick disagreed, "We need to do this now."

City Clerk Kupsch said, "We always have done this in December in past years."

There was also a discussion R-532-12/20 – Setting the 2021 Council Meeting dates, times, and location.

Kupsch said, "This was also always done in December."

Councilman Helmin Caba then brought up the question about fluoride in our water, "Even though there are positives (in reference how it works in regards to dental hygiene), but it is not a valid enough reason, especially if no one else in the county is doing it. We need to remove the fluoride from our water."

King said, "I had asked Luis Perez-Jimenez (Director of Operations at the USA-PA (Utility Service Associates Perth Amboy) Middlesex Water Company) to look into this."

Perez-Jimenez said, "We would have to modify the permits"

Irizarry then spoke up, "I've heard no complaints about the fluoride in the water. I think it's good to have healthy teeth and a lot of people can't afford to go to the dentist."

Councilwoman Tejeda then asked about the pros and cons of fluoride in the water.

Perez-Jimenez, "The DEP gives the limits on how much fluoride that we can have, and we have a 0.7 level which has no negative health effects."

Petrick then spoke up and stated, "I heard that fluoride is good for the development of teeth in younger people. Just to make it clear, you still need to brush and floss your teeth every day."

Caba continued, "We also shower and bathe in this water." Petrick continued, "What is the immediate and lifetime exposure to fluoride?"

Irizarry answered this question, "We were told a person would have to drink 2 liters of the water every day for 70 years to harm them."

Perez-Jimenez then said, "Fluoride is a corrosive material."

King suggested that straw poll be taken of the councilmembers if we should remove fluoride from the water. Pabon stated that the council doesn't have enough information to make a decision right now.

King asked Perez-Jimenez if there was any financial savings to remove the fluoride, "It's about \$10,000 a year to add the fluoride."

Petrick also suggested that they be given the pros and cons of fluoride.

King then asked, "Will there be any upgrades needed to remove the fluoride?"

Perez-Jimenez again stated, "There are no harmful effects, and the fluoride is added after the water filtration process is completed."

Tejeda also agreed that more information is needed in this decision.

There was a discussion regarding R-408-12/20 — An agreement with Bayshore Single Stream Solutions, LLC for marketing and recycling of single stream recyclable materials.

Hoffman explained, "This is an award-winning company, and they adhere to high ethical standards."

Irizarry was concerned, "This company says that they will not accept coat hangers as recyclables."

Hoffman explained, "It's the wooden ones that would not be accepted and we have sent out mailers regarding recyclable materials (and how they should be disposed of). This company may do dual streaming in the future. We used to make a larger profit on recyclables in the past."

There was a question to as why pots and pans are not recyclable. Hoffman explained that anything that newer appliances have requiring an outlet for them to operate would not be acceptable. "There is a way for them to be disposed of (bring them down to the Department of Public Works to determine where to dispose of them)."

OEM Director Larry Cattano came up to explain R-511-12/20 – For the Perth Amboy Police Department to participate in the 1033 Program to request and acquire excess Department of Defense Equipment.

Cattano explained that this would be under the category of Code No. A which would be Regular and Non-Military Supplies that you can purchase in a regular store. "For us to get weapons or any heavy-duty artillery, we would have to get council's approval before acquiring it."

Cattano was then asked if the police department was aware that Seabra's liquor license had been suspended. Cattano explained, "We should get the notice from the city clerk's office to go to Seabra's Armory with a notice in our hands so they can hand over their liquor license to us."

Law Director King then spoke up, "Seabra's cannot serve liquor – only food – and their liquor license was supposed to be turned over to the city on 12/6/20."

Victoria Kupsch had a comment to make about the council's question about changing the meeting time. "You can do this at Wednesday's (12/9/20) meeting."

meeting."

It was decided that R-528 – adopting legal newspapers for official notices and R-532 – setting the 2021 council meeting dates, times, and locations would be reworded for Wednesday's meeting. R-529 thru R-531 – appointing members to the Planning Board and Board of Adjustments would be voided. These appointments will be done at a January Meeting.

R-535 – 12/20 – Awarding a contract to Turn-Key Technologies for the purchase of parking garage cameras in an amount not to exceed the sum of \$22,619.04

R-535 was discussed by Council President Petrick. The old cameras we have can't cover the whole parking area (in the Jefferson Street Parking Garage).

Petrick then explained R-536-12/20 – A public hearing and adoption of the 2021 budget for the Perth Amboy Business Improvement District (BID) for January 1, 2021 – December 31, 2021. had to be removed because they didn't have a meeting.

Public Portion:

Resident Vince Mackiel was the first to speak, "The city council should approve the Public Safety Committee. Martin Luther King, Jr. always advocated for better housing and community involvement. "We need something in place. We are faced with healthcare issues. We need a public safety committee to discuss housing, healthcare issues, and the economic state of the 10% of black people to help them. More needs to be done. They renamed Madison Avenue "Martin Luther King, Jr. Boulevard. It's only sym-

Resident Jeremy Baratta came up next, "Why was the BID Meeting cancelled? Could it be because they may not have followed the proper procedures? Sometimes the worst vice is advice. We are in the middle of a pandemic. We have a lot of federal police agencies that discuss police activities and training. Take time to look at this ordinance (Citizen's Advisory Group). They are trying to promote a certain political platform and want to exclude the police in some of their discussions. There should be a committee to describe their function." He then disputed the comment made earlier by Perez-Jimenez. "Fluoride costs \$1.10 per resident per year. You would save \$100,000 to eliminate fluoride."

Alan Silber came up next. He referenced R-539 - Commending B.J. Bienvenido Torres and Caroline Pozycki Torres for the contributions they have made to our waterfront community. "Everyone should abstain from voting to give an award to someone who is presently running for office." Silber then asked, "What are the duties and qualifications of a Library Director? We have not had a certified Director for close to 5 years. In 2017, there's a posting for the job for Library Director and they needed to have a license. Wilda does whatever she wants, even when it comes to interim appointments." He then turned his attention to the Code Enforcement Department and talked about a house at 395 Rector Street which is part of the Landings property and in terrible condition. "It was bought in 2016 and this house is boarded up. Has Code Enforcement looked into this? J.B. Vas would come to meetings and talk about the housing in Perth Amboy and he lives close to that address. Did he ever talk about this? Were any citations

or summonses issued at this address? Is their any list of vacant homes?" He then questioned, "There are many dead fish at the marina, and it can't be because of the fluoride."

Cattano came up to answer the question regarding the fish. "We are trying to determine if it is because of algae or lack of oxygen." He also wanted to let the council know that an officer did go to the Armory and confiscated their liquor license.

Councilman Fernando Irizarry questioned, "Why was the ordinance that I asked to be put on the agenda regarding marijuana not here? Is it possible to have a special meeting? If we don't have time to get a special meeting in December, I ask that it be put on the agenda in January."

Council President Bill Petrick promised Irizarry that he would make sure this was done. "I have two more years to be on the council."

King then told Irizarry there was something in place regarding the marijuana ordinance.

Code Enforcement Irving Lozada came up and addressed some of the Landings Properties, "There were 7 that were issued summonses, but you have to remember that the courts are still closed."

Petrick then stated that Covid only happened recently. These seven properties are 12 years old."

Lozada said, "I was not an employee, then."

Petrick questioned, "Can these proceedings be done through Zoom?"

Lozada responded, "We can't control court dates if the lawyers have to reschedule. Zoom is a lot more difficult. Documents have to be loaded also."

Councilman Joel Pabon spoke up, "I have been complaining about the property at 395 Rector St. for a year. The old Armory building was knocked down. We need to put these properties up for sale. Let Kushner sue us. The Landings residents deserve better and we can't give Kushner any more breaks. They should knock that building down at 395 Rector. Kushner knocked down the old Armory to save on taxes."

Petrick then suggested, "We should let the appropriate departments see if they are unsafe structures."

The meeting went into closed session at 7:00 p.m. with no further action to be taken.

# **Endorsements of Political Candidates Questioned Among Topics Discussed** *12/9/20 Council Meeting*

PERTH AMBOY – The meeting commenced at 7:12 p.m. All Council Members were present. No one from the audience came up to speak on any of the ordinances. When it came to the first public portion, resident Ken Balut was first to speak.

He questioned R-508-12/20-An agreement with Bayshore Single Stream Solutions LLC for marketing and recycling of single stream recyclable materi-

"Why isn't there any money mentioned?"

Law Director Peter King responded, "Bayshore will be paying the city \$82 per ton."

Balot then questioned R-509-2/20 — Professional Services agreement with Center State Engineering for project cost for design engineering, specifications, BID documents, and construction inspection for the New Jersey Department of Transportation Municipal and Urban Aid Grant improvements to certain streets off of Convery Boulevard. Cost not to exceed \$39,000.

"Why was this contact not bidded out?"

City Clerk Victoria Kupsch answered, "This is for professional services. It is not bidded out"

Balut wasn't satisfied, "Still some of the work involved in this project should be bidded out. I'm also waiting to see the bills that Centerstate Engineering sent out to Kushner. I already OPRA'd this. There has been no action for over a year."

He then went on to question R-531-12/20 – A contract to Turn-Key Technologies for the purchase of parking garage cameras in an amount not to exceed \$22,619.04.

"Will they (the cameras) work?"

Council President William Petrick fielded this question. "This is the same company who installed the cameras that are presently in the Jefferson Street Parking Deck."

Balut continued, "The cameras on Smith Street never worked and information can be deleted. You need to have a backup system."

Petrick then stated, "Maybe Cloud Storage can be used."

Balut ended by stating, "Cameras were altered and changed in the past. I have copies of original tapes that I had turned over to the prosecutor's office that were later altered."

After the public portion was closed, Council President Petrick announced that the council needed to take a brief break to go into a closed session. The council went into the closed session at 7:28 p.m. and returned at 7:55 p.m. When the council returned, Law Director King told the council that you cannot have a resolution to amend an ordinance. The question was regarding putting a late starter on agenda.

City Clerk Victoria Kupsch told the council they would need a unanimous vote to put this particular resolution on the agenda. It was moved by Council President Petrick and seconded by Councilwoman Tejeda to add the late-starter on the agenda. When it came to voting, Councilmen Caba and Irizarry voted "Yes", but Councilman Pabon voted, "No" which stopped the voting since the vote had to be unanimous.

For Ordinance No. 1 – RE: Handicapped Parking. It was moved by Irizarry and seconded by Tejeda. Ordinance No.

2 – Special Events. Moved by Irizarry and seconded by Pabon. Ordinance No. 3 – Administration of Government RE: Budget and Fiscal Procedures. Moved by Irizarry and seconded by Caba

For the consent agenda, R-498 thru R-532, R-534 thru R-535, was moved by Irizarry and seconded by Pabon. R-533 was voted on separately.

R-533 – 12/20 – Expressing appreciation to Lisa Nanton for her outstanding efforts and dedication to the city.

Before voting, Pabon wanted to thank Lisa Nanton for her service, especially when it came to securing funds for the Prop House which has cleaned up this place a lot. "The ball room is open, and the lights are working. As someone who lives right across the street from the Proprietary House, I can tell you that I and the other homeowners on that street are very happy." R-533 was moved by Irizarry and seconded by Caba. All voted "Yes".

**Public Portion:** 

Ken Balut came up to speak and questioned whether municipal prosecutors can make political endorsements. He also questioned how a captain who worked as a campaign manager for the mayor received a \$12,000 raise. "A captain had been suspended. There is a video showing people going into mailboxes and they had been investigating this since September 24, 2020. Why have there been no announcements from the business administrator, the mayor, or the police department for people to make sure they watch their mailboxes?" He then talked about the Kushner properties. "The mayor in 2009 extended Kushner's contract even though he had done nothing for the city. The mayor took it upon herself to do this contract - and its garbage. She doesn't want to take on Kushner." Balut then talked about Code Enforcement. "They should enforce the law. How many tickets did Code Enforcement give to the Landings? They have no fire-blocks in their building. It is about time people stood up and not let Kushner build more garbage. Kushner likes to brag about his developments in Long Branch.

Law Director King responded to Balut's question involving the municipal prosecutor giving endorsements. "They are not held to the same standards as judges would be. There is nothing governing prosecutors."

Council President Petrick asked if a prosecutor can endorse the mayor during the elections.

King emphasized again, "Nothing precludes a prosecutor from doing this as there are for judges."

Petrick then asked, "Can a provisional captain get additional pay?"

King responded, "If they are doing the duty for that position, then they can get the pay. If he is on his own time, he can work on a political campaign."

Pabon questioned, "Will this

be a civil service violation?"

Petrick said, "Would there would be a problem because a code enforcement employee was interviewing people who may have taken ballots from people's mailboxes?"

King explained, "If this was done during the working hours and they were using city equipment, that would be illegal. If this was done on their own personal time, and using their own personal electronic devices, there is no violation. I don't know if there were any criminal complaints."

Petrick spoke up, "People did file complaints." Petrick then described the video. "An individual filed a complaint of theft of mail from their mailbox."

King responded, "The county can investigate."

Petrick asked if he could be informed how far up the complaint went.

King gave two scenarios: "A person can get suspended with pay while an investigation is going on. If there is an indictment, a person can be suspended without pay."

**Council Comments:** 

Helmin Caba was concerned because Covid numbers are rising at alarming rates. "There were a thousand cases this month and sixty kids got it in one day. We are number one in the county. Protect all your loved ones. We need to get the Covid numbers on a daily basis."

B.A. Patricia Perkins responded, "We get the numbers from OEM Director Cattano, and sometimes they (the county) will miss a day or two. As soon as I receive them, I give them to you."

Caba reminded everyone that there are now two dropboxes for the mail-in ballots. "The one that was at the police department for the first election, and now an additional one was added at city hall. Exercise your right to vote. This is my last meeting as Councilman, and I want to thank all of you, especially for the ones who voted for me four years ago. There are many challenges left ahead and anyone coming into my seat (on the council), God bless you. Rest assured, no matter what, I'll always be involved. Have a blessed Christmas and a Happy New Year."

Councilman Fernando Irizarry, who is also at his last meeting as councilman read from a prepared statement (see p.).

Councilman Joel Pabon was also very concerned about the Covid numbers. He suggested that the council put out a letter

to go to the county explaining that we need more screening in the city. "They were no-shows during the election. It's almost a year (since the Covid hit) and it's not getting better - it's getting worse. We have a large amount of people here. The county needs to help us as we have always helped the county." Pabon then urged when people who fill out the mail-in ballots, don't write-in names of people who are not on the ballot. Don't waste your ballot. There is only two people running for mayor. The county Board of Elections was closed because of Covid-19 in their office. I hope the county gets everything in place. We need help with Covid relief and with the election. Covid is not something to play with. I just can't believe the Covid numbers, especially when it comes to the kids. Enjoy the holidays and do the right thing. Use your mask and wash your hands. I want to thank Councilmen Irizarry and Caba for their service. I have respect for those who serve the public. From the bottom of my heart, I wish you both the best."

Councilwoman Milady Tejeda said, "People have been getting sick from their Thanksgiving celebrations. I want to thank Councilmen Caba and Irizarry for their service. It's been an honor to be a part of this team. We are going to miss Irizarry as our official translator. Maybe he could come back and work as a translator for the council. Enjoy your holidays and be safe."

Council President Bill Petrick stated, "The JRF is supposed to be getting the 15-minute response Covid test kits from the state."

B.A. Perkins spoke up, "The rapid test that Council President Petrick is talking about is not that accurate."

Petrick then continued. He thanked YMCA CEO and President Steve Jobin for the use of the Y facilities. "I want to thank both my colleagues: Caba and Irizarry for all of their hard work and efforts. No one can compare with Irizarry when it came to his translation skills. I appreciate your insight, diligence, and questions and I appreciate all the hours that you spent on this dais. I will miss you. Be safe. Be cautious. Wear a mask and practice social distancing. I have relatives who are waiting to see if they are getting sick. We are all still waiting for the vaccine. I wish everyone Happy Holidays and most of us will be back in January."

The meeting was adjourned at 9:00 p.m.

# Lopez, Coughlin & Mazzeo Bill to Expand Eligibility for Extended Unemployment Benefits Signed into Law

TRENTON – In an effort to help out-of-work residents who have exhausted their unemployment insurance (UI) benefits amid the current economic recession caused by the COVID-19 pandemic, a bill to make certain workers eligible for extended unemployment benefits was signed into law Friday by Governor Phil Murphy. The measure received final legislative approval in November, passing the full Assembly 74-0 and Senate 39-0.

Previously, an individual who exhausted regular UI benefits may have then qualified for extended UI benefits if the wages they were paid during their base year — which are used to calculate their benefits — were 40 times their weekly benefit rate.

The new law (A-4852) provides that a person would be eligible for extended UI benefits either because they had qualified for regular UI benefits or they attained the current re-

quirement of being paid wages 40 times the individual's weekly benefit rate, instead of being required to meet both qualifications, as previously required.

The new law applies to claims filed after June 27, 2020.

Sponsors of the law, Assemblywoman Yvonne Lopez (D-Middlesex), Assembly Speaker Craig Coughlin (D-Middlesex) and Assemblyman Vince Mazzeo (D-Atlantic) released the following joint statement:

"As the COVID-19 pandemic continues to surge in New Jersey with no clear end in sight, we must do everything in our power to bolster our unemployment program and help unemployed workers through this difficult time. Uncertain times call for innovative measures and extending unemployment benefits for eligible workers under this new law will certainly help bridge the gap for workers to find new employment opportunities."

# Hackensack Meridian Health Palisades Medical Center Remains Safe for In-Person Care

# Current COVID-19 Cases Represent 2% of all Hospitalizations in Northern New Jersey

Press Release 12/7/20

NORTH BERGEN, NJ – Hackensack Meridian Palisades Medical Center and its dedicated physicians, nurses and staff are safely and effectively providing high-quality, compassionate care. Given the rampant community spread of COVID-19 in New Jersey, following is an update for patients and physicians on COVID-19 cases at Hackensack Meridian Palisades Medical Center:

•There are currently 1,560 CO-VID-19 hospitalizations in North Jersey. Hackensack Meridian Palisades Medical Center currently has 35 COVID-19 patients, or 2% of all North Jersey hospitalizations. Two-thirds of the beds are non-COVID-19 cases.

•The infection control team is confident that the COVID-19 cluster, identified the week of November 12, is isolated and has not resulted in any new cases. There are approximately three dozen team members out of 1,265 who are out of work due to either a positive COVID-test or because they were in contact with someone who had COVID. This number fluctuates daily.

•There is no evidence of transmission from team members to patients, or vice versa. Rigorous contact tracing and testing are being conducted daily.
•The hospital continues to be

adequately staffed and daily reviews are conducted to safely redeploy team members where care is needed most. Staff from non-emergent health care procedures have been deployed to support COVID-19 efforts.

"In these unprecedented times, it is normal to feel concerned about practicing medicine or seeking in-person care for non-COVID-19 conditions, and we want to assure patients and physicians that their health and

safety is our top priority," said Anthony J. Passannante, Jr., M.D., FACC, President, Hackensack Meridian Palisades Medical Center. "In many cases, delaying care could worsen conditions or lead to more serious treatments and procedures, and we urge patients to get the care they need in close consultation with their doctor's office."

In addition, many robust steps have been taken to protect team members and patients, and these measures are continually enhanced to maintain an environment where it is safe to practice medicine and seek inperson care, including:

• Strict adherence to all safety protocols established by the CDC and the New Jersey Department of Health.

•All of our clinical team members are wearing N-95 masks, and properly trained and fittested.

•Increased daily COVID-19 testing of team members in any of our units with a greater probability or incidence of confirmed cases. Greater surveillance of team members better enables us to identify those who are asymptomatic but test positive and ensure they rest at home.

•Suspending visitation with hospitalized patients, with exceptions for labor and delivery, end-of-life care, pediatrics and adult patients with special needs.

•All team members must undergo comprehensive screening, including a temperature check, before working at a hospital or patient care locations. If there is an issue, the team member is instructed to report to Occupational Health immediately and not come to work.

•Patients are tested for CO-VID-19 on admission and we have begun serial testing any patients that stay for more than two days. This is because patients may initially test negative upon entering the hospital but convert to positive over the next few days from illness acquired in the community.

•Team members who test positive are required to self-quarantine at home. Additionally, the network conducts rigorous contact tracing so that if a team member comes in contact with a team member who is positive, they too must self-quarantine as well.

•Intensive cleaning of all facilities including hand-held misters, and UV lighting in all treatment and common areas.

•Continuing to provide universal masking, enforcing its usage and ensuring everyone has the appropriate personal protective equipment (PPE) by creating an equipment stockpile, including eye protection.

# Review: How The Grinch Stole Christmas

"All the Who's down in Whoville love Christmas! But the
Grinch who lives just north of
Whoville did not!"

That's the beginning of one of the most famous Christmas stories ever written. One of the most famous children authors of all time Dr. Seuss (Theodor Seuss "Ted" Geisel). He wrote some of the most famous children's stories of all time including "The Cat in the Hat", "The Sneeches", "Green Eggs and Ham", and of course, "How the Grinch Stole Christmas". He helped thousands of children learn to read with his works of literature. Of course, these stories were made into television specials and movies.


I will look at all three versions of "How the Grinch Stole Christmas."

The original, if you've never seen it, "How the Grinch Stole Christmas" animated TV special, won an Emmy and a Grammy award. The Grinch believed that Christmas would come without all the Christmas cheer, presents, etc. We know in love he disguises himself as Santa Claus and using his dog, Max as a reindeer makes his way down to Whoville from the mountains and steals everybody's Christmas presents, their trees and every piece of Christmas cheer in order to destroy it. At the top of a mountain. when the Grinch realizes the Christmas does not come from the store or from a box or from the Christmas tree it comes from the love that's inside us all of us. Dr. Seuss wrote the story about commercialism in 1957. When he wrote the story on how commercialism has infected Christmas, the Grinch was just one of those personas that Dr. Suess had.

The 1966 animated special featured Boris Karloff who both narrated and performed the voice of the Grinch. Warner Brothers famous voice actress June Forey voiced Cindy Lou Who and Thurl Ravenscroft (who voiced Tony the Tiger) sings the famous "You're Mean One, Mr. Grinch".

The 2000 Live Action Movie, "How the Grinch Stole Christmas" featured Jim Carrey as the Grinch. This version isn't too bad. It is a little bit too dark, but





Jim Carrey is so funny in it. He added lots of great jokes. The look of the film is a little weird, but I think that the costumes really make up for it. It's a lot better than any of the other live action film versions of Dr. Seuss that were made later on (such as "The Cat in the Hat".

They concentrate a little too long on other aspects of the Who's and the backstory of the Grinch. Remember, the book is only a few pages long.

My biggest complaint about the animated 2018 Benedict Cumberbatch version is that Cumberbatch does not use his English accent which takes away from it. It takes away from Cumberbatch, who is a wonderful actor. The animation is fine. There is a lot of gags added that is not really needed a give no dimension to the Who's, especially Little Cindy Lou Who, who is turned into "a supergirl" who jumps around doing crazy stunts.

This version is okay with beautiful colors that make you feel like Christmas, but there was no real reason for its existence. There is a rap version of "You're A Mean One, Mr. Grinch," sung by Tyler, the Creator.

I think there are good things in both animated versions, but the original version by the great animator Chuck Jones is the one to go for. Chuck Jones brought back the Grinch into other sequels or prequels: "Halloween is Grinch Night" and "The Grinch Grinches the Cat in the Hat."

# Pallone Leads Call for Adequate Health and Safety Protections for Laundry Workers in Perth Amboy

Press Release 12/1/20 LONG BRANCH, NJ - Congressman Frank Pallone, Jr. (NJ-06), Senator Joseph Vitale, Speaker Craig Coughlin, and Assemblywoman Yvonne Lopez today sent a letter to Unitex/ Med-Apparel Services, Inc. demanding that the company uphold safety standards to protect workers during the COVID-19 pandemic. The workers clean linens for hospitals in New Jersev and New York. The workers held a rally on September 29 to demand stronger protections during the pandemic and went on strike on November 18 and 19 to protest the company's alleged unfair labor practices.

"We write with concern regarding reports on the lack of adequate health and safety protections for essential workers at your Perth Amboy, New Jersey, facility. We are also troubled by reports that Med-Apparel Services, Inc. and its parent company, Unitex, are attempting to use workers' pension funds as a bargaining chip before the company will give its employees the modest wage increases it has proposed, and that Unitex/Med-

Apparel flatly refuses to commit to implementing COVID-19 safety reforms. We urge you to immediately return to goodfaith negotiations with these workers and their union and to uphold critical COVID-19 safety standards in your Perth Amboy facility," the lawmakers

"We're grateful for the support from Congressman Pallone in this important fight for justice for essential workers. Our members are essential laundry workers, and they have stepped up during the COVID-19 pandemic, facing significant health risks to keep many New Jersey hospitals and nursing homes safe. These brave and dedicated workers will not accept intimidation, illegal threats, or unreasonable concessions from Unitex," said Alberto Arroyo, Co-Manager of the Laundry, Distribution, and Food Service Joint Board, Workers United/ SEIU, and a top union official negotiating on behalf of the Perth Amboy Unitex employees. "It's time for Unitex, a wealthy corporation, to deliver the fair new union contract our members have earned. For us and our members, a fair new union contract must include COVID-19 protections, modest wage increases, and continuation of pension benefits for current and future employees."

"We're glad to have Congressman Pallone on our side as we fight for a fair new union contract. We're essential workers and we deserve to be treated much better by our employer Unitex. I have dedicated years of my life to this job. It's hard work cleaning and processing gowns, sheets, and other linens for hospitals and nursing homes in New Jersey," Brígida Vidal, a worker at the Perth Amboy facility said. "But I am proud to help keep many of New Jersey's health care facilities clean and safe every day, especially during the COVID-19 pandemic. Over the years, my co-workers and I have helped Unitex become a very wealthy and successful company. But instead of treating us fairly, Unitex recently forced us to strike after they illegally threatened us and tried to intimidate us into accepting a bad contract. We won't stop fighting until we win the fair new union contract we deserve."

# World War II - 75 Years Ago

On December 14, 1945, the Truman Administration intervenes in the Chinese Civil War by dispatching General of the Army George C. Marshall to China to negotiate a truce between the Nationalists and the Communist Chinese.

The United Nations announces on December 15 that its permanent headquarters is to be located in the U.S. In the Netherlands East Indies, the almost-two-month-long Battle of Ambarawa, in central Java, ends in a victory for the newly formed Indonesian Army as the British are forced to retreat to Semarang, some 10 miles to the north.

In Tokyo on December 16, Gen. of the Army Douglas MacArthur, Supreme Commander for the Allied Powers, orders the end of Shinto as the official religion of Japan. Former Japanese prime minister Fumimaro Konoe, central to transforming Japan into a totalitarian state in the 1930s and suspected of possible war crimes, commits suicide in his home by swallowing poison. The Sinclair Oil Co. ends a long wage dispute when it grants an 18% pay raise and a 40-hour work week to members of the Oil Workers International union.

The Senate on December 17 votes for the U.S. to assist in establishing a Jewish homeland in Palestine. In Japan, voting laws are amended to permit women to cast ballots.

In the U.K. on December 18, the House of Lords dismisses William Joyce's appeal against his sentence of death for high treason. Joyce, as "Lord Haw Haw," had broadcast Nazi propaganda over the radio from Berlin.

Eleanor Roosevelt, widow of the late president, on December 19 is appointed as one of the first U.S. delegates to the United Nations. The Swiss parliament passes a law allowing for the immediate expulsion from the country of any foreigner holding pro-Nazi or fascist views.

In Italy, on December 20, Edda Mussolini Ciano — *Il Duce's* daughter and the widow of Italian foreign minister, Count Galeazzo Ciano (executed for treason in January 1944 because he had voted to remove Mussolini from power in July 1943) — is sentenced to two years in prison for aiding Fascism. Rationing of automobile and truck tires ends in the U.S. In the Soviet Union, seven Germans are hung in Smolensk for crimes against Soviet citizens, including murder and rape; three others charged are sentenced to long terms of forced labor. Over 50,000 Smolensk residents gather to watch the executions.

George S. Patton dies in his sleep in a hospital in Heidelberg, Germany, from a combination of fluid in his lungs and congestive heart failure. Karl Renner becomes the first president of a reconstituted Austria.

Both the United Kingdom and the United States on December 22 officially recognize the government of the Socialist Federal Republic of Yugoslavia, headed by Josip Broz Tito.

From Vatican City, Pope Pius XII on December 23 publishes an encyclical — Orientales omnes Ecclesias ("All the Eastern Churches") — to the faithful of the Ukrainian Greek Catholic and the Ruthenian Greek Catholic Churches, commemorating their 350 years of union with Rome. After the war, many members of these churches have come under the rule of the Soviet Union, which is exerting pressure for church members to forsake Rome, abandon their church and join the Russian Orthodox Church (controlled by Moscow). In the document, the Pontiff writes: "We know that grievous snares are being set for your faith. There seems ground for fear that in the near future still greater hardships will befall those who refuse to betray their sacred religious allegiance." (In fact, between 1945 and 1958, six Ruthenian bishops are murdered, sentenced to death or die in prison camps. In 1946, after continued persecution, the Ruthenian church is folded into the Russian Orthodox Church.)

On December 24, the remains of Gen. George S. Patton are laid to rest in the Luxembourg American Cemetery and Memorial in Luxembourg City, Luxembourg.

On Guam on December 25, Rear Adm. Shigematsu Sakaibara of the Imperial Japanese Navy is sentenced by a military tribunal to death by hanging for ordering the execution on October 7, 1943, of 98 American civilians on Wake Island.

Adm. Chen Shaokuan is relieved as supreme commander of the (Nationalist) Republic of China Navy on December 26. Ordered by Chiang Kai-shek to attack Communist positions in Shantung Province, Chen refuses, stating that the navy had not recovered sufficiently from the war with Japan. The Gaoyou-Shaobo campaign in China ends in a Communist victory after a week of fighting. The Nationalist forces lose 80 artillery pieces, over 6,000 small arms and suffer over 4,000 casualties.

The Moscow Conference of Foreign Ministers takes place on December 27. Representatives of the "Big Three" powers — the U.K., the U.S. and the U.S.S.R. — meet and make some far-reaching decisions. Among them: international control of atomic energy; creation of a Far Eastern Commission and Allied Council for Japan; withdrawal of foreign troops from China; and an independent Korea within five years. As to the latter, despite the demands of many Koreans for immediate independence, the Allies agree to a four-part trusteeship (the Big Three plus the Republic of China) that over time will work out the governmental details of a unified and independent Korea. In the meantime, the Soviet Union will administer the nation north of the 38th Parallel, and the U.S. will administer south of it. Terrorist attacks are carried out against British military bases in Palestine, including a police station in Jaffa and an ammunition dump in Tel Aviv. In Washington, D.C., the International Monetary Fund (IMF) begins its official existence. First formed at the Bretton Woods Conference in 1944, the IMF has 29 member countries. The organization's goal is the rebuilding of the international payments system.

On December 28, 1945, in Washington, D.C., President Truman signs into law the War Brides Act that exempts spouses and natural and adopted children of U.S. military service personnel from the immigration quotas and mental and health standards currently in force. A spokesman for the United Nations says that the organization will choose a site "in the general area" of either Boston or New York City for its permanent headquarters.

Koreans in Seoul attack U.S. soldiers on December 29 to protest the decision made at the Foreign Ministers' Conference in Moscow on December 27 to wait for as long as five years before reinstating Korean independence. In the Soviet Union, the Politburo on December 29 approves Lavrenty Beria's request to be dismissed as the head of the NKVD, the interior ministry, responsible for law enforcement and secret-police activities. (The "dismissal" is to allow him to focus on his secret new role in leading atomic-weapons research. Sergei Kruglov is named to replace Beria as head of the Soviet Internal Affairs Ministry (MVD), the re-named NKVD.) In Paris, the government announces that all air transport will be taken over by the state-owned airline, Air France.

Friedrich Gustav Bernhard, a German Lt. Gen. of Cavalry and Panzer commander, captured by the Red Army, is tried on December 30 by a Soviet military tribunal and found guilty of atrocities and war crimes in the Bryansk region of Russia, about 360 miles southwest of Moscow. He is hanged the same day. In the Netherlands East Indies, 2,600 U.S.-trained Dutch troops land at Batavia, Java, to reimpose colonial rule.

In the U.K., the British Home Guard is disbanded on December 31. Chiang Kai-shek announces his conditional acceptance of a Chinese Communist offer of a ceasefire in the Chinese Civil War. In Washington, D.C., the Marine Corps reports that, as of December 31, there are about 46,000 U.S. Marines stationed in northern China.

In Tokyo, Emperor Hirohito issues a proclamation on January 1, 1946, requiring that his subjects refrain from: believing that he is descended from divinity and the notion that they are superior to other races and destined to rule the world. The United Kingdom, India, and Thailand sign a treaty of peace in Singapore. In the U.K., London Airport (later renamed Heathrow Airport) opens to serve civilian air traffic. The results of the December elections for the Central Legislative Assembly for India are announced: the Indian National Congress wins half of the contested seats, while the Muslim League wins all seats reserved for Muslims.

King Zog I of Albania formally abdicates his throne on January 2. General strikes protesting French rule take place in Damascus, Syria, and Beirut, Lebanon. The U.S. Army partially lifts its ban against soldiers marrying enemy nationals, allowing GIs to wed Austrian women. (The prohibition against marriage to Germans continues.)

The Polish government on January 3 nationalizes all industries with over 50 workers and all businesses formerly owned by Germans. In London, William Joyce, who had broadcast Nazi propaganda over German radio during the war as "Lord Haw Haw," is hanged for treason.




