Land Swap Between City & Board of Education Discussed

10/7/19 Caucus

PERTH AMBOY - Director of Human Services and Recreation Ken Ortiz appeared at the council to discuss why the land swap between the city and the Board of Education is vital. Ortiz stated, "The proposed land swap exchange started in 2013 after a study was done to address key items such as open space and park land. Most athletic fields are in the northern part of the city. We need to address our open space land. 25% of our city's households do not own a car. Compared to other cities, we have a significant lack of parks and open spaces. Many of the most densely parts of the city have the least amount of parks. We have a deficit of 30 playgrounds. There were many suggestions from focus groups. An organization called Kaboom has helped build playgrounds around this city. Dalton Park just added 2 basketball courts. A kayak storage was placed on Sadowski Parkway and we are

getting a ton of activity from out-of-towners who use the kayak ramp. This is an opportunity to generate revenue in renting and storing kayaks. Also added on Sadowski Parkway were water fountains and a shower and a recreation facility. I can get more details about these facilities that were installed during a holiday. The Middlesex County Park located on Washington Street has an expected completion date by the end of 2020. Second Street Park has 6 acres (to build on). The Raritan River Park which is located by the Victory Bridge will have a large ballpark, a riverwalk, and a fishing pier. Washington Park is in total disrepair. Over 200 kids started their own softball leagues and they do their own officiating. We're trying to patch up (the field) so the storm water doesn't cause flooding. We'll have to install more synthetic grass. We'll expand our parks quite a bit, but we need to generate revenue, so we don't have to use city funding to maintain the parks. We have to follow the criteria from Green Acres and the NJDEP. We're looking to do an exchange of property with the Board of Education involving the Seaman Street lot, Lucey Center, the New Brunswick Avenue parking lot and Flynn School. With the Seaman Street lot, elevated levels of lead and arsenic were found and that's why Kaboom rejected that area for a playground. The state said to remove the contaminants or cap it. Some contaminants (on the Seaman Street lot) were just 6 inches below the surface. Kids like to dig, and 6 inches is nothing, and they can easily be exposed to contaminants. The Lucey Center (on William Street) has .69 acres, but there is a lot of vandalism that goes on there, and there is only one way to go in and out. With the Board of Education property, they have 1.5 acres located on the corner

Tensions Continue, But Not as High 10/9/19 Council Meeting

PERTH AMBOY – During the first public comments, resident Stanley Sierakowski came up to question R-445-10/19 – A contract with D&H Alternative Risk Solutions of Newton New Jersey for Risk Management, Third Party Administrative Services, Managed Medical Care and PPO Access Administration and Safety Training for a 3 year period commencing January 1, 2020 thru December 31, 2022 for an amount not to exceed \$255,000 per year.

Council President Bill Petrick stated, "This is a company who gave us a \$2 million check (At a previous meeting, a representative from this company came up to explain how they had gone to court on some cases, such as when an employee went out on maternity leave and was paid during that time and she never came back to work. They were able to go to court to recoup some of that money.)"

Sierakowski then questioned R-440-10/19 – Professional services with Center State Engineering for preparations of a preapplication for Green Acres Land Diversion – Board of Education Land Swap (175 Seaman Ave.) in an amount not to exceed \$7,500.

Sierakowski stated, "The city can't use this land because of the contaminants. Donate it to the Board of Education for a parking lot. It can't be used for anything else." He then talked about the lot on the corner of New Brunswick Avenue and East Avenue. "The city probably wants it for housing."

Council President William Petrick responded, "We proposed to use that lot for a park."

Sierakowski retorted back, "You might not even be here next year."

Petrick responded back, "I will be here."

Sierakowski added, "It's a great location for a condo."

Resident Ken Balut came up next. He talked about R-453 – Authorizing submission of an application to the Middlesex County Department of Community Services for the Code Blue Warming Center Funding Opportunity. Balut referenced, "What's going to happen when the hospital changes to a psychiatric hospital?" He then pivoted over to R-450-10/19 – Authorizing the city to execute a contract with the Raritan Bay Area YMCA – Center for Support, Success, and Prosperity in the amount \$15,000 (which is a CDBG Grant).

"The Y owes us over \$2 million. The CEO and employees get a lot of benefits. You should see how much money they get. It's up to the council to do a complaint and investigate this. The same employee who had gotten a house through a CDBG Grant is now buying another house."

Law Director Peter King responded, "The Jewish Renaissance is a private entity."

Resident Stanley Sierakowski shouted out from the audience, "The council should go to the attorney general to investigate this."

Petrick then questioned,

Councilwoman Zusette Dato spoke up, "I trust the Planning Board's decisions."

Reilly also had a question regarding Resolution 156-2019: SARA (South Amboy Redevelopment Agency) appointment. "I want to make sure that everyone is okay with Camille Tooker's appointment. Did other people apply?"

Council President Mickey Gross stated, "Camille (Tooker) has done a great job in the past on this board and will continue to do so."

Councilwoman Zusette Dato added, "Camille was nominated and approved to be on this board."

Gross and Mayor Fred Henry both stated, "It's a vote to reappoint Camille Tooker to SARA. Henry then clarified, "Tooker's term was up (which made reappointment necessary)."

Reilly then questioned the property at the corner of lower

John Street and Roswell Street. "Superstorm Sandy happened 7 years ago. My concerns would be rescinding Resolution 141-2015."

Skarzynski responded, "People didn't know about the closing date to rebuild after Superstorm Sandy and what could be built (after the storm)."

Reilly responded, "I talked to Tom Kelly (Building Inspector) who stated that site needs to be cleaned up."

Dato said, "I think 7 years is sufficient (for that spot to have been cleaned up)."

Mayor Henry added, "There's a cleanup pending."

Gross then added, "That particular location may be grandfathered in."

Law Director Francis Womack stated that he will look to see if orders are pending on this property (John and Rosewell).

B.A. Glenn Skarzynski gave an overview of Business Item g.) A resolution purchasing a 2-ton asphalt hot patch trailer. "This will enable us to do hot patches which will create smoother and longer lasting street surfaces."

Skarzynski then discussed the Best Practices results: "Our information was sent into the Department of Consumer Affairs and we should have our results no later than October 3, 2019."

Councilman Reilly then questioned Item No. j.) Resolution

authorizing a tax lien for maintenance performed at 356 Ward Ave. "Are there monthly fees for a late payment?"

B.A. Skarzynski answered, "There is a lien on the property if they were in default. Decisions are made on a case by case basis."

Reilly then questioned, "Are there any considerations if a person is a senior?"

Skarzynski added, "We may extend (extra courtesy) if a person is caught between a rock and a hard place."

There also was a discussion regarding Business item No. h.) A resolution authorizing a sewer payment installment plan.

Councilwoman Dato said, "It sounds like there may be a glitch in the utility system."

Skarzynski responded, "There has been miscommunication with the water utility since we no longer do the billing. We have a lien on the property that we had to do a cleanup for. The cleanups are discretionary."

Reilly then questioned Business Item No. l.) An alleyway clearing. "Residents have been complaining about the number of people who speed in that alleyway. "Maybe we can look into placing a speed limit sign or installing speed bumps."

Skarzynski said, "We can look into this."

There was a lengthy discussion regarding Business Item No. m.) The Broadway Festival.

Reilly spoke up and explained there were mixed feelings about the Arts Festival, "Some businesses said that the Arts Festival helped them, while some said it actually hurt them. Some of the bars were not happy."

Council President Gross spoke next, "I heard both positive and negative from the bars. You have to do what's right and best. You can't win that argument."

Council Vice President Christine Noble thought it was a great event. "I think there was one specific tavern who had a problem."

Gross then requested that the Council make suggestions.

Dato was the first to respond, "We should survey the business owners. Any traffic coming into town is good, but we also have limited parking."

Gross spoke again, "Camille Tooker is the one suggested having limited food vendors."

Mayor Henry felt that the people who complained should make suggestions.

Reilly said, "We tried helping the businesses on Broadway. Surveying those businesses is a good idea. We've tried to engage our businesses in the past, but we've gotten poor responses. We used to have a Waterfront Festival."

Gross then added, "One business actually complained about having the fireworks because it brought too much traffic into the city."

Mayor Henry then stated, "If the festival helps most businesses, it's important. Maybe the bars should have half price sales during these events."

After that discussion, Reilly asked if the county can do fire inspections in town.

B.A. Skarzynski answered, "I don't think so, but I can give them a call."

Council Comments:

Vice President Christine Noble congratulated The Friends of the South Amboy for recent events they sponsored throughout the city.

Councilwoman Zusette Dato was delighted that Assemblyman and current Assembly Speaker Craig Coughlin came to the council meeting tonight to present a check to two food pantries (the Presbyterian Church had 2 employees present. There also was a check for St. Mary's Food Pantry to be given to them later because no one was present.) These checks were part of the proceeds from the Bowling for Hunger event.

Dato also congratulated the Artsfest Committee for the work they did on the Festival. "It was a great day."

Councilman Reilly stated, "The Friends of South Amboy raised a lot of money and their next event will be held sometime in December." Reilly was also concerned about a fire haz-

ard (piles of pallets near the old St. Mary's School).

B.A. Skarzynski responded, "Someone is running an illegal business near there. Summons were issued and we're trying to get the owner to court."

Gross spoke up, "This business is blatantly violating the law"

Law Director Womack then said, "The city will send another notice to the owners."

Reilly then questioned why emails he had sent to B.A. Glenn Skarzynski were unanswered.

Skarznynski responded, "Some of the issues may be something that should be taken care of by the City Clerk."

Gross came to Skarzynski's defense, "Glenn is bombarded with e-mails and I'm guilty of doing that myself. I also call Glenn a lot."

Reilly continued, "I see Glenn responding to e-mails that were sent after mine."

Gross spoke next. He also complimented the Art Society. He urged everyone to see the upcoming Holocaust Remembrance event to take place. "There will also be an event discussing opioid abuse. My hats off to Kathy Kudelkak who is part of the South Amboy Alliance who helps put these programs together. She is part of the Municipal Alliance."


B.A. Glenn Skarzynski stated, "The DPW received new uniforms and the mechanics were able to rehabilitate some of the older vehicles. Some of the pews and some 50 chairs are to be replaced in city hall. The Municipal Alliance will also have dances, movies, and an upcoming Trunk or Treat for the kids. There will be a delivery for bicycle racks and the cost will be picked up by the Board of Education."

City Engineer Mark Rasimowicz said, "There will be milling and paving on Pine Street. There was a blockage that was caused by a hairbrush on the pump station on Raritan Street which is an old system. The DPW and Sewer Team reacted quickly and there was no backup in the homes in that area. We are looking to do upgrades to the pump system."

Mayor Fred Henry spoke last. He began by thanking the Public Works Department and the Arts Council for all the work that they've done. He also mentioned the upcoming Holocaust exhibit and citywide yard sale (weekend of 10/5-6/19). "The Public Works Department has new hirees and have acquired new equipment." He then spoke about the Historical Society and their cooperation with the School System and the YMCA. He thanked SARA who paid for the new digital signs by the high school. "There have been beach cleanups, but there are still things that need to be cleaned up, but Glenn is a go-getter. We always thank the Council for supporting us."

Councilman Brian McLaughlin was absent from the meeting.

Tensions Continue, But Not as High

"When the YMCA collects fees, should some of the money they collect go to paying the city what they owe. Is the Y cooperating with the auditor?"

Business Administrator Frederick Carr stated, "The Council can decide not to award the money (allocated to Center for Support, Success, and Prosperity) and can roll it over to the Department of Recreation.

After the public portion was closed, there was a vote on the ordinances. Ordinance No. 1 An ordinance to amend an ordinance entitled, "Vehicles and Traffic" re: parking prohibited on Andrews Drive and Wagner

When it came time to vote: Council Members Joel Pabon and Milady Tejeda both voted: "No" for Andrews Drive, but "Yes" for Wagner. Pabon said that they need to address the issues related to the Heat Club (local bar). The other Council Members all voted "Yes" to everything.

City Engineer Jeff Rauch came forward to give more detailed information, "The Zoning and Planning Boards were not involved in this. Code Enforcement is the one who has to deal with the problems associated with parking for this club. They are the ones who have to investigate this."

When it came to vote for Resolutions, R-428 thru R-449 and R-452 thru R-453 was moved by Councilman Fernando Irizarry and seconded by Councilman Joel Pabon. R-450 was asked to be pulled to be voted on separately by Councilman Fernando Irizarry. Councilwoman Milady Tejeda asked for R-451 - A contract with the Jewish Renaissance Foundation Alternative Education Institute in the amount of \$15,000 (CDBG Grant) to be voted on separately.

R-450 was moved by Councilman Irizarry and seconded by Councilman Joel Pabon. When to vote, everyone voted "Yes" except for Irizarry who voted "No." For R-451, Councilwoman Teieda said they needed to table this because many people have come here to talk about concerns about the Jewish Renaissance giving houses to people who they felt were not entitled to or did not meet the criteria to qualify for those

B.A. Carr wanted to clarify R-450. "This is not for the YMCA which is part of the Public Safety Complex. It's only for the property located on Smith Street."

During the second public portion, Stanley Sierakowski came up first and told the council they must have oversight (when granting the CDBG monies). "You should know that person's income that is requesting the money, and who will benefit from the grant." Sierakowski then asked, "Did the council win or lose the case dissolving PARA? And if you did lose the case, what reasons were given, and did you have a recourse?"

Council President Petrick responded, "We're waiting for the minutes to come out."

Resident Ken Balut came up,

"Go to Long Branch to see the units that Kushner built there. The DeCotiis Law Firm is filing a lawsuit against the city regarding the Kushner properties. There was a person who owned a Kushner property who had a laundry unit in it which was not even big enough to put in washer and a dryer. No firestops were put in. After Arlene Quinones Perez left, she said the Mayor gave her power to negotiate for the city with Kushner. An owner of a unit at the Kushner property in Perth Amboy voted by phone (at the special PARA meeting) to approve a new 600-unit Kushner project. There was no quorum for that meeting. There will be an impact on the schools and traffic. These people (the Kushners) are criminals. The apartments are garbage. Why are we bending over backwards for Kushner? We are lower than Asbury Park and Long Branch if you allow this. Our City Engineer did not even know the old naval building was knocked down. The Engineer did not know about the lights (on the walkway near the Landings associated with that building) were out. This is incompetency.'

Police Chief Roman McKeon came up next and addressed Council President Petrick, "You (the council) and the Mayor do not support each other. Now, the police have been victimized. Since I was promoted to Chief, I have been criticized, and have been under a microscope. I know a lot of people have not been happy with my promotion. I found the e-mail from Council President Petrick to be offensive. He implies that I don't know what I am doing." He then continued to address Petrick. "You question our detectives and how we do investigations. We need unity, togetherness, and to work as a team. The people love this city. You need to get politics out of this, and you need to respect me as I respect you. The police are in the crossfire." He then went on to explain how a robbery took place in one of the stores in downtown Smith Street. "The police were able to get fingerprints off of a bag of potato chips which enabled us capture the robber. You can pull all the reports of all the incidents I'm telling you about."

Petrick responded, "I addressed issues from the public. Sometimes they come to us with their concerns instead of the police."

McKeon responded, "There is no such thing as a secret in Perth Amboy."

Petrick then continued, "A former B.A. said that Department Heads don't have to respond to the council. People complained that there is not enough police presence downtown."

McKeon added, "We are down 30 officers." McKeon continued, "There are not enough officers to back up an officer who may need additional assistance. There was an instance where we were looking for 2 missing kids near the YMCA. At the same time, there was activity being investigated on the other side of town. Our Narcotics Division went from 7 to 3 officers. Our Community Officers went from 6 to 2. The Traffic Division went from 6 personnel to 3. Whenever a Crossing Guard is absent, we have to have someone from the Traffic Division to cover for them." McKeon went on to explain, "The police made arrest where they confiscated over \$15,000 in drugs. Supervisors are working overtime and getting burnt out. I know we have to have more police who have their feet on the ground. There were 132 police officers under the Joe Vas administration. Now, there are 110. We are struggling to keep the substation (on Madison Avenue) open, but sometimes we don't have the manpower to open it. I will take the heat. Between September 2018 to September 2019 violent crime went down 17%. I appreciate the 5 new officers that were given to us. I don't like to share e-mails like this. Our police department was recognized by the state. We don't always need to have negative rhetoric, but we need to know you'll have our back. I know you support us."

Petrick then asked McKeon, "In the case of the missing children, did you ask for help from the Fire Department?"

McKeon answered no.

Petrick said, "You should have utilized them.'

McKeon explained, "In the case of the missing children, (who were at the YMCA) – they live on the other side of the tracks that are not active, and they decided to walk home. Just ask me, and I will give you the truth. I don't tell you how to run your job. Don't tell me how to run mine. I've been doing this for 30 years. You can talk about me, but support my officers."

Resident Alan Silber came up. As he started to talk, Chief McKeon was leaving the council chambers. Silber remarked, "I thought the chief would still be here (until the end of the meeting). McKeon came back and sat down to hear what Silber had to say. Silber remarked, "I can't believe all the police officers that are here at this meeting. At the last meeting (9/25/19), there was only one officer and there was a large intimidating crowd. If the chief had been notified about their permit (protesting outside of city hall and the council chambers) to have all those people there at the last meeting, then there should have been more officers here." At that point, McKeon got up and left the meeting.

Silber then questioned the council, "What will happen when we have more buildings come into the city? The special PARA meeting was advertised on Saturday, but nothing was posted on the bulletin board (by the City Clerk's Office). What was the emergency (calling for a special PARA Meeting)? It (the topics) should have been discussed on the same day as the regular PARA Meeting.

Resident Sharon Hubberman came up to speak next, "The tides have turned." She then talked about people who own private companies and don't clean up their garbage. "This also tells you about the leadership (in our city). The last meeting was a lack of leadership. The council supported the police, the DPW, and the fire departments when it came to the

budget. There was a directive that the council could not contact the department heads. We had contaminated water which caused resentment. We have 3 contaminated wells and multiple levels of certain contaminants. How is my statement causing indignation? What I share with you is from my heart and for the people."

Former President of the Library Board of Trustees Barbara Sottilaro came up to speak next. She thanked the council for getting the work down paving Gornik Drive. "There still some streets in that area that need paving." She also thanked the council for keeping the taxes lower. "I'm appalled at the mayor's actions and her attack on Joel Pabon." Sottilaro was concerned that the Perth Amboy Library has an interim Library Director for the past 11 months. "He is a nice man, but he's not qualified for the job. We need a certified Library Director."

B.A. Carr responded, "We only got one person who is qualified, but they live in California."

Barbara Sottilaro suggested, "We should go to Rutgers."

Carr responded, "We have not gotten a response from them."

Council President Petrick then asked, "Are there statewide searches?'

Sottilaro answered, "There are many social medial sites (where the city can advertise for a Library Director)."

Carr responded, "I have put searches on them all. If you can find a director, let me know."

Petrick then said, "I heard they need 2 positions in the library: a Library Director and another employee."

Sottilaro said, "The only position open is for Library Director."

Petrick said, "Eleni (Glykis the Former Library Director) was very innovative, but we lost

Sottilaro concluded, "A lot of times, the Library Board of Trustees don't have quorum when the meet, and sometimes people will phone in to the meetings."

Resident Reinaldo Aviles came up to speak and addressed the situation with finding a Library Director, "I don't know if you would get a qualified person. People know that Eleni was pushed out, and that she had a lack of support." He then went on to talk about the special PARA meeting. "Under certain circumstances, you (a member of a municipal board) can phone into a meeting. With a special meeting, there has to be 48 hours prior notice before the meeting. The Mayor said it was a special meeting. If it was not posted, then the meeting was null and void."

Council Comments:

Councilman Helmin Caba said, "I was accused of not picking up my budget binder. Unless there was a new binder (that was made up), then this was the only budget given to the council. The Mayor's Aide at the time accused me of not picking up the budget. I had the budget at the time she said I didn't. Someone at the last meeting (9/25/19) said that no councils anywhere in the state did defunding of titles. It was done here in the past. The

term was then called: "phased out". I was accused of not being a true Latino. We gave everyone at that last meeting their 5 minutes, but not for us to be shouted at. I'm for protesting, but do it respectfully. There was a preprotest with the same group of people. They were shouting a phrase: "White men out!" That is reverse discrimination. That should not have a place in Perth Amboy. Race, nationality, and gender should not matter. Everyone is quick to throw out those terms (to cry discrimination). We need to get over it." Caba then addressed what happened in 2016, "I was at your (the Mayor's) campaign headquarters. Your (the Mayor's) people showed me a selected few of Petrick's posts on his Facebook. I look at Petrick's Facebook and he reposted things from Hilary Clinton, Bernie Sanders, moderate conservative – all different views and current events, but he did not comment on the posts. They were cherry picked. The Mayor tried to say I was quiet about the posts (in 2016). If it was only posts from one party, then I would have protested. Let's not mud things up. Go through Petrick's Facebook to see for yourself. Saying "White men out!" has no place in our city. I know the police feel they are underpaid and unappreciated. The morale is down, but not because of the council."

Councilman Fernando Irizarry had no comments.

Councilman Joel Pabon said, 'Many of us have been in charge of people. I have in my job and in the military. My biggest concern is that nobody talks to the police officers before they leave. After 4-5 years, the police get a substantial pay raise. I urge McKeon to sit down with the officers and let them know they should hang in there. McKeon has to question how he can stop the bleeding. It's not us."

Councilwoman Milady Tejeda said, "Some people complain about nonessential people (being defunded). They should picket about needing more police. They advocated for defunded positions, but not for our police. The administration is there day to day. We used to get a lot of briefings about what's going on in the city, but it stopped. Citizens question us about things that happen in the city that we don't know about. If 600 units are built (by Kushner), what school will those kids go to that live in those buildings? I will never vote "Yes" to another apartment building going up."

Council President Bill Petrick said, "I appreciate all those who spoke, and I appreciated what Chief McKeon said, but the buck stops with him. I have relatives in the police department here and in other towns. If there's a morale problem in the police department, then McKeon should look within. I asked Mr. Carr to work with Barbara (Sottilaro) to find a new Library Director. We had an innovative young woman who was driven out and suspended because she spoke the truth. Many individuals left the town because of all the negativity."

Land Swap Between City & Board of Discussed

of New Brunswick Avenue and East Avenue. Regarding the lot at Flynn School – we never took ownership of the property, although we maintain it. Of the 1.5 acres (New Brunswick Avenue and East Avenue), the Board of Education wants to put a preschool on it. There's a lack of parking and would be an even more increase of traffic. We're going back to the Board of Education to see if we can make a swap for this land. We don't have money for the remediation of the Seaman Street land. We can swap the Flynn School park for the Seaman Street park. It's giving up clean property at Flynn for the contaminated property at Seaman. It's a 2 for 1 swap.'

After the presentation, Business Administrator Frederick Carr talked about the Best Practices inventory for the calendar year 2019. "We were able to correct the deficiencies early. We have 43 right answers. Only 30 right answers are required. Because of this, state aid is not needed."

City Engineer Jeff Rauch came up to explain R-429: Authorizing execution of a professional services agreement with Center State Engineering for oversight services required for the replacement of the Fayette Street Bridge from start of engineering design to final construction in an amount not to exceed \$50,000.

"We have to review the status, make recommendations and do the invoicing which will involve several city departments. NJ Transit and the NJDOT will make the final sign-off. The bridge will be demolished completely and replaced. There will be pre-manufactured sections will replace the old sections during certain times when rebuilding the bridge."

Ken Ortiz came up to talk about R-453-10/19 - Authorizing submission of an application to the Middlesex County Department of Community Services for the Code Blue Warming Center Funding Opportunity. Ortiz explained, "This is to reimburse us for running the program or if we have to contract a third party to do so. We and the city of New Brunswick are Tier 1 status. We're eligible to get up to \$25,000 in reimbursements. We have to follow the Code Blue criteria. Every municipality should have a Code Blue Shelter."

Councilman Fernando Irizarry spoke up, "I heard a rumor that people from other cities are dropped off here."

Business Administrator Frederick Carr spoke up, "It's not a rumor"

Councilman Joel Pabon questioned, "Can we get more than \$25,000 since we get a lot of people coming in here?"

Ortiz replied, "That cost is set. The county provides cots, bedding, food, and linens. City buildings are used. We can use the Prosperity Center (on Smith Street) to send people to sleep overnight. I'm asking the council if you want a storefront where people can stay overnight? In our building, we separate people who are homeless from families who just lost heat. There are a lot of moving parts."

Irizarry said, "We are always on the losing end. You are telling me there are not 10 homeless people in Woodbridge? We are being abused."

Ortiz responded, "We fight to get more restrictions (on people coming from out of town for assistance). When those people contact us, we try to see if they can get assistance in the towns where they live."

Irizarry continued, "I'm not telling you that I'm against the homeless, but we are being taken advantage of."

During the public portion, resident Maria Garcia came up first. She asked a series of questions and wanted a response after she asked them, "Was the Mayor involved in preparing the budget? What was the shortfall in the budget? What departments did you (the council) make cuts in?"

Carr responded, "The Mayor was involved in the budget. The shortfall was \$7.3 million. Initially, the increase in taxes was 5.4% and then presented to the

council at 3.7%. The council made cuts, layoffs, and reductions. Programs got cut. There are no cuts in the staff. There were positions that were defunded. Only the Mayor can layoff or fire employees. Employees were transferred or are still working in their same departments."

Resident Stanley Sierakowski came up next. He referenced R-447-10/19 thru R-452-10/19 (dealing wit the CDBG Grants). "I remember when a woman came here to try to get a grant to restore a private historic home. Have people come here to explain their needs and what they intend to do with the grant." He also asked, "What is the status of PARA being dissolved? There was an emergency PARA meeting held without a quorum. You don't have the power to dissolve PARA. The meeting was held at 10:00 a.m. One of the PARA members had recused himself for 10 years when it came to the Kushner properties because his wife owned one of the units. For this PARA special meeting, he phoned in and voted "Yes" on all agenda items. It was an invalid meeting. They approved the 600 units (that Kushner wants to build).'

Law Director Peter King responded, "The council can make an application with the DCA to dissolve PARA. PARA said they sent information to the DCA on why they should remain intact (because they are still in nego-

tiations with a lot of contracts)."

Resident Ken Balut came up to speak about some of the rising legal fees on some cases being litigated, "The Batista fees are already up to \$150,000." He also said for R-450 - CDBG Grant for the YMCA: Center for Support, Success & Prosperity in the amount of \$15,000. And R-451 - CDBG Grant for the Jewish Renaissance Foundation Alternative Education Institute in the amount of \$15,000. "We should not give the Y a penny. With the Jewish Renaissance, people were given houses that they were not qualified for. Was that a poor person who benefited? The lawyer who drew up the contract was one of our judges. You all went on a conference involving the poor. The 10:00 a.m. PARA meeting was a fraud. Jacobs (the PARA member who called in to the meeting) sold the unit to his wife for a dollar. Hindenlang at one time lived at a Kushner unit. That meeting should have been voided. Quinones (former Perth Amboy Law Director) said she was negotiating with the city with Kushner (even after she left the city as Law Director). We are supposed to be sharing the profits with the Y. This has got to stop. Bring it up to the comptroller's office. After I left the council, I wrote a letter with

Perth Amboy to Decide on Runoff Voting System This November

PERTH AMBOY - The candidate that gets the majority of votes wins. That's what most voters expect—but often, that's not the case. The people of Perth Amboy have seen a number of mayoral elections won by less than 50 percent of the vote—sometimes much less. A question on the ballot this fall just might change that.

The November ballot in Perth Amboy will include a referendum question that proposes a switch to a runoff system for municipal elections. If approved by voters, no candidate will take office without at least 50 percent of the vote. If no candidate garners more than 50 percent, a runoff between the top two vote getters would take place.

This "50+1" proposal was approved by the city council earlier this year. This set the process in motion that will place the question before Perth Amboy voters this November.

"The system we have now doesn't necessarily give us the best candidate," says local attorney Allen Papp. He is a member of "Vote YES on the Referendum," a committee formed to support the referendum question. "The problem is, when you have three, four, five candidates, the votes get split and you end up with someone running the city who is representing a minority of the voters, and I don't think that is necessarily a good thing."

Fernando Irizarry, who is a member of the Perth Amboy City Council, organized the committee to inform the public about the ballot question. "I think it's important for us to educate the community on what they are going to see on the ballot in November," Irizarry says. "Most people don't even know there is going to be an important question on the ballot. I want to make sure our community understands what they are going to be voting for."

The runoff election system isn't new to Perth Amboy. The city had this system for a time in the past, but scrapped it several years ago for the current plurality system in which the highest vote getter wins, even if he or she gets only a minority of the votes. Many people believe the present system makes it much easier for incumbents to get reelected, especially when there is more than one opponent.

Supporters of the runoff system admit that a second tier of runoff elections will cost the city more money. So is it worth the additional expenditure in a cash-strapped community like Perth Amboy? "It is," says Lisa Nanton, former city council president and community activist. "The winner will be the person a majority of the people want for mayor, and that's definitely worth the cost."

Papp agrees, and says it's important to put the cost in perspective. "We've got upward of a \$80 million budget. A few thousand dollars is really insignificant when the important thing is who best to govern the city."

The Vote <u>YES</u> on the Referendum Committee, composed of local political leaders and activists, plans an education campaign between now and November. It will get the message out on social media, in print, and even door to door.

Irizarry believes it will be good for the city. "I think we will elect leaders who reflect the will of community."

Volunteer from Catholic Charities, Diocese of Metuchen Assists Migrants at the Border

Press Release 10/9/19

PERTH AMBOY - Erio Rosario-Perales is not your typical student. A graduate student at Rutgers, Erio is a full time employee at Catholic Charities, Diocese of Metuchen with a passion for social justice. Erio originally studied Human Resources Management with a minor in Labor Studies. During his iunior year. Erio took a course for his labor studies minor that would change his life.

A community organization representative visited the class and told her story of enduring an unfathomable journey of immigration that included the experience of sexual abuse. As Erio listened to her tell her story in Spanish, he immediately felt a connection. Erio, himself being Puerto Rican, compared it to his own family's move to the States, not having to deal with immigration proceedings, "When my family came here, we got on a plane and moved here, and that was that."

Erio was so moved he interned at the organization that very summer. The following year, Erio declared a second major in Labor Studies. When the opportunity came up though Catholic Charities, Diocese of Metuchen to volunteer at the Diocese of Laredo to assist with the influx of migrants at their shelter, Erio knew he had to go.

Erio took the trip to volunteer for Catholic Charities of the Diocese of Laredo in June, 2019. They had a small building and a small team. Every week new volunteers came into the shelter. Erio was there for two weeks, and the addition of one more person to a small staff made a big difference.

Catholic Charities of the Diocese of Laredo was tracking who was coming in, what shelter they were going to, what their final destination was, and their travel information. The operation included transportation coordination, provisions of food, water, clothing, and sanitation items so migrants could shower. When migrants were released from detention centers, having been there for a couple of days to about a week, Erio's job was to do intake. Erio said, "I made it my mission to make sure I had a smile on my face and to treat them with dignity, because I was probably the first person who treated them as a human being in a very long

Erio described conditions of the migrants seen at the Laredo Shelter; of people who didn't know where they were going, hadn't showered, who were wearing the same clothes day after day, who had no shoelaces, and of babies with old diapers. Some people were dropped off at a bus stop or at the airport without food in hot conditions that at times reached 112 degrees. These are people who don't speak English and don't know anyone, and who may or may not have any money.

If they were assigned to the Laredo shelter, they would go into another room where another team member would assist them with getting in touch with their families and help to arrange their travel. If there was not room at the Laredo shelter, they were dispersed to other shelters that were working in partnership with the Diocese of Laredo. They had to work quickly each day, as tomorrow would bring an additional 200 people.

ages, pregnant women, single dads with kids, single moms with kids, but very rarely he would see an entire family. So he was especially moved to see a family who thought they would never see each other again be reunited right in front

Erio knows he will have these experiences with him forever and it solidified his desire to work in the field of Immigration. Currently, Erio is pursuing his Masters in Labor Employment Relations and is taking steps toward earning his accreditation in Immigration Services. Ultimately, Erio plans to attend law school to officially pursue becoming an immigration at-

complaints about the Y. There was supposed to be a meeting and the meeting was cancelled. The hospital will be turned into a psych ward. The council gets blamed for everything."

Resident and businessman David Caba came up to speak next. "I look at the disrespect (that was shown at the last council meeting (9/25/19)). I deal with other cities that act very professional, then I see people here disrespecting the council. We even had a bishop who said he had a church on 185 Hall Ave. who tried to get you to change your vote. You got elected to look out for 60,000 people and not just 4 people. This bishop threatened you by saying you will not get reelected. I'm shameful and I have a lot of integrity and I take pride in it. Asbury Park which also has water views is selling their properties for \$5 million. We are putting rental units on the Waterfront."

Resident Alan Silber came up next, "When I heard about the PARA meeting, it was disgraceful. Was there anybody there from the public?"

Carr responded, "I went in (and saw some of the members) and went right out of the room. They threw George (the cameraman) out, so there was no filming of the meeting."


Silber continued, "If you can phone into a meeting, why even bother coming to a meeting?"

Law Director King explained, "Calling in to a meeting is an exception."

Silber then continued, "Why was it an emergency meeting? The mayor has been in office for 11 years and she works for the city. She does not own it. She might own certain people. That meeting (PARA) was shameful." He then referenced homeless people, "When I was driving on Market Street when I was going to the train station to drop off my wife. When I arrived at the train station, I saw people in the waiting room sleeping on the floor and on benches at 10:00 a.m. Also, it's not the council's job to translate for people (who come up and speak in another language). When people watch it on TV, it's as if the council is speaking those words – and not translating for the person speaking." Silber then referenced the bishop spoke in Spanish at the 9/25/19 meeting and Councilman Fernando Irizarry translated the bishop's words into English. "I saw a picture of that bishop whispering in Assemblyman Coughlin's ear. Was he translating for Coughlin?"

The Council adjourned into closed session. Councilman Helmin Caba was not present at the Caucus due to illness.

Update on City Employees Whose Previous Titles were Defunded

Statement Read at September Council Meeting

PERTH AMBOY - Today, 1 October 2019 the defunding resolution passed by the City Council on 9 September 2019 along with the formal adoption of the COPA Budget took effect. This defunding has resulted in the following actions taking place based on the actions of Mayor and City Council.

- 1. Only the Mayor may layoff or fire employees in the City of Perth Amboy. The Mayor has not laid off or fired any additional employees. That is her Statutory authority and it cannot be usurped by the actions of the City Council.
- 2. The Council defunding positions is not a lay off or the removal of an employee. This is just the removal of the money allocated to pay that employee. Therefore:
- **a.** Jeanette Rios Jeanette, previously assigned as the Mayor's aide (defunded position) has been reassigned as Executive Assistant to the BA with duties in the Mayor's Office effective 1 October 2019.
- **b. Noelia Colon** Noelia, previously assigned as the Public Information Officer (defunded position) has taken a position in the BID.
- **c. Ivette Rios** Ivette, assigned to Code Enforcement (defunded position) will continue to work in Code Enforcement as a code enforcement Officer. The budget line item for the Code Enforcement Department has sufficient funding in spite of the defunding by Council action of one position. This funding is sufficient till the end of this fiscal year.
- **d. Lisette Martinez** Lisette, assigned to the Office of Aging (defunded position) will continue to work in the Office of Aging and no personnel are to be transferred from that department.
- e. Mark Cintron Mark, assigned as a Prosecutor in the Courts (defunded position) will continue to work based on the City Council Presidents email indicating that funding will be made available and transferred during a Council meeting in November.

 3. Failure of the City Council to enact budgetary transfers during a Council meeting in November will result in all a budgetary shortfall in Office of Aging and the Department of Law.

We've made financial decisions aligned with district goals. For example, food services had \$250,000 increases in one year. We've been honored as a lighthouse district. We've made innovative progress while striving for academic success. I want to continue to work hard to you towards excellence.

Question: What will you contribute to the Board of Education?

Dr. Danielle Brown: Experience. I've been a teacher. I've been a Board of Education Member here. I have a bachelor's degree in education and a master's degree educational leadership and curriculum development. I have a pulse on the community. I have an opendoor policy with different groups where they share their thoughts and are brought back to the board and heard. We are all working for the greater good not just individual desires

Junior Iglesia: I have a master's degree in childhood education and a bachelor's degree in finance and investment. I am a parent and my 3 young children are attending public schools (in Perth Amboy). I have a lot at stake in the school district. I've been a teacher for over 8 years. Right now, I am a Dual Language teacher in New York. I bring that experience here. We collaborate and work together.

Beth Lieberman: My experience as a classroom teacher has given me a unique experience of student, staff, parents and the community. I have an unwavering commitment to the community. I'm committed to education. I'm a great listener and problem solver.

and problem solver. Justin Ross: I'm a good listener. know how to count and work with others. Kids first, education first, the community - the parents. I traveled and work with kids in San Francisco. I know how to be a problem solver. I've worked with teens who were intense. I taught in South America where I learned Spanish. I will use all those experiences to the Board and will be positive and will complete our objectives as needed. Stanley Sierakowski: I've been described as an assertive person. I do not hesitate to challenge authority. Who, what, where, why, when, and where applicable, how. If elected, I want to be appointed a liaison to the City Council all of who I know personally. I will attend the Redevelopment agency meetings and Planning Board meetings. There was land taken away from you. The land was supposed to be used by you for a school in Harbortown was supposed to be given to you. I want that to be investigated.

Tashi Vasquez: I too have a master's in public administration and a School B.A. Certificate of Eligibility. My passion and dedication to years of the city. I've spent 17 years working here. I am an alumnus of PAHS. This is my home and where I want to continue to serve. I've lived those concerns and I'll continue to serve. It's not just going to a meeting. It's what is going on in the community. I will dedicate my time and my service on the Board with teamwork, dedication and passion.

Question: Two-part question: To the incumbents: How do you plan to improve and rebuild the trust of the community? To all other candidates: How do you plan on establishing a positive reputation and building the community's trust?

Junior Iglesia: Right now, we have the highest graduation rate in our school district. We have been working diligently to have the best education diligently. Because of what we have done, the community trusts us.

Beth Lieberman: Advocacy for programs, implementing funding of maintenance of current buildings, ensure the needs of student and staff are met. As a member of the Board of Education, we have to provide advocacy for direct channels – advocate for our district if it means to go to politicians, if we will.

Justin Ross: Building trust in the community is something I've been doing for the past 2 months. I am dedicated to this community. I want to laud achievements we've had as a district. As a Board Member, I plan to spend every moment to move this district forward. I've knocked on doors as a community member. I've gone to community events. My actions will show what will do for the Board.

Stanley Sierakowski: Rapport and trust. I will promote the needs not only for students, but for parents. For example, gridlock. I would expand the busing program to eliminate 10 cars by transporting 10 students (by bus). For the teachers I would expand the free Parking by the hospital, using eminent domain to condemn land to procure parking and for schools. I plan to attend council meetings, zoning, redevelopment agency meetings to see that needs are met. If you are in the dark without an effective liaison, most people don't know what's going on. We need effective liaisons. Know what's up.

Tashi Vasquez: I'd like to believe I have the trust of the community. When people come up to you in ShopRite and ask the concerns of the community, they trust you. When it comes to trust, I'm there to listen. That's what we have done in this board. That trust is here in the public and the community. We'll get the word out to you.

Dr. Danielle Brown: Trust is not broken. Can it be improved? Yes. Concerns that come to us do not go unnoticed. We are the community. We are Perth Amboy. Truth matters. Improve on that trust. Improve on that relationship. Being transparent and remain being fair on issues that pertain to all of us. We are the community.

Question: Staff members, especially at the elementary level are reported being physically assaulted by students, for instance, being hit, kicked, or bitten. They feel neither their needs nor the child's needs are being met, as a Board Member, how will you address this?

Beth Lieberman: There is a code of conduct that is in place and should be implemented. As a Board Member I will advocate for this code of conduct. If that code of conduct is not effective, I have to evaluate why it isn't effective, not only in elementary schools, but middle and high schools as well.

Justin Ross: We do have a code of conduct. If a child in elementary school hitting teacher or hitting others, there is a problem not only in the classroom, but at home. Who is the advocate of the child? Outreach to the parent is important. Implement the policy. For an elementary student, start at a (discipline) level that is appropriate, that the child understands. The code of conduct should be applied.

Stanley Sierakowski: If a student made a verbal threat or physically assaulted another student, teacher or anyone, I would have that student removed immediately until it was adjudicated. A school should be a place of safety for students and teachers. If I thought I would be physically assaulted, I would call the police. You don't let abusive, violent students (stay). A verbal threat - many people implement that threat. Those people should be removed as soon as possible, and depending on their age be charged with a crime.

Tashi Vasquez: If a teacher is being hit or kicked, are they being listened to? –These are not bad kids. Perth Amboy generally has amazing kids. Let's be very careful how we classify our students. It could be an issue of overcrowding. We have to be very careful. We are listeners. We have hired a new Director of Special Services and a new Supervisor and are working diligently to take a good look at that program. We need to look at the students.

Dr. Danielle Brown: It is the desire of the Board of Education that our students have the best learning environment possible. Another is to provide support and the best instructional environment possible and school safety and school learning are possible. As a Board Member, it's our responsibility that these policies are conducive to these things. We should not classify all students who kick or hit. Take all factors into consideration.

Junior Iglesia: If a staff member reports being assaulted by students? We shouldn't look who is right or who is wrong. What are the needs of the student/educator? Every staff member should be safe. Every student's needs should be met. Look closely to our needs. As a Board Member how are we going to make sure every staff are safe to meets the need to this district. Invest in appropriate learning programs, maybe reducing classroom

Question: This schoolyear, Shull School staff had no copy paper. Staff members are paying for copy paper out of their own pocket. As a Board Member, will you ensure the staff has proper materials vital to do their job?

Justin Ross: There should be a committee or some sort of liaison to find out a solution to that problem. As a schoolteacher, staff should not be paying for supplies. As a Board Member, I would listen to what problem is and figure out through committees and find a solution to the problem.

Stanley Sierakowski: I was in a bureaucracy for almost 30 years. Usually there was a primary person to go to make sure we have supplies. If so, go to another building for supplies. If staff members pay for a supply out of their own pocket, there should be an understanding that they are reimbursed. Why should you pay for supplies when there's a \$300 million budget? When I worked, we did inventory all the time. If something is missing, you see the person who ordered it.

Tashi Vasquez: This is district-wide. Our teachers go beyond what their expectations are. They buy things for their classroom. I thank you for that. As a Board Member, our role is as Board Members is to listen and to advocate. We cannot

do an administrative function. It is the job of the school administrator to ensure every school gets what they need.

Dr. Danielle Brown: Information is power, but it also brings sobriety. Sobriety is really important. We have to make sure we are not overstepping our bounds. I would ask the question to who is responsible for ordering the paper. When addressed, leave it in the hands of that administrator. We do thank the teachers who have above and beyond to ensure our needs are met.

Junior Iglesia: As a Board Member, we cannot call or send an email to order paper. That is not the function of a Board Member. This is unacceptable. I'm on the curriculum committee. With good communication, we will solve this. We do have to improve communication and follow proper protocol to make sure we meet their needs. This is not acceptable.

Beth Lieberman: One of the roles of a Board of Education is to provide the resources for children to have the best education possible. It's not the Board of Education Members responsibility to get paper. There has to be lack of communication. It becomes the responsibility of the Board of Education to make sure that it is brought to the administrator's attention.

Question: Last school year, the Superintendent received over \$30,000 in bonus money. The taxpayers were never informed what the bonus money was for. What would you do to make sure the taxpayers know where their money is going?

Justin Ross: I need to understand I'm working for my constituents. Identify why that happened. As an advocate for staff and for students, I can only do so much. I have to no knowledge sitting here as to tell you. It is an issue that is a responsibility of the Board. A good Board will know where every dime goes.

Stanley Sierakowski: I would ask what it is for. Is this a performance bonus? Is it in the contract? You have to honor a contract. I do not begrudge people getting money for performances, as long as everyone is able to partake in that evaluation and goals are met. I don't know if it was deserved or not. I did not investigate it.

Tashi Vasquez: As a member of the personnel committee and the finance committee, I find it my obligation today to speak to those Merit Goals. What the Superintendent received was Merit Goal Pay. Money did not go missing. It was not unknown to the public. Merit Goals were enacted when the then governor enacted Superintendent cap. With that cap, he put out Merit goals for each Superintendent in the state to meet. Those merit goals are discussed to those Board Members who are not conflicted. Board Members who are conflicted are not part of that conversation. The Superintendent is evaluated on those merit goals. The Superintendent is doing an amazing job. He has not gotten a raise in 3 years. Money did not disappear.

Dr. Danielle Brown and Junior Iglesia both stated they were satisfied with Vasquez's explanation of the Superintendent's bonus in merit goal pay.

Beth Lieberman: I was just informed as to the process of by which Merit Goal Pay is produced. To this day, I'm not really sure what bonuses were for. I think when a Superintendent meets his bonuses, it's because of the teachers and the staff of the entire district. Not only should those bonuses be awarded to the Superintendent but to the staff. We have been in negotiation with the staff for 3 years now. They have not received any kind of Merit Pay. Those kinds of Merit Pays really do need to be revisited to see if they are promoting education in

this district.

Question: Last year, over 100 staff members resigned or retired from the school district. Central Administration says their exit survey shows they are leaving for more money. The AFT survey says they are leaving due to inadequate support and lack of leadership. As a Board of Ed Member, what would you do to stop the exodus?

Stanley Sierakowski: If those members that resigned or went to other school systems or quit, have issues, the first thing they should do is go to the union – not to a Board Member. Have the union file a lawsuit and deal at that level. They have the other option of hiring an attorney. I saw on the TV the statistics were on the screen (about this issue at BOE meetings). Unless you know the facts of each individual case, there is no way to comment on it. I used to be a shop steward also. As a shop steward, I was misled, deceived, lied to from both ends.

Tashi Vasquez: Two different reasons: money and lack of support. Both those explanations are given on exit surveys. Exit surveys are somewhat flawed. If I'm a teacher, and I'm going to HR to leave a district, I possibly will say a half-truth - and if I go to the union, I may give them another half-truth. Exit surveys may not be the best way to measure why our staff is leaving. 100 staff members have left our district for various reasons. When your neighboring district is offering \$10,000 more, it is a problem. So is support and morale and we are working on that. We need honesty from both ends. We need to open up that door of communication.

Dr. Danielle Brown: It's important question to ask at what point are they leaving? Primarily it's in the first 3 years. A lack of pay can also be translated as a lack of support. If you are a first-year teacher, it's the bills. If I can go to next door and make \$5,000 to \$10,000 more, that neighboring school district is supporting me more than the school district I'm starting at. As a Board Member, I want to work with the AFT so that there's incentives in those first 3 years, so we keep those teachers in our district.

Junior Iglesia: As a Board Member, I was one of the first members that recognized there were many teachers leaving our district and the staff retention record was a problem in our district. My goal is for every staff member to retire — to have a career in our school district. The longer a staff member works in a school district, the better they are prepared. We have to work in create a more supportive working environment. We need to continue to increase increments in salary.

Beth Lieberman: This is a reflection of the morale of the amazing staff in Perth Amboy. We need to give our staff and teachers the means they need to be included in decision making, curriculum decision making, provide the resources so they can do their job properly. The way to show staff that they are respected in value is to provide timely contracts and honor contractual agreements.

Justin Ross: What you want to do ideally is catch new teacher and keep them. Do more teachers leave compared than other districts? Are teachers leaving? Part has to do with salary. Part has to do with support. I would look into creating a program to pair young teachers with veteran teachers. It's worked out well in my career. To have that support, to have that name, does wonders in your first year. Since most teachers are leaving within the first 3 years. It helps a new teacher and is important. Give them an endorsement as a mentor teacher. Focus on what makes veteran teachers better. Give them autonomy.

Question: What factors are critical to the quality of education? What would you do to preserve and improve it?

Tashi Vasquez: The most important person in education is the teacher, and we have to provide them the support they need. Caring staff and administrators that understand there are social and emotional situations in a classroom. We have been working on them with curriculum, programs for the teacher. How do we improve this? We're sending teachers out to get more training.

Dr. Danielle Brown: The learning environment is crucial in education. Assistance is important. Teachers can flourish here in a couple of years they can become administrators. It is important to be liaisons to the community. We've got to be aware of those things. Consistency is important.

Junior Iglesia: Learning environment and learning space is the most important factors as well as well qualified educators. As far as space, we are working in the biggest project in New Jersey in the spring of 2020 we will begin construction of the biggest high school in New Jersey, totally funded by the SDA (School Development Authority). In 2024, will open that high school. We must make sure we have the staff we need for the high school. We invested \$50 million in our budget to start preparing for the opening of the new high school. We are working now for our future. Beth Lieberman: I would make sure that funding schools are a priority and acknowledging the classroom size and addressing the overcrowding. We must provide staff and teachers with necessary resources. A valued staff is a productive staff. Often, they are the bottom line.

Justin Ross: Consistency is first. Children need to understand there is a place for them. There is a crossing guard, a cafeteria worker there for them. Emphasize the community. Everyone is a part of a community. We need a rigorous curriculum that gives kids opportunity – not only 4-year colleges, but 2-year colleges. Focus on career paths. Perth Amboy can become better.

Stanley Sierakowski: Try to create with school system with the teacher, a positive vision for that student. Bring back successful students who are athletes (or other high achievers). Tell them their future can be positive.

Question: How would you balance budget pressures against the growing needs of the community which includes the rising population and overcrowding?

Dr. Danielle Brown: Information is power. The more information you have, the better decisions you can make. When you take into account all the factors, you balance with what funding you have available. Be informed. Are we in a crisis or not in a crisis?

Junior Iglesia: Work smart. Looking ahead. We know the school district is growing. It's one reason we are getting a new high school. We need to balance the budget. We included in the budget to have the resources we need to operate the new high school. We also have a policy on the board - raising taxes is the last choice – not the first.

Beth Lieberman: A large part of our budget comes from outside the city. A major amount goes to salary and other necessities and resources. As a Board Member I will be ever vigilant and careful eye on the budget. Our primary goal is that of educating the child.

Justin Ross: We only have so much control over the budget. Most goes to salary and benefits. Balancing the budget goes with advocating – working with the AFT and

NJEA and to establish trust and respect. Class size has been a problem. It's always a struggle.

Stanley Sierakowski: If it's legal, I would try sell bonds for capital improvement projects. Another way long term, the biggest banker in the United States is the federal government. Pass legislation on a federal level to allocate the cost of that area in grants per student. Divert they trillions of dollars and bring it back for healthcare and education.

Tashi Vasquez: Be informed. Ask questions and do your research. As a Board, we've been doing that. The SDA has invested \$5 billion in new schools. It didn't come out of our budget. We have to keep pressure in our state, so they continue to build for our students. 1000 students last 10 years; 1000 in the next 10 years. We know what the numbers are. We are preparing for those numbers. Collaboration with the city and making things work.

Question: Where do you stand on the privatization of services within the schools? Are you in favor of privatization of support staff?

Junior Iglesia: I totally oppose privatization of any kind.

Beth Lieberman: The Board of Education is one of the largest employers in the city of Perth Amboy. The Board of Education has to be judicious when privatizing. Sometimes it is more fiscally responsible to do that.

Justin Ross: I am against privatizing. However, you do need privatizing where the school itself does not handle. We have a workforce in Perth Amboy need to invest in the people of Perth Amboy. We have the workforce in Perth Amboy to strengthen our school system here. Special Education should be privatized to be improved.

Stanley Sierakowski: Privatization is outsourcing the jobs. What generally happens is like on the Turnpike which was privatized. The new vendor/owner for the company gave them a chance to reapply and with no benefits, sick days or vacation days. It's a lack of humanity for a person to make an extra million dollars. Look at those who are outsourced. Those people have no benefits. I'm against outsourcing people's future and their children's future.

Tashi Vasquez: I am against privatization. We have to care of own. We take care of our support staff and encourage continuing education. We have to keep it in house. We are caring for our support staff. Dr. Danielle Brown: I'm opposed to privatization. I'm pro-community.

Question: How do you currently volunteer for the Perth Amboy community and in what capacity?

Beth Lieberman: I have attended afterschool events such as the harvest festival, science fair projects. I've organized trips outside the community. I donate monies to

charities.

Justin Ross: I've been involved in years with the Civic Trust, an organization that lets people learn about government. I'm on the Board of Trustees at the Library. One of the first events I worked on was the Thomas Mundy Peterson event. I am fully invested to better the community.

Stanley Sierakowski: I've been retired 2 days, so I'll have more time to volunteer. I attend City Council Meetings. I try to expose greed, disfunction, so money is better spent. I want to see a skyline in 30-50 years here to look at. New Brunswick had the vision to do that. I want to be a part of the process to create that vision in Perth Ambov that outlives all of us here. Tashi Vasquez: I've been involved since I was a student. I continue to be involved. I find time to still do things outside my daily role. I along with a couple of friends started a woman's networking groups. We help get a girl a prom dress or shoes for young ladies who cannot afford prom. I raise money for the Leaf Foundation. I was called to give. I started as a youth minister. I'm committed to this city and to our youth.

Dr. Danielle Brown: My call is public service. I'm a pastor at the largest church in the city. I'm positive the light shines in this city. Through Mercy House, we feed the homeless in the soup kitchen every Thursday. We provide social services. We held back-to-school giveaways. I'm a member of the Perth Amboy NAACP. I'm currently on the strategic task force with particular attention to the quality of life committee

Junior Iglesia: I love public service. I work in New York City as an educator. I'm part of the school leadership committee. My 2 daughters play soccer. I try to go to their games. Before I was elected to the Board, I founded the Perth Amboy Soccer Organization. I serve on the Perth Amboy Democratic Committee.

Question: How do you feel about a librarian in every school?

Justin Ross: I love the idea. I'm on the Library Board of Trustees. The people helped steer me are librarians. They are vital. They are crucial. I will advocate for a librarian in school and the community. Many mentors of a community use this library.

Stanley Sierakowski: I'm in favor of librarians in every school. When I was young, I looked for books on dinosaurs and Greek mythology. They bring an installment to any person growing up. Books can change your life forever.

Tashi Vasquez: Reading is fundamental. There is a need for them (librarians/media specialists). Look to share services and collaborate with the public library.

Dr. Danielle Brown: When I was writing my dissertation, I remember the research process. There was so many things my librarian taught me I was using 13 years later. Having a library in every school is a great idea. I would love for it to happen

Junior Iglesia: If we have to give our students a gift the love of reading could be the greatest gift. Students should read a as a habit.

Beth Lieberman: Libraries are needed to teach how to find information in resources. Libraries no longer teach a child just reading. The children navigate technology and learn with librarians/media specialists. They are very important in our schools.

Closing Statements:

Tashi Vasquez: I am here not to make promises, but to continue leading our district to success. I have advocated for the community. I have a personal obligation to serve our community. I support excellent schools. Keep personal agendas out of the classrooms.

Stanley Sierakowski: One of my favorite quotes is: "All power to the imagination!" that's for the students. The other one is "One's reach shall exceed one's grasp or what's heaven for?" again that's for the students. I would be the best liaison you would have. You've been left out of the loop. Most people don't know what a PILOT is. There is no oversight. Developers can steal your land. I'm committed to control the oversight.

Justin Ross: You want someone who cares and who has the qualifications and who has the passion for children and their education. My goal is the install the love of learning. When you know learning, there's no limit. I believe in this community.

Beth Lieberman: I believe education first. My hope is I've given an honest picture of my vision and trust how I can advance policy to be in a leadership role in this community. I've spent my whole life dedicated to education.

Junior Iglesia: \$2 million is what we saved our community. We had a budget to approve that included a \$2 million tax increase. We had \$48 million surplus. I believe in the policy of raising property tax as a last choice. I made the motion to amend the resolution to approve that budget without the tax increase. We were then able to save \$2 million. We will act in your best interest.

Dr. Danielle Brown: We've made so much progress. Consistency is key. The numbers are there. The graduation rate, the test scores. It tells our story. The Board of Education we have should continue. Give us another 3 years.

PERTH AMBOY - On 10/12/19 at 09:35, the Department was dispatched to 364 State Street for a reported fire. Units arrived to find heavy fire in the first floor commercial occupancy, with occupants trapped on the floors above. Firefighters quickly deployed two ground ladders and rescued 5 occupants including a baby from the second and third floors. Additionally several attached buildings also filled with smoke and had to be immediately evacuated. Three hoselines and extensive overhaul were needed to extinguish the fire which took two hours.

6 people were transported to the hospital, including 1 firefighter, with the majority treated for smoke inhalation.

Responding units were E-2, E-3, E-4, T-2, T-3, C-1, C-2, C-3, C-5 & C-9. Mutual aid that responded were Hopelawn Rescue 8, Keasbey Truck 4-2-4, South Amboy Engine 9, Sayreville Engine 3 & Iselin Engine 9-2. Port Reading Engine 2-2, Avenel Engine 5-1 and Sayreville Truck 2 covered the City during the incident. The fire is under investigation by the PAFD.

In times of market volatility or when a financial need arises, it is only natural to consider selling some investments. Understanding the tax consequences is key to making an informed and planned decision. Here is what you need to know BEFORE you sell:

As the above tax rate chart suggests, understanding the tax consequence of selling an investment can be complicated. Your tax obligation could be subject to no tax or up to 37 percent plus an additional 3.8 percent for the net investment income tax. Here are some ideas to consider:

Within retirement accounts

- Generally not taxable. Selling investments within your retirement accounts is not usually a taxable event. The potential tax event occurs when you take the funds out of your account either by a withdrawal or occasionally as a rollover into another account.
- Follow the account rules. Each of your retirement accounts has its own set of rules. If you follow them, you can avoid early withdrawal penalties. Following the holding period rules within Roth accounts can also make your withdrawals tax-free.

Gains and losses outside of retirement accounts

- Losses. Your losses are first used to offset any investment gains. Any excess losses can offset your ordinary income up to \$3,000 per year. So the benefit of losses can be worth next to nothing or up to 37 percent if it offsets ordinary income.
- Non-investment losses. Unfortunately, individuals may not offset losses on the sale of non-investment property. So if you sell a car and make money, you need to report the gain. If you sell the car and lose money, there is no deductible loss unless it is part of a business transaction.
- Long-term better than short-term. Holding an investment for longer than one year is key if you want to minimize your tax obligation. Short-term gains are taxed the same as wages. Remember your investment decisions can often have quite different tax consequences. The best suggestion is to seek advice BEFORE you sell.

World War II - 75 Years Ago

The German Army begins retreating from Athens on October 13, 1944. Soviet forces reach the outskirts of Riga, Latvia. German V-1 and V-2 rockets land on the port of Antwerp, Belgium, crucial to the Allies for landing supplies. American troops enter Aachen, Germany, and engage in heavy, house-to-house street fighting in the first major battle on German soil.

On October 14, British troops begin moving into Athens even as the Germans are withdrawing. In Germany, Field Marshal Erwin Rommel, implicated in the "July 20 Plot" to assassinate Hitler, is visited at home — where he is recuperating from wounds suffered in France — by two generals from Hitler's headquarters. (Although Rommel was aware of the plot, he was not a participant.) He is given three choices: defend himself to Hitler in person, undergo a public trial in the People's Court (a Nazi kangaroo court, in which he would undoubtedly be convicted), or commit suicide with the promise of a state funeral and a guarantee of immunity from prosecution for his wife and family (families of plotters are being prosecuted). Deciding that there is really only one option, Rommel chooses to swallow a cyanide capsule given to him after saying goodbye to his wife and fifteen-year-old son. His death is announced publicly as resulting from wounds he had suffered when his car was strafed in France. Der Führer declares a day of mourning and, as promised, authorizes a state funeral for the Desert Fox.

On October 15, the Allies and the Germans engage in an artillery duel at Aachen. In Asia, the British and Chinese begin a joint offensive from Myitkyina to Bhamo, in Burma. In Budapest, the Hungarian chief of state, Adm. Miklós Horthy, shortly after announcing Hungary's withdrawal from the war against the Soviets, is taken prisoner by a German commando unit led by SS Maj. Otto Skorzeny. Horthy is told that unless he recants Hungary's withdrawal from the Axis and abdicates, his son (abducted by Skorzeny and his men hours earlier) will be killed. Horthy complies, naming Ferenc Szálasi as head of state and prime minister. Szálasi immediately vows to continue the alliance with Germany, promising to keep the country open as an escape route for German troops fighting in the Balkans. Horthy is brought by Skorzeny to Bavaria, where he is held in "protective custody."

The Red Army and Partisans under Josip Broz Tito liberate Belgrade, Yugoslavia, on October 16. The Red Army enters German territory near Goldap in East Prussia; thousands of German civilians flee the area in panic. Goldap is the first town in Germany to fall to the Allies. U.S. carrier-based planes, as well as aircraft from airfields on New Guinea, conduct air strikes on Leyte, Cebu and Mindanao, in the Philippines.

In the Philippines, the U.S. Navy on October 17 begins mine-sweeping operations in Leyte Gulf. In Italy, the U.S. Fifth Army's II Corps continues its attacks toward Bologna. At an SS officers' conference, Reichsfuhrer-SS Heinrich Himmler states that Warsaw "must completely disappear from the surface of the earth and serve only as a transport station for the Wehrmacht. No stone can remain standing. Every building must be razed to its foundation." While Hitler's plan to destroy the city — and build "Warschau, a new German city" in its place — dates back to June 1939, the Warsaw Uprising has infuriated the Nazi leadership and it is decided to make an example of the Polish capital. Even as the city's residents are being expelled, German teams are working with a will on obliterating the city. Ultimately destroyed are: 10,455 buildings, 953 historical buildings, 25 churches, 14 libraries, 81 elementary schools, 64 high schools, two universities, most historical monuments and much artwork.

Hitler on October 18 orders a call-up of all males between the ages of 16 and 60 for Home Guard duties. SS chief Heinrich Himmler becomes Commander-in-Chief, Forces of the Interior. German radio says that 50,000 officers have been killed so far in the war. Soviet troops cross the Norwegian frontier while the Soviet 4th Ukrainian Front enters Czechoslovakia. German troops from Greece and southern Yugoslavia are falling back rapidly to avoid being cut off by the advancing Red Army. The Greek government-in-exile returns to Athens from Italy.

The Germans evacuate Belgrade, Yugoslavia, on October 19. In Burma, the British capture an important Japanese supply depot at Mohnyin. In the U.S., the Navy says that African-American women may join the WAVES (Women Accepted for Volunteer Emergency Service, the women's branch of the U.S. Naval Reserve).

On October 20, the U.S. Sixth Army's X and XXIV Corps along with Filipino guerrillas make amphibious landings in the Philippines, on the east coast of Leyte. The 60,000 men sent ashore encounter stiff Japanese resistance. Coming ashore at Leyte after a beachhead is established, U.S. Gen. Douglas MacArthur makes a speech via a portable radio transmitter that begins: "This is the voice of freedom, General MacArthur speaking. People of the Philippines: I have returned." Soviet and Yugoslavian Army troops occupy Belgrade. Yugoslavian Partisan forces take Dubrovnik, on the Adriatic coast.

Aachen is occupied by the U.S. First Army on October 21. It is the first German city to be captured. (Goldap, in eastern Prussia, captured by the Soviets on October 16, is a small town.) In Yugoslavia, German and Croatian forces establish a line of defense northwest of Belgrade. In the Palau Islands in the Pacific, organized Japanese resistance on Angaur Island ends. 1,300 Japanese are dead and 45 are captured. American casualties number 265 dead, 1,335 wounded. U.S. heavy bombers begin operating from the island's airfield.

Canadian troops of the British Eighth Army capture Cervia, in northeastern Italy on the Adriatic coast, on October 22. The 14th Soviet Army reaches the Norwegian border.

Much activity of note occurs on October 23. The Allies recognize Gen. Charles de Gaulle's Provisional Government of the French Republic as the legitimate government of France. The Battle of Leyte Gulf—the biggest sea battle in history—begins. For the first time, the Americans experience heavy attacks from Japanese *kamikaze* aircraft. (*Kamikaze*, which means "divine wind," are special attack units—first organized in August 1944—of pilots who fly suicide missions against Allied naval vessels. Over the course of the war, over 3,000 *kamikaze* pilots and 7,000 Allied naval personnel will die in these attacks.) The light aircraft carrier *USS Princeton* is heavily damaged by a bomb dropped from a Japanese Yokosuka D4Y "Judy" dive bomber and sinks with the loss of 108 men (1,361 are rescued). The Battle of San Bernardino Strait takes place, as the Japanese try to stop U.S. Gen. MacArthur's Sixth Army landings on Leyte Island, in the Philippines. American B-29 Superfortress

heavy bombers begin using Tinian, in the Mariana Islands, as a base for the systematic bombing of Japan.

In Europe, the Red Army continues its drive westward, capturing several towns on October 24. In Berlin, Hitler informs his generals of his plan to launch a surprise counteroffensive against a weakly held section of the Allied line in the Ardennes region of Belgium, Luxembourg and France. In the Territory of Hawaii, martial law is lifted, and *habeas corpus* (the right to appeal to a court for a judgment of wrongful imprisonment) is restored.

On October 25, in the Pacific, the submarine *USS Tang*, credited with sinking more enemy ships than any other American submarine, sinks off Turnabout Island in the Strait of Formosa when struck by its own torpedo that, malfunctioning, makes a circular run. Nine crewmen survive, 78 are lost. *Tang* had sunk 33 ships totaling 116,454 tons. Off the Philippines, the most intense fighting of the Battle of Leyte Gulf takes place. The Japanese lose three aircraft carriers, two battleships, two cruisers and five destroyers. The Americans lose two escort carriers (one — *USS St. Lo* — by *kamikaze* attack) and two destroyers. Romania is fully liberated by the Red Army and Romanian troops. Soviet troops take the German base of Kirkenes, in far northeastern in Norway near the Soviet border.

In the Philippines on October 26, elements of the U.S. Army's XXIV Corps unsuccessfully attack Japanese positions on Catmon Hill, north of Dulag, on the east coast of Leyte. Japanese reinforcements arrive at Ormoc, on the western side of the island, northwest of Dulag. The Battle of Leyte Gulf ends with the Japanese losing yet more ships: three cruisers, three destroyers and a submarine. The Imperial Japanese Navy now ceases to be a factor in the war. U.S. Gen. Joseph "Vinegar Joe" Stilwell, commander of the China-Burma-India Theater, departs China, having been recalled from his command by President Roosevelt. Nationalist Chinese leader Chiang Kai-shek had sent to Roosevelt a demand that Stilwell be removed, stating his willingness to accept any other qualified U.S. general to fill the post. Allied losses in Burma and China are high, and Stilwell — highly and openly contemptuous of the Chinese leader — has been clashing continually with Chiang over a lack of aggressiveness on the part of Chinese forces in fighting the Japanese and rampant corruption within the Nationalist government. Stilwell has also had ongoing conflicts with U.S. Army Maj. Gen. Claire Chennault, commander of air forces in the theater, as well as British and Chinese commanders.

Another battle breaks out on October 27, 1944, in the Hürtgen Forest, on the border between Belgium and Germany. The sporadic fighting will last for months. Josip Broz Tito arrives in liberated Belgrade, Yugoslavia.

In Moscow, the U.S.S.R. and Bulgaria on October 28 sign an armistice agreement. The Germans begin to evacuate Albania. In Czechoslovakia, the Slovak National Uprising against the Nazi-collaborationist government of Jozef Tiso is put down by the German Army after two months of fighting. Over 12,000 Slovaks are killed in action or murdered in reprisals; the Germans suffer 4,200 killed and 5,000 wounded.

U.S. Maj. Gen. Albert C. Wedemeyer on October 29 arrives in China to replace Gen. Joseph Stilwell as Commanding General, U.S. Forces, China-Burma-India Theater and Chief of Staff to Generalissimo Chiang Kai-shek. Wedemeyer is dismayed to find that his predecessor has left the country without meeting with him and briefing him on theater conditions. Upon searching headquarters, Wedemeyer discovers that Stilwell has left no record of future plans or ideas, nor any documentation of past or planned operations. Questioning Stilwell's staff officers, Wedemeyer learns that they know little; they say Stilwell always kept things "in his hip pocket."

Counterattacks against the Soviets by the 3rd Panzer Korps near Debrecen, Hungary, on October 30 end with the Germans claiming that they have inflicted 25,000 casualties and destroyed 600 tanks. However, this doesn't hinder the Red Army — it begins a major offensive into Hungary. Teen-aged Holocaust diarist Anne Frank is transferred from Auschwitz to the Belsen concentration camp, in Lower Saxony in northwestern Germany. The Greek government, back in Athens, bans the ELAS National Militia, the communist resistance movement.

On the orders of Prime Minister Churchill, British troops on October 31 move into Salonika, in Greece, to assist the government in its efforts to prevent a takeover by communist insurgents in the wake of the recent withdrawal of German troops. In Denmark, a precision raid by Royal Air Force bombers flying at rooftop level destroys *Gestapo* headquarters in Aarhus, on the east coast of the Jutland peninsula. The *Gestapo* was about to initiate an anti-resistance operation, but all records are lost in the raid, killing the operation.

British forces take Thessaloniki, in Greece, on November 1. In Japan, the first of some 9,000 balloon bombs are launched (through April 1945) from Tokyo. The hydrogen-filled balloons — laden with either high-explosive or incendiary devices, or both — will ride the jet stream at around 37,000 feet in altitude to reach the west coast of North America, coming down from Mexico to Canada and Alaska. Only one of the devices is known to cause casualties. The destroyer *USS Abner Read* is sunk by a Japanese *kamikaze* attack in Leyte Gulf. All but 22 of her crew of 336 are rescued.

Canadian troops take Zeebrugge, on the Belgian coast, on November 2. Belgium is now completely liberated. The Red Army enters south-eastern Hungary. In Budapest, 50,000 Jews are sent on a forced march to Austria; some 10,000 will die in the six days it takes them to reach their destination. MOVIE REVIEW: JOKER

Joaquin Phoenix brings a new twist on an old character in "Joker".

Just when you think that things will be the same, they're not. The character of the Joker has been done many times on screen. He appeared in "Batman: The Animated Series" voiced by Mark Hamill. He was portrayed in the Batman TV series with Adam West by Caesar Romero. Jack Nicholson portrayed him with Michael Keaton in the 1989 Batman film. And don't forget Christian Bale's Batman and the Oscar-winning performance by Heath Ledger in 2008 The Dark Knight.

"Joker" concentrates more on the psychological aspect of what makes the Joker tick. The Joker's, Arthur Fleck, a man who is destitute and can't even get the medication that he needs to keep his life stable. He lives in a crummy apartment in Gotham City with his mother, Penny Fleck. A garbage strike is crippling the city, and he just wants to try to make other people laugh. Arthur works as a clown who at the beginning of the film is standing in front of a store with a going-out-of-business sign. He is mugged. A fellow clown gives him a gun in order to protect himself, but he brings it to a kid's party in a hospital



and it accidentally falls out of his pants. Because of this, he is fired from his job. Arthur then finds out a lot of things about his life as if he is pulling out thread and his life just slowly begins to unravel. He's obsessed with a late-night television talk show host Murry Franklin (Robert De Niro). Arthur's big dream is to be a standup comedian. He gets his big break on the Murry Franklin Show after an open mic night at a club.

Batman does not appear in "Joker". (Bruce Wayne is 8 years old) The story is well done, and I especially love the grittiness and dirtiness of Gotham City which is sort of told in the mid-seventies and early eighties.

The soundtrack is reminiscent of the music that was used in the TV mini-series "Chernobyl". When you leave the theater, you will still hear that music

echoing in your ears. The cast is first-rate, and Joaquin Phoenix is sure to get it Oscar nomina-

"Joker" is nothing like anything I've ever seen before. Be warned: "Joker" is not for children. The film is intensely violent, but not in a graphic way just a quick terrible violence as Arthur slowly evolves into the person we know of today. This is an adult comic book movie that is a serious drama about the psyche of a man and how he falls apart because of terrible circumstances and the hand that he is dealt. Mental illness is no joke, but at least Joker talks about some of the terrible things that happen to people who are mentally ill and are too afraid to seek treatment. Should you see the movie? 
