

They had run out of photo paper for the machine and could not print the photos. When I told them I desperately needed the photos printed and couldn't wait, one of the workers actually went to another store to get the paper and I was able to print the photos within a few hours. A friend came by later to pick them up for me.

Then there were friends who came and visited my dad in the hospital and others who offered their kindness through favors.

Recently, my mom and I had to go to the NJMVC in Hazlet. My mom dropped her cell phone and couldn't find it. I tried calling it, but there was no answer. After looking in my car and walking around the building (a strip mall that includes other stores - the line wrapped all around the whole building) and asking if anyone found a cell phone, one woman told me to ask the guard. I asked him and he handed me the phone. A woman had found it and given it to him.

We had brought foldable chairs to wait in the line (pay in mind this is at 7:30 a.m. - there were people there who had been in line since 8:30 p.m. the previous night). When the line started moving, a young man saw that my mother's and my hands were full, so he carried the chair for us. (We were carrying packed lunches, water bottles, and the needed papers for the MVC and hand sanitizer). Note that they only let a certain number of people in per day.

These individuals did not have to do these things - but they did. There is kindness in the world.

All over the news you see people rioting, looting, fighting with each other and full of hate. What happened to having your opinion on politics without being crucified by others who have opposing views than you? That was always a part of the beauty of the United States you are free to voice your opinion without repercussions from

the government or anyone for that matter. It seems things are different now and we are slowly losing our freedom of speech and many of our other freedoms as well. We cannot let this hap-

Coming on the 19th Anniversary of 9-11-01, I remember what 9-12-01 looked like - the day after. People were stuck in New York and New Jersey and in airports everywhere. Cars lined up on Amboy Avenue from the Outerbridge Crossing. People opened up their houses to strangers just so they could use the bathroom and have a bite to eat or so they did not have to sleep in their cars or outside. Road Work on Rte. 35, Citizen Advisory Council, Water/Sewer Bill Dispute, **Vote-By-Mail Topics of Discussion**

9/9/20 Caucus & Council Meetings

By: Katherine Massopust PERTH AMBOY – There were several key topics discussed at

the 9/9/20 Caucus and Council Meetings which were held inperson at the YMCA Auditorium.

The first topic discussed at the caucus was referring to R-314-9/20 – Authorizing the insertion of revenue in the CY 2020 Budget pursuant to N.J.S.A. 40A:4-87 (Chapter 159, P.L. 1948) for the NJDOT FY2020 Municipal Aid Grant in the amount of \$508,467.00

Councilman Fernando Irizarry remarked, "For 2 years there are barriers up on Rte. 35 which have inconvenienced our citizens. We have given 2 ½ years. Those barriers are up with nothing happening.

When asked why this is so, Interim Business Administrator Patricia Perkins had no answer and stated she will research the problem.

Council President William Petrick stated the reason why there was such a long delay in the work to begin is because of multiple pipelines in the area. The NJDOT (New Jersey Division of Transit) had to get permission because of not damaging the pipelines when construction begins. He directed B.A. Perkins to City Engineer Jeff Rauch who could help with the matter.

Councilman Joel Pabon stated, "It's a pretty poor excuse. I'm not blaming the current B.A. because she just got here. They state there are different pipelines buried here. We should say please give us a better answer. Once I saw a biker cutting weeds in that area (because he couldn't get through on his bicycle). I called, and the city came and cut the weeds the next day. I really hope someone comes up (with an answer) why these things are happening."

Council President Petrick stated that City Engineer Jeff Rauch should reach out to the

The next topic of discussion was referring to R-324-9/20 Authorizing the cancellation on Menpe, Corp. BOD bill account no. 10046-0 in the amount of \$22,866.66 due to ongoing dispute of April 23 bill.

ry asked what BOD stands for. It was explained it means biochemical oxygen demand. BOD is the traditional, most widely used test to establish concentration of organic matter in wastewater samples (i.e., relative strength). BOD is based on the principle that if sufficient oxygen is available, aerobic biological decomposition (i.e., stabilization of organic waste) by microorganisms will continue until all waste is consumed. (Source: University of Georgia Education: Understanding Laboratory Wastewater Tests)

It was further explained that Tropical Cheese is unique in the process they use and there are no local factories that use a processes similar to them.

Interim Business Administrator Patricia Perkins explained that although they (Menpe

Corp.) have questions of the bill, they paid 66% of the bill, they ask that since the bill is in dispute, they asked if they don't pay interest on the outstanding

Councilman Fernando Irizarry asked that if they (Menpe Corp.) are asking for cancellation of interest because they are disputing the bill. "If the bill is resolved, why should they pay interest?'

Interim B.A. Perkins remarked, "If you want to forgive the bill, you can do it."

Councilman Joel Pabon asked, "If we forgive the bill, what happens?"

Council President Bill Petrick answered, "That's the power of the council. My understanding is Menpe and yourself should go to Middlesex Water Company for an appointment." Petrick then asked the Business Administrator, "Has anyone actually spoken with someone who spoke to them?'

Irizarry asked, "Can you tell us what the dispute is about?"

Luis Perez Jimenez - Director of Operations at the USA-PA (Utility Service Associates Perth Amboy) Middlesex Water Company) answered, "Their dispute is that they state they think they are paying too much. They say their BOD is too high. The lab analyzes the BOD and sends the results every week. Tropical Cheese is unique in the county (referring to the processes they use)."

During the public portion, Harry Pozycki founder of the Citizen's Campaign was first to speak. He talked about the Civic Trust Committee which was proposed on the agenda. "I am here to discuss the ordinance that was discussed a couple of weeks ago. The ordinance is moving along with the City of Patterson. Mayor Ras J. Baraka of Newark is moving forward. Perth Amboy has an opportunity to lead here. We are asking tonight to vote on Introduction. This is a one-page ordinance. Introduction of it will clarify it and alleviate any confusion. When the ordinance comes up it will require a public hearing. There is no commitment made with an introduction. Perth Amboy has an opportunity to lead Councilman Fernando Irizar- with the commission it should create. I ask that a motion be made." Pozycki continued, "Donna Stewart, President of the Perth Amboy NAACP states that the Perth Amboy Public safety Ordinance – the process of creating the ordinance must continue without delay. Our generation must heal. I made a commitment with the Perth Amboy PBA to promote the ordinance."

Resident Ken Balut spoke next. "Have we gotten the check from Kushner, yet? He owes us \$4 million for a piece of property that hasn't been addressed. The streets on Amboy Avenue have heavy duty trucks (driving

Council President Bill Petrick stated, "When you were council president (addressing Balut), there were delays then. There was swampland. There was a

delay because the Board of Education didn't know how much land they needed." Petrick then added, "There needs to be coordination between the administration and the county.'

Balut stated, "That was going to be negotiated. Amboy Avenue – the Mayor gave a \$11,000 raise to someone she wanted to run for council. Is it right for a mayor to give out raises? What about covering up what judges do? A judge who dismissed a sexual harassment complaint – no one touches the judge who misuses authority."

Robert McCoy came up next to speak. "I want to lend my support on the creation of the Public Safety Commission."

Resident Maria Rodgers came up next also lending support for the creation of the commission.

Resident Alan Silber came up to speak next, "I didn't hear anything about older people (referring to the age range recommendations suggested in the creation of the commission) as if they had nothing to say. We're a small part of a nationwide movement. The Citizen's Campaign sees things happening. When people all over the nation protest, an ordinance is put through. I didn't hear there will be a police officer on the committee. I think it's rushed, and we need to take time. Let's get more of a finished product, then let's do something.

Resident and Businessman Jeremy Baratta spoke next. "I agree with the comments that Mr. Silber made. Those with special interests should not

strongarm the council." Daniel Gonzalez PBA delegate to Local #13 came up next. As a union delegate, we're not against it. We know what's going on in the country. We should come together as a team. I do agree some of this should not be rushed. The (definition) of use of force is very broad. If we are going to do it – do it right. It can be positive for both the police and citizens alike."

Council President Petrick added, "The council will appreciate your feedback."

Councilman Irizarry stated, "People who are on the board should be vetted. What age group would you recommend if not 15 -20 years old? We have to invite senior citizens, too?"

Gonzalez answered, "I don't think age is a factor. It's not clear in the file I read – it's not clear on the duties."

Councilman Helmin Caba said, "We have to vet these Board Members. If they don't have a preconceived perception of police officers. We need to protect and support the police officers. Thank you for giving your point of view."

Councilman Fernando Irizarry said, "Suppose you have someone who does not have a (criminal) background, but this person was related to a family member who was (abused) by a police officer. Would you want someone (like that) on the commit-

Gonzalez answered, "That would be your decision. The more maturity you have, that tells if you should sit on a board. Some people joined the protest – they were just supporting the cause."

Councilman Joel Pabon stated, "I was hoping the police chief would come up with something. Surprisingly our Mayor and Police Chief - he never spoke to the PBA. There has to be some things that need to be done. It needs to be put on the agenda and questions asked."

Councilwoman Milady Tejeda spoke up, "I agree with everything said here. It's a very delicate time - not only here - but with the whole country."

The council convened to a closed session at 6:20 p.m. They returned at 7:07 p.m. and adjourned the caucus at 7:08 p.m. The regular portion of the council meeting then began.

No one spoke during the first public comments on agenda items only.

Ordinance No. 1 was passed unanimously.

Ordinance No. 2 – An ordinance to amend and ordinance entitled "Administration of Government" (Ordinance No. 1-72 and Amendments) adopted July 28, 1972 also known as Chapter 4 et seq of the code of the City of Perth Amboy. RE: Interim Appointments.

Fernando Irizarry, Joel Pabon voted "no"; Milady Tejeda, Helmin Caba, and William Petrick voted, "yes". Motion passes.

The council originally passed the consent agenda but went backwards and reversed what they passed. They voided their original vote and voted again on the consent agenda as follows: R-313 thru R-323; R-325 thru R-331; R-333 thru R-342. R-332 was removed; R-343 was voided. The consent agenda was moved by Fernando Irizarry and seconded by Milady Tejeda. It passed unanimously.

R-324 was pulled for further discussion.

Interim B.A. Patricia Perkins stated, "After meeting with Menpe Corp. and members of the administration, the dispute is still ongoing. The total owed is \$22,866.66. They paid 2/3 of the amount owed until the end of this dispute."

Council President Bill Petrick said, "They could avoid interest in the dispute and late fees. There are residents who had a toilet running and have a water/sewer bill they can't afford. They are paying on interest charged. They are agreeing to settlements. I think this body needs to look at that and see what it is going to cost the rest of the public. Maybe you can intercede with the Freeholders – maybe change their rates. I hate to wipe the bill out with one vote."

When it came to voting on R-324, the entire council voted "No".

Public Portion:

Resident Ken Balut came up to speak first. He referred to the misconduct of a judge whom he feels is guilty of misconduct. "A complaint should have been reviewed by a different judge in a different town. He did not talk to the victim. Our municipal judge did not approve it. There was misuse of a handicapped placard. The Prosecutor gave 3 of us the finger. It happened a couple of months ago. There needs to be an investigation of the court."

Law Director Peter King said, "You can send any complaint vou want to me."

Balut said, "When I sat in that seat (council president), I called the Attorney General's Office myself. It's not up to a citizen."

Balut then said, "Look what's happening to the Kushner Property. He owes us \$6,000 plus the \$4,000,000. Look at the lawsuits. Look at the Batista case."

Petrick answered, "The court went in our favor. She was unreasonable."

Balut continued, "We bleed money. We were bleeding out thousands. Perth Amboy is not one of the safest cities in America. Look at the FBI statistics. I put in how many calls from this year and last year. Somebody has to hold these people accountable. Things have to change!"

Resident Jeremy Baratta came up next. "With regards to the judge and parking – I took the pictures. I have at least one photo. This judge parked his vehicle in an unlawful manner." Baratta continued to complain, "The

prosecutor gave me the finger and made a statement after the meeting broke. If anyone wants photos of the judge parking his car, I took them." Baratta then referred to the city's legal bills, "The administration doesn't care about the legal bills for two reasons: 1) It's not her money; 2) more money that goes to legal bills means lawyers make more money. The only ones who get rich are the lawyers – the ones who suffer are the taxpayers. I am suing the city over OPRA requests. The City is in transit. It has to do with the BID. What percentage of the city's funding has been wasted on lawyers? Wilda does not care. It's not her money. Stop the bleeding."

Council President Petrick asked, "What are the appropriate actions to take?"

Law Director Peter King answered, "I can interview him. I do not have an official complaint."

Baratta said, "If you see something - say something!"

It was suggested that if Baratta and Balut were so concerned about these individuals, they should file a formal complaint. Council Comments:

Councilman Helmin Caba 9-11-01 and responders who sacrificed for our freedom and those who fight overseas."

Councilman Fernando Irizarry had no comments.

Councilman Joel Pabon said, "I want to give some remarks about our Governor made about vote-by-mail. Schools have opened up - inside dining - demonstrations all over. It is not a democratic process, there should have been a choice. It's unheard of this day and age that voters have to vote by mail. This is a democratic town. Our legislatures signed and agreed to that. The month is going to be spent getting that in place. Bal-

lots go out, you fill them out and send it. DO NOT GIVE THEM OUT! There are so many people that just go through the motions. That vote goes to where you are registered. When I first worked in the post office, I reached out to the Board of Elections. We sent back ballot after ballot. There are going to be so many ballots returned. We are not ready to do what the Governor wants. The only way to vote at the polls is if you are disabled. I want to express my feelings."

Councilwoman Milady Tejeda stated, "I would like to remember those who lost their lives on 9-11-01. I wish the best to the Board of Education having to learn remote. I wish well to the parents who have to go out and work and make sure their kids learn. I work in a hospital and it hurts me when people don't take this virus seriously.'

Council President Bill Petrick thanked everyone who came and everyone out in TV land; he thanked Steve Jobin (CEO and President of the YMCA), the YMCA and the city council. "I echo Councilman Pabon. There should be no reason not to use the voting machines. The state invested in brand new electronic voting machines. Let everyone wear a mask and gloves. This decision is a mistake. said, "Honor the victims of Please remember to vote your conscience. Don't put it aside. There will be a box in front of police headquarters. You can also use any mailbox. The ballot box goes directly to Middlesex County. I invite everyone to the 9-11-01 ceremony at noon on Friday (9/11/20). Remember all of our service men and women and those who are in and out of uniform defending our coun-

Councilman Helmin Caba noted that anyone can bring their ballot to any polling place and bring it there on election day.

The meeting adjourned at 7:57 p.m. All council members were present.

Then he continued working as a science teacher until he retired in June 2020.

Lopez, Carter & McKnight Bill to Allow Long-**Term Care Workers to Earn Paid Sick Leave Clears Assembly Panel**

Press Release 8/24/20

TRENTON - With the goal to make it easier for employees in long-term care facilities to take time off if they become ill, the Assembly Appropriations Committee on Monday advanced a measure to allow long-term care workers who are placed through a staffing agency to accrue paid sick leave.

Under current New Jersey law, employers must provide employees with earned sick leave at a rate of one hour for every 30 hours worked. However, this requirement does not apply to per diem health care employees such as long-term care workers. The bill (A-4483), spon-

sored by Assembly Democrats Yvonne Lopez (D-Middlesex), Linda Carter (D-Middlesex, Somerset, Union) and Angela McKnight (D-Hudson), would amend existing law to no longer categorize long-term care employees placed through a staffing agency as per diem workers, thus allowing them to accrue paid sick leave.

The measure's sponsors released the following joint state-

"Staffing shortages are all too common in long-term care facilities. If an employee feels sick and doesn't have access to paid time off, they might choose to come to work anyway to avoid losing pay and to make sure residents receive care. Unfortunately, this means they may infect elderly residents with weak immune systems. This is extremely problematic in a COVID-19 reality.

"Allowing long-term care employees to earn paid sick leave is the right and responsible thing to do for staff and residents alike."

Team Wilda Diaz 2020: Stronger Together

Perth Amboy Mayor Wilda Diaz Seeks Reelection for 4th Term

Wilda Diaz was re-elected as Mayor of the City of Perth Amboy for a third [four-year] term in November 2016. She was first sworn-in on July 1, 2008, becoming the first female to hold that office and is currently the only elected Latina mayor of Puerto Rican descent in the State of New Jersey.

As she marks her 10 year anniversary in serving the City of Perth Amboy, she remains at the forefront of issues such as, expanding programs for our children, youth and families, maintaining an open and honest government, business expansion, economic development, job creation and preserving the City's history. In December 2017, Mayor Diaz completed her 4-year term as the first Latina to serve as president and chair of the New Jersey Urban Mayors Association (NJUMA). Through her term, she was dedicated to working with state and federal lawmakers and officials to develop appropriate and effective public policy measures that impacts all New Jersey urban communities. She also has served on the League Management Reform Committee for the New Jersey League of Municipalities and currently serves as the Chairwoman for the Perth Amboy Redevelopment Agency (PARA).

Prior to taking office, Mayor Diaz spent 20 years in the banking industry where she started as a teller at a local bank after graduating from Perth Amboy High School in 1983. She quickly rose through the ranks and was an assistant vice-president with Banco Popular when she won the mayoral seat in May 2008 and as a result, resigned from that position.

A dedicated community activist, Mayor Diaz chaired the Board of Trustees for the Jewish Renaissance Medical Center, a nonprofit group that provides health care to underserved communities.

She was a driving force behind the Puerto Rican Patriotic Cultural Committee (Comité Cultural Patriótico Puertorriqueño de Perth Amboy), which sponsors the annual Hall Avenue Puerto Rican festival. Additionally, she served as a member of the Perth Amboy Merchants Association (PAMA) and has been honored by local organizations such as the Puerto Rican Association for Human Development (PRAHD) and the Jewish Renaissance Foundation (JFR) for her involvement in the community.

Diaz was inducted in the New Jersey League of Municipalities' Hall of Fame for serving as Mayor of her community for 10 years. She also received the "Community Leaders of Distinction" award by the Middlesex County Regional Chamber of Commerce. At the end of 2015, NBC Latino and NBC Nightly News released a feature story Diaz, as the "First Woman Mayor of a Changing New Jersey Town." Additionally, Mayor Diaz received the 2015 LatinoJustice "Latina Trailblazers" award for public service. In 2014, she was honored as "Community Leader" by the Hispanic American Law Enforcement Association and "Humanitarian of the Year" by The Coalition of Hispanic Phy-

Diaz was earlier recognized by El Diario La Prensa as "Mujeres Destacadas 2012" (Outstanding Women of 2012) and was featured in Real Simple Magazine as, "The Accidental Politician" among only four female mayors nation-wide. World War II - 75 Years Ago

The Belgian government announces on September 14, 1945, that three Belgian army divisions, comprising 17,000 men, will participate in the occupation of Germany as part of the British Army of the Rhine, under the supreme command of Field Marshal Bernard Montgomery.

On September 15, 300 RAF aircraft overfly London to mark the fifth anniversary of the Battle of Britain; commemorative parades are held throughout the nation. In Washington, D.C., the U.S. Department of War issues figures showing that a total of 7,306,000 soldiers (including a small number of Allied forces and civilians) and 126,859,000 tons of war cargo had been moved from American ports to all fronts between December 1941 and August 31, 1945. The U.S. Office of War Information is dissolved.

The Japanese garrison in Hong Kong officially surrenders on September 16. The British Royal Navy's Rear Adm. Cecil Harcourt signs the formal surrender instrument with American, Chinese and Canadian representatives present. The British land troops at Batavia, Netherlands East Indies, and announce that their mission is to secure the area until Dutch authorities arrive to resume their colonial rule.

In Germany, on September 17, Josef Kramer, former SS commandant of the Auschwitz and Bergen-Belsen concentration camps, and 44 male and female SS personnel on his staffs are brought before a British military tribunal at Lüneburg on charges of conspiracy to commit mass murder. Kramer and 10 others are found guilty and subsequently executed, 19 are given prison terms and 14 are acquitted; one individual is never tried, because of illness. Chinese Nationalist troops occupy Peking. In Batavia, Dutch East Indies, rallies take place supporting Indonesian independence.

In Egypt, on September 18, Mahmoud El Essawy is executed, after Prime Minister Mahmoud El Nokrashy Pasha confirms the sentence. The 28-year-old lawyer had assassinated the late Egyptian prime minister, Ahmad Maher Pasha, El Nokrashy's predecessor, on February 24, 1945, moments after Maher announced that Egypt had declared war on the Axis countries.

On September 19, in London, William Joyce, who had broadcast Nazi propaganda as "Lord Haw-Haw," is sentenced to death for treason. In Korea, Kim Il-sung, after eight years of exile in the Soviet Union, arrives at the northern port of Wonsan aboard the Soviet warship Pugachev and begins organizing the Korean Workers' Party. In the southern part of the Korean peninsula, U.S. occupation authorities revoke all Japanese laws restricting freedom of religion, assembly, speech and press.

Mohandas Gandhi and Jawaharlal Nehru on September 20 demand that all British troops depart India. British Prime Minister Clement Attlee promises independence for India "at the earliest possible date." In the U.S., German rocket engineers, who had been captured and brought to the U.S., begin to work on America's rocket program. Zionist leader Chaim Weizmann, a senior member of the Jewish Agency for Palestine, makes an appeal to the U.S., the U.K., France and the U.S.S.R. for compensation from Germany for crimes against Jews.

Indian leaders Mohandas Gandhi and Jawaharlal Nehru and the All-India Congress Party on September 21 demand that all of Southeast Asia should be free of imperialist domination.

British troops on September 22 release 1,400 Vichy French soldiers from former Japanese prison camps around Saigon, Vietnam. Many of the released soldiers enter Saigon and go on a deadly rampage, attacking Viet Minh (anti-French Vietnamese nationalist) supporters and killing innocent civilians, including children. The soldiers are abetted by some of the estimated 20,000 French civilians who live in Saigon, who join in the rampage. In Germany, Gen. George S. Patton, military governor of Bavaria, publicly questions the necessity of the "de-Nazification" program (the removal of former Nazi Party members from political, administrative and governmental positions) being carried out there. Patton likens "this Nazi thing" to "a Democratic and Republican election fight," offering the opinion that Germans with experience in infrastructure management were forced to join the Nazi Party. The comments spark outrage back in the U.S. and garner a large amount of negative press.

In Cairo, the Egyptian government on September 23 demands that British forces withdraw from the Sudan, an Anglo-Egyptian condominium. The U.K. demurs. (In international law, a condominium is a territory over which two or more countries formally agree to share equal sovereignty and to exercise their rights jointly without dividing the territory.) Per the Potsdam Agreement, Nationalist Chinese soldiers occupy the Kingdom of Laos north of the 16th parallel.

In Tokyo, Japanese Emperor Hirohito says on September 24 that he did not want war; he blames former prime minister Hideki Tojo for the attack on Pearl Harbor. In Saigon, Vietnam, the Viet Minh successfully organize a general strike that shuts down all commerce, along with electricity and water supplies. In a Saigon suburb, members of a Vietnamese criminal organization massacre 150 French and Eurasian civilians, including children, in retaliation for the French rampage in Saigon two days earlier.

On September 25, the National Socialist German Workers' (Nazi) Party, the German armed forces (*Wehrmacht*), the SS, the SA (*Sturmabteilung*, the Nazi Party's original paramilitary security force) and the *Gestapo* are officially declared illegal in Germany by the Four-Power Allied Control Commission. All German foreign affairs will be handled by the Allies. Germans are ordered to turn in all gold, silver and platinum coins and bullion. All items looted from Nazi-conquered countries are also to be turned over. The last Soviet soldier leaves Norwegian territory at 8:55 p.m., local time.

In Washington, D.C., President Truman announces on September 26 that, per a decision at the recent Potsdam Conference, surviving German naval vessels will be divided equally between the United States, the United Kingdom and the Soviet Union. He notes also that no decision has yet been made on the disposal of what remains of the Imperial Japanese Navy's fleet. The first American death in Vietnam occurs, in Saigon, as OSS officer Lt. Col. A. Peter Dewey — a distant relative of New York Governor Thomas Dewey — is shot and killed at a roadblock by three Viet Minh guerrillas. Dewey was leading a seven-man team searching for missing American pilots and assessing the condition of the country after the Japanese surrender. The guerrillas say they mistook him for a French officer. Before his death, Dewey had filed a report on the deepening Vietnam crisis, urging that the U.S. "ought to clear out of Southeast Asia." Dewey becomes the first of more than 38,200 U.S. soldiers (and 58,220 military personnel overall) killed by Hồ Chi Minh's forces.

Japanese Emperor Hirohito on September 27 visits Gen. of the Army Douglas MacArthur at the latter's headquarters in Tokyo. In India, 17 people are killed and 75 injured during religious violence between Hindus and Muslims in Bombay.

On September 28, Gen. of the Army Dwight D. Eisenhower, military governor of the American Occupation Zone, after a heated argument with Gen. George S. Patton over Patton's naïve and impolitic de-Nazification comments made on September 22, relieves Patton as military governor of Bavaria. Across Indonesia (technically, the Netherlands East Indies), anti-Dutch riots take place. In India, police in Bombay fire on rioters during the third day of sectarian violence in the city.

British troops land on Java, in the Dutch East Indies, on September 29 to help the Dutch battle Indonesian nationalists. In Buenos Aires, Argentina, an estimated 500,000 conservative protesters — upset by social reforms he had gotten passed — call for the resignation of Juan Perón, the nation's Vice President, Secretary of War and Minister of Labor.

U.S. Marines of the III Amphibious Corps land at Tientsin, in northern China, on September 30 to disarm 630,000 Japanese troops and participate in the occupation there. In the U.S., "War Time" (year-round Daylight Saving Time) is ended.

The U.S. Office of Strategic Services, known as the OSS, disbands on October 1, 1945. Heavyweight boxing champion Joe Louis is discharged from the U.S. Army. King Leopold III returns to Belgium from Austria, where he had been exiled by the Germans. A royal proclamation defends his actions during the war (including surrendering to the Germans in 1940 and meeting with Hitler, for example), but his return to the Belgian throne is met with popular resistance.

Gen. George S. Patton is notified by Gen. of the Army Eisenhower's office on October 2 that he is being removed from command of the U.S. Third Army and will head an Army unit compiling a history of the war in Germany. President Truman receives a gift from an old friend in Missouri: A painted glass sign mounted on a walnut base that says: "The buck stops here." Truman places it on his desk and refers to it occasionally during his time in office.

The United Nations Executive Committee on October 3 recommends that the organization's permanent headquarters be located in the U.S., with San Francisco as the most-favored site. Ten-year-old Elvis Presley makes his first public appearance, singing in a contest at the Mississippi-Alabama Fair & Dairy Show. Dressed as a cowboy, young Elvis stands on a stepstool to reach the microphone. He sings "Old Shep," and places fifth.

In Paris, the trial of Pierre Laval, former head of state of Vichy France, opens on October 4. The charges: Plotting against the security of the state and collaboration with the enemy. In Japan, Gen. of the Army Douglas MacArthur, Supreme Commander for the Allied Powers, orders civil liberties restored within the country. One thousand Dutch troops arrive in Batavia, Netherlands East Indies. Some cities are in the hands of Indonesian nationalist separatists, including Surabaya and Bandung.
