

Police Recognized, Budget Amendment, Archaeological Investigation, of Many Topics Discussed 6/8/22 Council Meeting

PERTH AMBOY - The meeting began with a presentation honoring 15 police officers: Acting Chief Larry Cattano, Lt. Joseph Sulikowski, Sgt. Emma Cabrera, Sgt. Sandy Rivera, Sgt. Luis Corro, Officer Luis Marte, Officer Kyle Savioa, Officer Hani Tawfik, Officer Frank Morales, Officer Selina Diaz, Officer William Perez, Officer Anthony Garcia, Officer Danny Hernandez, Officer Andrew Hadjioannou, Officer Jose Lopez.

For the ordinances with a public hearing:

Ordinance No. 1 - Ordinance to amend an ordinance entitled "An Ordinance designating restricted parking spaces for use by handicapped persons," (Ordinance No. 380-85 and amendments) adopted July 2, 1985, also known as chapter 255A et seq of the code of the city of Perth Amboy. No one spoke.

Ordinance No. 2 - An ordinance creating chapter (Inclusionary zoning) of the municipal code requiring all applicable developments to include a mandatory on-site affordable housing set-aside. Requires recommendation by the Planning Board prior to adoption

It was noted that both Ordinance No. 2 & No. 3 had to be sent to the Planning Board for review.

Resident Ken Balut spoke first in person, "How much does the attorney and experts make doing this - \$200,000 -\$300,000? This is supposed to be for the poor. Outsiders are telling us what to do. How many thousands of dollars do these lawyers make? This lawyer gets paid thousands to sit here. We pay money to lawyers who don't live in this town. You guys have to get the plan early so you see what is going on. You (the council) are the last to find out. The poor are not going to get the money - no, it's going to some rich law firm. It has to stop."

Resident Sharon Hubberman spoke via Zoom, "There is definitely a shortage of affordable housing. New Jersey is facing a crisis. The Rent Leveling Board has consistently reached out to the council for rent control. Perth Amboy does not have a quota requirement. There are two bills forging ahead for affordable housing exemptions. We don't have a quota requirement. How many applicants do you need to meet that quota? We have a lack of free space and lack of open space. You are

opening up a Pandora's Box. I advise the council not to be oblivious to what this entails and what will happen. Dig a little first and have a full investigation."

Ordinance No. 3 - An Ordinance amending section 430, zoning and land development, to create section 430-126, affordable housing. Requires recommendation by Planning Board prior to adoption

Resident Ken Balut came up to speak, "If you guys are voting on giving this to the Planning Board, why doesn't the Planning Board have this already? It should be completely reviewed by the Planning Board and the city council. Look at Woodbridge – A solar farm was supposed to be across from Wegmans. Look at it now - housing developments! Nobody is looking at this. We are looking at people having electric cars, making a huge amount of money telling us what to do. Over here, we are overcrowded. 4.5 square miles! Look at all the property at Atlantic City that's underdeveloped. All we do is rentals and more Section 8. The rich stuff the poor into a little hole. They are shipping them to us. The Planning Board and the Council - have a conversation. The Board of Education should be here, too. Where are we going to put the children? There's no place to put them. Wait till next year when they can't afford electric cars, heat, gas and all the space heaters!"

Resident Sharon Hubberman spoke via Zoom, "I don't know why you need to go to the Planning Board in order to draw an inclusionary agreement. We should be talking about open space. One family homes should be built so people can have the American Dream and own a home. I don't think they will help our town. It will strain our already strained infrastructure. A moratorium may be

Mayor Fred Henry stated that the girl's field will be finished by this fall.


Council President Mickey Gross stated that Balka was doing a great job.

Parking, Community Policing Discussed 6/6/22 Caucus

By: Katherine Massopust PERTH AMBOY - There were two presentations. The first presentation was by Anna Wilkins Daily, expressing appreciation to the city for the work she has done over the years. (see op-ed on p.4. for full statement).

The second presentation was by Mike J. McAtee from Urban Engineers who gave a presentation on the Fayette Street Bridge.

Ordinance No. 2 - An ordinance creating the chapter (Inclusionary Zoning) of the Municipal Code requiring all applicable developments to include a mandatory on-site affordable housing set-aside.

Ordinance No. 3 - An ordinance amending section 430, Zoning and Land Development, to create section 430-126, Affordable Housing.

It was noted by Law Director William Opel that the Planning Board has to hear Ordinances 2 & 3 therefore these two ordinances were tabled to give the Planning Board more time. Ordinance No. 2 (first reading) - An ordinance authorizing a lease agreement between Grzankowski Holdings LLC and the City of Perth Amboy for property located at 497B Smith Street for use as a Perth Amboy Substation. Acting Police Chief Larry Cattano came up to speak, "The substation is for that section that does not have anything officially designated from that location. It will have video surveillance. We received computers from the military – brand new in the box." Council President Petrick asked how many officers will be stationed there. Cattano answered, "Special Ones from Monday thru Saturday. For the summer, on Sun-

days, there will be a couple of hours per day. It is the gateway to our city. There is a 1-year lease so we can try it out. There is parking in the rear and adjacent."

Council President Petrick then asked Business Administrator Michael Green about the proposed Fire Substation on Amboy Avenue.

Green answered that the location needs to be inspected further to see which way to proceed.

Petrick then asked about the Budget Amendment.

Green answered, "The administration gave its amendments, unless the council decides against the administration's amendments."

Petrick stated, "We have a budget now. Work with it. Get it done."

Resolution R-296-22 – Authorizing the City of Perth Amboy Fire Department to submit an application to the NJ American Rescue Plan Firefighter Grant Program in an amount not to exceed \$75,000. Fire Chief Ed Mullen came up to explain about this. He stated it is for a turnout gear washer and dryer and an airpack (SCBA - Self Contained Breathing Apparatus) washer. "This equipment washes 14 air-packs an hour. It will remove all carcinogens in the equipment and keep our firefighters safe and healthy."

cepting an award from the New Jersey Department of Transportation for the Safe Routes to School (SRTS) Program in the amount of \$650,000.

Councilman Joel Pabon stated discussing parking for the new high school being built on Convery Boulevard, "There is zero parking in the area. Even if you took away the Youth Complex, there is no parking. I don't know how much you can do, asking maybe for a parking deck. They built that little park. All the houses are supposed to be gone. I think we better start things today. It is a disaster waiting to happen. It's crazy. Where is the parking?" Pabon then stated, "At the last meeting, residents complained about one bar. What do we do with schools? There is no parking there. No one is thinking about parking. We have to start thinking about this now. We have to start thinking where they are swapping land." Tashi Vazquez who is the Vice-President of the Board of Education came on Zoom, "As requested, \$650,000 spending grant to increase walkability to the Rose Lopez School. This specific elementary school safety concerns, also included safety and separate traffic signs and crosswalks to ensure the safety to schools. Rose Lopez School was singled out." Vazquez stated that a traffic light will be put on Ogdon and Seaman Streets. City Engineer Jeff Rauch spoke on Zoom, "The county is doing a signal on New Brunswick Avenue and Ogdon and on Ogdon and Seaman Avenue. When a dispatch emergency goes green on Ogdon and Seaman, it goes red for Seaman allowing vehicles not colliding

Statement by Anna Wilkins Daily at the 6/6/22 Caucus I am Anna Wilkins Daily.

First, I want to clarify that even though I do not have any biological relatives who live in the state of New Jersey, I am not planning on moving anytime soon.

Thank you, Mr. President for giving me this opportunity to share my gratitude to this city for opportunities to service this community,

I want to extend my Welcome to the most recent council members and staff whom I have not met.

1. When I first moved here in 1967 from North Carolina, I worked briefly as a substitute teacher before I became Lab technician at Raritan Bay Medical Center where I was the only blood bank technician during the evening shift.

2. While obtaining a Master's Degree in Urban Science education at Rutgers University I completed a one year internship teaching middle school science in Plainfield, instead of working in Plainfield, I decided to pursue a teaching position in Perth Amboy. By that time my husband and I were property owners here in Perth Amboy, and had a one year old son. So I wanted to work in the community where I lived.

During my 32 years in the science department at Perth Amboy High School, I taught courses in Medical laboratory techniques, Microbiology, Health Careers Awareness, Laboratory Animal handling, Earth Science and Biology. Each year I took the Earth Science classes to the water treatment plant and waste water sewage treatment plant for a better understanding of our environment and the relevance of the text book information. 3. My first year teaching, I was assigned to teach Medical technology, microbiology and A course in Laboratory Animal handling, I Developed, wrote the curricula for the courses in Medical laboratory Tech-Microbiology, and niques, Health Career awareness and explorations. There were no curriculum, teacher's guide nor

I was selected by Princeton University as a Distinguished High School Teacher for the state of NJ and the National Science Teachers Association as the National Number 1 Exemplary High School Science Teacher for the entire United States.

I always reached out to the parents, participated in community activities, and tried to make the lessons relevant and interesting. We did not have computers during that time. I had the students do lots of research exercises that required the students to use encyclopedias, newspapers, visit both the school and local public the library. I had my classes get library cards so that we could use materials in the public library for various assignment. I took out a school subscription to one of our area newspapers so that Each week we received a classroom supply of newspapers.

It was the city of Perth Amboy and parents that afforded me the opportunity to expose students to my self-designed methods of teaching and achieve all the honors and awards as an outstanding educator. I also attended Kean University where I obtained a second master's degree. I was a volunteer in church and community organizations. As a member of the Perth Amboy Public Library bd of trustees, I served under 5 presidents and was the secretary before being elected president. Throughout the years and under different city administrations, we were always told that the library bewe voted for, and they should be helping us in the first place. It was said promises from a politician goes through one ear then comes out the other ear! "How True!"

longed to the city, and the trustees served in advisory capacity. Having attended various state trustees functions I was made aware of governing boards. We wrote the city administration with copies to the council when we inquired about becoming a governing board but were always told that the library was a municipal entity, and trustees were only allowed to advocate for the library, and were sternly told that we were to have nothing to do with the staff since they were civil service employees.

The library never had enough employees to qualify for the maximum amount of state funding. There were times when we would come before the council advocating for more staff.

The trustee board had no say in who was appointed to the board, hired staff, or replaced. We were told that only the city administration could hire and or dismiss staff. Thus we had nothing to do with the former director leaving.

Trustees helped initiate the plans to renovate the building. We had a committee who along with a former city administer interviewed various contractors with the architectural plans. What we submitted was not accepted by the city, and completely different plans were made. It was the trustees who started having the Taste of Perth Amboy as a fund raiser. We also had other programs to help raise funds for renovating the library.

Shortly after the former mayor assumed her seat on the board, we started getting money from the county and freeholders. The mayor as well as a former school superintendent both took their seats as members of the board of Trustees. City ordinance required a seat on the trustee board for a school board member as well as mayor. We also made copies of the Bill of Rights that are posted on the wall.



more advisable."

Council President William Petrick stated, "I completely agree with you. The council needs to send this to the Planning Board who does a perfunctory review. I was opposed to this, but it is a court mandate."

Hubberman then added, "I would like to see this court mandate. Urban communities are exempt."

Petrick then said, "I tried to get a second set of eyes to review it."

Law Director William Opel said, "According to municipal land use, the Planning Board is required to review."

Petrick then stated, "I agree with Sharon Hubberman. There is no real affordable housing requirement in Perth Amboy. It's multifaceted and allows the city to control the process."

For Ordinances No. 2 & No. 3, the council voted unanimously to send the ordinances to the Planning Board.

Ordinance No. 4 – An ordinance to amend an ordinance entitled, "Police Department" (Ordinance No. C-74 and Amendments) adopted October 17, 1928, also known as Chapter 95 of the Code of the city of Perth Amboy. Re: Composition

Resident Ken Balut came up to speak, "You're going to need this. Atlantic City is 4.5 square miles. 210 (police officers) for 4.5 square miles and their housing is for the summer. People can't afford the gas money. People can't afford to go to the shore. You are going to have fights, loud music, etc. We are going to need more police. There should not be 15 minutes to answer a police call or ambulance calls. You get \$15 million. We need more police officers now on the streets - to be proactive and stop car accidents. You want more people here. They can't' afford to go down the shore with \$4.99 for a dozen eggs and the rising cost of gas. How are the poor people going to enjoy the summer? How are they going to the shore? You need to take care of the poor people in this town. From Joe (Vas) to (Wilda) Diaz to (Helmin) Caba – doing the same thing. The poor get nothing Resident Sharon Hubberman spoke via Zoom, "In regards to this ordinance - we need to add those extra ten officers to the Police Department. If you were to look at the recommendation to the size of the population, that is a better number than 135. There is the position of another captain if we rule out the Deputy Police Chief (Only have a Police Chief) in structure. You need leadership roles to mange as addressing the police force." Councilman B.J. Torres voted "No". All the other councilmembers voted, "Yes." Public Comments on Agenda Items Only: Ken Balut spoke first, "We can save a lot of money if we do the right things. If you sit and ask questions and look at reports. My first meeting I saved \$25,000 by asking questions. The lawyers don't care about this - it's taxpayers' money. The budget. This is June. You should be saving money. \$15 million from the American Rescue Act. It is for the people right now. Money needs to be spent. It's the American Recovery Act to help the poor. Next meeting I'd like to know where the money has to be spent. It's not wait around two years for election time. It belongs to the people."

The next person to speak is Resident and Musician Toney Lee. He spoke about R-306/6/22

"When I found out it about Thomas Mundy Peterson, I researched it myself. I work with kids. I am a mentor for boys ages 9-12. Information is vital. I need to be here to say this. It makes us proud. Young people need this right now."

Sharon Hubberman spoke via Zoom, "The amendment to the Budget - it appears year to year there is an increase in expenses and other expenses. What are these other increases? Business Administrator Michael Green stated, "This amendment increases the salary for additional cost for an individual transferred to the Clerk's Office. Some of our employees got transferred. There are more costs for gas, electric, diesel. Fireworks gets \$8,000. Perth Amboy is cohost. The OECD (Office of Economic and Community Development) is adding \$2.5 million worth of grants."

Hubberman then added, "Other expenses - salaries and wages included?"

B.A. Michael Green said, "Add the cost of about \$503,000 in addition to the budget. List of adding grants."

Councilman B.J. Torres said, "There is an increase in the fireworks is the additional amount. South Amboy is with us. Do they share with us?"

B.A. Michael Green added,

For the consent agenda, R-288 thru R-300 and R-302 thru R-305 was moved by Pabon, seconded by Tejeda.

R-301-6/22 – Authorizing the Planning Board of the City of Perth Amboy to conduct a preliminary investigation to determine whether a certain area within the Municipality is a condemnation area in need of redevelopment. It was moved by Pabon, seconded by Tejeda. All voted, "Yes."

Councilman Pabon remarked on R-306 (Thomas Mundy Peterson Site Archaeological Dig), "This should have been done a long time ago. It was supposed to include the kids from schools. We should pass this." It was moved by Pabon, seconded by Tejeda. All voted "Yes."

R-307-6/22 – Amending the CY 2022 Budget.

R-307 was moved by Tejeda, seconded by Morales. Pabon and Petrick voted, "No." Tejeda, Torres, Morales voted, "Yes."

Council President Bill Petrick explained why he voted, "No." "There are a number of factors here that the general public does not see. The amendment to the budget requires moneyfor a \$40,000 increase in salary for an administrator on above 2-digit salary. One makes \$100,000 and wants to add \$40,000. A number of people who were campaign workers were hired at \$40,000 apiece. People were hired at \$80,000 and get hundreds of thousands. When the budget is submitted to the administration and ignored after several weeks, this is in no way good for the community. It is neglectful. We have an obligation to the community to oversee the government. I don't see this on this budget amendment. I don't see the council justifying this as requested. That is why I voted, "No."." Late-starter Resolution R-308 - The 2022-2023 Perth Amboy School Budget General Fund. To add to the agenda, it was moved by Tejeda, seconded by Pabon. To add all voted, "Yes." When it came to pass the resolution, it was moved by Tejeda, seconded by Morales. William Petrick voted, "No."

Public Portion (in-person first): **Retired Police Captain Miguel** Pellot spoke first. "Giving me time on Monday, Mr. Green sent out an email. P1 has moved and P2 will begin very shortly. We will never forget. It was said by President Bush at the evening of September 11, 2001. What it means to me: 6 Perth Amboy Police Officers were sent to Ground Zero. Anything we can do to divert terrorist attacks. I will never forget what I heard, saw, smelled that day. Many years later, I became sick and had to leave the job I love. I took an oath to protect people and go by the law. I want to remind you - you also took that oath. Put morals over money. Each case is individual. I want everybody to speak your truth. Sometimes all people want is the truth. They may not like what they hear, but it's the truth. I will continue to speak my truth. People want to hear the truth. That's all I ask of each and every one here."

Ken Balut spoke next, "Thomas Mundy Peterson - It's Kushner's property. The past administration bent over backwards for Kushner, Donald Trump's brother-in-law. I had to fight to get Kushner to pave that road. Kushner - they always bend over backwards - why are we negotiating a PILOT for Kushner? Why? He owes us \$4 million from 2006. This alone everyone should be aware of. Kushner should have gone out of his way to negotiate. Why is everybody afraid of Kushner? Read McGreevey's book. No one has an answer. Fernando Gonzalez and I wanted to dump him. Why does McCabe and Northgrave love Kushner? 14 some years later and he still gets away with this. It has got to stop."

Resident Maria Vera spoke via Zoom, "Mr. Green, our administration is supposed to make our town perfect. What has Mayor Caba done for Perth Amboy? It's been 2 years." Green did not answer.

Vera then continued, "He doesn't have an answer. It's called incompetent. What is your vision for Perth Amboy? If there is no vision, you are not doing your job." Green answered, "Make and continue to make Perth Amboy a safe place to live and work." Vera said, "We had a bar with a shooting and complaints. You tell me you are protecting the people. Green explained, "The El Patio Bar is going before the ABC (Division of Alcoholic Beverage Control). We do not live in Russia. This is the United States. I do not have the legal authority to take their license. We want to see a safe Perth Amboy. We received grants from the state and the federal government to assure quality of life for our residents." City Director Joel Rosa spoke next via Zoom, "I am a proud Perth Amboy Resident. I am Chair of PARA (Perth Amboy

Redevelopment Agency). We are doing our due diligence. We work in unity. I welcome all residents to come. Our meetings are on Zoom on Tuesday at 6 p.m. and the links are posted on the city's website. We are the ones who work on a city project. You can email me at JRosa@ PerthAmboyNJ.org I will make myself available to the council. I wouldn't mind making a presentation to the council."

Resident Lisa Nanton spoke via Zoom, "Thank you for supporting R-306 (Thomas Mundy Peterson Archeological Investigation). I want to thank Councilman Pabon for voting against the budget. Why aren't the PARA meetings in person? They are on Zoom, then they go into closed session, and nobody knows what is going on. When I was on the city council, I had to have a thick skin. I will listen to the gadflies, and I listened to the public at those council meetings. We removed our Law Director who was selling our waterfront property for next to nothing. When the public talks, they have the courage to speak up, and you should listen." Nanton then asked the Business Administrator if he did his homework and could answer the questions she asked at the previous caucus.

B.A. Green stated he indeed answered the questions and had sent her an email with the answers. He proceeded to read out loud the email he had sent to Nanton.

Sharon Hubberman spoke via Zoom, "I was reading the 2020 Water Quality Report on the city website - a notice from Middlesex Water. I did not receive a notice in the mail regarding this notice on the city website. I received some feedback to disregard the notice since it does not involve Perth Amboy. If the notice is on the city's website, why was it not mailed to everyone? In the Waterfront, people climb on the bars (to the beach) which is very unsafe. I saw a person climb over the barrier and came out with a marijuana (cigarette). It is a health hazard. I thought there was no smoking (in certain areas) and it is not being enforced."

Council Comments:

Councilwoman Rose Morales

"Someone is moving Clerk's Office - we need a Records Clerk." Green explained that the city must advertise internally first, then if no one is hired, the city can advertise externally.

Council President Bill Petrick asked how many votes will be needed to pass the amendment to the budget. Law Director William Opel answered that under the Faulkner Act, the budget needs 3 votes to pass under Section 46.

Ordinance No.2 (First Reading) – An ordinance authorizing a lease agreement between the Grzankowski Holdings LLC and the city of Perth Amboy for property located at 497B Smith Street for use as a Perth Amboy Substation.

Councilman Joel Pabon said, "We have a police substation on Madison Avenue. People double thanked everyone who participated. "On Monday, I do appreciate comments for my wellbeing." She then asked about her concerns with the transparency of Zoom, "Now we use this technology to participate in the meeting. Certain individuals use false names and attack council members. She asked Law Director William Opel if it is possible to track down and find out who is falsely using the technology.

Opel stated that he was not sure if it could be done, but a technician would be better to answer, but legally there are privacy issues. "The council chose hybrid meetings. I don't know what results we will see. We have in the past allowed people from California to speak. There

with parents (vehicles). There will be crosswalk improvements. Safety comes first. The crossing on New Brunswick Avenue will have ADA ramps and on Ogdon and Seaman, the entire signal will be tied into New Brunswick Avenue and Amboy Avenue. Red for Seaman, green for Ogdon. Also green for New Brunswick Avenue, red for Amboy or coming down New Brunswick Avenue.'

There was a discussion regarding the Budget which the administration wished to be amended.

B.A. Michael Green stated that there were additional costs. Council President Petrick argued that these items were not part of the original budget and there is no vote on record. Green stated that the budget incorporates a grant list and utility costs have increase and there also was a hiree in the Clerk's Office. He added that the budget amendment needs 3 votes to pass.

Law Director Opel reminded the council that this is a caucus meeting, and the voting is Wednesday (6/8/22) at the regular council meeting.

Petrick then stated, "This is not our job. The budget has been confirmed by the state." He then said that the council needed more time to look at it. Public Comments:

Resident Anna Daily came up to the mike first, "I once was a resident where they are building the new high school. Something needs to be done. Regarding the Thomas Mundy Peterson Archeology Dig (R-306), the Historical Commission was trying to get that done for so many years. That is when we got the plaque (in city hall council chambers). My understanding is that the funding is around for it – if it is not approved by the city, whatever this holdover is, I am pleading with you to pass this."

The next person to speak was a woman with the first name of Aliana who spoke in Spanish over Zoom. Councilman Pabon translated. "There are 2 issues. Why are police officers not protecting properties? Every day I get tickets after tickets on her car. Our phantom mayor is not around. Tickets are for opposite side of the street (parking). It doesn't matter where you park." Resident Lisa Nanton spoke via Zoom. She asked about Ordinance No. 4 - An ordinance to amend an ordinance entitled "Police Department" (Ordinance No. C-74 and Amendments) adopted October 17, 1928 also known as Chapter 95 of the code of the city of Perth Amboy. Re: Composition

Nanton then asked about the Bridge on Fayette Street, "Who is responsible to secure funding options. Who is responsible for inspecting and the cost of the bridge (construction of the bridge). The Construction fund is TBD. 10 years later, we still don't know who is going to fund the bridge"

Petrick answered, "One bridge the city of Perth Amboy is responsible for. Other bridges we have in town - those are all NJ Transit Bridges."

Colonia Resident Raji Patel who is a former Perth Amboy resident spoke via Zoom, "I moved out more than a month ago. I am a longtime resident of Perth Amboy. There is a lot of drugs. How come we never see the mayor? What are my taxes going to? This is unfair and unreasonable. You guys have to put it together. My next-door neighbor's convertible was stolen. There was a shooting in Harbortown. Another homicide in the last year. I have to leave my town. Leave - no one really cares. Nobody says nothing. Kids being bullied, everybody only worried about their money. Big music all the time - not a priority call. Have to get it together. When do I hear the mayor talk? What does he have to say to citizens? A PILOT? You want a PILOT? What about residents? Hard working people?"

Resident Maria Vera spoke next via Zoom, "Listen. Truly in his heart he had to move out of Amboy because we have a mayor that doesn't care. We do have a lot of crime in town. We all pay taxes. Yesterday two houses were playing loud music at 2:00 a.m. We have to go to work tomorrow. The Waterfront is a great place to be. Mr. Green, what do we pay for - port 'o potties locked, if they work? Would you go into one?"

B.A. Green answered, "I am a marine and I would go into one."

Vera added, "We have a port 'o potty, and the owner (of the house behind it) sold her house because it leaked into her house. Stop spending money on something we don't need. The days we are having music down the Waterfront. We need more check points. We have too many crimes. There were three huge are First Amendment issues if accidents in the last weeks. There are too many cars with dark tinted windows. If somebody hits me, how will I know if it is a guy or a lady? The substation. We don't see cops walking anymore." Vera proceeded to complain about dog poop all over the Waterfront but ran out of time on the clock." Acting Police Chief Larry Cattano came up to the microphone, "We have officers assigned to areas. We respond. It is difficult to catch every car (playing loud music). They see the police car and turn it down. Harbortown - we just had a social down there with police officers." Cattano then spoke abut crime, "We come across windows smashed. It's a nationwide problem. We are working with the FBI on a large scale operation."

Thanks to the council and administration, funds were made available to make the plaque that currently hangs on the wall of council chambers. I helped pursue the efforts to get the day that he voted recognized by the state legislatures as Thomas Mundy Peterson Day each year. I learned about Juneteenth, and as a member of organizations in other cities, our efforts were instrumental in getting it a national holiday. One of my organizations is having a Juneteenth Flag Raising Ceremony on Sat. June 18th here in front of city hall at 3 p.m. Everyone is invited to attend.

I share in the great pride of this historic city.





Series Review: Moon Knight

"If this the real world, I want to go back and save the world." – Mark.

Marvel and Disney+ brings another hero to TV in the new streaming series, "Moon Knight," based on the Marvel Comics superhero. First of all, who is Moon Knight? Originally, the character was more like Batman, fighting werewolves, monsters, and street level crime. In recent decades, new writers have dived into the psychological element of Moon Knight and how he is connected to the Egyptian gods, especially the god of the moon.

We will go through each of the 6 episodes, and then I will tell you: Is Moon Knight worth watching?

Episode 1: The Goldfish Problem - Steven Grant (Oscar Isaac) works at the British Museum in London. He longs to become a tour guide but is just a guy who works at a gift shop, and he is having problems sleeping. Everything is thrown into chaos when Steven wakes up in the Austrian Alps and meets a cult leader, Arthur Harrow (Ethan Hawke). Harrow is associated with Ammit (the Egyptian crocodile goddess who devours your soul if you are not worthy). Steven has two personalities: one is Steven, the other Mark. Both are the avatar for Khonshu (the Egyptian god of the moon). He believes in protecting the innocent, but he is brutal. Artur wants Steven to give him his scarab that will lead him to the tomb of the crocodile goddess so he can unleash her. Steven lets Mark take over the body and summons protective white armor and transforms into Moon Knight and unleashes a jackal while he is in the museum.

Episode 2: Summon the Suit

- Steven is learning how to control this ability and trying to stop this cult leader, and to dealing with a god who wants

both Mark and Steven to cooperate and do his job. Steven has a wife, Layla El-Faouly (May Calamawy) whom he is on the brink of divorce. Arthur was the avatar for Khonshu, and Arthur wants the scarab to find Ammit's tomb. His wife tells him not to do it because the cult leader's plan is to wipe out humanity. Two different suits come into play. When he is Steven, he is in a suit and tie and mask that covers his entire face, and Mark is a full cloak and armor. They kill the jackal but lose the scarab.

Episode 3: The Friendly Type – While looking at Ammit's tomb, they follow the clues. Mark wants to go before the Egyptian gods so that they can stop the cult leader from destroying the world. This leaves our heroes without any powers for a while.

Episode 4: The Tomb – Steven, Mark, and Layla eventually find clues to the tomb. Both Mark and Steven's knowledge help them find the tomb of crocodile goddess. Her vessel is contained to be protected by the Eye of Horus and they find in the inside of a sarcophagus inside the body of Alexander the Great. Mark and out get it out but are shot by the cult leader's followers. Mark wakes up in an asylum.

Episode 5: Asylum – Eventually both personalities: Mark and Steven find out they are not in an asylum but are on a mystical boat on their way to the afterlife, with the hippopotamus woman goddess Taweret and she is taking them to the afterlife. Mark and Steven discover a lot about their past on this journey and what are the causes of his psychological problems and why he can't sleep at night, what happened to his brother, and his relationship with his mom. Mark wakes up and finds out that he has reached the afterlife, but he has to go back and defeat the cult leader before all



humanity is destroyed.

Episode 6: Gods and Monsters – The final confrontation begins when Arthur unleashes the crocodile goddess and spreads power among his followers in order to destroy all of humanity. Khonshu tries to stop the goddess himself but is unable to. Mark and Steven fully regenerated through their powers defeat the cult leader and bury the crocodile goddess inside Arthur. Khonshu wants them to end the cult leader's life, but Mark refuses. Our hero ends back in his small flat in London trying to come to terms with his life. Khonshu finds a new avatar.

Is this show worth watching? Absolutely. It is more than just a TV show that is about a superhero who uses Egyptian powers to defeat bad guys. It is more of a statement about the mentally ill, and the deep problems that they have, how people deal with stress, loss, abandonment, pain, and is excellently well acted by Oscar Isaac who is playing three characters at the same time: Steven, Mark, and Moon Knight. These are three complicated characters who are trying to work together to stop this great evil, but also are trying to work out their own problems.

Marvel and Disney have given all their shows big budgets, and these shows are like giant mini movies. Don't worry, there is plenty of action and adventure, but you have to watch them all in order to follow. It is really worth your time to watch.



This Week in the Civil War 160 Years Ago June 15, 1862 – July 5, 1862 By Phil Kohn

From Tucson, Arizona Territory, Col. James Carleton, commanding the Federal California Column, on June 15, 1862, dispatches three couriers to alert Col. Canby, at Ft. Craig, of his presence. (Carleton is unaware that Canby has been promoted to brigadier general and is at Santa Fe. Col. John Chivington, of the 1st Colorado Infantry, is now at Ft. Craig and the commandant of the Southern Military District of New Mexico.)

Union troops, on June 16, attack at James Island, South Carolina, a location crucial to the control of Charleston harbor. The federal attack is soundly repulsed. In Confederate Arizona, troopers of the 7th Texas Cavalry are once again set upon by local residents while foraging. This time the fighting takes place close to Mesilla, not far from Ft. Fillmore, where the troopers are based. The locals resent the Confederates' attempts to take what sparse forage there is in the area. One Confederate officer and seven troopers are killed in the melee.

On June 17, U.S. Army commands are shuffled in the East. Objecting to being subordinated to Maj. Gen. John Pope — brought east to head the Federal Army of Virginia — Maj. Gen. John Frémont requests to be relieved, tendering his resignation from the army. Frémont is replaced by Maj. Gen. Franz Sigel.

Brig. Gen. George Morgan's 9,000 Federal troops seize the Cumberland Gap in the Appalachian Mountains near the junctions of Kentucky, Virginia and Tennessee on June 18. Capture of this pass through the mountains by the Union presents a serious problem for Confederates in eastern Tennessee. In Arizona, the three Union couriers that had been dispatched from Tucson to alert Ft. Craig of the California Column's presence at Tucson are attacked by Chiracahua Apaches as they cross into their territory at Apache Pass. Two of the men are killed, but the third — John Jones, a civilian scout — wages a two-hour, running gun battle and escapes, continuing on his way to the Rio Grande.

On June 20, a Union advance is made on Vicksburg, Mississippi, the last Confederate stronghold left on the Mississippi River. Southern troops under Maj. Gen. Earl Van Dorn begin further fortifying the defensively strong city. Disturbed by Gen. Beauregard's loss of Corinth, Mississippi, President Davis declares Beauregard — who has put himself on sick leave — absent without leave and places Gen. Braxton Bragg in command of the Army of Tennessee.

A 140-trooper detachment of the 1st California Cavalry, under Lt. Col. Edward Eyre, departs Tucson for Ft. Craig on June 21.

On June 22, Lt. Col. Eyre's detachment of 1st California Cavalry troopers is attacked by Chiricahua Apaches as they traverse Apache Pass in the mountains east of Tucson. The Apaches are driven off and the detachment continues on its way with no casualties.

Having arrived at Richmond from the Shenandoah Valley, Maj. Gen. Thomas "Stonewall" Jackson on June 23 meets for the first time with Gen. Robert E. Lee and his command staff: generals Daniel Harvey Hill, A.P. Hill and James Longstreet.

In an attempt to head off what is feared will be a crippling blow to Richmond, Gen. Robert E. Lee, on June 25 begins, at Oak Grove, Virginia, a series of offensive thrusts at McClellan in what will come to be known as the Seven Days Campaign. In the West, civilian scout John Jones, after completing a hazardous ride of 200 miles all alone after his escape from an attack by Apaches, arrives at the Rio Grande about five miles north of Mesilla. Turning north to head for Ft. Craig, he is captured by pickets from the 7th Texas Cavalry and brought to Ft. Fillmore for interrogation. Col. William Steele confiscates Jones's dispatches, learning of the whereabouts of the California Column, its numbers and its planned movements. Steele begins preparations for moving his command.

Lee's Confederates hit McClellan's troops at Mechanicsville, Virginia, on June 26. Out West, Col. Steele sends a message to Brig. Gen. Sibley that because of a scarcity of food and forage, a growing number of men falling ill, hostile locals and the approaching California Column, he will have to abandon Ft. Fillmore, near Mesilla. Meanwhile, Jones the scout, manages to communicate with Union sympathizers from his jail cell, and they alert Col. Chivington at Ft. Craig that reinforcements are on the way.

In the third of the Seven Days Battles, at Gaines' Mill on June 27, Lee loses 8,750 casualties to McClellan's 6,837. McClellan, however, still fearing that his Army of the Potomac is greatly outnumbered, continues pulling his forces back.

The Seven Days Campaign continues with a clash at Savage's Station, Virginia, on June 29, 1862, marked by confusion on both sides. The Army of the Potomac continues its withdrawal, leaving behind some 2,500 sick and wounded soldiers. In New Mexico, alerted by local Unionists that the Confederates at Mesilla had captured a Union courier who says that reinforcements are nearing, Col. Chivington dispatches scouting parties westward from Ft. Craig to search for them. One of them runs into Lt. Col. Eyre's detachment of California Cavalry.

June 30 sees the sixth engagement of the Seven Days Campaign, at White Oak Swamp. The federals are able to consolidate their position, but McClellan again orders a withdrawal southward, to a strong position on Malvern Hill, north of the James River.

July 1: Confederates under Robert E. Lee attack McClellan's Army of the Potomac at Malvern Hill,

Southern forces seem disorganized and are held off by the Federals' wellplaced infantry and artillery. The action marks the end of the Seven Days' Campaign. Afterward, the Federals withdraw to Harrison's Landing on the James River. The result: McClellan remains near Richmond, but the Virginia capital is still unconquered. Neither army has destroyed the other. The Seven Days' toll: for the North, 16,000 casualties; for the South, over 20,000. At Booneville, Mississippi, some 850 Union troops led by Col. Philip Sheridan defeat a Confederate force of around 5,000 under Brig. Gen. James Chalmers. In Washington, the government approves a joint venture by the Union Pacific and the Central Pacific to build a railroad across the West.

On July 2, Abraham Lincoln calls for 300,000 more volunteers for three years' Federal military service. He also signs into law the Morrill Land Grant Act that will give states federal land upon which to build agricultural colleges.

Federal troops under Col. William Weer on July 3 engage and defeat Col. Stand Watie's Cherokee Mounted Rifles at Locust Grove, northwest of Tahlequah, the capital of the Cherokee Nation, in Indian Territory.

In an attempt to counter Union moves and strengths in Tennessee, Gen. Braxton Bragg, now commanding the Confederate Army of Tennessee, plans an invasion of the central portion of the state emanating from Chattanooga in the east. Accordingly, on July 4 he begins shipping the bulk of his army — division by division, by train — from Tupelo, Mississippi, to Chattanooga. To create a diversion, Confederate Col. John Hunt Morgan on July 4 launches a partisan cavalry raid into Kentucky. On July 5, Maj. Gen. Ambrose Burnside sails from his base in North Carolina with Federal reinforcements for McClellan's Army of the Potomac, camped along the James River, southeast of Richmond.







Public Notice of EPA's Proposed Approval for Polychlorinated Biphenyl (PCB) Cleanup Plan at the Former ASARCO Facility site Perth Amboy, New Jersey Date: June 17, 2022

The U.S. Environmental Protection Agency (EPA) has prepared a draft approval of the polychlorinated biphenyl (PCB) cleanup plan submitted by First Environment, Inc. for a portion of the Former ASARCO Facility site in Perth Amboy, New Jersey, under the agency's PCB Cleanup Program.

The cleanup plan calls for removing and disposing PCB-contaminated soil offsite, engineering a site-wide cap, and institutional controls, more specifically, a deed notice to maintain the cap for PCB-contaminated soil indefinitely. Once the soil is removed, First Environment, Inc. will sample to verify that PCB contaminated materials have been removed from the site. They will install the cap and sample soil gas below the surface. To prevent further migration or unacceptable exposures of PCB contamination at the site, First Environment, Inc. will implement further actions if necessary. Once completed, long-term maintenance and monitoring of the lot-wide cap will continue.

EPA is taking comments from the public on the draft approval for PCB cleanup at the Former ASARCO Facility site from **June 17, 2022** to **July 18, 2022**. EPA will consider comments submitted during the comment period before making a final decision. If EPA issues an approval, the owner of the property must accept the approval in writing, and cleanup activities will follow. Comments may be emailed to <u>everett.adolph@epa.gov</u> or postmarked to the mailing address below no later than **July 18, 2022**.


