#### The Future of Sunshine Alley, Funding for City Employees Remain Prevalent

11/21/22 Caucus/Council Meetings

PERTH AMBOY - The caucus started off with a presentation by Renee Skelton who is the Chair of the Historic Preservation Commission. She stated that the grants available are few and far between. "There is a lot of competition for this money for items that are already on the State Register. Sunshine Alley does not qualify for those grants. I tried to push Sunshine Alley into a qualified category to recognize that it should be on the National Register. We were told that it should be a part of a larger range of historic streets. Cobblestone and Butcherblock are unique. You asked what is the restoration plan. It will cost between \$25,000 to \$30,000 to restore the alley. We got a \$7,500 grant for the whole year thanks to the OECD. There are certified local governments who do a good job at preserving their history and they are eligible to receive grants between \$25,000 to \$30,000 each year. We are trying to revive our ordinance to make the HPC work better. We've used the State Preservation Historical Society and lawyers familiar with preservation and other towns (with an active HPC) to consult with. We are an advisory board and not regulatory. We report to the Planning Board. Our objective was to list our historic landmarks. We've had demolitions and destructions happen because they were not listed as historic sites. A revision of the ordinance will give us more guidelines and we've used some of the information from other HPC's cities. Business Administrator Greene was more concerned about protecting private property sites. We do not have eminent domain rights. We should have meetings to decide what we want to do. We can't force ourselves on anyone. We need to put this revision on the agenda and time is running out. Council President Petrick has tried many times to put this on the agenda."

Council President Petrick responded, "We can introduce this ordinance tonight when we go

into closed session." He also responded, "Yes," when Skelton asked him if this will be on the agenda for first reading tonight.

Skelton continued, "New Jersey has a \$3 billion tourism industry. I volunteer at the Proprietary House, and we get people coming to visit from all over the State of New Jersey. The Proprietary House is the number one tourist attraction (in the city) and we can work with the local businesses. Perth Amboy was chosen to participate in the 250th Anniversary of our Country in two years. We are economically disadvantaged and need every opportunity to showcase our town."

Councilman Joel Pabon spoke up, "I was surprised that no one talked to you about Sunshine Alley until you saw it being discussed on a Zoom Meeting."

Law Director William Opel then spoke up, "The council wanted to appropriate funds for bids to do the work."

Skelton then explained, "If the council looks at the amendments to the ordinance, the red markings are additions, and nothing has changed from the original ordinance."

Councilman B.J. Torres then spoke up, "What will be the maintenance on the alley? How much will it cost? And what are the plans for the alley?"

B.A. Greene responded, "When we have our walking tours, the alley could be included."

Torres continued, "This can be an investment to boost our history and culture, but we need to have a return on our investment."

Skelton then reminded the council, "The historic value of the town is part of the Master Plan."


Petrick then spoke up and said, "That will come out of the Planning Board."



#### Abandoned and Vacant Properties, Sewer Bill Increases Topics for Discussion 11/21/22 Council Meeting

By: Katherine Massopust SOUTH AMBOY – There was a brief discussion about Ordinance No. 22-16 which affected abandoned and vacant properties. Councilwoman Zusette Dato asked what the penalty would be regarding the history of the ordinance is have the properties been neglected.

Business Administrator Glenn Skarzynski stated that it came into question when there is a property that didn't comply.

Law Director Francis Womack stated that the ordinance would comply with new state laws and the fines and penalties were adjusted accordingly.

Dato asked, "If the city must take care of abandoned property, do we put a lien on it?"

B.A. Skarzynski answered, "It (the ordinance) puts in a lot of things. It is now much easier (to take care of the blighted properties)."

**Council Comments:** 

Councilman Tom Reilly thanked the food pantries and first responders. He reminded everyone of the Friends of South Amboy Basketball Event on Saturday, December 17th at South Amboy High School. "Come down to support our charity. The Friends of South Amby help people feeling hardship. 50/50's will be sold. It will also be on South Amboy TV. I wish everyone a Happy Thanksgiving. Consider volunteering for the First Aid Squad and Fire Department. They are always looking for volunteers. Support local businesses."

Reilly then asked about the raise in sewer rates.

B.A. Glenn Skarzynski answered, "Three years ago, we informed the public that we were not self-sustaining. It has been 11 years since there was an increase. The adjustment in rates will increase over a 3-year period. We were under drought conditions and water use is up, specifically water usage. We are taking a critical look in that. Our goal is to make sewer selfsustaining. Only different fees is the 65+ years or disabled. Everyone else is raised. It's on our radar."

Reilly asked about the infamous "Pigeon Palace."

B. A. Skarzynski answered, "An entity is looking to purchase it. I hope to have a date in a few weeks."

Reilly stated, "I ask to make that a priority. We've got to get that thing knocked down."

Councilman Brian McLaughlin wished everyone a Happy Thanksgiving. He asked why the Ferry Terminal is up for rebidding.

Skarzynski answered, "It should be \$2 million. We are rejecting all the bids and sending out for more. It is not a blank check – it is a reasonably priced commodity. One bid was for over \$6 million and another for \$9 million."

Councilwoman Zusette Dato reminded everyone of the food drive at the senior center from 8 a.m. to 4 p.m. "Happy Thanksgiving."

Council Vice President Christine Noble wished everyone a Happy Thanksgiving.

Council President Mickey Gross wished everyone a Happy Thanksgiving. "Thank you to all first responders, for all you do!"

Mayor Fred Henry thanked the food pantry for giving out 270 turkey dinners and the South Amboy kitchen for cooking the turkey meals. I want to thank everyone. There was an emergency at Hillcrest. There was a gas leak, and it took the Office of Emergency Management, Fire Department, and Police Department for a smooth evacuation."

Business Administrator Glenn Skarzynski said that the city is working on the budget and opening bids on the Ferry Terminal will be on December 9th. Public Portion:

Resident Mary Szaro came up to speak. She gave a spotlight on the Green Team stating that the Team will have completed the requirements by 2023. She gave highlights on the Green Team's accomplishments and plans. She said they have installed an Environmental Commission and happy to get other ones. She stated there is a Wildlife Interaction Plan, Brownfield Interaction Plan. "We are holding a Green Fair on March 4, 2023." Szaro pointed out

Chris Smiga who was present at the council meeting who is leading a bright future for South Amboy. "Get the lead out," Community Forestry Management Plan, an Innovative Community Project which promotes the Green Team and a Community Educational and Outreach in the fall of 2022. Also included are Diversity and Equality Programs and Historic Preservation. She gave the council a chart explaining the details of the Green Team.

Chris Smiga came up to speak, "Under the direction of Jay Elliot (Director of Code Enforcement), we reached out to Edison. The households voluntarily participated in ta drinking water program. Half the households want a ban on lead. Middlesex Water has a "Get the Lead Out," timeline."

Council President Mickey Gross said, "The new law on the books is if you rent an apartment, the landlord is responsible to have someone come out and test the property. Also have an inspection done. It is on the landlord to do this."

Smiga continued, "We would like the city to create an Environmental Commission."

The next person to speak was Resident Norman Gayle who was experiencing a high sewer bill despite being a senior. "There is no dispute on facts. The billing of seniors is also on water. Right or wrongly, I will gather feedback. Some people got a lower sewer bill – but its not for commercial water."

Council President Gross said, "I didn't' realize we've ever done that. Middlesex Water is not our friend. We got a separate meter to specify for a sewer bill. They charge for a separate meter. Make sure. For multifamily property, they get that increase as well."

Councilwoman Dato said, "We've discussed this. We understand the need for an increase. It is uniform for homeowners with buildings that are that large."

The meeting adjourned at 7:43 p.m. All Council Members were present.

#### Perth Amboy Redevelopment Agency Works Toward a More Vibrant, Cultural Community PARA Focuses on Three Key Projects into 2023 \*Photo Submitted

Press Release 11/29/22 PERTH AMBOY – Fueled by Perth Amboy's strategic location at the crossroads of New Jersey, the city has a unique opportunity to create more mixedused communities and generate more tax revenue within its many redevelopment areas.

The Perth Amboy Redevelopment Agency (PARA) has identified three key projects that it is now advancing for 2023. Some initiatives build upon older plans that have been discussed for years, while others have been brought forth by developers eager to take advantage of all that Perth Amboy offers as a waterfront urban core.

"A key reason for the enormous interest in Perth Amboy is our unparalleled transportation infrastructure," said PARA Chairman Joel Rosa. "The city has a NJ Transit train stop at the heart of the downtown, a beautiful marina for boat travelers

public transportation that can take you anywhere throughout the state and major highways that pass through the region."

A major project on the drawing board is known as "Gateway," sitting on 54 acres of developable property just south of Smith Street at the Route 35 Victory Bridge.

Redevelopers consider the Gateway site a prime parcel. It sits on the water near the Cornucopia Cruise Line. It's just a 10-minute walk to the NJ Transit station, as well as the Smith Street retail corridor. Gateway is also just steps from the planned Borinqueneer Park and what will be an extended riverfront walkway and park.

In short, says renowned architect Dean Marchetto, the location is ideal for "place making," and has "opportunities for affordable housing, jobs, and social empowerment." Many proposals have been put forth,



taking advantage of the easy access of this property to the city's downtown and waterfront.

Another opportunity is creating a transit village at the Perth Amboy Train Station. The blocks between Market Street and New Brunswick Avenue and between the NJ Transit tracks and Maple Street represent a rare opportunity to redevelop many vacant and cityowned parcels downtown.

The timing is ideal. NJ Transit is earmarking nearly \$50 million to overhaul the Perth Amboy Train Station, built in 1927, listed on the National Register


of Historic Places in 1984 and now serving nearly 900 weekday commuters each day.

The goal is to build density on the four blocks between Market Street and New Brunswick Avenue, replacing low-rise buildings that are currently not taking advantage of the strategic proximity of the train station. PARA is also eager to introduce entertainment and culture into the downtown mix, creating a more vibrant outdoor environment into the evening hours.

Another key project will be at 599 Fayette St., a brownfield that is the former site of a municipal landfill that closed in 1974. The 20-acre parcel is ideal for office space, homes and commercial/retail opportunities.

This unique site of empty land in the middle of the city, with easy access to Smith Street and all the local highways, is ideal for redevelopment, with private investors required to cap the landfill as a "final remedy,"

Open Letter to Perth Amboy Residents on the **Disinformation** of Hackensack Meridian Raritan **Bay Medical** Center Services

Dear residents and community partners I write to you to stop the spread of disinformation about losing hospital services with its ongoing expansion at Raritan Bay Medical Center behavioral health services. In October 2022, Raritan Bay Medical Center shared two publications that included the fol-

1. The announcement of the opening of its first Long Term Acute Care Hospital (LTACH)

2. Interview with the new President and Chief Hospital Executive, Patricia Carroll

The Medical Center's executive leaders stated that the ongoing expansion would not result in losing hospital services.

On November 23, 2022, Hackensack Meridian Raritan Bay Medical Center once again reaffirmed its commitment to the City of Perth Amboy and investment in health services in a letter to my office and state legislative officials. This correspondence was also shared with our city council members.

The disinformation of losing hospital services due to behavioral health expansion is false, deceptive, and obscures the truth. Therefore, decisive action is needed when this falsehood spreads because it undermines our ability to engage in factbased public discourse.

I ask residents to challenge these falsehoods when heard, as they only serve those individuals who wish to take advantage of our community. We all must ensure that our residents are properly informed.

As always, my Administration will continue to provide good governance, maintain the highest standards of quality of life, and ensure the public safety of all our residents.

portant thing is that you need to make appointments to the HPC. We are behind."

City Clerk Kupsch spoke up, "We are behind in all municipal appointments."

Petrick stated, "They need to be reappointed quickly and applicants interviewed. Board appointments were supposed to have staggered expiration dates."

Opel responded, "We tried to have expired staggered dates on all boards."

Kupsch ended the discussion and said, "There was an ordinance to make all terms expire in the calendar year."

Next on the agenda was Towing Suspension appeals.

The first person to speak was a Police Captain. He stated, "There was a letter sent to A.T. Towing regarding charges because of fees that were issued. Overcharges included storage and cleanup fees."

Councilman Pabon said, "Did Adele Tawfik (the owner of A.T. Towing) accuse his employee of theft by overcharging for fees? Action should have been taken immediately instead of after a year when the complaint was made."

City Clerk Victoria Kupsch spoke up, "The towing contracts were signed in late September and contracts had not been issued in many years."

Pabon then asked, "Why was a towing contract given to A.T. Towing while they were being investigated?"

Law Director Opel then explained, "There is a rotating list of towers. There is an investigation going on and it is not a suspension."

A second police officer came up to speak, "When people complained about overcharging fees is when we investigated."

Adele Tawfik from A.T. Towing came up to speak. He said, "It wasn't until July 2022 that I was made aware of employee theft. Once I was made aware of it, the money that was overcharged was given back to the person whose car was towed. I've had to have an auditor come in. We should not be penalized for something we weren't aware of. A forensic auditor is going through all the paperwork before any criminal charges can be filed against our employee. We were not on the city contract list when the money was stolen from us."

Councilwoman Rose Morales asked, "Were there any prior incidents with this towing company?"

The Police Captain said, "I will look."

Opel spoke up again, "We haven't had towing contracts for a while."

Councilman Torres then remarked, "We need to have our own towing lot. This affects our whole community (insurance). We need to have a cohesive plan going forward when it comes to towing vehicles.

B.A. Greene responded, "The previous administration had no

towing contracts."

A representative from Scott's Towing came up next. He stated, "We need to get a copy of the investigation. I was not aware of this, and we need to prepare for what we need to present."

Council President Petrick responded, "I'm surprised that Scott Towing did not get any paperwork regarding a suspension since Tawfik got it."

Tawfik responded, "I did not get it. I only got it through my lawyer."

Opel ended the discussion, "If the council has no objection, we can reschedule the hearing and you have twenty days to render your decision."

The council then discussed the ordinances. Pabon was concerned about Ordinance No. 5

- Using \$465,000 from ARPA Funds for the restoration and paving of Sunshine Alley. "We need to check with the engineers on how it will be renovated, and we need to see the detailed paperwork. Let's not spend more money than we should have."

There were questions regarding an item under bids. Maria Rivera from the Purchasing Department explained that the RFP's for a Public Defender for \$350 per session and a Conflict Public Defender for \$350 per case, there should only have been one bid, even though it went out twice for bids.

B.A. Greene explained, "We are putting out a bid for another prosecutor since you rejected the one on the last agenda."

Victoria Kupsch spoke up, "The HPC Ordinance Amendment will be added as an Ordinance No. 3 for the first reading tonight."

Councilwoman Tejeda had a question regarding Ordinance No. 1 (first reading) – Administration of Government regarding residency of officers and employees. "Will this be only for people from Perth Amboy?"

Petrick explained, "This is removing some streets due to the fact there are no more residents living on those streets and that there are certain positions that do not require residencies."

Discussions then moved on to the Resolutions. City Clerk Kupsch made a correction on R-545-11/22 – Public Hearing and adoption on the 2023 Perth Amboy Business Improvement District Budget. "You have to remove the word "adoption" because the BID did not adopt their budget, yet."

Council President Petrick then spoke about R-547-11/22 – Insertion of revenue in the CY: 2022 Budget for the National Opioid Settlement in the amount of \$36,102.75.

"At the League of Municipal Conference Meeting, they offered municipalities free Narcan."

For R-559-11/22 – Authorizing a contract to purchase food gift cards from Wakefern Food Corp. in the amount not to exceed \$400,000.

Council President Petrick asked to table, and Joel Pabon seconded that motion.

There was a discussion on

R-560-11/22 — Authorizing a contract with Hanan A. Boulas, Esq. to represent the City of Perth Amboy as a Public Defender and a Conflict Public Defender for the period commencing January 1, 2023, and terminating December 31, 2023, in an amount not to exceed \$37,100."

Petrick asked, "Do we have more than one public defender?"

Maria Rivera from the Purchasing Department came up, "It always has been advertised that way, and usually the Conflict Public Defender would be another person."

Greene then talked about R-561-11/22 – A contract with Holiday Outdoor Décor for the purchase of Hometown Hero Light Pole Banners in an amount not to exceed \$43,068. "This would be for 200 banners."

Rivera added, "The OECD and the BID will be funding this project and split the cost between the two of them."

Fire Chief Ed Mullen came up to explain R-563-11/22 – A refund of a Fire Safety Permit of \$54 to El Caribe Multi-Services for a property located on 329 Maple Street.

"This is because they couldn't use a hotplate."

He went on to explain R-565-11/22 – A contract with Witmer Public Safety Group for the purchase of a Lion Bullseye Fire Extinguisher Training System in the amount of \$47,371.57.

"\$17,000 of this money will be for training. This system can be taken to different events to teach the public how to safely use fire extinguishers. Some of the features will include glowing flames and would be acting as if it were an actual fire-. We can see if it has a warranty along with it."/

There was a brief discussion on R-568-11/22 – A change order to the contract with Z Brothers Concrete Contractors for Street Improvement to Sadowski Parkway on High Street for \$62,870.58.

Greene explained, "That had to do with the conditions of the field."

Opel then added, "It will also help pay for additional traffic control officers."

Petrick then said, "There is a lot of debris, rusting, and leaves on Sadowski Parkway."

There was a discussion regarding R-569-11/22 — Authorizing payment to essential workers in an amount not to exceed \$485,000 which is being funded through the American Rescue Plan Act. (This resolution was put on the agenda by Council President Petrick)

Councilwoman Rose Morales spoke first, "At a previous meeting, they said that we can't do this.

Law Director Opel responded, "The mayor and administration can only do this. The council can only do a resolution supporting payment."

Petrick responded, "The mayor hasn't acted, so we have the authority to do this."

Opel disagreed, "The council

cannot authorize payments."

Councilwoman Tejeda spoke next, "I have no problem with this resolution except for a small item in Section No. 3."

Pabon then spoke up, "This should have been a resolution coming from the administration."

Petrick responded, "I don't care who takes responsibility for this as long as it is done."

B.J. Torres then passionately pleaded to the city employees, "We are trying to get this money to you that you deserve. It is your money."

Greene then spoke up, "There are some people (employees) who also applied for disaster relief."

Pabon suggested, "Any people that we have any doubts about you need to put them aside."

Morales was adamant and said, "We need a definite date when employees will get their money."

Torres was adamant when he said, "We should table all ARPA funds until the funds for the employees are given."

Petrick spoke up, "Now, it is splitting hairs. Who will give out money to authorize payment to the employees – the administration or us?"

B.A. Greene then responded, "We have to be good stewards for these federal funds."

Public Portion (In-house first):
Resident Mel Ramos spoke
first, "The 1683 Society has
guidelines when it comes to preserving stones for Sunshine Alley. We have information from
Nantucket. You have to appreci-

ate our history and preserve the

history of Sunshine Alley." The meeting was open to Zoom Participants. The only person to speak was Resident Maria Garcia, "We have been asking for 30 years to repair Sunshine Alley. In other countries, they preserved their historic cobblestone roads, and we should do the same."

The council went into closed session at 7:35 p.m. and came back at 7:58 p.m. to resume the caucus meeting and at 7:59 p.m. they adjourned the caucus meeting. The council meeting began at 8:00 p.m.

The meeting was opened up to the public for agenda items only. No one spoke in-person. On Zoom the first person to speak was Resident Sharon Hubberman. She asked, "Why is there a moratorium from doing any road repairs from December 1, 2022, thru April 1, 2023?"

Business Administrator Greene explained that no work can be done due to bad weather conditions.

The next speaker on Zoom was Resident Jeremy Baratta who questioned the positions for Public Defender and Prosecutors. "Why couldn't you find a local resident for those positions?"

Council President William Petrick stated, "There was only one bid."

Baratta continued, "When I attended the League of Municipalities, I spoke to two local people who were interested in

both of those positions. Maybe you should advertise those positions again. I've looked at a lot of those bid packets and they were not filled out correctly. There were fatal errors in their bids which made them invalid."

Law Director Opel addressed this, "Most were RFP's and the questions were answered satisfactorily."

Next was the public portion on ordinances that had their own public hearing. The one ordinance which drew a lot of attention was No. 5 – Appropriating \$465,000 from ARPA Funds for the restoration and paving of Sunshine Alley. All those who spoke about this were people on Toom

Resident Maria Garcia spoke first, "This is a lot of money, but it is due to the fact of a lack of maintenance for many years. Costs will continue to rise if it is not fixed. Preserve it like other towns do."

Councilman B.J. Torres responded, "We should table this until we can allocate money to our city employees, and we need a comprehensive plan (for these repairs)."

Council President Petrick then spoke up, "I feel we talk a lot about our history, and we have lost historic properties already (Eagleswood, Copperworks Building)."

Torres spoke again, "We lost over 70% of our historic sites in 30 years. If we had a plan, we could preserve more. It is putting the cart before the horse."

Sharon Hubberman spoke next via Zoom, "What technique will be used to preserve the alley? It has to be moved in mind with conservation. I am in favor of restoration, and we need a method to preserve the Alley. Will they reuse the cobblestone?"

Petrick answered, "They will remove the cobblestone, lift it up, a base would be required and recompress and stabilize the roadway. It will cost more as time goes by. They may use the original blueprints."

Caroline Pozycki spoke next via Zoom, "We should look at the priorities of our community. An organization of tiny membership goes in front of our employees. This will not benefit the community. What about our arts, children, and families? I'm appalled. There was no public hearing on this cobblestone which is behind the mayor's house."

The next speaker on Zoom was Jeremy Baratta, "There has been 30 years of neglect. I showed Sunshine Alley to someone who is interested in our historic sites. These ARPA funds were to be used to create jobs. It is an economic depressed area. This will increase the ambiance. Those property owners also pay their taxes. Take care of the Alley. It is part of the infrastructure and neglected roadways. Why punish those residents because the mayor lives on that street? Pass the ordinance."

The council voted on the or-

Ordinance No. 1 – Water/ Wastewater Improvements issuing bonds in the amount of \$1,500,000 - was moved by Pabon, seconded by Tejeda. The only person to vote "No" was Torres.

Ordinance No. 2, 3,4 was moved by Pabon, seconded by Tejeda.

Ordinance No. 5 - Sunshine Alley – was moved by Pabon, seconded by Tejeda. Councilman Joel Pabon abstained. B.J. Torres voted "No," motion passes.

There was a correction made on the bids. The RFP for Public Defender and Conflict Public Defender. Conflict Public Defender was removed from the bids.

Ordinance No. 1 (First Reading) – Administration of Government regarding residency of officers and employees was moved by Pabon, seconded by Tejeda. When it came time to vote, Morales and Tejeda voted, "No." motion passes.

Ordinance No. 2 (First Reading) – Streets and Sidewalks – was moved by Pabon, seconded by Tejeda.

For the consent agenda, R-545 thru R-558; and R-560 thru R-568 was moved by Pabon, seconded by Tejeda.

R-559 - Authorizing a contract to purchase food gift cards from Wakefern Food Corporation in an amount not to exceed \$400,000. was tabled.

R-569 – Authorizing payment to essential workers in an amount not to exceed \$485,000 which is being funded through the American Rescue Plan Act. It was moved by Pabon, seconded by Petrick.

Before they voted individually, one of the council members asked for clarification.

Councilwoman Tejeda wanted more details.

Torres said, "We made the move, and the employees deserve their money, and not just talk. This could have been done months ago, and the mayor didn't do anything."

Law Director Opel responded, "The council doesn't have the authority to authorize payment. It can be challenged."

Petrick responded. The Administration can cure this.

Opel then said, "I can't sign the resolution as presented."

When it came to vote for R-569, Tejeda and Morales voted "No".

R-570 - 11/22 - Have free parking from <math>11/25/22 to 1/1/2023 - was voted on to be

put on as a late-starter. It was moved by Pabon to be put on the agenda, seconded by Tejeda. When it came time to vote on it, it was moved by Pabon, seconded by Tejeda. All voted, "Yes".

There was a hearing on the BID Budget, but no one spoke. Public Portion: No one spoke in person. The only person to speak via Zoom was Resident Sharon Hubberman. "I want to thank the Perth Amboy and Woodbridge Police who caught the robbery suspects of those catalytic converters. I wish all a Happy Thanksgiving."

## **Assembly Speaker Announces \$3 Million Investment into the Proprietary House**

Funding Will Go Towards Revitalization in Anticipation of Nation's Semiquincentennial Anniversary

PERTH AMBOY – Assembly Speaker Craig Coughlin (D-19th Dist.) announced a \$3 million investment in the Proprietary House in preparation for the nation's Semiquincentennial anniversary. The anniversary, taking place in 2026, will mark the signing of the Declaration of Independence and our nation's 250th year of independence.

Support of the Proprietary House was among a number of historic Revolutionary War sites to share in a \$25 million initiative advanced by legislators using federal American Rescue Plan dollars, as the state is preparing to greet visitors, both far and near, to mark the anni-

In the spring, Coughlin visited the Proprietary House with Assemblywoman Yvonne Lopez (D-19th Dist.) and other dignitaries to discuss the upcoming anniversary and how best to prepare the home for thousands of history buffs from across the globe.

Local officials say the home at 149 Kearny Ave. is the last-standing mansion of a royal governor among the 13 colonies. The nation's birthday should serve as an opportunity to educate a new generation about the historical significance of the state-owned structure.

"The historical significance of Perth Amboy during the Revolutionary War rivals any city in Massachusetts, Pennsylvania or Virginia," Coughlin said. "As America prepares for celebrations in 2026, it is vital that Perth Amboy's history play an integral role, as well as a top tourism site."

Coughlin, along with fellow 19th district lawmakers Sen. Joe Vitale and Lopez, led the charge for state funding to support sorely needed renovations of Proprietary House. Prior to this latest grant, the legislators secured \$3 million in the state's fiscal '19 budget to support the building's rehabilitation.

The site is now well maintained and showcases late 18th century living as the home of a loyalist royal governor, William Franklin through 1776.

"Perth Amboy played such a pivotal role during the Revolutionary War; our port was a major point of access," explained Lopez, who lives just a few blocks from the Proprietary House. "In fact, our official city seal reads "aportus optimus," which is Latin for 'best port.' We were a gateway to the New World, to rival New York.

"Many are unaware that more battles were fought in New Jersey during the war than any other state," the assemblywoman added. "And key decisions were

made right here, in New Jersey, that led to the successful outcome of the war."

"Revolution NJ," through the non-profit Crossroads of the American Revolution, was established in 2018 as the state's planning entity for the upcoming anniversary. The group is now conducting planning studies to establish New Jersey as a major Revolutionary War Heritage Tourism destination.

"Urban areas are typically overlooked for heritage tourism potential, but are precisely the types of places that stand to benefit enormously," Lopez said. "We need more grants to make the Proprietary House ready to accommodate many more visitors, while further boosting its historical and heritage identity in Middlesex County."

Vitale said about six percent of New Jersey's tourism dollars are generated from heritage tourism, amounting to just under \$400 million in state and local tax revenues and \$3 billion in economic impact.

"That's about half of the average activity generated by heritage tourism nationally and third of what New Jersey could do if we were putting weight behind advertising and branding the way our neighbors do it," the senator said. "There's a New Jersey story to be told and we're working to tell it."

During the Revolutionary War, Proprietary House was occupied by both Patriot and British troops and, for a time, served as headquarters for both American General Hugh Mercer and British General Sir William Howe.

After the war, Proprietary House was abandoned, vandalized, and nearly destroyed by fire. Exposed to the elements, the ruins stood as mute witness to the wrenching personal costs of the American Revolution. Yet, its fortunes would be revived along with those of the new nation

After hosting a royal governor, it became a stylish hotel, a private residence, a run-down boarding house and, now, a museum, operated by the non-profit Proprietary House Association. It is open for guided tours, lectures, concerts, storytelling, ghost tours, and teas, as well as for weddings, dinners, meetings, and luncheons.

The ground and first floors of the original mansion are now leased to the Association, charged with raising funds for programs, interpretation and restoration. Since the 1970s, countless volunteer hours and the financial support of historyloving donors have enabled the ongoing restoration of Proprietary House and its museum.

Funds will be allocated to the New Jersey Department of the Treasury and distributed to Revolution NJ, in partnership with the New Jersey Historical Commission and Crossroads of the American Revolution, to help in the restoration of the following state-owned Revolutionary War sites:

- Trenton's Old Barracks
- Battle Monument in TrentonPrinceton Battlefield State
- Monmouth Battlefield State ParkProprietary House in Perth
- Amboy

'New Jersey's role in the American Revolution is unquestionably significant," Coughlin said. "The Battles of Trenton and Princeton singularly re-energized the fledging effort at perhaps the most crucial point of the war. Today's sizable \$25 million investment in capital upgrades across ten critical, state-owned sites marks a big step in the leveraging the full civic and economic potential of our state's consequential revolutionary war history, not just in preparation for 2026 but for the years that lie ahead."







#### **LGBTQ Curriculum Main Topic for Discussion**

11/17/22 Board of Education Meeting

By: Katherine Massopust PERTH AMBOY – The meeting began with the Student Representative report.

During the public portion, District Representative Lynn Audet for the Perth Amboy Federation gave a statement.

It was suggested by Board Member Junior Iglesia for the sake of convenience, that speakers be allowed to speak for 5 minutes instead of the usual 3 minutes.

A mother of a student came up to speak. She mentioned that on Monday, November 21, 2022, there was to be a meeting with Board Members and parents to discuss the LGBTQ Curriculum. "There is a subject understanding their body. The kids have to come up to the board and identify the clitoris, vagina, and penis. This is inappropriate. Let's fight for the parents. Our parents are not in agreement. They are taking away boy/girl and putting in they/them. Now learn all this in the classroom. I don't want none of it. It encourages you might feel like a boy or a girl. It over sexualizes our children and removes innocence. It promotes transgenderism and hormone blockers. There is a new push to skip natural growth to our children. It promotes sexual activity. One project is to discuss the Pride Flag. There is a time and place for everything. We are not allowed to say "God" in school, but we can say "penis." Let's emphasize how to respect one another indoctrinate our kids."

Resident Sharon Hubberman spoke on Zoom, "I sent an email to the Board President, Vice President and Board Secretary regarding publication of the special meeting (on 11/21/22) and have not received a response." Hubberman stated that she did not receive any details about this meeting and if it is for the public. "We received \$291 million dedicated part of the taxes, but most comes from the state. Changes should be emphasized in a way that parents can understand. Many changes are not age appropriate. The Board of Education should have that discussion publicly."

Board Member Junior Iglesia stated, "One main goal in education is to accomplish this goal is to listen to public concerns. 80% of Latinos do not speak English. It is in the best interest of the Board of Education to make the meeting more inclusive. We need the Board of Education an English/Spanish Translator.

Board Vice President Tashi Vazquez stated, "I've been on the Board for six years now. I never had someone that doesn't speak English at no time during my tenure have we stopped someone from speaking. By no means this service is not being provided. It is not a new concept."

Iglesia said, "We need to advertise it more. Parents feel intimidates. We can make it better."

Vazquez asked, "For a part or the entire meeting?"

Iglesia answered, "The public

portion is the concern. It will be a safe space."

The Board agreed.

Igelsia said, "It is an issue of great concern." He continued to mention different districts in New Jersey who modified the LGBTQ Curriculum to be more age appropriate. "We all have to work together as one community. There are different pathways to teach. We need to decide what is the best course of action."

Board President Ken Puccio responded to Igleia's suggestions, "The state mandates what we teach. We are three months into the school year. They have to do what is mandated. Next time, we will have three new Board Members."

Board Vice President Tashi Vazquez said, "The Special Meeting is not for the Board to vote upon the program. It is to communicate with the parents. It is a heavy conversation. It gives the parents an opportunity to put in their questions."

Puccio added, "We are human beings. My personal opinion – I cannot let that cloud my judgement. Nobody is ignoring them. All of us care deeply. It is the parents' job to come up and speak. Right now, I cannot interfere with my oath of office. People in Trenton don't think about this. They want people's votes."

Board Member Stephanie Márquez-Villafañe said, "The districts (who modified the curriculum) are being sued. Four districts are involved in lawsuits."

Puccio added, "To go into that loopholes are not an easy decision to make. The decision falls on your lap. This curriculum has been around since 2020. It is up to the people. Children have already been exposed to the curriculum."

Stephanie Márquez-Villafañe said, "I agree with Mr. Puccio. Were having a meeting. That's going to be heard. There is a line where the School Board can and can't do."

It was noted that there will be three new Board of Education Members in January.

Superintendent Dr. David Roman said, "We cannot go against the State Board of Education. The Conversation is at the legislative level. We must adhere to it. There are other areas that are alarming to parents. We feel your pain. That is why we have an opt out."

There was a discussion as to whether the Board should have a special meeting on December 1st to vote upon this. The only Board Member to vote "yes" was Junior Iglesia.

It was noted that Board Members Tashi Vazquez, Junior Iglesia, and Dr. Danielle Brown (not present at the meeting) did not seek reelection and will be leaving the Board.

After the Public Portion was closed, Dr. David Roman stated there were reasons that executive sessions were so long. That is because not all the Board Members agree on things and there are heated discussions. "Board Vice President Tashi

came to the table with open mind. You are a professional. What we do here is difficult. It has been a pleasure. I am looking forward to working with the new Board Members."

Board President Ken Puccio said, "The perception is out there that Mr. Iglesia and I are adversaries. In the six years I've seen Mr. Iglesia – he takes his office seriously. He is a father and schoolteacher in New York City. It's been my pleasure to serve with him." Puccio then spoke about Tashi Vazquez, "I can't say enough about Ms. Tashi Vazquez. I've known Tashi since she was ten years old when I was doing the DARE Program. They picked Tashi for the newspaper article. The newspaper quoted Tashi all over the place. This is the soul of Perth Amboy. She works 18 hours a day. It comes from the heart. She means well. We need a lot more Junior Iglesia, Tashi Vazquez and Dr. Danielle Browns. I am proud to say that Tashi is my friend. Thank you for what you do."

Board Member Michael George said, "I've been on this Board during that time. Danielle is one of my students. Kudos to Ken Puccio and Tashi Vazquez and Mr. Igelsia. I have respect for you. We are losing four good people. (If Ken Puccio wins the Council election of which he is a candidate for, he will leave the BOE). Our hands are somewhat tied. We fight for you. I want to thank Tashi Vazquez, Junior Iglesia, Dr. Danielle Brown, and Ken Puccio for serving on the Board. You should be very proud."

The Board went into closed session at 7:04 p.m. They returned at 8:40 p.m.

Board President Puccio gave the Board President's report. He mentioned his condolences to Board Member Dr. Danielle Brown who lost her father, Harold Brown who was part of the Perth Amboy 1968 State Championship Basketball Team. "I was at that game." Puccio also offered his sympathy to the family of Tyrone Fashaw, "Mr. Perth Amboy, - There wasn't a football game he wasn't involved in. He would take photos of games and ask for nothing. The last fourteen years has been a roller coaster – the happiest and the hardest."

Superintendent Dr. David Roman said, "He is the premiere reason this district has moved forward. The district is welcoming everyone to the table. We don't always have agreements in executive sessions. We work together for this district. He offered the opportunity to engage in us the quality of work being done. We're building up a school to be opened up in September 2024. Have a Healthy, Happy, Peaceful Thanksgiving!"

Vazquez spoke about the DARE Program which she views as a wonderful addition to our students. "It builds a foundation."

Puccio said, "Teaching DARE I get a better understanding what teaching is."

There was a brief discussion on the donation of 450 winter coats from Mr. Eladio Ruiz and his project, "Cathy's Kids," under the direction of Mr. Michael LoBrace and Mr. Francisco Velez. It was noted that the principals will determine who is most in need.

There was also a brief discussion on a \$500 donation to the Ignacio Cruz Early Learning Center form the Colonial Pipeline Company and a donation of 75 book bags from Home Depot of Perth Amboy. The principals will see that the students receive the supplies.

There was a brief discussion about changes in Zoom.

Board Vice President Vazquez spoke about armed security guards, "We thought it is very important. We have to do whatever is best for the community. We have to think about our students. You can hire police officers, security guards. They are here to make us safe."

Dr. Roman thanked Dr. Tibor, "He has his ands full as an educator. He is thoughtful and pragmatic to keep everyone safe. We have a very safe school district."

Near the end of the meeting, out-going Board Members Junior Iglesia and Tashi Vazquez made a few brief statements.

Board Member Junior Iglesia said, "For me, six years have been an honor. We learn to disagree. The decisions and collaborative – we all want what is best for the district. We don't get paid for this."

Board Vice President Tashi Vazquez thanked Dr. Roman and Ken Puccio. "I want to advocate. I want to be the light for somebody else and make sure to do that for our students. Being a Board Member gave me a voice. I am going to continue to do this when I can."

Board President Ken Puccio said, "My destiny has not been decided yet. After serving on the Board for 14 years, I've got to serve with Mr. George. Stephanie — who sat there through the hardest times. You were the voice. You guys are here all the time. You bring us through a lot of negativity. You can't please everyone. A lot between the 14 years ago. Them, you, us — we've seen you grow up."

Vazquez added, "Some accomplishments over the last 6 years." She went on to describe the clap-out which was suggested by Randy Convery for a teacher with certain credentials that was retiring. "To do that – what you think is simple can be immense. We don't talk about the things. This Board has done a lot. It takes all of us. The community to put us in the right direction and tell us what is going on. It is not getting a rubber stamp. We are more different than you think. Get involved in local politics. Don't give up! I encourage you to come with an open mind."

The meeting adjourned at 9:48 p.m. Board Members Dr. Danielle Brown and Stacy Peralta were not present.

Junior Igleisa, Tashi Vazquez and Dr. Danielle Brown chose not to run for reelection to the Board

The Friends of Perth Amboy Free Public Library Promotes Literacy and More!

By: Katherine Massopust PERTH AMBOY - After Wilda Diaz took office, she formed a committee to raise money to renovate the library. It was initially under the umbrella of Celebrate Perth Amboy which later became Save Our Carnegie Library. By 2009, the library's conditions were terrible, including a leaky roof, mold coming off the ceiling, and a slew of other much needed repairs and attention. The Save Our Carnegie Library was chaired by Karen Kubulak and had multiple fundraisers to raise money for library renovations. One of those fundraisers was a gala at the Raritan Bay Yacht Club chaired by then trustee, Jim Woller.

However, then Library Board of Trustees President Barbara Sottilaro wanted to set up something more permanent to help the library, hence the restart of a Friends of Perth Amboy Free Public Library organization.

On February 24, 2010, the Friends of Perth Amboy Free Public Library Steering Committee was formed. It consisted of Barbara Sottilaro (Liaison to the Library Board of Trustees), Katherine Massopust (Founding President), Arlene Fogarty (Founding Vice-President), Toni Gianfrancesco (Founding Secretary), Joyce Signorile (Founding Treasurer), and Gloria Spear and Pinkie Rodgers who were Founding Membersat-Large. The Friends Steering Committee was later joined by Linda Luden.

The organization soon ratified their by-laws, registered with the State of New Jersey as a Nonprofit Organization, opened a bank account, and a post office box and were well on their way to get their 501c-3 status. The Friends held a logo contest with art students at Perth Amboy High School under the direction of Art Teacher Mrs. Marcella Massopust and decided upon a logo.

Realizing the need for funding for renovations to the library, the Friends of Perth Amboy Free Public Library held numerous fundraisers for the muchneeded renovations.

To start with, the Friends had several book sales at the library. This was to fill a dual purpose. Library Director Pat Gandy had plenty of old books to sell, and at the same time, the Friends raised money for the library.

The Friends also undertook the massive responsibility to run two Taste of Perth Amboy's at St. Demetrios Greek Orthodox Church's Hall. This was done upon the request of the late Carlos Martins who was also a member of the Save Our Carnegie Library Committee which by now became less active after their own numerous fundraisers. Barbara Sottilaro chaired the 2011 Taste of Perth Amboy with Carlos Martins, and the 2012 Taste of Perth Amboy with Rozalia Czaban.

On June 7, 2013, The Friends had a special open meeting at the Raritan Bay YMCA to highlight the work they did. It included a film made by the Friends in conjunction with the city that showed the poor conditions that the library was in. Councilmen Joel Pabon and

Kenny Gonzalez were in the film (the video can be viewed on the Friends website, Media Gallery, Taste of Perth Amboy 2011).

A citywide jug collection was initiated to help with the renovation of the library. This began with the Save Our Carnegie Library Committee, and later continued by the Friends of Perth Amboy Free Public Library. The Friends collected over \$1000 in change which was donated to the city for renovations.

Checks from the proceeds of these events were presented at Perth Amboy City Council Meetings. These proceeds totaled over \$15,000 for library renovations.

Beginning In 2011, the Friends in conjunction with the Kearny Cottage Historical Association created a 2012 Calendar with restored photographs and sold them as a fundraiser. Each month of the calendar was sponsored by a different business in Perth Amboy. The proceeds from sales of the calendars are split between the Friends of Perth Amboy Free Public Library and the Kearny Cottage Historical Association. With a two-year hiatus due to the pandemic in from 2020-2022, these historic calendars are now being continued and are on sale now at the Barge and from Friends members.

The Friends have hosted many authors and different programs over the years and continue to support the library and promote literacy. One of the first programs the Friends had was Children's Author Artie Bennet, author of The Butt Book and Poopendous! who came to read to local school children. His popularity is growing, and the reading of his books remain an ever-popular event with the children.

In 2015 the Friends began their Book Sales at the Brighton Avenue Community Center and are there for every second and fourth Saturday of the month from 1 p.m. to 4 p.m. This was chaired by Linda Luden. Members Alice George and Norine Gall soon joined the organization, often coming to the Saturday Afternoon Book Sales.

In 2015 the Friends had their first Book Fair at Barnes and Noble in Menlo Park, NJ. A percentage of the net sales that take place on that date benefited the Perth Amboy Free Public Library. The Friends continued the Book Fair at Barnes and

Noble. The PAFOL reached out to all 5 public elementary schools, Assumption Catholic School and Perth Amboy Catholic School for a book donation valuing \$200 per school. The following year, the Friends reached out to the Middle Schools in Perth Amboy, for a book donation. For the 2017 Book Fair, the Friends reached out to Alternative School, Ignacio Cruz Education Center, and Perth Amboy Lower Catholic School. In 2018, the Friends donated to the Perth Amboy Children's Library. Art Teacher Rachel Wittenberg helped with both years. The Friends would continue to have the Book Fairs at Barnes and Noble until the Barnes & Noble discontinued the program.

Because of the NJ law restricting the use of plastic bags, The Friends decided to sell reusable grocery bags which are available at the book sale and from members.

In 2016 the Friends launched the Museum Pass Program, which provides free passes to Grounds for Sculpture, the Intrepid Air and Space Museum, and the Museum of Natural History. This program continued until the hiatus during the pandemic, which has since been revived in 2022. The Thomas Edison Museum in Menlo Park, NJ has been added for January 2023.



The Black Panther, the Protector of Wakanda, the hero the king is now dead. #### This Week in the Civil War 160 Years Ago December 7, 1862 – December 20, 1862

Confederate Maj. Gen. Thomas Hindman, with 12,000 troops, on December 7, 1862, attacks 6,000 Union troops under Brig. Gen Francis Herron at Prairie Grove, Arkansas. Shortly after the battle is joined, U.S. Maj. Gen. James Blunt arrives with an additional 7,000 Federal soldiers. The fight lasts until dark, and Hindman's force withdraws during the night. U.S. casualties: 1,251; Confederate: 1,317. On the same day, Col. John Hunt Morgan leads Confederate cavalry against a Federal garrison at Huntsville, Tennessee. The Union loses 2,096 soldiers, including 1,800 taken prisoner. At Vicksburg, Mississippi, Lt. Gen. John Pemberton receives a communication from Jefferson Davis expressing concern about Pemberton's ability to defend against an attack by the Federal forces of Maj. Gen. Grant.

To address criticisms that he is ignoring the Western Theater, Confederate President Jefferson Davis on December 10 embarks on a month-long information-gathering trip, with stops in Tennessee, Georgia, Alabama and Mississippi. Union troops of Maj. Gen. Ambrose Burnside continue their preparations for an assault on Fredericksburg, Virginia. In Washington, D.C., a bill to create the state of West Virginia passes in the House of Representatives. (The Senate had approved the action in July 1862.)

On December 11, intending to relieve pressure on Confederate Maj. Gen. Earl Van Dorn in Mississippi and to disrupt Union Maj. Gen. Grant's communications, Confederate Brig. Gen. Nathan Bedford Forrest leads 2,100 cavalrymen and four guns out of Columbia, Tennessee, on a raid through western Tennessee. In the East, Brig. Gen. John Foster leads a massive Union raiding party of 10,000 infantry, 640 cavalry and 40 guns out of coastal New Bern, North Carolina, into the interior of the state. In Virginia, Maj. Gen. Ambrose Burnside's Army of the Potomac makes a hotly contested crossing of the Rappahannock River via five pontoon bridges and enters Fredericksburg. Spending the day clearing out Confederate troops, the Federals occupy the town by nightfall.

Confederate President Jefferson Davis, on his swing through the Western Theater, meets with Gen. Braxton Bragg at Murfreesboro, Tennessee, on December 12. Convinced that Bragg is in a secure position, Davis — over the vehement objection of both Bragg and his senior commander, Gen. Joseph Johnston — orders the transfer of 7,500 soldiers to Lt. Gen. Pemberton for the defense of Vicksburg, Mississippi. The move leaves Bragg with 37,000 troops. At Fredericksburg, Virginia, both armies position themselves for the impending battle. Near Vicksburg, on the Yazoo River, the ironclad gunboat *USS Cairo* is sunk by an electrically detonated Confederate mine near Haines Bluff, Mississippi.

In Virginia, on December 13, Maj. Gen. Ambrose Burnside, launches his 106,000-strong Army of the Potomac against Gen. Robert E. Lee's 72,000 Confederates positioned in and south of the city. On the Federal left, soldiers under Maj. Gen. George Meade penetrate Lt. Gen. Stonewall Jackson's Confederate lines, but they get no support from reinforcements and must withdraw. On the Federal right, wave after wave of Union soldiers is sent to attack Lt. Gen. James Longstreet's strongly entrenched troops on Marye's Heights, above the town. Confederate infantrymen are behind a stone wall bordering a sunken road, with their artillery above and behind them. The Yankees, who must traverse a long, open slope with only shallow depressions for shelter, are slaughtered. U.S. casualties: 12,700 killed or wounded. Confederate casualties: 5,300. At the end of the day, the Federals remain in Fredericksburg and the Confederates remain on the ridges above them.

On December 14, Maj. Gen. Burnside wishes to continue the attacks on the Confederate positions but is dissuaded by his subordinates. The defeated Army of the Potomac in and around Fredericksburg, Virginia, prepares to move back across the Rappahannock River, whence it came. Although vulnerable, the Federals are not attacked by Lee's Confederates — the Northern army still outnumbers the Southerners, and it is protected by massive artillery batteries across the river. In the Deep South, U.S. Maj. Gen. Nathaniel Banks arrives in New Orleans on December 14 to assume military command from Maj. Gen. Benjamin Butler, who departs the next day. Many residents of the Crescent City are elated to see the widely reviled "Beast" Butler leave. In North Carolina, Confederates at Kinston are routed by the massive raiding force of Brig. Gen. John Foster, which sacks the city.

Maj. Gen. U.S. Grant, targeting Vicksburg, Mississippi, on December 15 begins experiencing communications problems with his various forces caused by the actions of the Confederate cavalry of Brig. Gen. Nathan Bedford Forrest.

With his Army of the Potomac occupying Falmouth, Virginia, across from Fredericksburg, Maj. Gen. Ambrose Burnside on December 16 makes a statement accepting full responsibility for the debacle on December 13. Brig. Gen. John Foster's Union troops push the Confederates out of Whitehall, North Carolina, and burn the CSS Neuse, under construction there, as they continue to move westward in the Tar Heel State.

In Washington, because of continuing bickering and conflicts with Treasury Secretary Salmon P. Chase, Secretary of State William Seward tenders his resignation to President Lincoln on December 17. Three days later, Secretary Chase submits his resignation, also. After numerous meetings with the two men and others, Lincoln refuses to accept either resignation, asking both to stay on. They agree, but tensions remain. Brig. Gen. John Foster's troops attack Goldsboro, North Carolina, burning the railroad bridge across the Neuse River, the primary target of the raid. Afterward, they make their way back east to New Bern. In the West, Maj. Gen. Grant publishes his *General Order Number 11*. Although it deals with speculation and profiteering in his department (which includes parts of Kentucky, Tennessee and Mississippi), it specifically singles out Jews: "The Jews, as a class violating every regulation of trade established by the Treasury Department and also department orders, are hereby expelled from the department within twenty-four hours from receipt of this order." Although Grant's order is rescinded several weeks later, his reputation is tarnished by the adverse publicity that arises.

On December 18, Maj. Gen. Earl Van Dorn leads 3,500 Confederate cavalrymen behind the army of U.S. Maj. Gen. Grant, which is heading south toward Vicksburg. Brig. Gen. Forrest's cavalry defeats a Federal garrison at Lexington, Tennessee.

Forrest's cavalry on December 19 strikes the Mobile & Ohio Railroad near Three Way, Tennessee, destroying tracks and rolling stock, as well as stations and bridges in the vicinity, further hampering Grant's movements towards Vicksburg.

On December 20, Maj. Gen. William T. Sherman embarks on a water-borne operation that's part of Grant's plan for taking Vicksburg, Mississippi. Sherman leads 32,000 U.S. troops in 50 boats down the Mississippi River from Memphis. Confederate Maj. Gen. Van Dorn's men capture the huge Federal depot at Holly Springs, Mississippi, destroying \$1.5 million in supplies and taking 1,500 prisoners. The Confederates also burn 4,000 cotton bales to prevent them from falling into Union hands. The Confederate cavalry of Brig. Gen. Nathan Bedford Forrest captures Trenton, Tennessee. The losses force Grant to halt his overland advance on Vicksburg, thwarting his plan to join forces with Sherman's men moving down the Mississippi River. Grant withdraws his force some 60 miles northward, from Oxford, Mississippi, to La Grange, Tennessee.




